

Indoor Exercise—Hazardous To Your Health?

Pulled muscles and dislocated joints aren't what you had in mind when you set out to get in shape. However, as colder weather forces your shaping up indoors, that's what you could end up with. Here are some helpful hints from the 3M First Aid Center to help you get all the benefits of exercise without making muscle-straining blunders.

• DO make sure you have enough room for whatever exercise you'll be doing. Move away any objects or furniture which can get in your way. This is especially true with exercise videotapes. It's easy to get carried away, focusing on the television, and not your surroundings. You should also move area rugs that could slip during exercise and cause you to fall, and, position yourself away from any walls to avoid unnecessary obstruction.

• DON'T use exercise equipment unless it's been maintained and is in good working order. Equipment which hasn't been used in a while should be tested. If the seat on your stationary bike is loose, or the joints which



support the bike aren't tightened, you could cause some serious injury. Keeping a 3M Cold Comfort cold pack handy to "ice" down any bumps or sprains is a good idea, just in case you do slip or fall

• DO try these cold weather indoor exercises: aerobics/calisthenics, stationary bicycling, bowling, dancing, rowing machine, ice and roller skating, swimming, tennis, racquetball, squash walking on a stationary treadmill, weight training.

• DON'T workout without warming up. Ten minutes of stretching will go a long way in cutting down on minor injuries.



Great American Smokeout

The results of the Gallup Survey conducted after the Great American Smokeout are as follows:

* 36.9 percent of the nation's 50 million smokers participated. This means 18.4 million smokers quit or cut down for the day.

* 10.7 percent of the nation's smokers successfully abstained from smoking for 24 hours. This is a total of 5.4 million smokers.

* 3.4 million smokers were still abstaining from tobacco use one to three days after the Smokeout.

* 86 percent of those surveyed (1,203 men and women 18 or over, by telephone) had heard of the Great American Smokeout.

It is not surprising that participation figures are down from last year. As the country's smoking population continues to decrease, we are left with a "hard core" of smokers who are more difficult to reach.

We can expect decreases in participation because they reflect increases in the number of ex-smokers and nonsmokers in the population. The number who are successful for 24 hours and the number who are quitting for longer periods are very consistent from year to year.







Attention Drivers

EDITOR'S NOTE -- The following information came from Jimmy Martin, Irion County Sheriff and Department of Public Safety Trooper, Tom Usery. It was deemed to be of great importance and is being printed again.

Effective January 1, 1984 the State of Texas began issuing driver's license under a classified licensing plan. The classified plan does not effect the validity of an operator or chaufeur license issued under the old law. These license continue in effect according to their terms until such time they are converted to an equivalent class of license.

Regarding the application of minors who would apply for a driver's license; a Class C driver is one who is under the age of eighteen (18) years, provided the person is sixteen (16) years of age or older and has completed a driver training course approved by the Department, and has passed the examination required by Section 10 of this Act. The Department of Public Safety will not grant the application of any minor under the age of eighteen (18) years for a driver's

license unless application is signed by the parent of the applicant who has the custody of the applicant, otherwise by the guardian having the custody of the applicant, or in the event a minor under the age of eighteen (18) years has no parent, or guardian, the license shall not be issued to the minor unless his application therefore is signed by his employer or by the county judge of his residence.

Section 35 of the Statute concerns permitting unauthorized minors to drive. This section states that no person shall cause or knowingly permit his child or ward under the age of eighteen (18) years to drive a motor vehicle upon any highway when such minor is not authorized hereunder or in violation of any provisions of this Act.

Section 36 further states that "No person shall authorize or knowingly permit a motor vehicle owned by him under his control to be driven upon any highway by any person who is not authorized hereunder or in violation of any provisions of this Act.



A Touch of History

Texas' first traffic law was passed by the 30th legislature on April 17, 1907. In part it provided that: "All owners of automobiles or motor vehicles shall before using such...upon the public roads, streets or driveways, register with the county clerk of the county in which he resides, his name, which shall be registered by the county clerk in consecutive order in a book to be kept for that purpose, and shall be numbered in the order of their registration...." There was a fee of fifty cents.

The law was enacted in 1907, registration began in 1909 in Schleicher County with W.D. Ake's Buick No. 1,

and ended, after April 5, 1916, with J.B. Christian's Oakland, No. 143. The State of Texas then took over registration.

W.D. Ake settled in the Rudd Community in north eastern part of Schleicher County in 1892. He was Rudd postmaster from 1898 until 1920. Ake was also the first commissioner for Precinct No. 3. He was elected in 1901 when Schleicher County established her first government. He
