

County rescinds Burn Ban

Fire Chief Jerry Jones met briefly with Schleicher County Commissioner Monday, April 24th and advised that conditions are now right for them to lift the county-wide burn ban that has been in effect since November 28, 2005.


Jones told the commissioners that recent rains have "greened up" the undergrowth across most of the county. He said he drove over much of the county on Sunday and that his only concern was for the western-most portion of the county, and area where few people live and where lifting the burn ban would have little impact.

With that the commissioners agreed to Jones request to rescind the burn ban effective immediately. They noted, however, that the ban could be easily reinstated if Jones determines that conditions warrant such a move. It should be noted that outdoor burning of trash is still prohibited within the city limits by city ordinance.

The meeting was the commissioners' regularly scheduled session and was called to order by County Judge Johnny Griffin with commissioners Johnny Mayo, Kirk Griffin and Matt Brown in attendance. Commissioner Bill Clark arrived shortly after the meeting began.

Among other business, the commissioners met with Extension agents Roxanne Fentress and Cory Stevens who asked for the county's help with the annual spring clean up day on Friday, May 5.

The men approved the clean up date and agreed to make county crews and equipment available for trash pickup. To have trash picked up on that date call the Extension Office at 853-2132. No tires, wire, batteries or appliances containing Freon will be picked up. It should also be noted that county employees cannot go on private property.



FLDS man defies prophet, pays taxes on home

Patrick Pipkin, 23, of Colorado City, AZ, publicly defied FLDS Prophet Warren Jeffs last week and appeared at a meeting with Bruce Wisan, the Salt Lake City accountant who was recently appointed as Special Fiduciary to oversee property owned by the United Effort Plan trust. The UEP, which owns most of the property in the twin cities of Hildale, UT and C-City, AZ, was once controlled by Jeffs and his supporters. But a Utah judge last year removed the fundamentalist prophet and several of his lieutenants from their positions as UEP trustees.

Since that time, Wisan has been locked in a power struggle with Jeffs' followers who until now have refused to recognize his authority over the property.

Delinquent taxes, and a town full of Jeffs' faithful who are refusing to pay is threatening to bankrupt the twin cities, as well as the local school district.

Still, Jeffs' order stands and FLDS members are supposed to refrain from paying their taxes.

The first indication that there might be a leak in the dike came last week when an eviction order was issued for Lyle Jeffs, FLDS bishop and brother to Warren Jeffs. However, instead of standing firm and refusing to pay his taxes, a FLDS member appeared on Lyle Jeffs' behalf and paid some \$14,000, the amount necessary to settle Lyle Jeffs' tax liability.

But at the same time, Lyle Jeffs was pressuring Patrick Pipkin to ignore Wisan's

All Eldorado residents are being encouraged to participate in the Great Texas Trash Off on Friday, May 5th. Local sponsors include Eldorado Pride, Schleicher County, the City of Eldorado and the Texas Cooperative Extension.

We will have two major goals. The first goal is to clean up large items of trash and debris. The second goal is to encourage the planting of trees and other life giving plants. We will be emphasizing those that do not require large amounts of water for maintenance. County Judge Johnny Griffin and County Road Superintendent, Clay Burleson have stressed the County will be happy to pick up any items in the alleys on May 5th but cannot go on private property. If you have any large items that need to be picked up, please call the County Extension Office at 853-2132 and we will try to help make arrangements for pickup. Unfortunately, we do not have any means for tire disposal. Freezers and refrigerators can be picked up if the Freon has been removed by authorized personal. The City of Eldorado landfill will be open Friday, May 5th 8:00 a.m. 5:00 p.m. and load fees will be waived for Schleicher County residents, but not commercial loads. Remember to cover your load with a tarp before going to the landfill.

All volunteers are asked to meet at the Extension Office at 9:00 a.m. on Friday, May 5th, to sign up. Noon meal will be provided.

Later, when it was learned that Pipkin had attended a town hall meeting at which Wisan spoke, Pipkin was challenged by Lyle Jeffs and asked, "Are you for Warren?"

Pipkin reportedly told Lyle Jeffs that he still believed in the FLDS church, but not in Warren Jeffs.

On Thursday, April 21, 2006, Pipkin returned home to find his belongings in the yard along with a pair of notes from his mother telling him that he would be "damned" because of his decision not to follow Warren Jeffs.

At first, Colorado City town Marshall Helaman Barlow refused to intervene but did offer to help Pipkin gather his belongings so he could leave town. But, a phone call to Wisan's office brought a visit from attorney Jeffrey Shields who presented documentation that Pipkin had signed an occupancy agreement in which he also agreed to pay taxes.

That ended the standoff, but apparently not the animosity between Pipkin and family members who remain loyal to Warren Jeffs. Later that night, after Pipkin moved back into the house, his uncle, and several other family members, moved away in the middle of the night.

Meanwhile, Warren Jeffs remains a fugitive from justice. He is wanted by state authorities in Utah and Arizona and on a federal warrant for Unlawful Flight to Avoid Prosecution. The state charges against Jeffs stem from his involvement in arranging and ordering the marriage of under aged girls to older men within his church who were already married to one or more other women. Jeffs is also said to have presided over the marriage ceremonies and, on more than one occasion, he is said to have refused to allow an under aged girl to leave her marriage. That particular allegation resulted in him being charged by authorities in Washington County, Utah, as an accomplice to rape.

Healthy Rivers Help Rural Texas

In rural Texas, water is life. Never is that more clear than in a dry year like this one. Across much of the state, farmers and ranchers are suffering. The fish and wildlife that depend on rivers and streams are hurting too.

Of course, droughts are a fact of life here in Texas. They remind us how precious water really is. And how little of it we have in dry years.

That's why we need to plan carefully for population growth. Projections show that the population will double by mid-century. Most of those 40 million people will be living in urban or suburban areas. Right now, most water is used in rural areas.

These growing cities will demand more and more water. To some degree, shifting more water to urban areas is inevitable, and even appropriate. But the state needs to make sure that rural Texas is not left high and dry in the process.

One part of that picture is taking care of Texas rivers. Increasingly, hunting, fishing, and tourism are important components of rural economies. And those activities depend, to a large degree, on healthy rivers and streams.

But in many rivers the state has issued enough permits to drain them dry when rainfall is scarce. Right now many of those permits aren't being fully used, but that will change.

Heres how it works: Surface water is public property and people get perpetual permits to pump it out and use it. Within limits, that's fine. We all need water.

The problem is that Texas law sets few limits on how much water can be taken from a stream. If we take too much out, we can artificially worsen and extend droughts for the river and the wildlife that depend on it. That's on top of natural droughts like the one we are in right now. The growth in urban population means that more of these existing permits will start to be used and the water will be piped off to urban areas.

Healthy river systems benefit people as much as they do wildlife. Hunting, fishing and bird watching create billions of dollars in economic activity every year in Texas. Setting reasonable limits on water withdrawals would help keep our rivers healthy and it would help to protect the economy in rural Texas.

If were smart about it, Texas has enough water to meet human needs without unduly damaging our natural resources or rural economies. One of the simplest things we can do is to make sure that every

An open letter to our out-of-county subscribers

Let me preface my remarks by saying that we here at *The Success* have experienced no substantial problems with mail delivery inside the confines of Schleicher County. But, the same is not true for those papers we mail to our out-of-county subscribers.

Delivery times of a week or more are not at all uncommon and that is for newspapers sent to relatively close destinations like Austin and San Antonio. It gets worse, much, much worse for subscribers living farther away.

There have been many times when we have heard from subscribers who received two, three or four weeks worth of papers, all bundled together. Their assumption is that we mailed them that way in hopes of saving money. The assumption is wrong. The brutal truth is that the Postal

Service doesn't care to deliver newspapers or any other mail product that falls under the Periodical classification. The money is in the junk mail, but more about that in a moment. My purpose here is to explain in

advance to our out-of-county subscribers, provided the postal service can deliver this edition in time, why delivery is about to get much worse.

It's all about the dollars

You see, the U.S. Postal Service lost most of the lucrative 1st Class mail business years ago to E-mail and the Internet.

Instead of looking for ways to improve service and win back its lost customers, the powers-that-be at the Postal Service decided to go after other markets. That's when they began selling caps, T-shirts and other such nonsense.

What in the world were they thinking? If the Postal Service can't deliver the mail, the job for which it was created, how is it going to



compete in the hard-nosed world of retail with the likes of J. C. Penny's and Wal-Mart?

But, as my old Graddad was fond of saying, "Even a blind pig finds and acorn every once in awhile." So it was with the Postal Service.

What they found was that as Congress restricted telephone marketing and unsolicited faxes, the doorway opened for the Postal Service to expand its stake in the junk mail delivery business.

The door swung open even more widely as Internet users found ways to intercept junk E-mails and block the pop-up ads that once infested the Internet.

Companies like Capital One were quick to see the opportunity put their foot in the door before it slammed shut. The credit card solicitations mailed by Capital One and other companies like them represent the bulk of the Postal Service's business. In fact, Capital One is the single largest customer the Postal Service has.

Now for the bad news

In recent years, as the bulk mailers and mega-mailers grew, so did their influence over the U.S. Postal Service. That influence has been used to cut ever-sweeter deals and force other postal customers out of the mail stream.

According to the Domestic Mail Manual, Periodical Class mail like newspapers are supposed to be routed along with 1st Class mail. But



it almost never happens that way.

Now comes the new 24-sack rule, a sorting and sacking rule that guarantees more delays in out-of-county delivery even as it drives up the cost. The rule is set to take effect next month and I fear that it will kill off our out-of-county subscriber base.

Fighting Back

Partially in anticipation of the new rules, and partially in response to the already poor service our outof-county subscribers receive, we recently unveiled our E-Delivery edition. It is an electronic version of the paper that is identical in every way to the one you currently receive by mail, or purchase on the news racks, except it features more color photos. The E-Delivery edition is sent via E-mail directly to the subscriber's inbox, and (here's the best part) it arrives almost instantaneously.

The cost of an E-Delivery edition is only \$27 per year, that's less than the cost of an out-of-county mail subscription and it is delivered every. Wednesday afternoon, even before the paper appears on news racks.

Single issue copies of the E-Delivery edition may be purchased from our website at.www.myeldorado.net, but annual subscriptions are much more economical. And, even better, I'll send you a free sample.

Simply send me an e-mail with "Free Sample" in the subject line and I'll take care of the rest.

Benjamin Franklin was this country's first Postmaster General. But, before that, he was a newspaper publisher. Franklin often bragged on the national "Post Office" because of its efficiency in delivering the news. I wonder what he would say about the situation now?

Come tho think of it, however, Franklin also discovered electricity. So, he would probably be the first to sign up for an E-Delivery edition.

Committee cranks out property tax • legislation

AUSTIN — The 79th Texas Legislature convened for its third special session on April 17.

The House began its work by splitting the tax reform plan crafted for Gov. Rick Perry by former state comptroller

the 24-member Texas Tax Reform Commission into four separate pieces of legislation. On an 8-1



vote, the House Ways & Means committee ap-

proved the first of those four bills, House Bill 1, by Reps. Warren Chisum, R-Pampa, and co-sponsors Rob Eissler, R-The Woodlands, and Dan Branch, R-Dallas.

Rep. Mike Villareal, D-San Antonio, vice chairman of Ways & Means, cast the only vote against the bill. Villareal represents rich and poor school districts. He said the legislation widens the gap between rich and poor school districts in funding per student.

What the bill does, mainly

HB 1 buys down school district property taxes 17 cents to \$1.33 in the current year. An amended version of the bill contains a self-enrichment provision, letting local school districts conduct elections to add an extra 3 cents to the tax rate.

This buy down is supposed to give school districts "meaningful discretion" in setting tax rates. Chisum said his bill would satisfy the Texas Supreme Court order issued last fall that required the Legislature to meet in special session.

What to do with 'surplus'

water user in Texas uses water efficiently.

The city of San Antonio has proved that greatly increasing efficiency is possible by cutting its per capita water use nearly 40 percent since 1982. The result is that total water use in the city has stayed basically flat while the population has increased by more than 300,000.

If other cities followed San Antonio's lead, there . would simply be less need to move water from rural areas to cities.

Agricultural water conservation also has much promise. By providing financing to help willing farmers take actions like lining irrigation canals and installing efficient irrigation systems, the state and cities can help free up more water that could be moved without hurting rivers or farmers. Similarly, that type of funding might help finance land stewardship practices that protect the land, the wildlife, and the water supply.

Beyond conservation, the state needs to implement some common-sense legal protections for environmental flows in our rivers. During the last legislative session, a bill was filed that would have gotten things moving in the right direction. It never

College Pranks

During my freshman year at Baylor, I learned how to play. We guarded the campus the night before homecoming, as tradition dictates. When we saw a bunch of scouts, we'd go over to their campsite, pile out of the car, form a line, stand at attention, play taps on a trumpet, get back in the car and drive off.

We used to sit on Judge Baylor's statue and smoke. We had fun. We had so much fun I had to take an accounting course over in the summer.

That was OK with me. I didn't want to leave campus anyway.

However, with news from the state comptroller's office that the state budget surplus is \$8.2 billion rather than the \$4.3 billion reported earlier, the governor and others suggested using some of that money to buy down school property taxes much more: as low as 90 cents on the \$100 valuation of taxable property.

Advocacy groups for teachers and the poor argued that the state budget surplus is a phantom because of the longterm lag in teacher pay, inadequately funded health programs and a host of other needs. Others complained that HB 1 exacerbates the lack of equity in school funding, so the costper-student gap between rich districts and poor districts widens.

Full House to consider HB1

The amended version of HB 1 now moves to the full House for consideration.

Meanwhile, Sen. Florence Shapiro, R-Plano, offered SB 1, her version of school finance reform. It includes a \$2,000 raise for teachers.

But as concerns about teacher pay and the condition of public education in Texas pour in, the governor's office is holding fast its story, that until Gov. Perry changes his mind, the special session is only about one thing: lowering the tax rate.

Cigarette tax phase-in OK'd

House Ways & Means also approved a cigarette tax to help offset the cut in the property taxes.

Under the Perry-Sharp plan, the tax was a full dollar above the present tax of 41 cents per pack.

The committee instead adopted legislation by Rep. Peggy Hamric, R-Houston, phasing in a cigarette tax to increase by 55 cents after Sept. 1 and by another 25 cents in each of the two following years.




I, Robert Jay, have placed myself as a candidate for the position of School Board Trustee, Place 1, in the upcoming May 13 election.







Hilderbran responds to teachers' pay raise requests

"The governor called us into a special session with the purpose of keeping our schools open this fall, so that is my top priority," Hilderbran said. "Once we accomplish this, I expect and hope to get the opportunity to vote on a teacher pay raise and other funding issues."

The Texas Supreme Court ruled last year that the existing school finance system was unconstitutional because it did not allow counties any meaningful discretion for setting property tax rates. Because the majority of Texas counties were setting the rate at the Legislature-mandated \$1.50 cap, this resulted in a de facto statewide property tax. The Texas Constitution outlaws statewide

"I support a teacher pay raise, increasing teacher benefits, and giving teachers the tools they need to properly educate our children," Hilderbran said. "However, I am sure our educators would all agree that making sure our children are able to attend school this fall is the most pressing task."

Hilderbran noted that, during a special session, the Texas Legislature may only address those issues that the governor specifically requests in his proclamation ordering such a session.
