Taxpayers Ask IRS and his wife, John and Ka and his wife, John and Karen Q-I have arranged to have the proceeds of my National Service Life Insurance paid to my wife under option one in a lump sum. In a discussion of this matter the other night, the question arose as to what would happen if my wife and I were killed in an automobile accident. A-In the event both the insured and the beneficiary were killed in a common disaster, a determination would have to be made as to who died first. If this cannot be determined, it is assumed that the insured died carrying extra tackle. Also handy to have around the camp first. In this case the proceeds would be paid to the estate of the principal beneficiary. It is possible to avoid this kind of situation by providing in the designation of beneficiary the requirement that he or she survive the insured by a specific number of days, not to exceed 30. If the principal beneficiary does not survive the insured by the number of days indicated, the proceeds of the policy will be paid to the contingent beneficiary or the estate of the insured.






