But frequently, in return for their first chance at the profits, the preferred stockholders give up any voting rights or ability to control the company. If it turns out that the corporation is fabulously successful and earns huge profits, most of the profits will go to the common stockholders. It is a rule of thumb that the common stockholders take a greater risk with their investment but stand to make a greater profit. Leaving Houston on June 15, aboard the "Flying Dutchman," the group landed in Amsterdam about noon on Monday (allowing for five hours difference in time) and left immediately on tour to Volendam, city of quaint shops and where the inhabitants wear native Dutch costumes. Among other places visited was a cheese farm. On their return to Amsterdam, they took a boat ride on a canal around the city, and visited the diamond factory where the Queen of England had chosen the crown jewels.

They spent three days at the World's Fair in Brussels, and made visits to shops, lace factories, the Palace of Justice, and a tour of the city itself.

Traveling by train, they went to Cologne, Germany, visiting the shops, then on to Heidelberg through the beautiful Rhine Valley with its castle ruins and vineyards. Visits were made to Heidelberg Castle and Student Pubs.

The tour next took them to Lucerne, Switzerland, and a visit to Lion of Lucerne, a colossal rock statue in memory of Swiss Guards killed in defense of Marie Antoinette. A boat trip around the city on Lake Lucerne was also included, and of course, visits to the shops.

On to Venice, Italy, over St. Gotthard Pass through the beautiful snow-dotted Alps and William Tell country, they visited Como on the shores of Lake Como where Pliny the Elder was born and where Mussolini and his mistress were shot while trying to escape to Germany.

In Venice they visited St. Mark's Square and patronized the sidewalk cafes, made a gondola trip by canal to the market place, and saw the famed political buildings and opera house.

By bus the group went to Florence through Padua and Bologna, visiting cathedrals, art galleries, museums, palaces and shops as well as touring the city.

In Rome they visited the Vatican, saw the pope, and also St. Peter's Cathedral, the Colosseum, and other ruins, the Fountain of Trevi, and attended an opera.

From Rome they made a side trip over the Appian Way to Naples along the Tyrrhenian Sea and a boat trip to the Isle of Capri.

A bus trip along the coast from Rome took them by the Tower of Pisa to Rapallo, the beautiful center of the Italian Riviera, and to Monte Carlo.

Going from Nice by air to Paris, they toured Versailles, attended the Follies, visited Notre Dame, the Louvre, Eiffel Tower, and many other places.

A short trip was made to London, where they visited the Watch Tower, Buckingham Palace, Westminster Abbey, Wax Palace, and Old Curiosity Shop.

**STOCKS AND BONDS**

The phrase "stocks and bonds" is pretty familiar to most Americans whether they own any of them or not. The phrase has been used so often that many persons don't realize that there is a difference between stocks and bonds.

When you buy a share of stock in a corporation, you become a part owner of it. You own a share of everything the corporation has. If there are 1000 shares outstanding and you own one share, you have an "undivided" one thousandth share in the corporation. This means that no particular piece of the corporation's property is yours but that you have an interest in every piece of property.

bond, you are lending money to the corporation. You do not own any part of it. The corporation promises to pay you interest on the loan and to return your money when the bond "matures."

Unlike a stockholder, a bondholder usually has no voice in how the corporation is managed or in selection of the corporation officers. However, the bondholder receives his interest payments before any money is paid to the stockholder. He must be paid even if there is then nothing left to pay dividends to the stockholders. If the corporation quits doing business or goes bankrupt, the bondholders are repaid for their loans before any of the investment of the stockholders is returned.

Perhaps you have heard of "preferred stock." Usually, preferred stockholders have a right to collect a particular fixed amount of

# Editorial

## SATURDAY ELECTION

Saturday, July 26, is the date for the first Democratic Primary for the year in Texas. There likely will be a second primary (runoff) in August in several races.

The most important part of Saturday's election is perhaps not WHO you vote for, nearly so much as IF you vote. Voting has become pretty much taken for granted in the United States. We vote if we are inspired by a certain candidate or aggravated by another. Otherwise we just sit back and say to ourselves, "Let the others vote, my vote won't make much difference."

Even in Texas where people have a reputation of speaking their minds pretty often, we "stay away from the polls in droves." It's contagious. If a friend of ours says he doesn't think he will vote this year, we are inclined to say, "Oh well, you're right, not much we can do anyway."

It is with this last thought that The McLean News wishes to take issue.

There IS something we can do, and we should all consider it our bound duty.

We can investigate the issues to be decided. We can analyze the differences between the various candidates. We can determine just what each office seeker feels he must do to deserve election. We can find out why the candidates want to be elected. We can do these things, but it will take a little study of the situation. It won't be easy; in fact, it will require a great deal of research and probing on the part of each of us.

Some candidates we must judge solely by their stated platform, their policies and beliefs. Others, those who are already in office, can be "checked up on" by their voting record. We can determine, this way, if the candidate actually represents his constituents or himself.

In any event, an election is not just something to "let the other fellows decide." It was meant to be a mirror of public opinion. 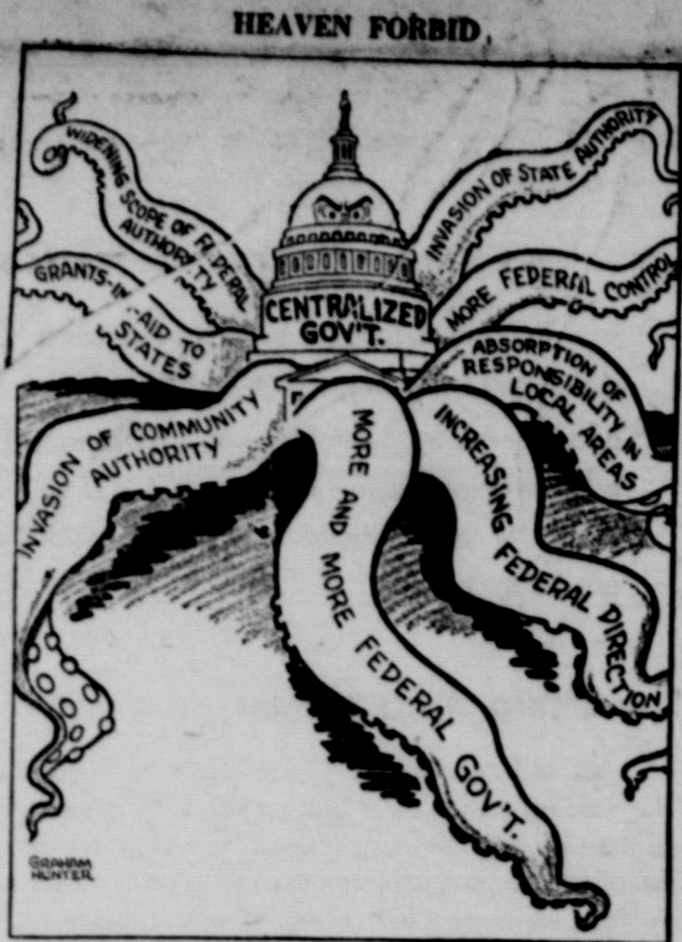
## ALL SET FOR INFLATION

Barring another shooting war, the greatest problem this country must deal with is further depreciation of the dollar.

The stage is all set for a massive new round of inflation. This year's federal deficit is expected to reach \$10 billion. It may be much more.

Inflation can be compared to war in its destructive capabilities. It wipes out savings. If it goes far enough it can lead to internal disorders on a vast scale and even to revolution. It can produce dictatorship and the death of all the freedoms. It can bring on economic collapse—which is what our communist enemies are hoping for.

Labor and business are asked to show restraint in the important matters of wages and prices. This is certainly needed. But the foremost need of all can only be supplied by government. Unbridled government spending, accompanied as it must be by huge deficits, is the most powerful of all inflationary forces. It bears the principal responsibility for the fact that the dollar's value has been cut in half since 1940. A government which attempts to be everything to all its people, and do everything for all its people, is a government that can ruin all its people.

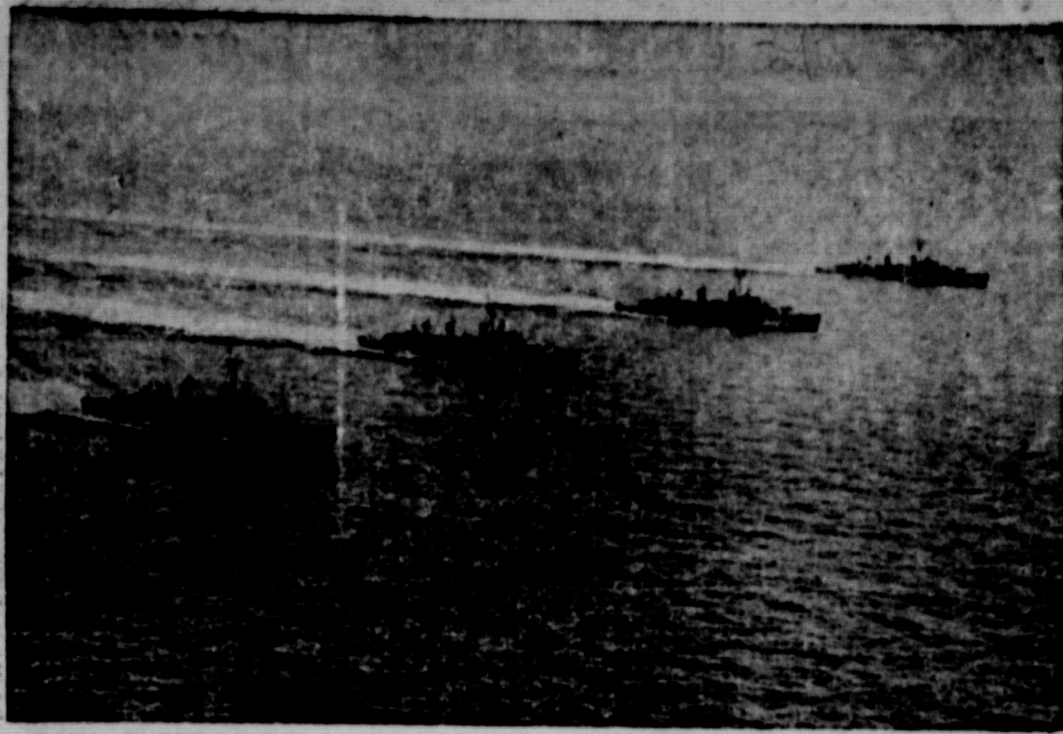

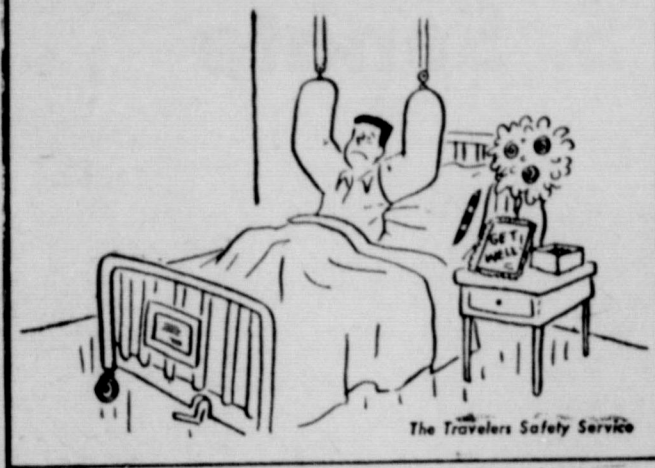

American forces were sent to Lebanon for one reason and one reason only—to preserve the independence of a strife-torn nation. The action was taken on the appeal of the Lebanese government. It followed a tragic series of events in the Middle East—an area of the world that is crucial in the struggle to maintain freedom.

The trade program works. The United States is now selling some twenty billion dollars' worth of goods annually to the rest of the world, and Texas, as a State

where export-import trade is of great economic importance, has a very large stake in continuance of Reciprocal Trade Agreements Program.

This bit of news, or, put in another way, this casual remark about what the quail situation might be this fall is passed on to the bird hunters. State Game Warden Waldon Fromme of Matador said this week that he counted exactly 27 coveys of birds in a 15 mile foray east of Matador. Mr. Fromme also said that he noticed several pairs of quail along the same route. "About 16 or 17 of the coveys were blues while the rest were bobs," he said. Fromme also stated that a majority of the coveys appeared very much like they were reaching the mature state. Quail reach the adult appearance in six weeks. Observing 27 coveys of birds within a 15-mile ranch road is a whale of a lot of birds in anybody's part of the country. I haven't seen 27 coveys of birds in a single day in many years.

Another bit of interesting news collected from Mr. Fromme was about some of the water dog catchers in that part of the country. From what I gathered, there are a few fellows around Matador who have struck it rich in this profession. Seems as though they seine some of the birds shallow lakes and catch barrels full of this Plains creature, transport them to New Mexico, Arizona, and even to California and peddle them for a fancy price. Rumor is that these Texas water dogs retail at 15c each to the fishermen.

Mr. Fromme also said that the usual method of transportation is to fill a barrel half full of water dogs, then add water until the barrel is full, and in so doing the animals could be hauled for days and they would still be lively and in good condition when the pickup truck arrived at some of the western lakes.

Arkansas, Georgia and some of

the other southern states, are noted for their delicious peaches, but not so the Texas Panhandle. Probably one year out of ten there is a peach crop in this area but usually the fruit will bloom out during some of our warm early spring days when the temperature is high and then the next day or so the crop will be completely killed by a hard freeze.

Haskell Hall, energetic Liquor Control Board inspector, recently mentioned the secret of how to successfully grow this choice fruit. Mr. Hall said that his father, a native Dallam County farmer and rancher, has done well with his particular method. The method is simply this: Dig a hole about two feet deep around the tree and about four feet in diameter, and then fill the hole with

water in the early spring just before a hard freeze. The cold weather will freeze the water into a solid cake of ice. Before the weather warms up there should be hay, grass, or cottonseed hulls stacked around the fruit tree and upon the ice to form a sort of insulation so the ice will not melt until summer is really at hand. The ice will retard the tree so that it will not bloom out until the danger of cold weather has passed, thus assuring a full crop of peaches.

There is but one reason why each home owner can't have all of the choice cherries he desires. Lack of initiative. Cherries are adapted to a colder climate and will thrive throughout this part of Texas. Four years out of five they will produce. The tree is also excellent for shade.

### Swamps on High Plains

Bone Lake, a mile or so east of Dumas, is usually bone dry, but today there were three young lads equipped with motor boat and water skis performing a few monkey shines as the cars passed by on Highway 15. John Easley, sheriff of Moore County, said there were three boats on the lake yesterday and that the fellows were "really skiing up a storm." Heavy rains fell last week in this area and filled many of the "buffalo waller" lakes. Ross Turner, sheriff of Sherman County, said that they received 2.7 inches of rain in Stratford and that to the south rainfall measured up to 4 inches. To drive through this so-called desert would make a stranger think of the swamplands in the South, es-

served in the middle of maize fields. If the water lasts until winter we should have good duck and goose shooting, considering the thousands of sections of maize and heglra stubble that will be handy for these migratory fowl.

If the rains do continue, the whole top part of Texas will turn out to be a jungle of tall weeds and grass and also a perfect haven for not only upland game birds such as quail and pheasants but a selected area for mallards, pintails, red-heads, canvasbacks and many other species of ducks.

Foam on waves is caused by salt in the water.
