This issue contains the highlights of the program, features of the entertainment planned, and other convention notes. We sincerely hope the visitors will enjoy their stay here and that when they leave they will think well of Ozona's hospitality.

We should hate to see our jail defiled by incarcerating such varmints as those who were caught looting the storm torn town of Rocksprings last week. Several cars are said to have been stopped by soldiers and when searched were found to contain quantities of salvaged goods, automobile tires, jewelry, clothing, etc. looted from the tornado wrecked stores and homes.

It must have been a considerable shock to the people of Rocksprings who had had such kindly treatment at the hands of people in towns both far and near, who had been cared for by soldiers and the Red Cross and provided with necessities in their hour of need by donations from people all over the state. But it was probably a worse shock to others who had visited the town viewed the ruins and seen the new graves in the cemetery, some fifty or more in number and had realized the helplessness of these people.

The old time villains who robbed widows and orphans, looted graves of the dead, pilfered the blind man's cup of his few coins or jerked the food from mouths of starving babies were the horn crooks beside the reptiles who followed on the heels of death and destruction and in the midst of ruins, want and misery gathered up a few valuables, the only things that could have been spared in the path of the terrible tornado, and sneaked out to turn them into gain while the people of Rocksprings were too busy burying their dead to notice. We say our jails are too good for that kind of cattle, they should be shot down in their tracks.

H. Boggs of San Angelo, representative of the 91st district in the Texas Legislature, has not abandoned his fight for a tax on University lands in 17 West Texas counties, who are finding the large blocks of tax exempt land within their borders an increased burden every year. In a circular letter just sent out by Mr. Boggs to members of the legislature and his friends over West Texas, he points out the conditional provision conditioning the grant of University lands that it be sold and asks why 17 West Texas counties should bear the burden of support

"These lands could be sold for forty to sixty million dollars and this money would be paid into the University permanent fund and the interest on this fund would then maintain the University, (as our forefathers certainly so intended) and it would save the tax payers of Texas three to four million dollars biannually (that we now appropriate to maintain the University). For the next two years the University and branches ask for \$7,412,672.00, (see page 184 of Appropriation budget) probably \$700.00 per student, while rural children only get \$14.00 per student," Mr. Boggs declares.

"It is unfair to the people of Texas as for the University to ask appropriations of millions of dollars of the tax payers' money every two years to maintain the University, when, by selling these lands, as the Constitution 'demanded' and putting this money into the permanent fund, the University could be and would be self supporting and save the already overburdened tax payers millions of dollars. Our FIRST duty is to Texas. Have you the strength and courage to join me in this effort?"

An attempt two or three years ago to tax University land might have been a different matter, although the legal aspects would have been the same. But since oil has been struck on University land and the institution is enjoying a monthly income of around \$200,000 a month, according to reports, the request of the 17 West Texas counties who are being sapped by thousands of tax-exempt lands in their borders seems not altogether unreasonable.

Well, all the road machinery that has been used in Crockett County for maintenance work has been removed according to accounts. We wonder what's to happen now.

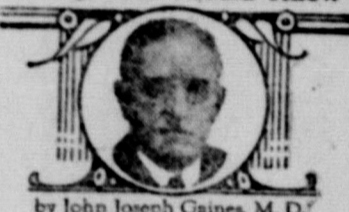

About Your Health

CANCER

We cannot know too much about things that concern life itself. This terrible disease always strikes terror in the heart of its victim as well as in the minds of those who love, or are called to minister to him. Hence, this brief article.

We know that cancer is not communicable—and that it is not distinctly hereditary, though the "tendency" may belong to certain families. I have noticed that ferid complexions are more liable to skin malignancy than the medium; and that the very dark individuals are more often afflicted with malignant growths of the internal organs. In either instance, continual irritation is the thing that brings cancer into activity. Hence, people with cancer-tendencies must avoid all things that set up continual irritation; a pipe-stem or cigar; a stiff, hard hat; a corset that exerts pressure in some particular locality; a rectal growth, simple at first, may become malignant by constant irritation; the eating of strong condiments, pepper, catsup, or other active irritants of the gastric membrane lining, continued for years, may hasten a malignant condition.

In this terrible disease, an ounce of prevention is worth many pounds of cure. May I insist upon the well-known axiom that, success with cancer depends upon its early recognition. Treatment here may well begin when a suspicion of the disease is aroused. Often to await the positive diagnosis is too late. Instant removal is the only safe way, if removal is possible. No matter what facilities may declare, we know this is the best possible advice. After removal, the X-ray or Radium becomes a God-send. I know of many cases happily cured by this line of action; I have never known any other way for a cure to be possible.

Mrs. Coolidge Hikes



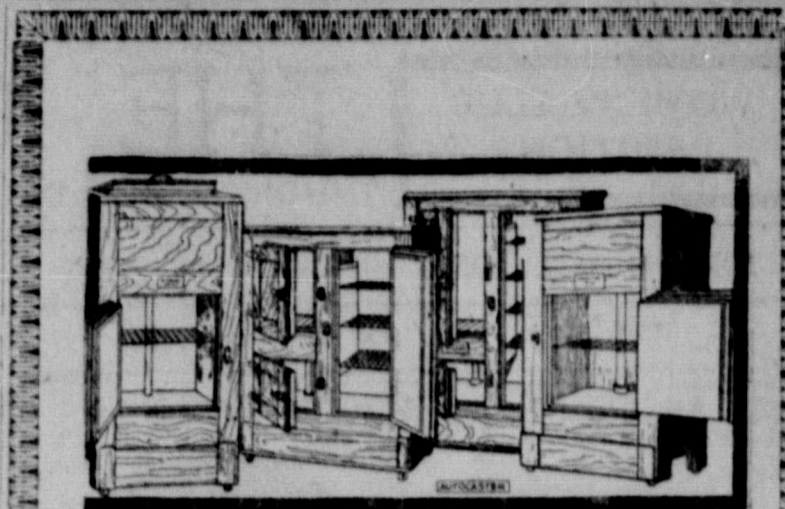

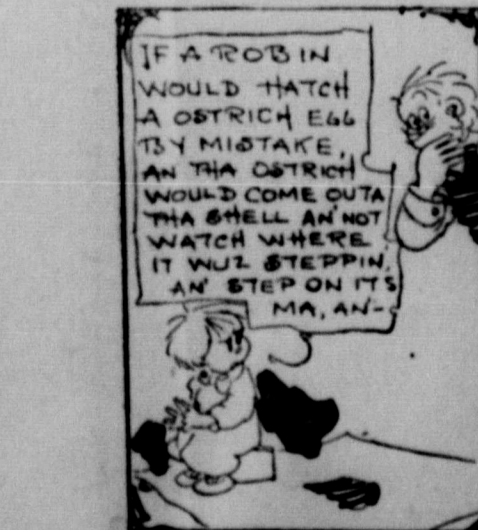

The Thirteen Club was federated with the State organization in 1915 and the name was changed to the Ozona Woman's Club. The membership at the present time is thirty-four.

The Woman's Club has been a vital factor in the community life of Ozona since its organization. Its footprints may be found in every path of progress that the town has made. It has worked hand-in-hand with the schools.

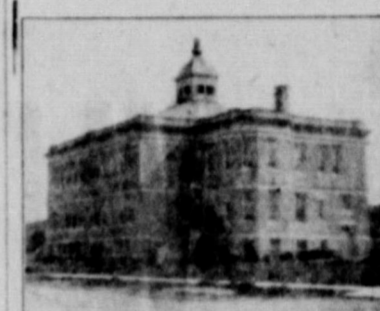
The stage in the school house auditorium was built and equipped by the club at a cost of \$500. The grand piano, victrola and scales were gifts also of the club. The club women were among the first to agitate the present building campaign for the school.

The club has led in every civic movement of the town. The retaining wall of the park, the permanent dump ground, the turning posts, the quarterly clean-up and the stock law enforcement were all club conceptions.

In the cultural life of the town the Woman's Club has figured conspicuously. Lyceum and Chautauque attractions are sponsored each

year by the club. The Ben Greet Shakespearean players appeared in two performances in Ozona, a thing hitherto unknown in so small a place, all because of live club women.

To enumerate all the activities of the Woman's Club would require several special editions. The latest achievement is the entertainment of the twelfth annual convention of the sixth district. Never before in the history of the district has such a small place as Ozona been so honored.

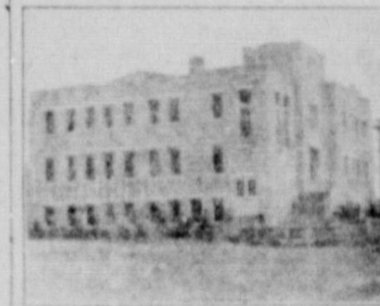


Ozona's splendid school building, built of native rock, one of the most substantial structures in Texas. Plans are now under discussion for the erection of an additional building adjoining this one.

Land case Goes To Tom Green Co.

Agreement Reached In Case Involving Land In Oil Section

A change of venue in the case of W. M. Noelke vs. P. L. Childress, involving title to several hundred acres of land in Crockett County, considered valuable from prospective oil development, was ordered Wednesday by Judge C. R. Sutton in district court here and the case will be tried before the district court of Tom Green County.

The reason assigned by the court in his order changing the venue in the case was that "the parties are well known and prominent, with wide acquaintance and a large number of relatives and personal friends, making it difficult if not impossible to obtain a jury and impossible to obtain a fair and impartial trial, and further that the case should be speedily tried."

The fact that the land under dispute is near the oil development area, is already valuable and may become more valuable, makes it imperative that a speedy settlement of the suit be had, it was pointed out. A motion by the plaintiff for a survey of the land was granted by the court and R. E. Ester of Midland was appointed to make the survey.

Several other cases were disposed of by the court the first of the week. The case of F. J. Bates vs. W. B. Powell for want of prosecution.

The suit brought by S. E. Couch against Bob Marchison, on a note was settled out of court and dismissed. Other cases settled and dismissed included that of Bob Campbell & Son vs the Snyder Consolidated Live Stock Co., et al; Ozona National Bank vs Dim Patrick, et al, suit on note, and G. W. Shield of San Angelo against the Ozona Improvement Co., a suit for commission.

In the case of Will P. Edwards against Earl Stirman, et al, to recover sheep, was continued on account of the illness of an attorney in the case.

The case of the Standard Accident Insurance Co. against Mrs. Louis Arnold, on insurance policy, is set for Friday. The defendant demanded a jury. Mrs. Arnold is the widow of Louis Arnold, aviator, who was killed in a plane crash here during the rodeo last summer.

Two divorces were granted by the court, Mexicans being the principals in each case. One was the case of Herlinda Rameriz Rico against Ignacio Rico, and the other was Felipe Fuentes against Juanita Fuentes.

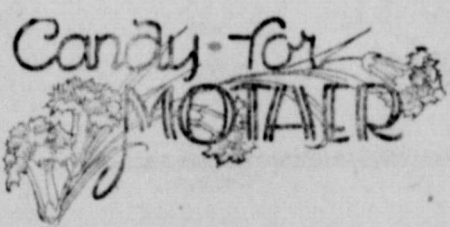

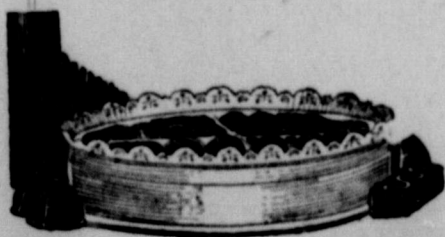



The way we make progress is not by jumps but by steps; not by going from evil to good, but by going from evil to lesser evil.

So the evil of today may be the discarded good of yesterday.

Slavery is an evil not countenanced in any civilized land. Yet at one time it was good. It was a distinct moral advance over the old practice of murdering in cold blood all captives taken in warfare.

Prize fighting is looked upon as an evil now and almost all of the states have laws aimed to prevent it.

But a century ago prize fighting was a distinct advance over the brutality of the sports of former times. Even such a fight as one in 1825 when two men fought for 75 rounds with naked fists and the loser had to be put to bed with 50 leeches on him was a step up from the spectacles such as throwing ferocious dogs into a lion's cage and watching them tear each other to pieces which had delighted the people at a previous date.

Some of the superstitions which were connected with religion in the past are now evils and repel men of greater intelligence instead of frightening them into good conduct.

They are evil now, but at one

time for more primitive people whom they kept from doing wrong they were good.

Duelling today is a crime. At one time it was good because it was an advance over past customs. It gave both parties a fair chance instead of being a cowardly assassination. It substituted honor for ambush and so at the time was a step ahead.

Today we have laws against beating wives. Wife beaters are jailed and dealt with summarily. Yet a century ago in England wife beating was considered the right of a husband. A man might beat his wife within an inch of her life and go unpunished so long as she didn't die. But if she died he was treated as a murderer.

That condition of affairs is hard to understand today. But it is an advance over the past when, in ancient Turkey, the husband had the power of life and death over the inmates of his harem.

It is true that the good of today may be the evil of tomorrow as it is that the evil of today was the good of the past.

The test of the times is not whether there are evils or not, but whether those evils are less or greater than the ones of the past; whether they are a step up or down.

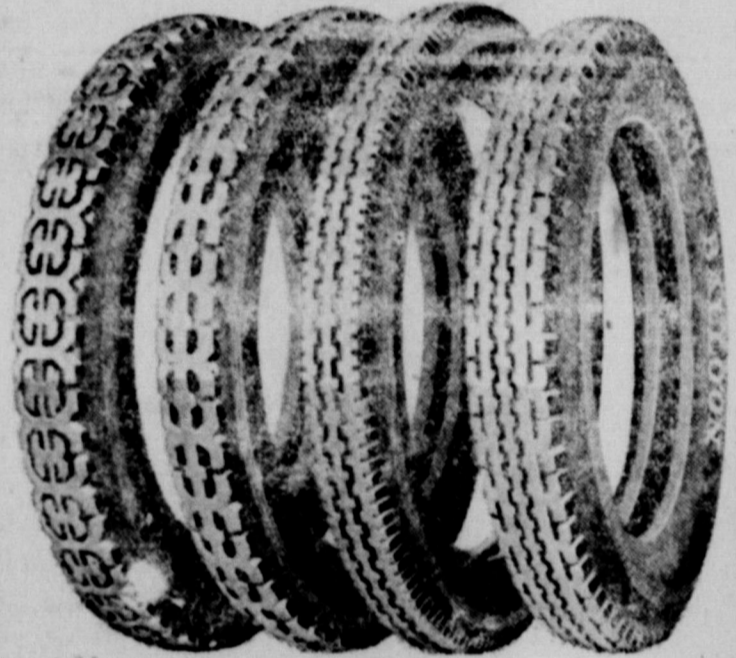
