## War Bond Drive Running Short As Deadline Nears

### Only \$200,000 Of \$365,000 Quota Sold; Only 6 Days Left

Only six more days remain before the end of the Third War Bond Drive and Crockett county stands approximately \$166,000 short of reaching its quota of \$365,000 assigned by the United States Treasury for the drive.

Scott Peters, county chairman, reported today that total sales to date in this county stand at approximately \$200,000. The county's quota has been fixed at \$365,000, to be subscribed by September 30 in the nationwide campaign toward a goal of 15 billion dollars in war bonds during September.

"It is of vital importance that every citizen in the nation at least meet its quota in this drive," Mr. Peters said. "I believe that the people of Crockett county will subscribe their quota if only they could be made to realize the importance of this drive. As everyone of us realizes, we have reached a critical stage in the war. Every ounce of energy must be directed toward supplying our fighting men with the weapons of war which to invade the continent of Europe. Our government has asked us to put every idle penny into war bonds to supply these weapons to our men and to help in controlling the threat of inflation, which would be a disastrous home-front collapse. I sincerely hope that the people of Crockett county will accept the challenge of this quota and subscribe the remaining amount in the next week."

Mr. Peters announced purchases totaling \$20,000 by four corporations operating in this county. The Plymouth Oil Co. subscribed \$10,000 in bonds, the Gulf Oil Corp., \$5,000, the Foxworth Galbraith Lumber Co., \$3,000 and the West Texas Utilities Co., \$2,000.

Members of Ozona Methodist Church have purchased a total of \$3,100 worth of War Bonds during the past week to be applied on the church building fund, Mr. Peters reported. This fund now amounts to approximately \$30,000, maturity value, all invested in War Bonds.

## O.E.S. Orders Purchase of \$50 Bond To Further Drive

Purchase of a \$50 War Bond in furtherance of the present Third War Loan drive in this county was ordered by members of the Order of Eastern Star in regular session at the lodge quarters Tuesday evening.

Mrs. Mary Frances Scheel as Worthy Matron and R. L. Flowers as Worthy Patron presided over the meeting. Miss Elizabeth Fussell and Mrs. Maude Rape were hostesses for the evening. The chapter had as a visitor, Mrs. L. B. Connell of San Antonio.

## A-C J. K. Colquitt To Receive Wings At Exercises In Phoenix

Mr. and Mrs. Lee Wilson will leave early Tuesday morning for Phoenix, Ariz., where they will witness graduation exercises at Williams Field in which their son, A.C.J. K. Colquitt will receive his wings and commission as a second lieutenant in the Army Air Corps. The graduation exercises are set for October 1.

Cadet Colquitt has been in training at Williams field as pilot of a B-25, Mitchell medium bomber and has been so classified. After his graduation, he will be granted a 10-day furlough and the Wilsons plan to return to Ozona with him immediately so that he may spend as much of his furlough here as possible. He is expected to be sent to California for transitional training with his crew members before going into combat service.

## Everardo Ramoz Reported Prisoner Of German Govt.

### Ozona Boy Believed Captured During Tunisian Campaign

Mrs. Tomasa Ramoz of Ozona received a telegram from the War Department last week advising that her son, Pvt. Everardo Ramoz, 22, is a prisoner of the German government. Information as to his capture was obtained through the International Red Cross.

Pvt. Ramoz is believed to have been captured by the Germans during the Tunisian campaign. The last word received by his family here from him was a letter received some three months ago. At that time he was somewhere in North Africa, a member of an American infantry unit.

The telegram from the War Department to the mother here reads as follows: "Report received through International Red Cross states your son, Private Everardo P. Ramoz is a prisoner of the German government. Letter of information follows from Provost Marshall General."

Pvt. Ramoz is the first Ozona soldier known to have been captured by the Germans. The only former Ozonans reported as prisoners of the enemy are Lt. J. E. McCulley, a former Ozona school teacher, who was recently reported to have died in a Japanese prison camp, and Charles Sapp, United States Marine, who was captured with the fall of the garrison on Wake Island and is a prisoner of the Japanese. Sapp is a son of Jess Sapp of Ozona. Lt. McCulley was stationed in the Philippines at the outbreak of war and was among General Wainwright's forces captured on Bataan and Corregidor.

Pvt. Ramoz entered the army December 15, 1942, with a contingent of selectees from Crockett County. After his preliminary training at Camp Wolter in Mineral Springs, Tex., he was sent to a camp in Pennsylvania where he was in training until his unit embarked for service in North Africa.

A Scouter training program and Boy Scout activities planning session of local Scout leaders and a special meeting of Scouts of Ozona Troop 53, with Joe Galbraith, Boy Scout field executive for the Concho Valley Council, in attendance at both sessions, is planned for Monday and Tuesday of next week.

Mr. Galbraith will be in charge of a Scouter rally and training program, possibly to be preceded by a "dutch" lunch at Butler's Cafe, starting at 7:30 next Monday evening. Members of the local Scout committee, including Lee Wilson, chairman, Frank James, Alvin Harrell and Arthur Phillips, and Scoutmaster Hubert Baker and Assistants Oscar Kost and Bill Cooper, Ranch District Chairman Wayne West and other interested Scout leaders will participate in the Monday night training session to be conducted by Mr. Galbraith. Plans for rejuvenating the Scout program here will also be discussed and plans laid for the season's activities.

Members of Troop 53 will be hosts at a rally of boys of Scout age on the regular meeting night of the troop Tuesday at the Scout Cabin. ## Father Of Ozonan Dies At Home In Christoval Monday

Funeral services were held in Christoval Tuesday afternoon from the Christoval Baptist Church for John W. Baucom, 68, father of Leo Baucom of Ozona, the Rev. R. R. Cumbie, pastor of the Christoval church officiating. Mr. Baucom died at his home in Christoval Monday afternoon at 2:30 o'clock. Burial was in the Christoval cemetery.

Mr. Baucom operated a ranch in the Christoval area for 28 years, moving there from Llano. He was born April 5, 1873.

Surviving are two sons, Elvin Baucom of Christoval and Leo Baucom of Ozona; one sister, Mrs. J. E. Goodpasture of Hydro, Okla., and one granddaughter, Sammy Louise Baucom of Christoval.

Pallbearers were A. L. Shaw, Lee Adkins, D. P. Holland, Waldo Kennedy, and F. M. Rawls, all of Christoval.

## Court Disposes Of Term Business In 2-Day Session

### Grand Jury Indicts Two For Forgery; Cases Continued To April

Business of the September term of the 112th district court was disposed of in short order the first of this week.

Judge W. C. Jackson convened the court Monday morning, impaneled a grand jury and wound up the session Tuesday afternoon, after hearing several non-jury cases and dismissing the petit jury panel before it ever reported for service.

Two indictments were returned by the grand jury, both charging forgery. One was against Bus Comer and one against Jimmy Rogers. The men were charged with forging a name to checks and attempting to pass them here. The cases were called for trial and continued until the next term, being set for hearing on the second day of the next term.

Abe Carruthers was named foreman of the grand jury. Other members of the panel were Hudson Mayes, Marshall Montgomery, John Fogarty, George Bunker, James Childress, Walter Dudley, T. C. Harris, E. C. Hagelstein, Chester H. Kenley, Tom Owens and Dempster Jones.

Three divorce cases were heard and divorces granted by Judge Jackson in the two-day session. In addition, judgment was entered in one suit for debt and orders were entered in two or three other civil suits.

In the case of Mrs. Bruce Galyon, et al vs Texas Pipeline Co. for damages, the motion of Robert Galyon, who joined his mother as plaintiff, for payment of \$1250 due him from the judgment in the case, was granted and the clerk ordered to pay him that sum. Judgment in favor of the plaintiff, W. T. Dawson, administrator of the estate of David Lee, deceased, against D. F. Parker, in the sum of \$1,851.96, was entered by the court with foreclosure on six head of milk cows and seven head of horses ordered.

Julia Sifuentes was granted full adoption of the three-month-old Manuel P. Pritchett. Transfer of the case of G. L. Brazeal vs United States Fidelity and Guaranty Co. to the United States District Court for the Northern District of Texas at San Angelo was ordered.

Divorce decrees were granted in the cases styled Isabel Mendosa Florez vs Jacinto Florez, whose three children are all over 18 years of age; Enrique Longoria vs Carmen Longoria, custody of two minor children to plaintiff during school months and to the defendant during the vacation months; and Pablo Alvarado vs Carolina Alvarado, with the defendant granted custody of the two minor children and \$20 monthly to be contributed by the plaintiff toward their support.

## Two Cases Of Poliomyelitis Discovered Here

### Mike Clayton Critically Ill; Carl Conklin Is Also Victim

Two cases of poliomyelitis, occurring almost simultaneously, were discovered here Tuesday when two children, both attending kindergarten, were taken to a San Angelo hospital where they were observed by a Dallas specialist in polio.

Mike Clayton, 5-year-old son of Mr. and Mrs. Boyd Clayton, is reported in a critical condition in the San Angelo hospital. Carl Conklin, also 5, son of Mr. and Mrs. Bill Conklin, is also suffering from the disease but his condition is described as not nearly so serious as that of the Clayton child. Both children are receiving the Kenney treatment as a safeguard against possible paralysis as an aftermath of the disease.

Dr. McFarland of Dallas, a specialist in polio, was called for consultation in the cases and after observing them for some time pronounced both as poliomyelitis, or infantile paralysis. Dr. McFarland said that there is yet no specific test to determine positive presence of the disease, that diagnosis is based purely on typical symptoms.

The Clayton child is suffering from what is described as a more serious type of the disease, known as the bulbar type, affecting the base of the brain or bulb of the spinal cord. The disease was manifested in a paralysis of the throat but some improvement was noted in this condition through the night Tuesday and into Wednesday. Physicians declared that if the child survived the first 48 to 72 hours, however, that he would have an excellent chance to recover, and without serious after-effects.

The Conklin child yesterday was reported to have developed some paralysis in the left leg. However, the attending physicians assured the parents that his was of the less dangerous type and with proper care and treatment, barring complicating developments, he would recover.

Another of the Conklin children, Nona Jane, younger sister of Carl, was in the same hospital under observation. She is suffering from a throat infection and cold, but so far no symptom of infantile paralysis has developed. Another case under observation is Penny Phillips, daughter of Mr. and Mrs. Babe Phillips, who is ill but to date she has developed no symptom of polio.

## Eleven Selectees Are Accepted For Service By Army

### Men Granted 21-Day Furloughs After Being Sworn In

Eleven of eighteen selectees from Crockett county who were examined at the U.S. Army induction station at Fort Bliss in El Paso last week were accepted for service and seven were rejected. Two other men, Valentin Elola and Ira Edwin Cook, transferred to other boards for induction, complete the September call from this county.

Men of the group sent from here last Thursday who were accepted for service in the Army are Eugenio Ramirez, Simon Silas Garza, Samuel L. Cervantez, Antonio Reyes, Samuel L. Rios, Pedro Siles Garza, Santos L. Cervantez, Jr., Raulfo Bergara, William James Carson, and Jack Manley Sawyer. Cecil Grant Haire was assigned to the Coast Guard.

The men were granted 21-day furloughs after being sworn into service and sent back to their homes here. They will leave October 7 to report for active duty

## City-Wide Clean-Up Ordered By Health Officer In Move To Safeguard Against Further Spread Of Infantile Paralysis

### Dr. Nesrsta To Speak At Mass Meeting Of Citizens At 8 Tonight; Schools Not To Be Closed; Urge Precautions

On advice of the State Health Department, Dr. G. L. Nesrsta, county health officer here, has called for a city-wide and thorough clean-up of Ozona, removal of all pig pens from the city, elimination of all fly and mosquito breeding places, and a campaign against mice and rats as a precaution against further spread of infantile paralysis in the city.

Discovery of two cases of the dread disease, first outbreak here in nearly thirty years, this week has resulted in the move for a thorough clean-up to remove a possible source of infection. Mike Clayton, son of Mr. and Mrs. Boyd Clayton, and Carl Conklin, son of Mr. and Mrs. Bill Conklin, both kindergarten pupils, are in San Angelo hospitals suffering from polio attacks.

Unless the outbreak reaches epidemic stage, schools will not be closed, Dr. Nesrsta said. Dr. George W. Cox, state health officer, in a telephone conversation with Dr. Nesrsta yesterday, advised the local health officer that there was no necessity for closing the schools, and that such action had not been taken generally over the state in areas where the disease had occurred. The kindergarten, however, has been closed temporarily since both cases were from members of the kindergarten class.

A mass meeting of citizens of Ozona has been called for 8 o'clock tonight (Thursday) in the high school auditorium at which meeting Dr. Nesrsta will speak on poliomyelitis, describe the symptoms of the disease, review what knowledge the medical profession has gained of the disease to date, and answer any questions. He will also outline the clean-up measures which are already being carried out and advise the citizenship on the best means for protecting themselves and their children against possible attacks from the disease.

Dr. Nesrsta as health officer, through cooperation of the sheriff's department, has launched a prompt clean-up drive. All city pens which may be in the city have been ordered removed immediately. Citizens are urged to clean up their premises at once, to remove all possible breeding places for flies and mosquitoes, see that garbage cans are tightly covered and that garbage is removed regularly.

A campaign against rats and mice, suspected carriers, is also urged by Dr. Nesrsta. All outside toilets must be constructed in a sanitary manner and properly treated with lime, the health officer ordered. Empty cans should be drained of stagnant water or hauled to the dump ground promptly, and all trash piles cleaned up. Regular and frequent inspections will be made of premises in all parts of the city, Dr. Nesrsta advised, and terms of the clean-up order will be strictly enforced. Stray dogs and cats must also be controlled, he said, and owners of these pets are asked to see that the animals do not run at large.

Dr. Nesrsta urged citizens to wash all raw foods thoroughly with soap and water before eating, guard against flies and mosquitoes and urged children to keep hands and faces clean, observe strict cleanliness in all personal habits and avoid over-exercise and fatigue.

Mrs. H. B. Tandy was home briefly last week on her way to Abilene. Her son, Bland, who has been under treatment in a Fort Worth hospital for an attack of poliomyelitis, has been transferred to the Camp Barkley hospital for further treatment.

Mrs. Joe Nussbaumer and children left recently for Pueblo, Colo., where they will join Lt. Nussbaumer, who is stationed there for training as a B-24 Liberator bomber pilot.

## More Knitters Are Needed To Complete Red Cross Quota

More knitters are needed to complete the quota of the Crockett County Red Cross chapter.

That's the SOS call this week from Mrs. Roy Henderson, chairman for knitting. A quota of 50 pairs of knitted gloves and 50 watch caps for men of the United States armed forces is yet to be completed and another quota of additional garments is expected to be assigned soon, Mrs. Henderson said.

All available knitters who will help with this work are asked to call Mrs. Henderson at once and to get the necessary yarn and instructions.

## Schools Prepare For Registration Ration Book 4

### Oct. 20 to 31 Set For New Sign-Up In War Rationing Program

Schools all over the nation are making preparations for another registration, this time for Ration Book No. 4.

Supt. C. S. Denham last week received instructions from the United States department of education advising him that the schools again would be responsible for registration of civilian consumers for War Ration Book No. 4.

The registration period has been designated from October 20 to October 31. The number of days required for the registration and the specific dates for such registration will be determined by local school administrators. Printed registration forms are to be issued through the local War Price and Rationing Boards and volunteer registrars will be recruited to help the teaching staff as in previous registrations. Registrars will be given a brief training period in advance of the registration.

Members of the Ozona Parent-Teachers Association, in the organization's opening meeting Monday, voted to make and fill 50 kits for service men as its contribution to the campaign of the local Red Cross chapter to provide 125 additional kits, to be given to service men as they embark for foreign service.

Mrs. Massie West, president of the association, made the opening address, pointing out that juvenile problems arising from the war have made the work of the organization more important than ever before, and calling on members to do their part toward promoting all war work in the community, both individually and as an organization.

Mrs. Carl Colwick reviewed "The White Cliffs," by Alice Duer Miller, Mrs. J. W. Henderson playing the piano accompaniment. Room mothers were named by the president and each was assigned the duty of soliciting and collecting membership fees from the parents of children in their respective grades.

**A. H. Wilson Buys 2,600-Acre Ranch Near Leakey, Texas**

A. H. Wilson of Ozona has purchased a 2,600-acre ranch eight miles east of Leakey, Texas, in Real County, from R. E. Wilson, no relation. The price was \$8 an acre.

The ranch is on Sabinal Canyon, west prong of the Sabinal river, and is well improved. There are four flowing springs on the place and several hundred bearing pecan trees along the river. No stock was involved in the deal. Mr. Wilson says he plans later to stock the place with goats, but for the present will let the land lie idle.

**Soldier In Foreign Service Thanks Red Cross For Personal Kit**

A letter of thanks from an American soldier, now in foreign service, for the gift of the little service kits which the American Red Cross makes up and presents to each soldier embarking for foreign service, has been received by the local chapter of the Red Cross. The kit, identified by a little label sewed into each as made by the local chapter, was one of several hundred made by Ozona women and sent to national headquarters for distribution.

"Received your gift bag while on the boat and am sending my appreciation and thanks," wrote Pvt. Harry Probert of a field artillery unit by V-Mail from his foreign station, probably England or North Africa since his APO is New York. "The boys all made good use of the cards, soap dishes, etc. The bags make good toilet article kits. We've been trading books after reading the one we were given. It's good to know folks back home remember you."

That's the kind of appreciation that comes from an American boy for the simple gift from home

folks provided by Red Cross workers. Ozona Red Cross workers have made from 400 to 500 of these kits and have recently accepted an additional quota of 125. Women workers under the production committee headed by Mrs. Hugh Childress made the kits or containers and the materials that go into filling the kits, including toilet articles, cards, books, etc., are purchased by donations from citizens.

Materials which go to fill these kits cost approximately \$1. Mrs. Childress reports that the committee is still considerably short on the necessary funds with which to fill the kits and asks that those who wish to make further donations to this cause see her at once or mail her a check.

## Drivers Licenses Begin To Expire Oct. 1; May Be Renewed Now

Some of the present Driver's License begin to expire in October, 1943. Each license expires 2 years from the date on that license.

Your license will be renewed any time before it expires without examination if you will mail an application with the renewal stub of your present license and the 50 cent fee. If you do not make the application before your present license expires, or if you do not attach the renewal stub of your present license to your application, it will not be renewed by mail.


It will be necessary to meet the License Examiner and take a complete examination as a new driver

if you do not renew your present license before it expires. At present the examiner is in Ozona the 1st, 3rd, and 5th Fridays of each month.

Renewal application blanks can be secured at the Court House any time. Commercial drivers license blanks are also available. Commercial licenses expire one year from the date of issuance and should be renewed before expiration date.

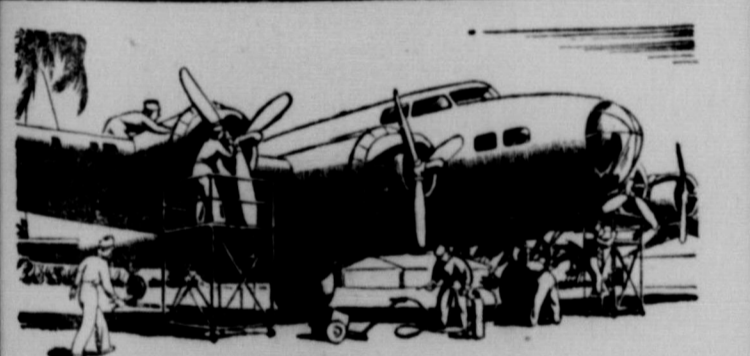

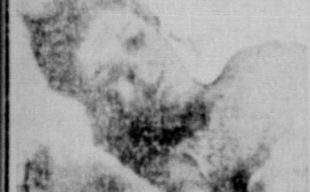
## Major Tandy Writes Greetings From Overseas Post Of Duty

## Drivers Licenses Begin To Expire Oct. 1; May Be Renewed Now

Some of the present Driver's License begin to Expire in October, 1943. Each license expires 2 years from the date on that license.

Your license will be renewed any time before it expires without examination if you will mail an application with the renewal stub of your present license and the 50 cent fee. If you do not make the application before your present license expires, or if you do not attach the renewal stub of your present license to your application, it will not be renewed by mail.

It will be necessary to meet the License Examiner and take a complete examination as a new driver

if you do not renew your present license before it expires. At present the examiner is in Ozona the 1st, 3rd, and 5th Fridays of each month.

Renewal application blanks can be secured at the Court House any time. Commercial drivers license blanks are also available. Commercial licenses expire one year from the date of issuance and should be renewed before expiration date.

### Parents Officially Notified Aviator Son Missing In Action

Mr. and Mrs. Bob Murchison of Fort Stockton yesterday received official notice by telegraph from the War Department that their son, Lt. Robert Perner Murchison, 22, was missing in action in the North African area. The parents previously had received word from one of Lt. Murchison's friends, a member of his flight, of his crash into the sea in his fighter plane on August 6.

"I regret to inform you that the Commanding General of the North African area reports your son, Second Lieutenant Robert P. Murchison, missing since August 6," read the official telegram. "If further details or other information of his status are received you will be promptly notified."

Thinking that the parents had been notified, a companion of Lt. Murchison who saw him crash after his engine had failed, wrote Mr. and Mrs. Murchison details of the crash. The flight was returning from a mission, the fellow officer wrote, when Lt. Murchison's engine failed. He signaled the flight leader that he was going to bail out but was never seen to leave his ship, a P-39 fighter plane.

Young Murchison, a nephew of Paul and Stephen Perner, Mrs. Hugh Childress, Mrs. Roy Henderson, Mrs. Will Baggett and Mrs. Max Schneemann of Ozona, was born April 14, 1921, in Sonora. He attended schools in Fort Stockton and Texas Military Institute in San Antonio and Sul Ross in Alpine. He began his aviation training March 29, 1942, taking his primary training at Vernon, his basic at Goodfellow field in San Angelo, advanced at Moore Field, Mission, Texas, and tactical at Miles Field, San Francisco. He left the United States for foreign service on his 22nd birthday.

### Recording Of Brands To Begin First Of October

### Brand Owners Have Two Years In Which To Make Recording

October 1 will see livestock owners throughout Texas trekking to the offices of the county clerks in the 254 counties to begin the recording or re-recording of brands and marks for livestock for on that date all records of the brands and marks on file become void under the terms of a bill passed by the last session of the Texas legislature.

The law requiring the recording of brands and marks was sponsored by Mrs. Florence Fenley of Uvalde, representative of the 77th district.

It is said that the new law fills a long-felt need of the stockmen and county clerks. It has been dif-

ficult in some counties where livestock raising is the principle industry to find and trace brands which apparently are not in use but which are tied up through the years by the first owners. The new statute will bring the brands and marks up to date before the records are overburdened again.

Under the terms of the bill the owner has two years from October 1 in which to record or re-record his brand or mark. This provision was made because some young ranchmen serving in the armed forces in the states or overseas might not be in position immediately to protect their brands.
