Says NRA Ruling Strips Government

MEANS DOOM OF AAA; SECURITIES LIQUOR CONTROL

Roosevelt Says All
Gov't Regulatory
Power Gone

WASHINGTON, May 31. (AP)—President Roosevelt said today that implications of the Supreme Court's decision on the NRA, mark the end of the agricultural adjustment administration, the securities commission and the federal alcohol administration.

HOLD CONFERENCE ON NRA DECISION

WASHINGTON, May 31. (AP)—A mounting tabulation of price cuts and wage slashes was maintained Thursday at NRA headquarters, while President Roosevelt still felt for the public before announcing what to do about NRA.

The chief executive went into the muddled situation with Donald Riechberg, Secretary Perkins and members of the National Industrial Recovery Board at a two-hour conference which discussed remedies generally but reached no conclusions.

Leaving the President's office, Riechberg, in apparent good humor, parried questions generally, but did disclose the compilation of code abandonments which his aids at NRA were tabulating.

The plan, he said, is to make this record public as a specific example of the immediate results flowing from the Supreme Court's decision that NRA's code structure was unconstitutional and therefore void.

The White House kept close check also on letters received. Of some 2,000 said Stephen T. Early, one of the White House secretaries, only three urged final abandonment of NRA, the remainder advocating its continuance in such form as the terms of the court opinion would permit.

Johnson is consulted. At the White House it was emphasized again that Gen. Hugh S. Johnson, first administrator of NRA, was but one of many whom the chief executive was consulting on ways and means of retaining the gains and purposes of the blue eagle agency.

Meanwhile, Capitol Hill reported little response to Johnson's radio appeal of Wednesday night asking the board to voluntarily suspend their representatives in the House and Senate to insist on a new NRA law.

At the same time his plan for writing such a statute continued under discussion, although there was no comment from official quarters. Johnson's idea was to revive the code on a voluntary basis with the Federal Trade Commission authorized to blink at antitrust law infractions and enforce prohibitions against unfair competitive practices.

Prominent in Washington's speculation on the situation also was the possibility that an amendment to the Constitution might be urged for the purpose of eliminating the limitations of the fundamental law which caused NRA's downfall.

TRADES DAY AND STOCK SHOW TO OPEN TOMORROW MORNING WITH LARGE STREET PARADE; QUILT SHOW FEATURE

The big parade of the Trades Day program tomorrow, June 1, will start promptly at ten o'clock in the morning in front of the Reporter-Telegram building.

City Marshal Andy Norwood will head the procession and conduct it over the line of march.

Sheriff A. C. Francis, T. O. Midkiff, and W. T. Blakeway will arrange the line of march and keep the divisions of the parade twenty feet apart. E. B. Dickenson is the superintendent of the day, and J. H. Fine again will act as clerk, along with Fletcher Currie, keeping a record of all entries and awards of prizes. John M. Gist will be in charge of placing the exhibits on the ground.

After the parade, when all exhibits are back in their places on the Trades Day grounds, the judging will begin. After the judging, there will be an old time Fiddlers Contest, the judges of which are Bud Cole and L. C. Proctor.

The parade line-up, as announced by Harry L. Haight and T. E. Bizzell, will be as follows:
Andy Norwood in the lead; county boys and cowboys, mounted; Percheron stallions; Shetland ponies; draft horses; mules; jacks; Percheron mares; race horses; cattle; Herefords, Durhams, Holsteins, Jerseys; bulls; dogs; sheep and goats; hogs on trucks; turkey gobblers and chickens on trucks, pigeons, etc., on trucks.

Trades Day quilt show will be held at 103 South Main street, of which Mrs. C. C. Caden is chairman. The judges are Miss Joelle Vannoy and Miss Myrtle Miller, home demonstration agent. Provision has been made for the distribution of nine prizes, one for each of the various classes.

Judges for the stock exhibit will be Debnam, Atkins, Stengel, Gibbons, and Taylor White.

SLOT MACHINE GAMING DEVICE LAW IS PASSED

Publication is being made today of an ordinance passed by the city council, regulating gambling devices, slot machines and marble machines in the City of Midland.

Gambling devices and slot machines, specifically defined in the ordinance, are prohibited.

Marble machines, also legally defined, may be operated upon payment to the city of a \$10 license fee, license receipt being provided. However, marble machines are expressly forbidden to be operated within 500 feet of a school building or school grounds.

Penalties for violations of the ordinance also are being published.

Runnells Co. Woman To Be New Agent

Mrs. Lura Hollingsworth, a new county home demonstration agent of Runnells county, has been appointed to succeed Miss Myrtle Miller, who resigned as home demonstration agent of Midland county this week, according to press reports from Ballinger.

Mrs. Hollingsworth will take up her duties here July 1. The advertisement to the Midland position was offered her by the state extension service because of her achievements in Runnells county since the first of 1934.

Miss Miller resigned in order to return to her studies at CIA.

Urge Diphtheria Immunization

Very few citizens have taken advantage of the diphtheria immunization course offered by the physicians, according to Miss Wilson, county health nurse.

"Notices have been sent to those families on the relief rolls of the city and county, asking them to take advantage of the generous offer made by the physicians," she said.

\$25,000 REWARD MAY BE OFFERED TO SPEED RANSOM

TACOMA, May 31. (AP)—A reward of \$25,000 may be offered within a few days if kidnapers fail to exchange George Weyerhaeuser, 9, for the \$200,000 ransom, a trustworthy source reported today.

The \$200,000 ransom lay ready for the kidnapers Thursday night, but apparently was not accepted. A source disclosed nothing had been heard from him.

"We had hoped to hear something Wednesday night or Thursday," said a close friend of the timber-wealthy clan, "but we are absolutely in the dark about him. We haven't heard a thing."

Fears increasing as the hours dragged by, Mr. and Mrs. J. P. Weyerhaeuser Jr., parents of the boy missing since Friday noon, sought frantically to effect his safe return. Two friends named as intermediaries between the parents and the kidnap band worked in secrecy.

The father and mother still have faith in the word of the kidnapers because they had complied as nearly as possible with every demand.

MOBILIZATION OF 44,000 ITALIAN TROOPS ORDERED

ROME, May 31. (AP)—The Italian government today announced the mobilization of 44,000 additional troops for service in East Africa. It stated that Ethiopian officials had arrested Italian diplomatic couriers who were carrying mail to the Italian consulate at Gondar. The couriers were released after representations made by the consulate.

The mobilization of Ethiopian forces and the arrival in East Africa of additional war materials will require us to adjust new defensive measures to guarantee the security of our colonies from attack," liberty it said.

S-P Trains Routed Over T & P Tracks

Passenger and freight trains of the Southern Pacific Lines were being detoured via the Texas and Pacific between Dallas and Sierra Blanca Wednesday and Thursday because of washouts on its mainline in the vicinity of Sanderson, Terrell county.

COLORADO FLOOD TOLL GROWS

COLORADO SPRINGS, May 31. (AP)—Twenty-three persons were reported dead and missing today and the flooded mountain streams loosed death and destruction.

Hundreds were homeless and the property damage at Colorado Springs, Pueblo and two small villages north of there was estimated at hundreds of thousands of dollars.

This city, on the eastern slope of the Rocky mountains, was in the focal point of the torments. Twelve persons were on the Colorado Springs death list and six persons were missing. Five other deaths were charged to the floods in northeastern Colorado.

CLOUBURST IN HONDO AREA IS REPORTED TODAY

HOUSTON, May 31. (AP)—A cloudburst in the vicinity of Hondo, 50 miles west of San Antonio, today interrupted service on the main line of the Southern Pacific railroad.

Seven to ten inches of rain fell in four hours. The fall was particularly heavy in the hill country north of Hondo.

DOZEN DEATHS IN NIGHT REPORTED

COLORADO SPRINGS, Colo., May 31. (AP)—Twelve more deaths, and heavy but as yet unestimated property damage were listed last night as the direct result of a spring storm that swelled Fountain and Monument creeks to giant torrents that swept through this city and Pueblo to the Arkansas river.

The tentative death list included: Mrs. Lydia Kennedy and Mrs. Ella V. Clark, swept from their car by the Monument creek flood.

Two unidentified men and a woman seen clinging to a car in the same area and overwhelmed by the water.

Two men swept from the roof of a house where they had taken refuge.

One man seen riding a timber down the stream.

Two persons in a coupe bearing the name of Captain Peter Whitford swept from his house by the same stream.

An unidentified man seen to fall into the flood from a tree.

C. Cimino, torn from his horse as he attempted to rescue a couple stranded in the swollen stream in their auto.

Traffic Halted
From the earlier death list was added the name of Captain Peter Cramer of the fire department, who made his way to safety after having been caught by the flood here while engaged in rescue work. Still somewhat limited, were returned to her studies at CIA.

ROYAL AIR FORCE HIT HEAVILY AS 44 MEN KILLED

Other Casualties to
South of Quetta
Are Expected

KARACHI, May 31. (AP)—An earthquake which jarred Northeast India early today was believed to have killed 20,000 persons in Quetta alone. The Royal Air Force garrison was reported badly hit with the death of 44 men.

The native city of Quetta, railway station and civil government offices were destroyed by three violent shocks.

FLANDIN CABINET OVERTHROWN AS HE LOSES FIGHT

PARIS, May 31. (AP)—The towering Premier Pierre-Etienne Flandin was overthrown heavily last night in his demand for dictatorial powers to defend the franc. Fernand Bouisson, presiding officer of the chamber attempted immediately to form a new government.

Act Against Speculators
The government, seeking to stem the flood from the Bank of France, launched simultaneously police action against speculators, closing at least one "financial establishment."

Evaluation of the franc, which Flandin predicted would follow his fall, remained an ever present threat.

Bouisson is committed to support of the franc, but Flandin declared in his farewell speech from the rostrum of the chamber that deviating was inevitable if his successor failed to get the dictatorial powers which were denied to him.

Budget Still Problem
The Flandin government was overthrown by a vote of 353 to 202. The premier had already tossed aside Louis Germain-Martin, his finance minister, in an effort to appease the opposition. But even a request for a modified time limit to the dictatorial powers demanded proved without avail.

The budget deficit of 6,000,000,000 francs hung over the heads of the new ministers. All leaders admitted it was impossible to balance the budget fully unless confidence were restored.

Herriot presented the question of confidence to the chamber on a vote on the government bill asking powers to issue decree laws to aid economic recovery, balance the budget and halt the drain of gold from the Bank of France which has been estimated at 12,000,000,000 francs.

A closing of the bourse was contemplated to avert a panic since traders ordinarily settle their accounts on the last day of the month.

CHANCE FOR THE INDIAN

The western Indian, who built up his entire culture before the white man came on the presence of vast buffalo herds, may shortly get a chance to revive the old-time ways on the same basis.

John Collier, commissioner of Indian affairs, has authorized the laying-out of buffalo ranges on the Pine Ridge and Crow reservations in South Dakota.

This is to be done as part of a new wild life and conservation program for Indian reservations, and it is expected to play a valuable part in rebuilding Indian morale and self-respect.

In many ways the idea has much to commend it. Once Indian independence was destroyed, our government tried to make the Indian fit into white civilization. The effort has not been crowned with very much success; it might be much wiser to return, as far as possible, to old conditions and give the Indian a chance to develop along his own lines.

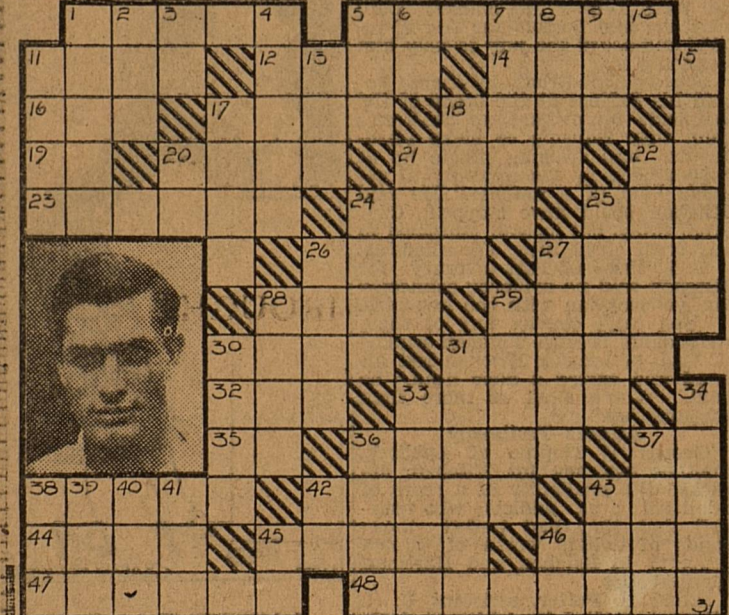

AN ORDINANCE DEFINING THE TERMS "GAMBLING DEVICE," "SLOT MACHINE" AND "MARBLE MACHINE;" PROHIBITING THE OPERATION, EXHIBITION, LEASING OR DISTRIBUTION OF ANY SUCH GAMBLING DEVICE OR SLOT MACHINE; PROVIDING FOR THE COLLECTION OF A LICENSE FEE OF \$100 FROM THE OWNER, MANAGER, OPERATOR, EXHIBITOR OR LESSOR OF ANY SUCH MARBLE MACHINE; PROVIDING FOR THE DISPLAY OF THE LICENSE RECEIPT ISSUED FOR EACH MARBLE MACHINE; PROHIBITING MARBLE MACHINES WITHIN 500 FEET OF ANY SCHOOL, BUILDING OR GROUNDS; PROVIDING PENALTIES FOR THE VIOLATION OF ANY PROVISION OF THIS ORDINANCE AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIDLAND:

Section 1. The following terms as used in this ordinance are hereby defined as follows:

(a) "Gambling Device" shall mean any machine, instrument, device or thing used or operated, or which may be used or operated, for the purpose of gambling, or for playing any game of chance for money or any other article or thing of value.

(b) "Slot Machine" is defined to mean any machine, instrument, device or thing which is used or operated, or which may be used or operated, by the insertion of any coin, slug or token, and which, as a result of certain combinations of numbers, symbols, pictures or other items, may entitle the player to any money, slugs, tokens, merchandise or any other article of value as a prize or reward resulting from the operation of such machine, instrument, device or thing, the player having no control over such prize or reward and no skill on his part being involved. The fact that such machine, instrument, device or thing may also vend merchandise shall be immaterial, and the vending of such merchandise in any manner shall not take such machine out of the foregoing definition of a "Slot Machine."

(c) "Marble Machine" shall mean, and is hereby defined to mean, every coin-operated marble machine, marble table machine, marble shooting table, or marble machine of any description, or any pin-ball machine, whether enumerated or not, and for the playing of which a fee is charged, regardless of whether such machine be used for the purpose of amusement, entertainment, or for vending commodities, merchandise, confections, or services of any kind, and which is operated by coins, slugs or tokens of any sort.

Section 2. It shall be unlawful for any person, firm or corporation to set up for operation, operate, lease, exhibit, or distribute for the purpose of operation or exhibition, any gambling device or slot machine, as such terms are hereinabove defined.

Section 3. From every person, firm or corporation owning, managing, operating, exhibiting or leasing a marble machine or machines, as such term is herein defined, and for the operation of which a fee of 1¢ or more is charged, a license fee of ten (\$10.00) dollars a year shall be collected for each machine, which fee shall be paid on or before the 1st day of July each year, beginning with the current year, to any official or employee of the City of Midland, who may be authorized by the City Council of the said City to collect such fee or fees and issue appropriate license receipt therefor.

Section 4. It shall be unlawful for any person, firm or corporation to set up for operation, operate, exhibit, or distribute for the purpose of operation or exhibition, any marble machine or machines, as such term is in this ordinance without first affixing or attaching thereto in a place plainly visible the license receipt covering such machine for the current year for which the same is being operated, exhibited, leased or distributed.

Section 5. No marble machine shall be permitted within 500 feet of any public school building or grounds.

Section 6. Any person, firm or corporation violating any of the provisions of this ordinance, upon conviction of such violation, shall be deemed guilty of a misdemeanor and shall be fined in a sum not to exceed one hundred (\$100.00) dollars, and the unlawful operation or exhibition of each gambling device, slot machine or marble machine shall constitute a distinct and separate offense for each day that the same is so operated or exhibited.

Section 7. All ordinances and parts of ordinances in conflict with this ordinance are hereby expressly repealed.

The fact that the City has no way of controlling the use and operation of coin-operated marble machines and other machines enumerated above and is in need of such regulation creates a public necessity for the passage of this ordinance on its first reading and it is so ordained.

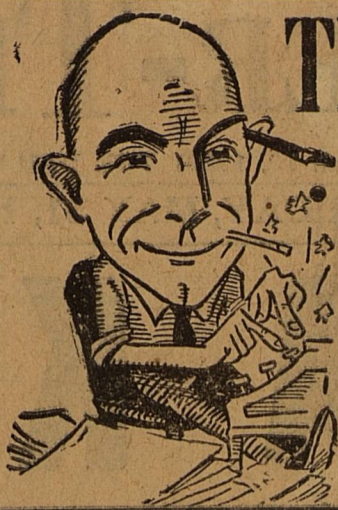

stored to Colorado Springs as the crest of the flood passed about 3 o'clock tonight. Highway and rail traffic to the south still was blocked by wrecked bridges and inundated roadbeds. Bridges, large and small crumbled before the swollen streams.
 A torrent rushing down Kowa creek struck Elbert, a small village 26 miles northeast of here.
Buildings Collapse
 A telephone operator, maintaining her post as the waters roared by, said she saw eight business buildings collapse before the torrent. The town's 300 residents fled to the highlands. Scores of homes went down under the boiling flood.
 Rescue squads, equipped with boats, ladders and ropes, worked to remove Colorado Springs residents from homes in lowlands. Scores were taken to safe places, but several families were stranded in houses, where water was eight feet deep.
 Dot Wetmore, the Elbert telephone operator, said she was "afraid to say about people drowning."
 "I don't see how they can escape death," she said anxiously. "The town's half gone. I don't know how many houses have been swept away, but I have seen eight business buildings go under water. If it gets much higher, we'll have to leave the office here."
 An earlier flood that morning sent residents scurrying to the hills before the higher water struck.
 Kiowa, 15 miles north of Elbert, was in the path of the rushing torrent. All communication with the town was out.
Flood Past Pueblo
 The body of William B. Menzie, 53-year-old coal miner, victim of a flood earlier in the week, was found today near Louisville, north of Denver. He was believed to have been swept from the higher water struck.
 Four other persons were drowned in the earlier floods, in other sections of the state. A mother and two children drowned at Haxton Saturday and a ranch boy was thrown from his horse into a flood-filled pond Friday.
 The crest of the Fountain creek torrent, rushing from Colorado Springs, was believed to be safely past Pueblo early last night.
 Precautions were being taken there, however, by 400 American Legionnaires, Red Cross emergency men, and FEWA workers who patrolled the lowlands, ordering residents to evacuate.
 Pueblo rivermen said they believed the earlier waters from this area had dug out the channel of the creek sufficiently to allow the heavy flood flow through without leaping the banks.

Connally to Urge Brazos Allotment

WASHINGTON, May 31, (AP)—Senator Connally (D-Tex.), said Thursday he planned shortly to ask Harry Hopkins and other officials of the work-relief administration to approve the proposed \$50,000,000 flood control project on the Brazos River in Texas as a means of relieving unemployment.
 A congressional steering committee, composed of Senators Sheppard and Connally, and Representatives Cross and Johnson, already had decided to seek the cost of construction from the work-relief administration instead of the public works administration and has induced Hopkins to have an engineer study the project.
