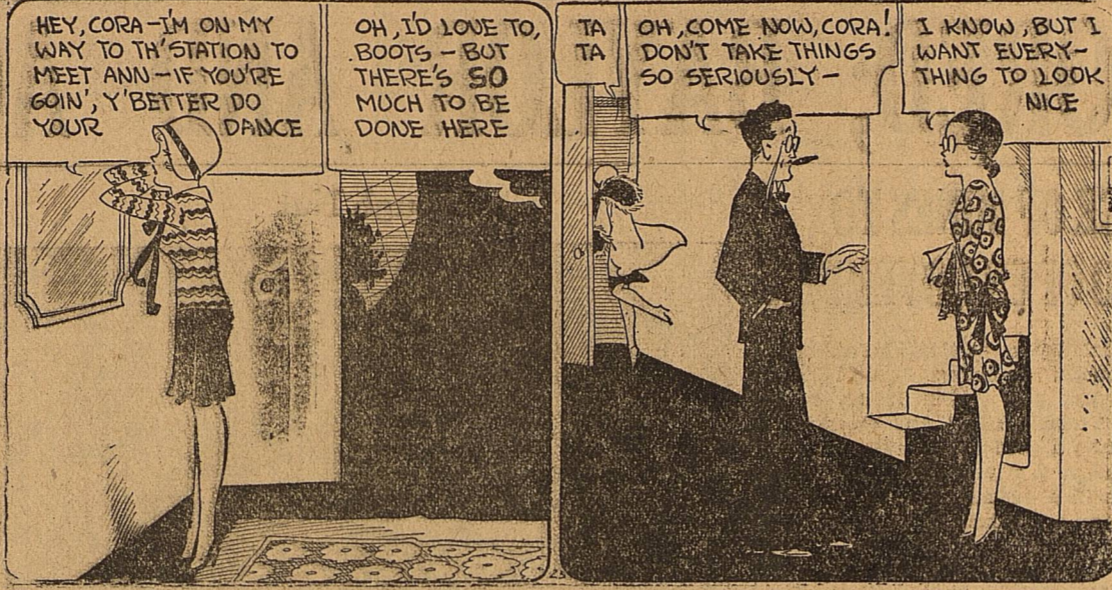

Seven Year Fight For Animal Riddance

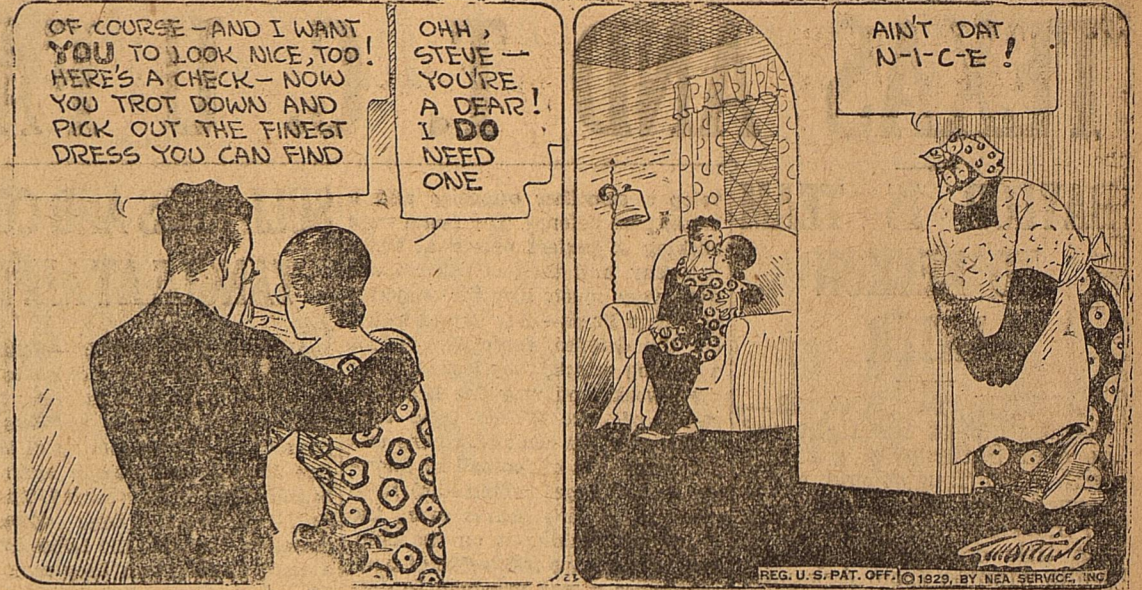

Wolf club has redeemed the following scalps: 655 wolves, 39 wild cats and 55 foxes. That the club has saved ranchmen and poultry raisers hundreds of thousands of dollars is evidenced by the fact that one wolf destroys at least \$1,000 worth of sheep, poultry, and goats in a year's time.
