Eyes are removed within 6 hours after death from persons who have generously authorized this use while living.

Eyes from any age person can be sued. The color of the eye, sex or race of the donor is also irrevelant.

All religions have approved the procedure.

Enucleation (removal) of eyes is carefully done and modern morticians close the eyes skillfully so that they appear normal.

The need for wearing glasses, or previous eye surgery, does not affect the donation of eyes.

Eyes cannot be designated for a specific person. They are used for the next patient on an eye surgeon's list. If a donated eye is diseased or cannot be used for grafting, it is carefully studied in research to help find causes and cures for blindness.

In addition to carrying a donor card, the Texas drivers license provides a space for the licensee to donate organs, tissue, or other body parts in the event of death.

In the event that donors move from the district where registered, they may transfer their registration to the nearest eye bank. In the event of the death of a transient donor the registered eye bank should be notified and then in turn arrange for the nearest eye bank to carry out procurement.

Anyone 18 years or over and of sound mind may be a donor. An individual under 18 years may become a donor if both parents or a legal guardian gives consent.

How can you help?

By signing a donor card for the Eye Bank and by encouraging others to do so. Spread the word to your friends.

Be sure that prior to your death your immediate family knows that you wish to have your eyes donated to the Eye Bank. Your next-of-kin must sign an "Authority For Removal" form before the eyes can be removed in the State of Texas.

By participating in the fund raising activities of the Lions Club to aid their sight conservation program. Authorities estimate that over 60 percent of the blind people might not be blind if a

Pee Wee Kizziar SPEARMAN-Pee Wee Kizziar, 45, died Thursday.


Services will be in the First Baptist Church Spearman Saturday at 3:00 p.m. Under the direction of Boxwell Brothers Funeral Home.


## York College

A class action is a lawsuit in which one or more persons can sue certain named defendants on behalf of other persons in the same or similar situation. The Court has ruled that the defendants may prosecute this lawsuit on behalf of all persons who are members and stockholders of Southern Farm Supply Association, Inc.

Plaintiffs instituted this 1. action on November 29, 1984, as Cause No. 65,323-C in this Court against the folliwing defendants, Bushland Grain Co-op, United Farm Industries, Dalhart Consumers Fuel Association, Inc., Abernathy Consumers Fuel Association of Hale County, Farmers Cooperative, White Deer Supply Co-op, and Consumers Fuel Co-Op Association, Inc

Since it was organized in 1981, the Company has completed six private drilling programs, which have raised a total of more than \$4.6 million. The


