Former Resident Killed as He **Bails From Plane**

S/Sgt. Jon Edward Eggleston, 20, B-17 armoured gunner with the 15th Air Force in Italy, was killed by civilians as he was parachuting from his plane, his parents. Mr. and Mrs. W. C. Eggleston of A-208 Victory Apt. Ft. Worth, former Matador residents, learned recently, through a letter from Lt. Charles Dews of Austin, recently liberated navigator of the crew which bailed out over Germany December 28.

Civilians shot and killed Eggleston and wounded Dews in the left arm. Dews pretended to be dead and was later taken prisoner. His letter said that other members were taken prisoners but had been liberated.

The letter from Dews was sent to his wife at Austin, who called Eggleson's parents and later went to Fort Worth to visit them. Mrs. Dews was with her husband while they were in Sioux City and Lincoln, Neb., where Eggleston also was stationed, and knew him personally, she told his parents. This was the first word they had received since the War Department notified them January 18, that their son was missing in action
