AUSTIN—Income and expense reports of candidates show that Aikin and Wilson lead in both receipts and expenditures, in their respective fields.

U. S. Sen. Price Daniel was out in front in financial support. He listed contributions totaling \$112,849.

Other gubernatorial contenders listed receipts as follows: Aikin, \$31,772; Senterfitt, \$23,865; Wilson, \$23,865; W. O. Daniel, \$1,770.

Sen. A. M. Aikin Jr., led in the Governor's race with \$19,657

in contributions, as compared with \$8,125 for Lt. Gov. Ben Ramsey and \$6,300 for John Lee Smith.

Will Wilson was far ahead of the pack in the attorney general's race, reporting financial support totaling \$21,021.

On the expenditure side of the ledger the leaders held the same positions. In the Governor's race Daniel spent \$82,474; Senterfitt \$32,081; Yarborough \$25,826; and O'Daniel \$20,589.

Among the candidates for Lt. Governor, Aikin reported expenses of \$12,244.82; Ramsey \$7,003; and Smith \$8,583.65.

Wilson again outdistanced his competitors in the campaign for attorney general with a total expenditure of \$10,962.

Shots Cut Polio

State Health Department officials believe shots enabled Texas to avert a bad polio year. Pre-season incidence of polio, they pointed out, was unusually high this year—224 cases as compared to 167 in 1955. But as the season progressed, immunization was stepped up. Since April 28 there have been only 269 cases compared to 375 in the same period last year.

"This would have been a major cause."

It came from the Texas Farm Bureau president who said the present federal program is inadequate.

AIKIN PLEDGES CONTINUANCE FARM-TO-MARKET ROAD PROGRAM

Continuance of the farm-to-market road program in Texas to keep pace with growing needs is being stressed by State Senator A. M. Aikin, Jr., of Paris in his campaign for Lieutenant Governor.

"It was my privilege several years ago to be a co-author and sponsor of a bill that set aside fifteen million dollars each year to be used exclusively in the construction and maintenance of farm-to-market roads," recalls the veteran of 19 years in the Texas Senate and four years in the House.

"I sincerely feel that this has been one of the finest programs that has been adopted, and I know you will agree that it has done and is doing a lot of good for our people."

The co-author of the Gilmer-Aikin laws for public schools also feels that "our counties should receive some help financially from the state on purchase of right-of-way. The Commissioners Courts are being called on to furnish right-of-way for many projects, and it has grown in such proportions that some help must be forthcoming from some source. The burden is too heavy for the counties to carry alone. In many places the counties are being asked to make available three hundred feet right-of-way across the entire county, and they are just not able to do it. However, I want it strictly understood that the control and the securing of right-of-way shall be left in the hands of the Commissioners Courts."

Senator Aikin's platform includes proposals for greater improvement of the state hospital system and greater discretion for the hospital board in the matter of salaries to maintain adequate staffs; a workable water conservation program, distinct from the question of water rights, under full local control; more adequate salaries for state employees in line with the salary schedules of private industry; enactment of a strict lobby registration law "with teeth in it" against unscrupulous insurance companies; enactment of the proposed constitutional amendment to the Veterans Land Program, and any additional legislation necessary to protect both the state and the veterans; for income from the available fund of the University of Texas and Texas A&M College to be freed entirely from appropriations so that salaries may be supplemented to attract and hold capable staff members; and amendment of the Teachers Retirement Section of the Constitution, a proposal of which he is the author.

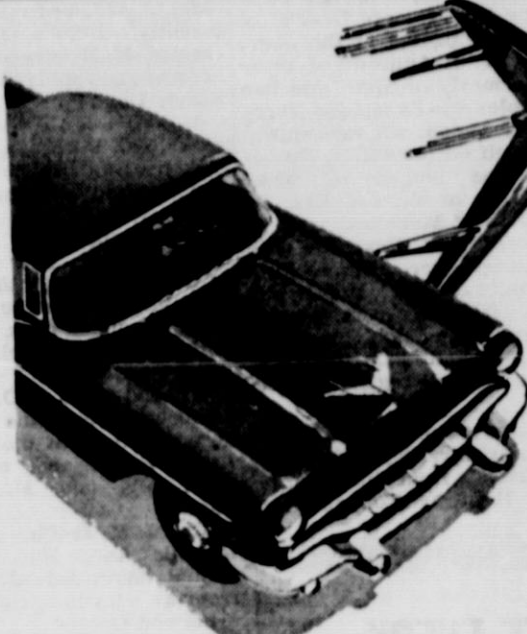

"My purpose is to let the farmers set up their own future goals and outline their needs," White said. "The Department of Agriculture will inaugurate programs on a self-supporting basis, eliminating the need for additional tax money from the state."

"This is the only practical way to adequately cover the increased demand for new services to agriculture in the state," said White.

The Commissioner, who is seeking re-election to the top agricultural job in Texas, pointed out that activities of his department have been expanded 400 percent since he first took office five years ago. Yet by putting the costs on a self-supporting plan, the burden of expense is kept from the shoulders of the taxpayers.

"My major concern is to improve our farmers' and ranchmen's economic outlook in these critical drought years," White added. "Our farm industry must have every opportunity to help itself pull out of the current slump."

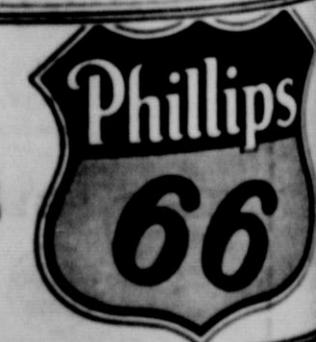
