Youthful Britons Manage To Have Fun Despite War

FORT OGLETHORPE, Ga., Aug. 31—Youthful Britons still turn from their war duties to normal recreational outlets, bright eyes, laughing Mary Churchill said today, but she admitted, British jitter-bugging just isn't up to American standards.

The youngest daughter of Britain's prime minister and an officer in her country's anti-aircraft service, Miss Churchill was here to visit with a portion of the Women's Army Corps, the American equal of her own auxiliary territorial service.

Good naturedly answering rapid fire questions during a brief interview, Subaltern Churchill said:

"Of course, we are still having fun" in England.

Jitterbugging? "Surely," she answered, "but we don't do the steps nearly as well as you Americans." Then laughing, she added: "Oh yes, I try sometimes."

Miss Churchill explained that she did technical work in a mixed anti-aircraft battery where she and fellow members handle devices used in aiming and firing the guns.

"We live in barracks at the battery," she said, "and are on call 24 hours a day. But like in ordinary Army life, we get evenings off occasionally."

THE STATE OF TEXAS COUNTY OF HANSFORD CITY OF SPEARMAN

To the resident, qualified, property taxpayers voters of the City of Spearman, Texas:

Take notice that an election will be held in the City of Spearman, Texas, on the 15th day of September, 1943, on the proposition and at the place more particularly set forth in the order of election adopted by the city commission on the 18th day of August, 1943, which is as follows:

Resolution and Order
 By the city commission of the City of Spearman, Texas, calling an election on the question of the issuance of revenue bonds of said city in the amount of \$51,000.00, for the purpose of securing funds with which to acquire a gas plant and distribution system serving the city of Spearman and its inhabitants and territory adjacent to said city; and pledging the revenues of said system for the payment thereof.

Whereas, the city commission deems it advisable and to the best interest of the City of Spearman to acquire a gas plant and distribution system serving said city and its inhabitants and territory adjacent to said city; and

Whereas, it is considered to be to the best interest of the city that such system be financed by the issuance of revenue bonds payable solely from and secured by an exclusive first lien on and pledge of the revenues of the said

gas plant and distribution system, and further secured by a first mortgage upon the real estate, fixtures and chattel property of said system, acquired or to be acquired, and by the pledge of an operating franchise to operate said system in event of foreclosure, all in accordance with the provisions of Articles 1111-1118, both inclusive, of the 1925 Revised Civil Statutes of Texas, as amended, and in no wise supported by an ad valorem or other tax on property in the city; and

Whereas, the city commission deems it advisable and proper that the question of the issuance of such revenue bonds and the pledging of such revenues and the mortgaging of said system be submitted to the qualified electors of said city;

Therefore, be it resolved and ordered by the city commission of the City of Spearman, Texas:

1. That an election be held on the 15th day of September, 1943, at which election the following proposition shall be submitted:

the City of Spearman, Texas, be authorized to issue \$51,000.00 Revenue Bonds of said city, maturing serially over a period of years not to exceed ten (10) years from their date, bearing interest at a rate not to exceed four (4%) per cent per annum, payable semi-annually, for the purpose of securing funds with which to acquire a gas plant and distribution system serving the City of Spearman and its inhabitants and territory adjacent to said city; said bonds to be issued in accordance with and secured in the manner provided by Articles 1111-1118, both inclusive, of the Revised Civil Statutes of Texas of 1925, as amended; said bonds to be secured by a pledge of the net revenues from the operation of the tem; and further secured by a gas plant and distribution system first mortgage on the properties of said system and a pledge of a franchise to operate said system for a term not to exceed twenty (20) years in the event foreclosure is necessary; each bond to be conditioned that the holder thereof shall never have the right to demand payment of said obligation out of any funds raised or to be raised by taxation.

2. That said election shall be held at the City Hall building, within said city, and the following named persons are hereby appointed managers thereof, to-wit:

O. C. Raney, presiding judge, J. D. Hester, assistant judge, Mrs. Sid Clark, clerk, Mrs. Gene Cline, clerk.

3. That said election shall be held under the provisions of and in accordance with the laws governing the issuance of municipal bonds by cities, as provided in the General Laws of the State of Texas, and only qualified electors, who own taxable property in the city and who have duly rendered the same for taxation, shall be qualified to vote.

The ballots for said election shall have written or printed thereon the following:

"For the issuance of gas system revenue bonds, and the mortgaging of the system and the pledging of the revenues and income of said system to the payment thereof."

"Against the issuance of gas system revenue bonds, and the mortgaging of the system and the pledging of the revenues and income of said system to the payment thereof."

Each voter shall mark out with black ink or black pencil one of the above expressions, thus leav-

ing the other as indicating his vote.

4. That a copy of this resolution and order, signed by the mayor of said city and attested by the city secretary, shall serve as proper notice of said election.

5. The mayor is authorized and directed to cause this notice of election to be posted at three public places within said city, one of which shall be at the City Hall and one of which shall be at the place designated for holding said election, for at least fifteen (15) full days prior to the date of said election.

6. The mayor is further authorized and directed to cause this notice of election to be published in some newspaper of general circulation published in said city, on the same day in each of two successive weeks, the date of first publication to be not less than fourteen (14) full days prior to the date of said election.

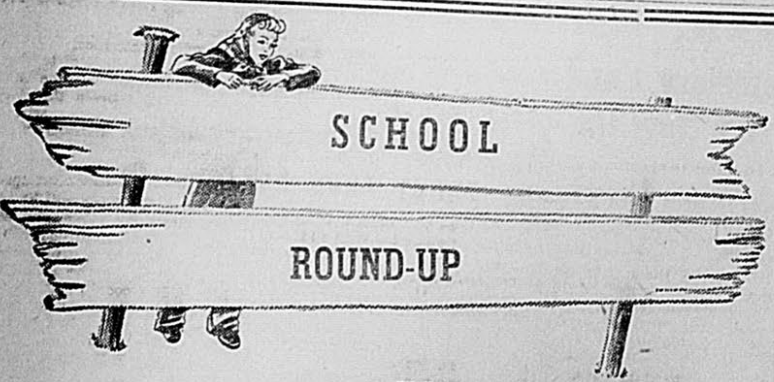

Hundreds of gunners are graduated each week from the school located near Fort Myers. The course lasts only six weeks and covers everything from BB and skeet shooting to firing from the power-operated turret of a large twin-engine bomber on special missions over the Gulf of Mexico.

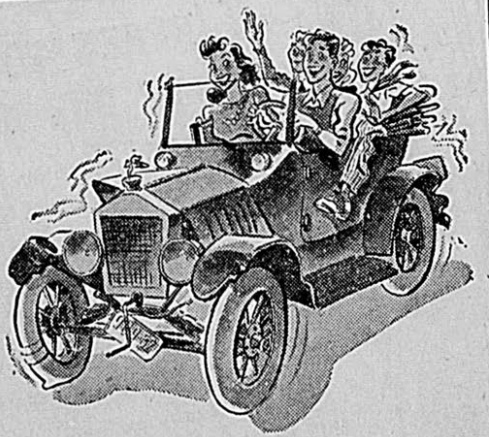

Income Tax Declaration Must Be Filed Before September 15

If you filed an income tax return for the year 1942, you will within the very near future, receive a letter from your Collector of Internal Revenue. In former years such a letter at this time of the year would be a reminder for you to pay another quarterly installment on your income tax for the prior year. This year, however, the letter which you will receive will enclose forms and instructions for filing a Declaration of your estimated Income and Victory Taxes for 1943—the current year. The first of such forms were placed in the mail Tuesday, August 17th, by the Collector of Internal Revenue for the Northern Division of Texas at Dallas. Additional forms will be sent to others of the approximately six hundred and fifty thousand persons who filed Income Tax Returns with the Dallas Collector for the year of 1942 as soon as the forms are received from the printer.

Not all of the people who receive these forms will be required to file declarations on or before September 15th. The following persons are required to file such declarations:

(1) Single, or married but not living with spouse at the date prescribed for the making of the declaration (whether or not head of a family), if he had for 1942, or reasonably expects to have for 1943—

(a) gross income of more than \$2,700 from wages subject to withholding; or
(b) gross income of \$500 or more from all sources, if more than \$100 of such income is from sources other than wages subject to withholding.

(2) Married and living with spouse at the date prescribed for the making of the declaration, if he had for 1942, or reasonably expects to have for 1943—

(a) gross income from wages subject to withholding which, when added to his spouse's gross income from such wages, exceeds \$3500; or
(b) gross income from other

other than wages subject to withholding which, when added to his spouse's gross income from such sources, exceeds \$100, and also his gross income from all sources exceeds \$624 for 1943, or the aggregate gross income from all sources of both spouses amounts to \$1200 or more for either 1942 or 1943.

(3) Also, required to file declarations are: Individuals, regardless of marital status, who were required to file an Income Tax Return for 1942 and whose wages subject to withholding for 1943 are reasonably expected to be less than such wages for 1942.

Heavy penalties are provided for failure to file a declaration required under the law, or to pay the amount of estimated tax which is to be paid when such declaration is filed. Therefore, you will want to study the instructions carefully, and file the declaration on or before September 15th, if there is any possibility that you may be required under the law to file the estimate of your Income and Victory Tax for the year 1943. Farmers must file their Declarations of 1943 estimated Income and Victory Taxes on or before Decem-

ber 15th. Farmers are deemed to be those persons having at least 80% of their gross income derived from farming operations.

At the present time the office and field officers of the Collector of Internal Revenue, Dallas, Texas, are studying the provisions of the new law so as to be able to assist the taxpayers in the northern part of Texas in the preparation of their declaration forms. It is planned for the field deputy collectors to visit practically all of the larger cities and towns during the two week period beginning Monday, August 30th, and ending Saturday, September 11th. Further information as to the time these visits will be made and the places which will be visited by the zone deputy collectors will be given in advance by way of posted and newspaper notices, and appropriate radio announcements.

In order to obtain the assistance of these zone deputy collectors, you should have immediately available the following information:

- (1) The amount of tax shown on your 1942 Income Tax Return
- (2) The estimated income and deduction items expected for 1943
- (3) The estimated amounts of Victory and Withholding taxes withheld by your employer from

your wages or salaries during 1943

(4) The payments you have made during 1943 to the Collector of Internal Revenue to be applied on your 1942 income tax

Zone deputy collectors will be glad to render all possible assistance in properly preparing your declaration forms if you will bring along this necessary information.

In addition to the visits of zone deputy collectors to the various cities and towns in northern Texas, the zone offices located in the sixteen larger cities, Dallas, Ft. Worth, Amarillo, Wichita Falls, Lubbock, Abilene, Eastland, Odessa, Paris, Sherman, Texarkana, San Angelo, Tyler, Corsicana, Longview and Nacogdoches, will be open during business hours for practically all the time between now and September 15th, when the declaration is to be filed. Zone deputy collectors located in these offices will also be glad to render you all possible assistance.

Remember—when you receive the forms and instructions from your Internal Revenue Tax Collector within the next several days—you should study the instructions to determine whether you will be required to file a declaration. If so, you should assemble at the earliest possible moment the information necessary for preparation of a declaration. If you need assistance in preparing the declaration of your estimated Income and Victory taxes for 1943, you should immediately consult a zone deputy collector in one of the sixteen zone offices located in the major cities of northern Texas or, if you reside in a smaller city or town, you should watch your

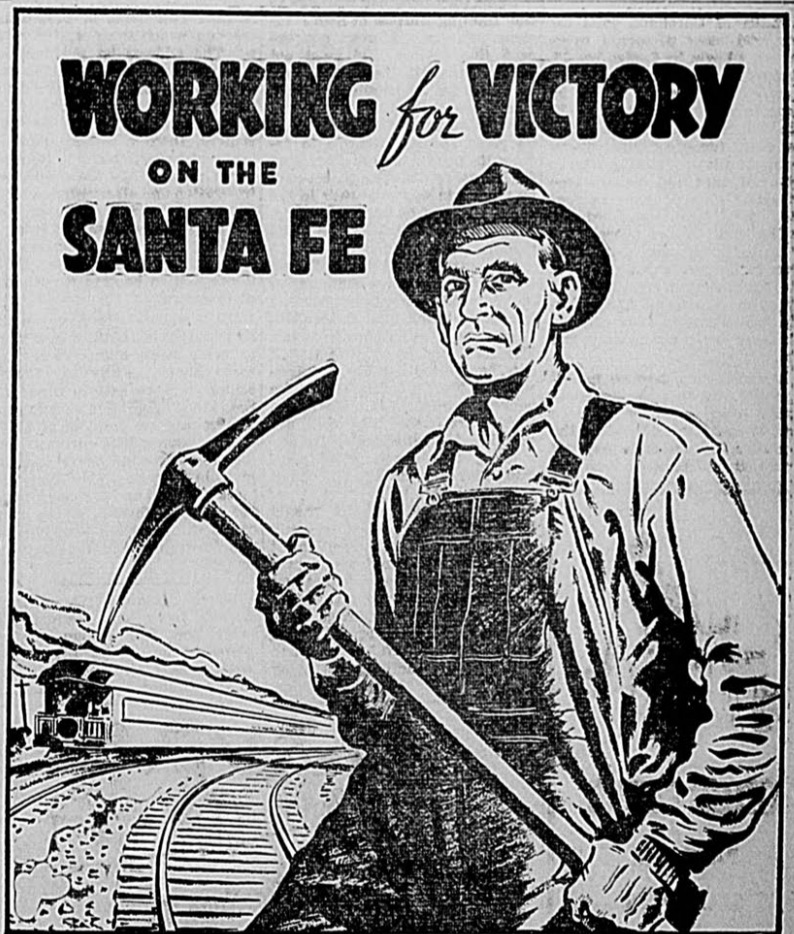

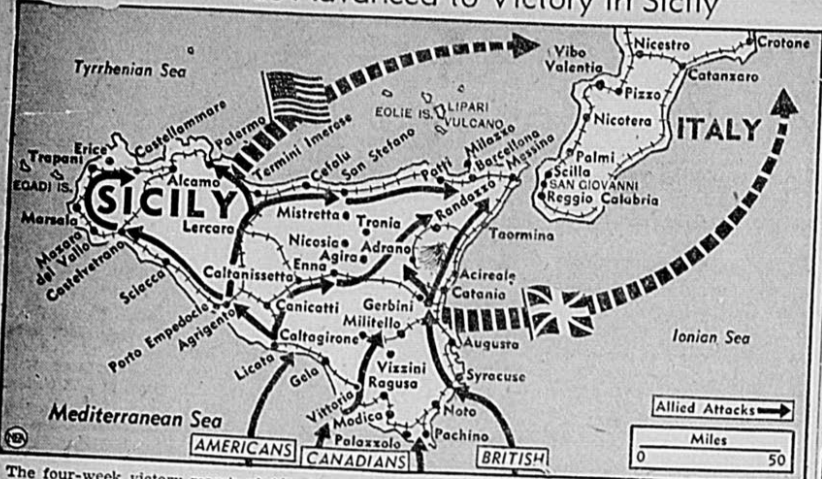

Begin Mailing Of Christmas Gifts Overseas

Mailing of Christmas gifts for army and navy personnel overseas must begin by September 15, if many of the men and women in armed services are not to be disappointed, and September 15 is less than a month away. The only way to insure against disappointment for the fighting men is to buy at once and mail early—mail your gifts as soon as possible after the September 15 starting date. If the parcels are not mailed early, that delay may prove to be just enough to prevent their arrival by Christmas Day, with consequent disappointment to the men who are offering their lives for their country and ours.

Christmas gifts may be mailed by parcel post to army men and women overseas only between Sept. 15 and Oct. 15. After the latter date, such parcels may not be mailed unless a written re-

quest from the soldier for the article is presented with each parcel. No soldier should have to ask for a Christmas gift; so gifts must be mailed on time. The navy also urges that gifts be mailed between Sept. 15 and Oct. 15.

Rules for Christmas mailings to the fighting forces overseas include: The parcel must not exceed five pounds, and must not be more than 15 inches in length or 36 inches in length and girth combined. It should be marked "Christmas parcel" so that it may be given special attention to assure its arrival before December 25. Not more than one parcel may be mailed in any one week to the same member of the armed forces by or in behalf of the same mailer.

The parcel must be well and strongly packed, in a container of metal, wood, strong fiber board, or similar material, then wrapped in strong paper and tied with twine. The cover should be such that it can be opened readily for censorship. The contents should be packed tightly. Perishable goods, such as fruits that may spoil, are prohibited. Intoxicants, inflammable materials, poisons, and anything that may damage other mail also are prohibited.

Gifts enclosed in glass should be substantially packed to avoid breakage. Sharp instruments must have their edges and points protected so that they cannot cut through the covering and injure postal personnel or damage other packages. Since the armed forces are being plentifully supplied with food and clothing, the Army and Navy recommend against

these as gifts.

Addresses must be written clearly and completely. In addition to the return address of the sender, a parcel for an army man should show name, rank, army serial number, branch of service, organization, army post office number and name of post office through which the parcel is routed. The address on a parcel for a navy man should include the name and rank or rating of the addressee, the naval unit to which rationed articles here.
