# Michelle Cook Crowned Homecoming Queen

### The Coronation

Last Friday night, Spearman High School crowned the 1989 Homecoming Queen and King. The new queen is Michelle Cook and the king is Scott Wilkerson. Mr. Wilkerson placed the crown on Ms. Cook's head during the coronation ceremony, before the football game between the Lynx and the White Deer Bucks.

The coronation ceremonies started with the three Queen candidates and the Queen's Court being paraded before the crowd in two classic convertibles. They passed in front of the home town fans and moved on around the track to the visitors' side.

On the visitors' side they were met by their escorts and King candidates. The escorts accompanied the girls across the football field. As they reached the home town side each girl and her escort was introduced to the crowd and presented a flower bouquet by a cheerleader.

Freshman court attendant Sophie Delgado and her escorts, Jeff Spencer and Danny Lopez, were the first to be presented. They were followed by Sophomore Mendy Lasater and her escorts, Barry Beck and Tracy Thompson. The third attendant to be presented was Kyla Nelson. Her escorts were David Boese and John

Hughes.

Next to be presented were the three Queen candidates and their King candidate escorts. First came Cacy McGill and her escorts, Edward Mayfield and Cody Reynolds. They were followed by Michelle Cook and her escort, Frank Salgado. The last candidate to be presented was Laci Lasater and her escort, Scott Wilkerson.

After the last candidate and her escort were presented to the crowd the announcer, Todd Dyess, announced the names of the Homecoming Queen and King for 1989.

The queen's crown was given to Mr. Wilkerson, who placed it on Ms. Cook's head. The couple then kissed and turned to thank the crowd.

After the Queen was crowned Ms. Cook, her court, and the other candidates were escorted to their private box on the track. Here they were seated to watch the homecoming football game.

### The Pep Rally

Homecoming events last week included an all-school pep rally, held Friday afternoon, at the Varsity Gym.

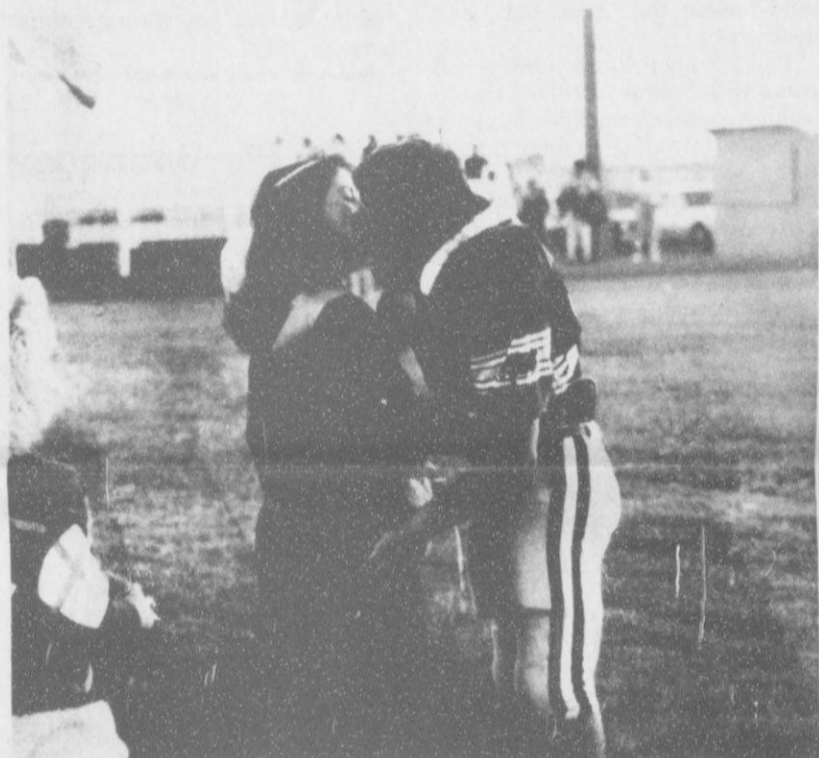
Music for the pep rally was provided by the Spearman High School Band. They played a couple of songs at the beginning

Booth space may be reserved by calling Claudine Hardy at 659-3440, or Donna Trantham at 659-2046 after 6:00 p.m.

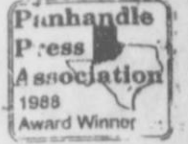

that got the students dancing in the stands. Their rendition of the SHS fight song had everybody in the gym up cheering.

**The Game**

The Lynx faced a frustrated Bucks football team for their '89 Homecoming football game. The Bucks had been a 16 - 0 State Championship team last year. This year they had struggled to a 1 - 2 record.

On Friday night they took out some of that frustration on the Lynx by beating them 18 - 7.

The game started well for the Lynx. They won the toss and elected to receive. They took the kickoff on the 20 yard line, and using a reverse maneuver advanced the ball to their own 40 yard line. There the drive stalled and the Lynx were forced to kick.

The Bucks let the punt bounce and took possession on their own 33 yard line. On the Bucks' first offensive play the Lynx defense looked pretty good. They held the Bucks to only a two yard gain.

On the next play the Bucks' quarterback found his receiver open, five yards deep in the Lynx secondary. He delivered the ball, the receiver shook off a tackle and rambled 30 yards to the Lynx' 30 yard line.

The next play by the Bucks was a running play that covered the remaining 30 yards for the touchdown. The PAT kick by the Bucks was muffed. This left the score at

6 - 0 in favor to the Bucks.

On the ensuing kickoff, the Lynx again got a good runback by Tim Dooly. He caught the ball on the 20 and advanced it to his own 47 yard line. On the very first play from scrimmage the Lynx offense turned the ball over by fumbling after a seven yard gain.

The Lynx defense then took the field and managed to contain the Bucks' attack for the first few downs. The Bucks only managed to make small, but steady, advances toward the Lynx goal line.

On the fourth play from scrimmage, a Buck running back broke several tackles and ran for a 32 yard touchdown. The play was called back because of a clipping penalty by one of the Bucks. Six plays later, the Bucks were able to make up the 15 yard clipping penalty and move the 43 yards for their second touchdown.

This brought the score up to 12 - 0, in favor of the Bucks.

The score stayed at 12 - 0 through the rest of the first half. The Lynx spent most of the half in the Bucks' end of the field, but could not seem to push the ball the last 20 or 30 yards for a score. The Lynx defense tightened up and held the Bucks scoreless.

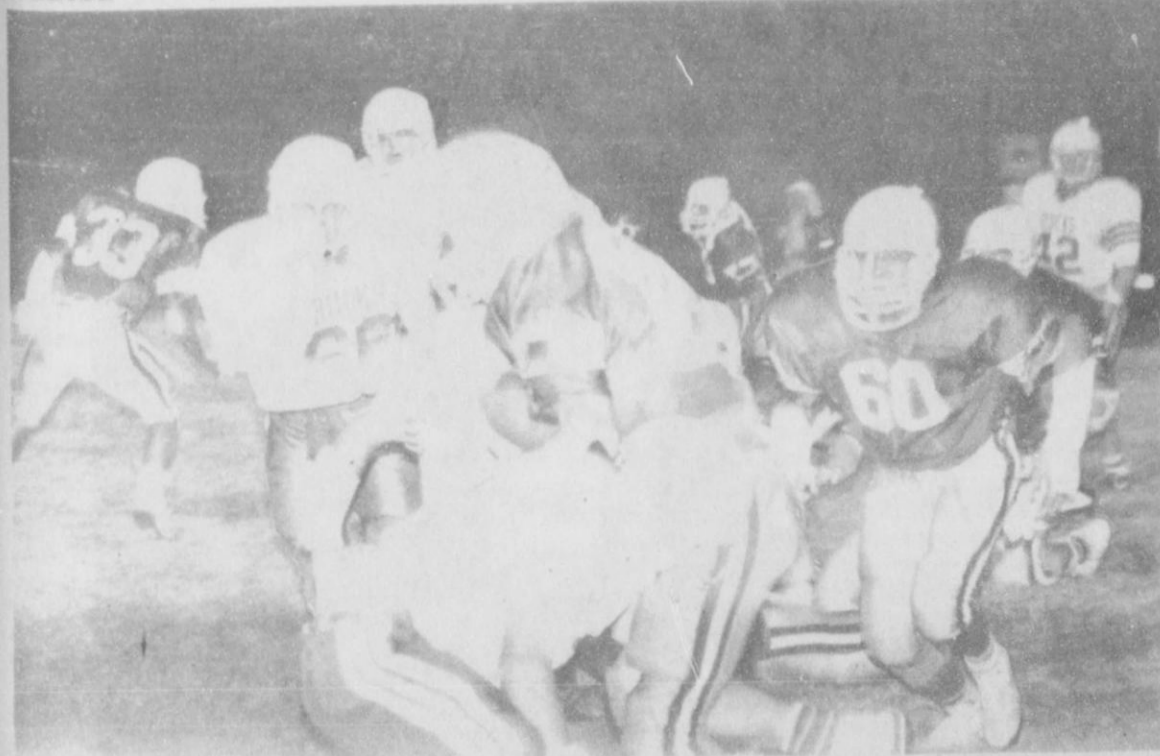

The fourth quarter started with the Lynx defense forcing the Bucks to fumble on their own 18 yard line. The Lynx recovered and the Lynx offense took over.

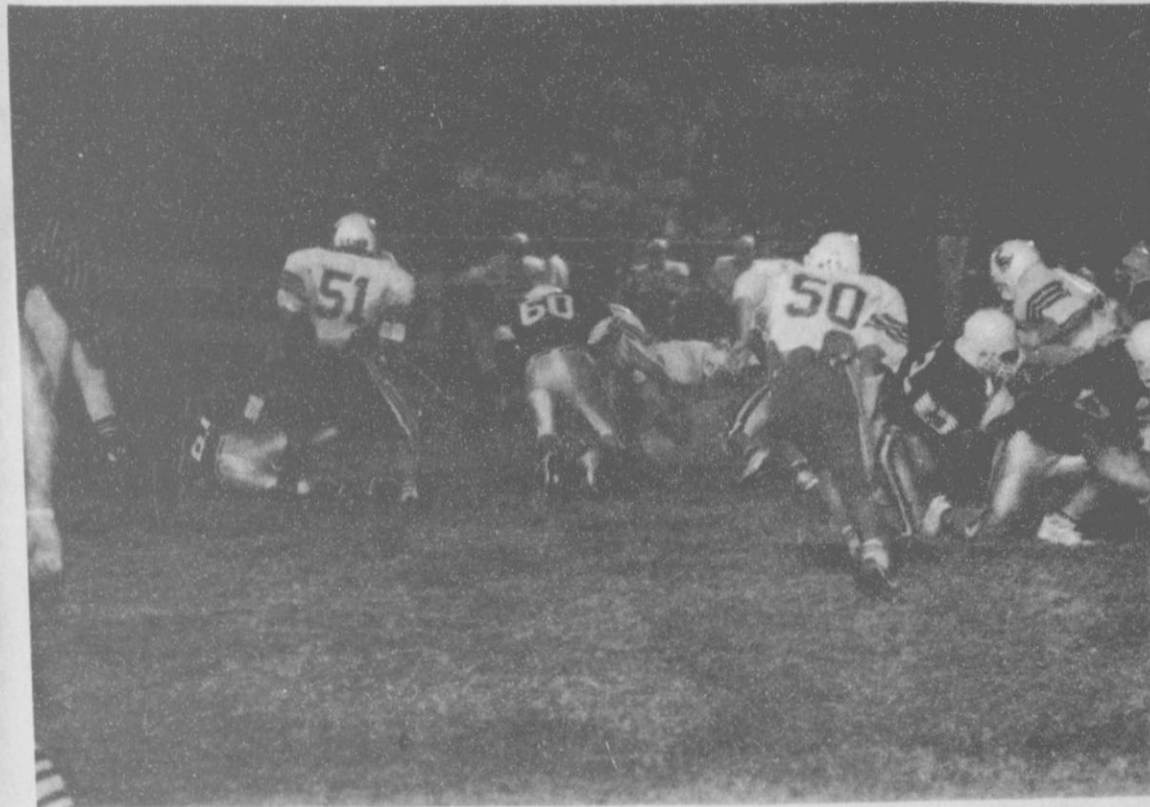

The score remained the same throughout the rest of the quarter. The Lynx offense was unable to move the ball once they crossed the mid-field stripe.

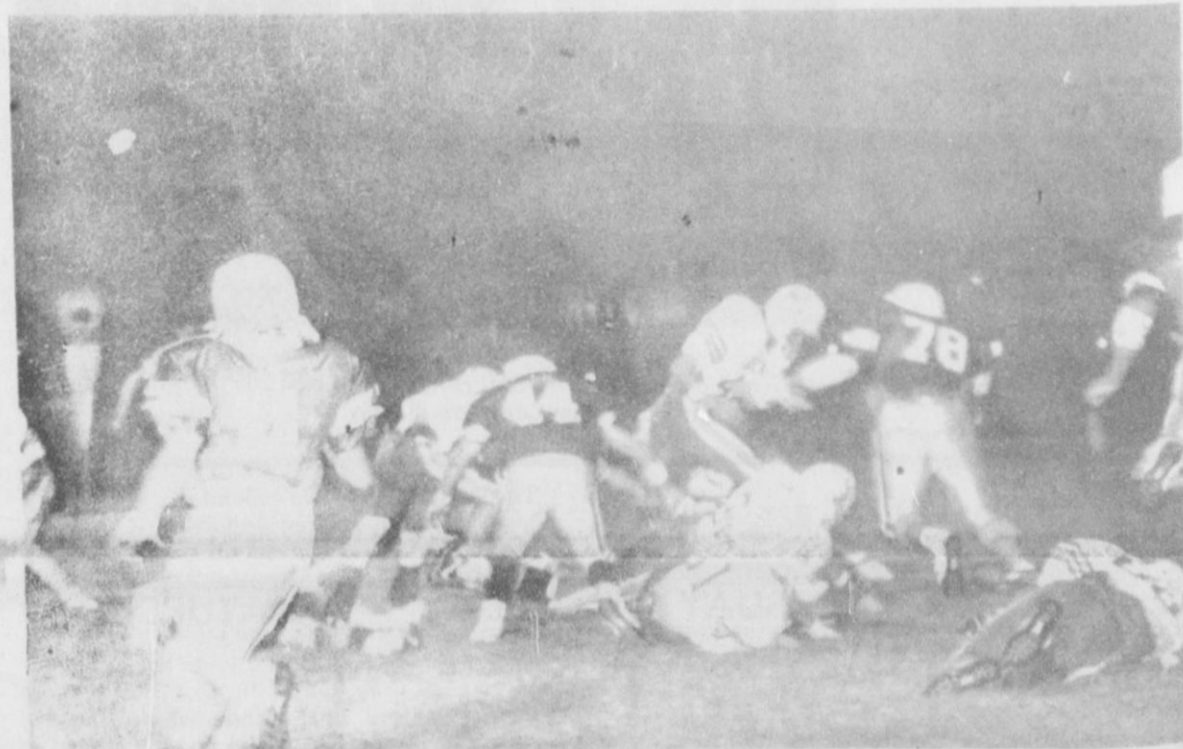

In summary these rules are as follows:

1. Application forms must be completely filled out.
2. Verification of Income, Termination of Income, Residence Household composition, and Resources is required, if questionable.
3. Net Income cannot exceed the Maximum Income Standards listed in the Income Standards Chart below.
4. Liquid resources assets cannot exceed \$1500. The equity value of a car greater than \$1500 is counted against the \$1500 limit. Personal property and home-stead are exempt assets.
5. Eligible persons must be residents of Hansford County.
6. Applicants must provide requested information and documentation requested or application will be denied.
7. Applicants have the right to appeal adverse decisions.

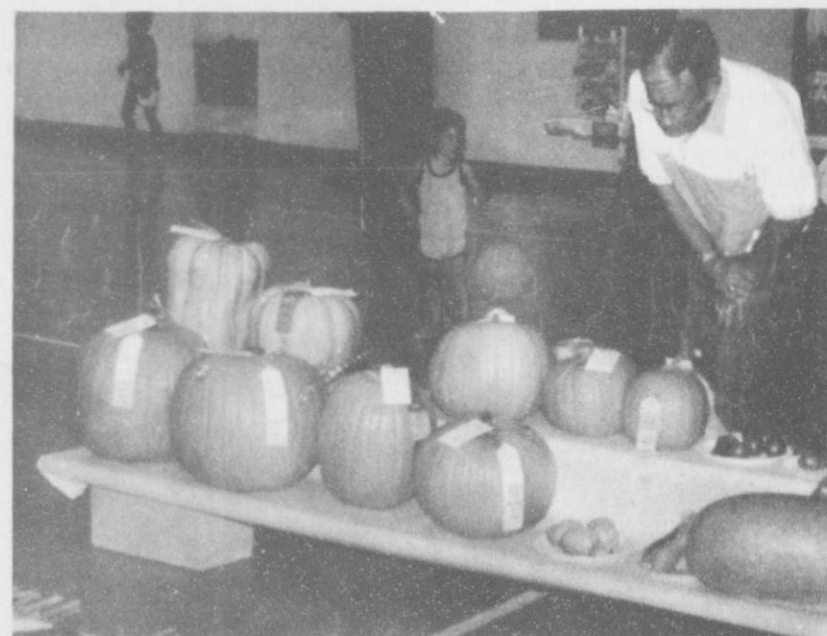

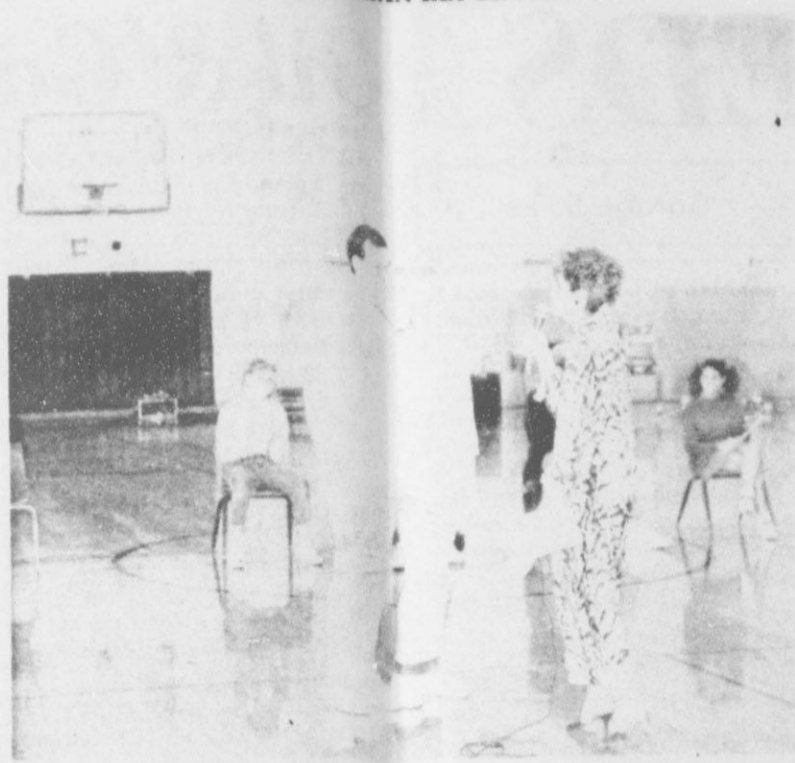
