# Council to Hold Hearing

The Spearman City Council will ask for residents views on the 911 Emergency System in a public hearing before deciding whether to participate in the proposed Panhandle-wide system.

The matter was tabled by council members at their regular session, held Aug. 22 in the council chambers.

George Young, Spearman resident, attended the meeting and stated his opposition to the surcharge fee which would be collected by the telephone company and used to pay for the PRPC-administered 911 service. Wayne Hughes of the Panhandle Regional Planning Commission was present and explained the Enhanced 911 system and answered questions concerning the system.

The council went into executive session to discuss litigation regarding paint failures on the water storage tanks and to discuss personnel matters regarding the city

After executive session, the council voted to authorize the law firm of Buckner, Baird, Lara, Swindell, Snell and Zoccolillo to file a lawsuit against the firms of McMorries and Glovier, Inc. and Industrial Painting and Sandblasting due to the paint failures on the city water storage tanks.

The council also discussed the deterioration of the city's wastewater treatment plant and a proposed refurbishment project. Dwight L. Brandt of Brandt Engineers Inc. spoke with the council about the need for repairs on the plant. After discussion, Brandt was authorized to compile a comprehensive plan and to present an approximate cost to the council.

Brandt also gave a status report on the airport improvements pro-

Jim Murray, city manager, stated that all the utilities, drainage and paving is installed and in accordance with city specifications on property that may be annexed to the city. After discussion, council members set a public hearing for Sept. 19 at 7:00 p.m. and another for Sept. 26 at 8:00 p.m. in relation to that matter.

A workshop on the 1989-90 proposed city budget was held, but no official action was taken.

The council voted to accept the final recommendation of the city council's committee reviewing the Spearman Volunteer Fire Department organization. Meeting dates for September were set for the 12th and the 26th. Approval was given to minutes of previous council meetings and monthly revenue and expense reports for

# City To Sue Paint

# Companies

The City Council voted last week to instruct Melissa Zoccolillo of the law firm Buckner, Baird, Lara, Swindell, Snell, and Zoccolillo to file litigation against the firms of McMorries and Glover, Inc. and Industrial Painting and Sandblasting. The City is taking this step because of a faulty, \$60,000, paint job done by these companies for the City two years

Two years ago the City hired the firm McMorries and Glover, Inc. to paint all of the elevated and ground water storage facilities owned by the City. After a short time the paint on the outside of the storage facilities began to peel. The City asked the paint firm to return and repair the peeling paint.

The firm of McMorries and Glover, Inc. returned and did some repair, but failed to bring the job up to the specified

standards the City contracted for. When the paint firm refused to take any further action to bring the outside paint job up to standard. the City hired Brandt Engineering of Amarillo to inspect the outside paint on the water storage facilities. Brandt was hired as an outside consultant to verify that the paint job was not up to the standards specified in the

contract between the City and the paint company. Brandt Engineering hired Southwestern Laboratory of Houston to check the quality of the paint.

Basically they said we didn't get what was specified," said City Manager Jim Murray. According to Murray the consulting Engineer couldn't believe the inside and outside of the facilities were painted by the same company. The paint on the inside of the facilities is doing fine but on the outside, the paint is peeling down to the primer coat.

# Hansford **Donates Flags**

As the young people of Spearman and Gruver return to school this week they will probably pass right by the flag pole without thinking much about the flag flying atop it.

Their minds will be filled with thoughts of the coming day, of classes and social events they will be attending. They will not stop to wonder about where that flag flying above their heads might have come from. It might be one of the flags that once flew over the nation's Capitol, and was donated to the Spearman and Gruver school districts by the U.S.S. Hansford Reunion Association.

The presentation of the flags took place at the Hansford County Court House on Saturday afternoon, August 19.

The Association is a group of men and their families, from all over the United States, who served aboard the USS Hansford during World War II. The USS Hansford was a troop transport ship commissioned in the summer of 1943. It served in the Pacific, delivering troops to the beachheads and then serving as a

hospital for the wounded. The Hansford was one of the ships closest to the USS Missouri, where the Japanese surrendered in Tokyo Harbor.

The Hansford got its name because of a mix up in the Navy Bureau of Ships in 1943. The transport was originally named the Gladwell, after a county in Michigan. In January the Navy assigned the name, Gladwell, to a destroyer. The name Gladwell was then struck from the transport and the process of selecting a new name began.

The name of the ship had to begin with a "H." Congressman Walter Rogers applied pressure to name the transport after the county in his district. Thanks to his persistence, the name Hansford was chosen over seven counties in Texas with names beginning with "H.

The men who served aboard the Hansford decided a few years ago to get together and share their experiences and memories of their time together in service to their country. The Association was organized and began to actively seek out members of the crew of the Hansford and to meet each year at a different location in the

This year they decided to meet at a site as close as possible to the county for which their ship was

The trip to the county their ship was named for began for the 43 Association members and their families with a bus trip from their hotel in Amarillo. They arrived in Spearman about 10:30 Saturday morning.

The idea for holding the reunion in the vicinity of the county the ship was named for came from the meeting of a county commissioner from Hansford and Glen Campbell, a member of the Association, last year. Campbell was elected program chairman for this year's reunion and began to work with county and city officials to organize the reunion and trip to Hansford County.

Their first stop in Spearman was the Station Master's House Museum. They took a tour of the museum, conducted by the board members of the museum. After the tour the group went to the county court house for lunch on the courthouse lawn, hosted by city and county officials, and catered by IV's Hungry Cowboy.

After the lunch came the official welcome of the Association to Hansford by county and city officials, and the exchange of gifts and tokens of appreciation as souvenirs of the Association's visit to the county.

R.L. McFarlin, county sheriff, presented each of the Association members with honorary Deputy Sheriff identity cards and Bill Barnett, president of the Association, was presented with two commemorative coins from the county sheriff's office.

Jim Murray of the city of Spearman presented each of the Association members with a key to the city and a "thank you" for visiting Hansford County and the city of Spearman.

The Association's Program Chairman, Glen Campbell, presented American flags that had flown over the United States Capitol to Barry Haenisch, principal of Gruver High School; to Larry Butler, superintendent of Spearman School District; and to Helen Boyd of the Station Master's House Museum. Presented to Judge McClellan was a framed picture of the USS Hansford and a map of its area of


for networking and sharing drug prevention techniques and skills for community mobilization. The Texans' War on Drugs

#### NOTICE OF PETITION FOR APPROVAL OF DEFERRED ACCOUNTING TREATMENT FOR TNP ONE, UNITS 1

AND 2 AND ADJUSTMENT TO PURCHASED POWER COST RECOVERY FACTOR ("PCRF") CALCULATION

Texas-New Mexico Power Company ("Company") hereby publishes notice that it has filed with the Public Utility Commission of Texas ("Commission") a Petition for for TNP One, Units 1 and 2 and Adjustment to PCRF Calculation pursuant to Sections 16(a), and 27 of Article 1446c, Vernon's Annotated Civil Statutes and Section 23.12(a) of the Substantive Rules of the Commission. TNP One is a lignite-fired generating station being constructed by the Company in Robertson County, Texas. The Company estimates that the first Unit of TNP One will be in commercial operation in June 1990. Unit 2 is estimated to be in commercial operation in June 1991. The Company's Petition has been designated as Docket No. 8880 at the Commission. In such Petition the Company seeks an order from the Commission allowing the Company to defer the depreciation, operation and maintenance expenses, tax expenses and carrying costs associated with TNP One, Units 1 and 2 from the respective commercial-in-service dates of those units until the time rates reflecting such costs are in effect. The Company is also requesting that the Commission approve an adjustment to the calculation of its PCRF factor. This change to the PCRF factor will not affect rates until the respective commercial operation dates of the units, and would be in effect from that date until each unit's costs are allowed into rate base by Commission order. Approval of this request will not result in an increase in current rates. The rate treatment afforded these costs will, however, have a bearing on overall costs which are included in rates that customers pay over the life of the plant. The Company seeks timely regulatory action to permit the deferral of these costs to be reflected in financial statements for the deferral period, which is from the date of commercial operation until each unit's costs are allowed in rate base.

At a prehearing conference held on July 17, 1989, the Administrative Law Judge set a September 8, 1989, deadline for motions to intervene and scheduled the hearing on the merits of the Company's Petition for November 27, 1989, at 10:00 a.m. at the Commission offices in Austin, Texas.

Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission as soon as possible.
