Hansford County voters go to polls November 8

With the general election nearing, concerned voters are reviewing their choices of candidates. On Nov. 8 Hansford County voters will make their choice of presidential candidates, along with their choice of senator, U.S. representative of District 13, railroad commissioner, Chief Justice of the Supreme Court of Texas, and five other justice places.

Voters will also be able to vote on presiding Judge of Court of Criminal Appeals, and two other justices on that court, a member of the state Board of Education, District 15, a state senator for District 31, a state representative for District 88, Justice for the 7th Court of Appeals, place one and two.

District judge for the 84th Judicial District and District Attorney for the 84th judicial district, and county attorney, sherriff, county tax assessor-collector, and county commissioner for precinct number three and county commissioner for precinct number one.

Presidential candidates include from the Republican party, George Bush and vice presidential running mate Dan Quayle, Democratic candidate for president, Michael S. Dukakis and running mate Lloyd Bentsen, and from the Libertarian party Ron Paul and running mate Andre Marrou and from the New Alliance Party Lenora B. Fulani and running mate Rafael Mendez.

Vying for the U.S. senator position in Texas are Beau Boulter of the Republican party Lloyd Bentsen of the Democratic party and Jeff Daiell of the Libertarian party.

Choices for U.S. representative for District 13 are from the Republican party, Larry S. Milner and Bill Sarparlius of the Democrats.

Competing for railroad commissioner are Ed Emmett of the Republicans, James E. Nugent for the Democrats, Richard Draheim of the Libertarian party and Reynaldo Lozano, Jr. of the New Alliance party.

In the railroad commissioner spot, unexpired term are Republican candidate Kent Hance and Democratic candidate, Clint Hackney.

For Chief Justice, unexpired term Tom Phillips, Republican, and Ted Z. Robertson, Democrat. For justice of Supreme Court, place one, Paul Murphy, Republican, and Lloyd Doggett, Democrat; place two - Nathan Hecht, Republican and Bill Kilgarlin; Democrat place two-Nathan Hecht. Republican and Bill Kilgarlin, Democrat place three Republican, Charles Ben Howell, and Democratic candidate, Raul A. Gonzalez and Libertarian candidate Calvin W. Scholz; place 4, unexpired term Republican, Barbara B. Culver, or Democratic candidate, Jack Hightower; place five, unexpired term, Eugene

A. Cook, Republican and Karl Bayer, Democrat.

Choices for presiding judge, Court of Criminal Appeals, Republican, David A. Berchelmann, Jr. and Democrat, Mike McCormick. On the ballot for judge of that court, place one, Charles F. Campbell, Democrat and Egon Tausch of the Libertarian party. For place two of Court of Appeals - Tom Rickoff, Chuck Miller, Democrat, and Carol Caul of the Libertarian party.

Candidates for member of District 15, State Board of Education, Republican, Monte Hasie, and Democrat Paul C. Dunn.

State Senator of District 31, Republican candidate, Teel Bivins, and Democratic candidate, Mel Phillips. Dick Waterfield is running unopposed as the Republican candidate for state representative of District 88.

On the ballot for Justice, 7th Court of Appeals District, place one, unopposed, Democrat, H. Bryan Poff, Jr. for place two of that court, unopposed, Democrat, John T. Boyd.

Choices for District Judge, 84th Judicial District, Republican candidate, J.E. Blackburn, and Democratic candidate, David Wagner. District Attorney choices for 84th District are Republican, Stephen F. Cross and Democrat, John La

Running on the ballot, unopposed for County Attorney is Republican, John L. Hutchison. Unopposed for sheriff is Democrat, R.L. McFarlin.

Also running unopposed for County Tax Assessor-Collector is Democrat Helen Dry. And unopposed Democratic candidate for County Commissioner of precinct three, B.J. Renner.

On the ballot for County Commissioner for precinct one is Democrat Garland Head and registered write-in candidate Ernie Vanderburg.

There will be three proposed constitutional amendments at the bottom for voters to consider. Amendment number one states, "The constitutional amendment and/or clarification providing that federal reimbursement of state highway dedicated funds are themselves dedicated for the purpose of acquiring rights-of-way and constructing, maintaining, and policing public roadways." Voters

choose whether they are for or against this and the next two amendments proposed.

Amendment number two states, "The constitutional amendment establishing an economic stabilization fund in the state treasury to be used to offset unforeseen shortfalls in revenue."

Proposed amendment three states, "The constitutional amendment to provide for the investment of the permanent university fund, the permanent school fund, and public employee retirement systems in the Texas growth fund created by the amendment, which will directly create, retain, and expand job opportunity and economic growth in Texas."

Registered voters of Hansford County are notified that the polling places in Hansford County will be open from 7 a.m. to 7 p.m. on Nov. 8 for voting in the general election to elect presidential electors, members of the Legislature, and state, district, county and precinct officers; and for the purpose of adopting or rejecting the proposed Constitutional Amendments as submitted by the 70th Legislature.

Voters of precinct one will vote

at the Hansford County Courthouse. Precinct two voting location is at the Renner Ranch.

Voting for precinct three is at the Community Bible Church in Gruver. Precinct four voting will be at Gruver County Agriculture building; precinct five at Spearman County Agriculture Building;

Precinct six voting location is at the Spearman High School; precinct seven will be at the Oslo Church:

Precinct eight is for absentee voters at the Hansford County Courthouse; and precinct nine is at the Morse Community Building.

Absentee voting by personal appearance will be conducted each weekday at the Hansford County Clerk's office, located in the Hansford County Courthouse. The clerk's office will be open on those days between the hours of 8:30 a.m. and 5 p.m. beginning Oct. 19 and ending on Nov. 4 prior to the



Texas 4-H develop'It's Up To Me' program

COLLEGE STATION -- What do youth who raised animals to show at the county fair have in common with children raising their self-esteem to avoid later problems with substance abuse, dropping out and teenage pregnancy? The answer is 4-H

Through a program called "It's Up To Me," developed by Texas 4-H, thousands of school children are studying topics such as "accepting yourself," "dealing with peer pressure," and "competing instead of comparing," this school

The 10-lessons and age-related activities were designed as a resource for teachers and youth workers to use in their classrooms and programs with children in grades 3 through 8.

Working cooperatively with the Texas Education Agency (TEA), the Texas Agricultural Extension Service has already distributed 1,200 of the teaching guides to school districts in Texas.

The Extension Service also has conducted training for more than 7,500 public school teachers, county Extension agents, sunday school teachers, juvenile probation officers, day care workers, 4-H and other youth leaders who will conduct the lessons.

The focus on building selfesteem is nothing new to 4-H, an 80-year-old youth development program that's part of the Texas Agricultural Extension Service, an educational outreach arm of the Texas A&M University System.

'The techniques we've used have always worked. Our programs teach kids practical life skills through learning projects ranging from nutritious meal planning or consumer shopping skills, to computers and community service projects," said Tom Davison, assistant director for 4-H and youth.

'But the point of any project is to also five youngsters the opportunity to plan, accept personal responsibility and interact with responsible adults. All things that build their self-esteem and sense of worth," he said.

Awareness of the problems facing young people prompted a 35-member statewide group of 4-H youth development workers and


Ailene Sparks White, 82, died Monday Oct. 10 in Amarillo.

New loan program for disadvantaged

The Farmers Home Administration (FmHA) is preparing to activate a loan program designed to help members of socially disadvantaged groups, including minorities, acquire land for farming, J. Lynn Futch, FmHA State Director, said today.

Under the new program, FmHA will try to find persons in those categories who are interested in farming and can qualify for an FmHA farm ownership loan. The agency would also be prepared to sell or lease to them a farm held in its inventory if any are available in that county, Futch said.

FmHA can also provide other loan and technical assistance, if needed, to help the borrower get


The new program was included in the agricultural credit act signed earlier this year, Futch said, and funds have been reserved for farm purchases based on the population of socially disadvantaged persons.

The population of such persons range from as low as 1 percent in some New England and midwestern states to highs of 68 percent in Hawaii, 57 percent in New Mexico, and somewhat lower percentages in southeastern states. Population groups involved are Hispanics, Native Americans, Blacks, Asians and Pacific Islanders.

Persons who think they might be eligible and who are farming or who would like to become farmers are urged to contact the Farmers Home Administration county office serving their area, Futch said.
