

## SHS track teams capture second

Spearman took second in both the boys' and girls' divisions of the Region 1-2A track meet last Saturday at Abilene Christian University.

Heather Murrell qualified for state in four events as she led the Spearman girls with first-place finishes in the 400, in which she is the three-time defending state champion, and 100 hurdles, plus a second in the long jump. Murrell ran the anchor leg on the 1600 meter relay team that was second to Panhandle.

The top two individuals in each event qualified for the Class 2A state meet in Austin coming up next weekend.

First-place finishes by Matt Tucker (shot put) and Lance Swan (discus) paced the Spearman boys. Tucker also qualified with a second in the discus, while Jerold Blan was second in the 3200.

Haskell won the boys' team title with 67 points, to 54 for Spearman. The SHS girls points total was 67 to Albany's team total of 83.

## Cafe opens

Kay and Jim Hamilton celebrated the grand opening of their new restaurant, Kay's Cafe, on May 1 with a Chamber of Commerce ribbon-cutting and free coffee and doughnuts for all.

Kay's Cafe, located on Main Street in Spearman, is a family-style restaurant with a full-line menu including steaks, seafood, fried chicken and sandwiches. Diners also have the choice of serving themselves at the combination salad bar/buffet. The buffet features hot foods daily, including three to four meats and three to four vegetables.

"I guess I've been in the restaurant business since I was born!" Kay says, referring to the Spearman restaurant her parents owned during her childhood. She also explains that her mother and father, Georgia and the late Rock McCloud, taught her how to cook and had her serving coffee by the time she was nine or ten years old.

After her marriage in 1960, Kay followed her husband with his jobs in the oil industry. The couple eventually settled in Mobeetie, where Kay owned and operated a service station and restaurant called The Stagecoach.

The idea of a cafe on Main Street first occurred to the Hamiltons when they decided to return to their hometown. The youngest Hamilton son, 16-year-old James, remains with his father in Mobeetie to finish out the school year, but the family has plans to settle in Spearman permanently.

Kay's Cafe has a full breakfast menu as well as fare for lunch and dinner and opens at 5 a.m. each day. Closing time is 9 p.m. daily. House specialties include charcoal-broiled steaks and Georgia's cream pies.

VOTE MAY 6th	If the budget had to be cut, in what areas would you lower expenditures?	Where do you see that our system could use improvements at this time?	What do you offer the school board that makes you a unique candidate?
Carolyn Gressett	I mean no criticism to any school board member, but I would not vote to go to the school board convention if it means that we do not have the right funds for our academics and libraries.	I think that we have a very good academic program and we just need to continue at this high level of achievement in this area. We especially need to improve our band and choir programs at all levels at this time.	I'm unique because I've been a parent to children in Spearman schools, but now I can be totally objective to any issue because my children have completed their schooling here.
Craig Schumann	Budget cuts are very hard to do. Every program is someone's priority. Academics must be everyone's TOP priority, however, so I would never cut here. Outside spending would be the first place I'd look to make cuts. Fine arts and vocational courses have been too much on the cutting block.	I believe that we need more and better communication from school to parent, and from administration to parent. I want more openness about school happenings on the part of school board members.	I offer many of the same qualities as the other candidates, such as dependability and willingness to serve. One difference is that as a school board member, I will take it on myself to admit it if I'm wrong and I will not pass the buck. I will be a good school board member for ALL people.
Linda H. Jarvis	We don't know how much money we'll have to work with because the state requirements for the budget have not been set, but in the past, budgets have been cut by use of volunteers whenever possible. Parents are interested in their children's opportunities and will respond to the school's needs in this community.	We need to create in our children a desire to learn and the recognition that they are able to excel in individual areas, and in so doing, upgrade academic levels. We should be more eager to recognize achievement in all areas--academics, music, vocational and athletics.	I was born and reared in this area and have a past, present and future interest in the schools. I have the education and ability to devote to the job and especially the time.
Charles Shieldknight	I do not think the budgets will need drastic cuts in any one program. I don't want any one program's viability hurt. Some minor cuts in all areas will be needed to hold the budget where it is.	I would like to see us take more advantage of some of the electronic media allowing us to offer our high school kids courses for college credit while still in high school, thereby lowering college costs. I'd like to strengthen choir and band programs. We would have to offer them before school or go to an eight period day in order to have time for House Bill 72's required courses.	I've got nine years' experience on the Board. I'm a property owner, so I understand the taxpayers' situation. I have four daughters in the school system and I'd like to get the best possible education for them.

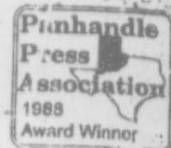
**Library features local artist's portraits**

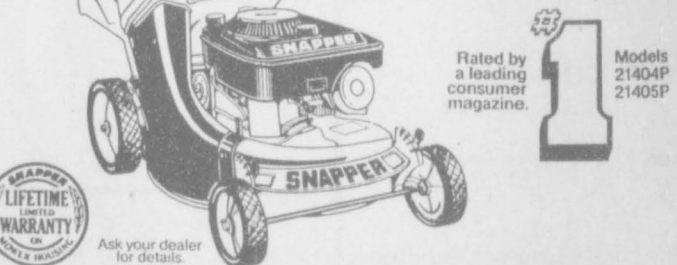

## Service informs farmers about "wetland" use

With the recent extended period of little or no rainfall, it is hard to imagine wetlands in Hansford County. However, according to the Food Security Act (FSA or the farm bill) of 1985 a majority of the playa lakes in the county are classified as wetlands.

This classification means several restrictions apply to these "wetland" playas when it comes

to farming them and remaining eligible for farm program benefits. The most serious restriction involves doing any type of alteration in the wetland area such as draining, dredging or filling. The

construction of pits, ponds, ditches, dikes or terraces in the wetland would be considered alteration.

The FSA has provisions which allow farming these wetlands when dry conditions are present due to a natural event such as drought. However, no action can be taken to alter the wetland other than to maintain an alteration which existed prior to December 23, 1985. The landuser has the responsibility of documenting that the alteration existed prior to this date if maintenance is performed. contact the Soil Conservation Service in Spearman for further information.

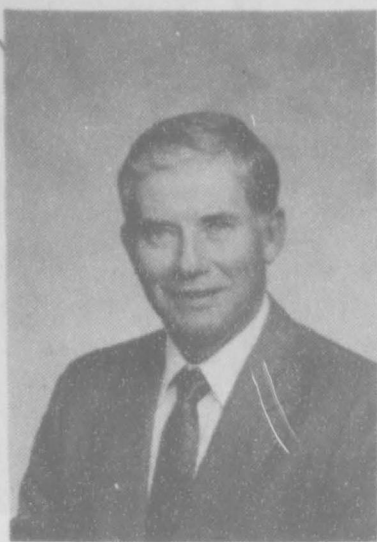
