For the unhappy consequences to the friend, the druggist was held blameless. The court pointed out that his label had no connection with what happened, because the prankster would have done the same thing even if the label had been right. Furthermore, a customer must show reasonable regard for his own safety. In another "wrong medicine" case. the customer made his purchase from a young, inexperienced clerk while the regular pharmacist was out of the store. Here the clerk, after bring-
