

California Bicycle Riders Camp Overnight in S-Anna

Passers-by of the little Kate and the high winds of west Texas Mathews Park in downtown Santa Anna got a surprise Friday morning, March 4, when they saw two young men arise from sleeping bags, unpack cooking equipment and perepare and eat breakfast. Overnight campers are rare in our little community, and perhaps the first at the downtown park.

Tom Peters, 29 and a friend. Mike Brownlee, 27, were about midway here in a cross-country bicycle trip that started February 10 in Santa Clara, California, Destination for the two bikers is Fort Myers, Florida.

A native of Olathe, Kansas, Peters has recently been employed as a computer programmer in Santa Clara. Despite having only one arm, Peters has always been very athletic and has found no problems handling a bicycle loaded with gear and equipment.

A Prairie Village, Kansas native, Brownlee is from Mill Valley, California where he has been employed as a mechanic. Upon his return he plans to enroll in school to get certification as an elementary teacher.

The pair have averaged about 80 miles a day, starting in Santa Clara and traveling the southern route along the California coast, across the coastal range to Bakersfield, through the Mojave Desert and across Arizona. They chose this season of the year for the trip to avoid the extreme cold of winter and the summer heat of the desert. However there has been enough cold to occassionally freeze water in their canteens along the route.

The longest one day leg of the journey was 145 miles; the trip from Eunice, N. M., to Santa Anna took two days. The pair expected to arrive in Waco Saturday for a days' rest and to meet Brownlee's sister, a student at Texas Christian University.

The two men have camped in state parks and city parks along the way, enjoying being a part of nature and experiencing the climates, smells, terrain and vastness of our country. The mountains presented a problem,

and the blowing sand at Andrews gave the two an unpleasant 'taste' of spring in West Texas! So far they have not ridden in rain. just missing storms by a day or two either way.

The men's ten-speed bikes provide transportation and carry 25 to 30 pounds of luggage and saddlebags. They prepare most of their food, but occassionally treat themselves to a meal in a restaurant. They have met many nice people along the way, and most have been friendly and helpful. They have been surprised at the interest of everyone in their trip. Their money was refunded at one California campground, a Texas couple gave them sandwiches, and they were given free admission to Carlsbad Caverns.

Many people are justly uneasy about two strangers arriving on bycicles, but no one has been belligerant or rude to the pair.

The immediate destination of the men is the Kansas City Royals baseball training camp at Fort Myers. An avid Royals fan. Peters wants to watch the activities at the camp. The return trip to California is not expected to be so adventurous. Brownlee will visit relatives in Kentucky and Kansas enroute to California.

They have kept diaries, and around every corner they have seen something worth mentioning. But right now, it is on to Fort Myers.

Gate receipts were good for both meets, and the concession stand did a booming business each


All expenses of the meet were paid by the club, and members donated their time and some food for the concession stand.
