Fire Dept. Needs... Police Recommend...

The regular meeting of the Santa Anna City Council was held on February, 7, 1985 at 6:30 p.m. in the Mountain City Civic Center with all council members present." '403'440

Minutes of the previous month were read; and approved. Mayor Hartman read a card of thanks from Glenn and Udell Copeland. A memorial had been sent by the city in honor of Mrs. Copeland's mother.

General election for the City of Santa Anna was set for April 6. Montie Guthrie III was appointed election judge.

Rob Chaney representing the Santa Anna National Bank came before the council to pledge for their depository. The \$100,000 treasury bond for the city came due on February 15, 1985. This bond will be renewed with the new bond maturing on March 31, 1988.

Lone Star Gas Representative, Joyce Wilkerson, came to the council meeting to see if a decision had been reached. Mayor Hartman stated that no decision had been made at this time. The mayor further stated that decision would probably be made in a special session. Mr. Wilkerson reminded the council of the April 3, 1985, deadline.

Councilperson Joe Guerrero spoke before the council on behalf of the Santa Anna Volunteer Fire Department. It was noted that there are approximately 17 bad fire plugs in the city that need to be repaired or replaced. Some won't work, some won't turn on and some if on can't be turned off. In addition, the department does not have enough hose to reach certain locations. It is hoped that some of the plugs on the old water line can be transferred. By transferring the plugs an estimated \$400 to \$600 can be saved off of the estimated \$1,100 replacement or repair cost of each plug. Priority locations are Avenue A between 4th and 5th Street and Avenue A at 8th

Mention was made that the Fire Department had \$200 to \$300 a month heating bills this winter. The excessive amount is due to the present

heating system which remains on a high setting to keep pipes from freezing. Because the department has no regular personnel manned at the station no one is there to adjust the heater. A request was made for some type of thermostat controlled heat. Insulating the metal building

was another possibility suggested. Chief Russ Ellis of the Santa Anna Police Department brought forth a variety of discussions before the council.

Five cases were filed through the Santa Anna Police Department in January. Chief Ellis attended a Legal Liabilities and Right of Law Enforcement Officers seminar in Huntsville on January 29, 1985. He noted that he would like to share information learned with the council at a workshop or executive session.

Chief Ellis requested that the council consider the feasibility of changing the length of the speed zone on Wallis and South 8th St. It appears to be inadequate for the volume of traffic through Santa Anna currently and with the expected increase of traffic due to the Stacy Dam project. It was noted that the city does not have the authority to change this zoning. The request is being referred to the Highway Department.

The possibility of a Reserve Police Force was brought up by Chief Ellis. The council, upon a motion made by Councilperson Horner, tabled the matter for now. Plans are to hold a workshop to learn more about.

A new schedule of acceptable fines was presented before the council by Chief Ellis. He noted that the state is asking a .50 cent increase on court fees and an additional \$12.50 on certain violations. The new schedule drawn up by the Santa Anna Police Department is in line with Coleman and Tom Green Counties.

The biggest change in the new schedule is the speeding fine. Speeds from 31 mph to 40 mph over the limit will be assessed at \$4 per mile over the limit rather than at a fixed rate as before. Fines for 40 mph or over are fixed at \$206.50.

The final question raised by Chief Ellis was the city limit on the east side of town on Hwy 84 - 67. The city is checking into this matter currently.

The council adjourned into executive session. Upon return, Councilperson Joe Guerrero announced that he would run for Council for

Mention was made of the city landfill passing inspection.

The accounts payable were approved to be paid in the usual manner.

City Secretary Pat Rutherford reminded all present of the blood drive being held on February 15, 1985, for Paula Michelle Sindt, Glenn and Udell Copeland's granddaughter. This young lady was involved in an accident during the last icy storm. She and a friend had stopped to help a stranded motorist when a third automobile struck them. She is presently at Parkland Memorial Hospital. She has undergone two surgeries and faces several more: There is a fund set up at the Santa Anna National Bank for the family as expenses are climbing. Replanking Due For Railroad Crossing

On January 29, 1985, the State Highway and Public Transportation Commission approved a program which provided funds for the replanking of 134 railroad crossings for Texas' State Highway System in

The replanking program is estimated to cost \$3.5 million per year to replace rough crossings. There are approximately 2,400 crossings on the state's roadways. Highway Department engineers estimate that a 16-year replacement cycle, whereby approximately 150 crossings are replanked each year. would be effective in providing smooth roadway crossings.

The 134 projects chosen for 1985 were designated from priority lists submitted by Texas' 24 highway districts.

Two of the approved crossings are in Coleman County. One is located on US 283, the Brady Highway, in Santa Anna and the other on FM 568 east of Coleman.

The replanking program is accomplished in cooperation with the railroads.

Another of Santa Anna's rail crossways, the one on Second Street. is in desperate need of repair. It should be noted though, that this crossing is not on a State Highway and therefore is not the responsibility of the State.

35th Judicial District

Sentences Set for Area Crimes

Steve Ellis, District Attorney for the 35th Judicial District of Texas, announced today the appointment of Gene Gerringer as District Attorney Investigator for Brown County. Gerringer assumed his duties on February 1, 1985, replacing former District Attorney Investigator Bill Donahoo, the newly elected Sheriff of Brown County.

Two Coleman County cases heard recently in the 35th Judicial District Court were:

Mark Lee Martin, 21, who was sentenced to eight years in the Texas Department of Corrections upon his plea of guilty to Aggravated Assault, a third degree felony. Martin was placed on probation and ordered to pay a fine and probation fee. Martin became belligerent with Chief of Police Russell Ellis in Santa Anna upon Ellis answering a disturbance call at Martin's mother's residence.

Marin threatened to kill Ellis and another young woman who was present. Martin later lunged at Ellis with a knife coming within approximately four feet of Ellis. Martin was represented by a courtappointed attorney. David Marney, 17, who was con-

victed of Robbery, a second degree felony. His punishment was fixed at four years confinement in the Texas Department of Corrections. Marney's time in the penitentiary was not probated. Marney robbed an Allsup's convenience store in Santa Anna in the summer of 1984, during which he threatened the store clerk with a knife. Marney was represented by a court-appointed attorney.

Coleman County is also served by the 42nd Judicial District in Abilene. Information of cases in this district are unknown at this time.



Nice restaurants, expensive cars and clothes, these were the trappings that went with Teutsch's lifestyle.

But state and federal law enforcement officials say there was another side to Teutsch's life, one not quite so glamorous. Investigators say the 34-year-old Corpus Christi native was involved in an international narcotics ring suspected of committing at least six murders.

Now Teutsch is running from the law and this week he has been placed on the list of Texas Most Wanted. A \$1,000 reward is being offered for information leading to the capture of Teutsch.

Investigators say Teutsch disappeared in June, 1982, after failing to appear to answer federal charges of Racketeering, Influence, Corrupt Organization (R.I.C.O.). The charges stem from a 1981 arrest in Corpus Christi on four counts of conspiracy to smuggle marijuana and cocaine into the United States.

Texas Department of Public Safety officials say Teutsch was a member of the late Samuel Cammarata organization, a far-flung syndicate that had international drug connections.

Teutsch is described as a white male, 6 ft. 2 in., 225 pounds, with black hair and brown eyes. But investigators say Teutsch is an accomplished make-up artist and may have altered his appearance. He also uses numerous aliases, including Tommy Titsch, Tommy Tyson and Thomas William Teutsch.

Prior to his disappearance, Teutsch left a note suggesting that he was going to commit suicide. But investigators scoff at the notion, pointing out that sightings have been reported of the fugitive since then.

Anyone who might have information about Teutsch's location is asked to call Texas Crime Stoppers tollfree at 1-800-252-8477 or their local Crime Stoppers program. In all cases callers do not have to reveal their identities.

Texas Most Wanted is a cooperative effort between Texas Crime Stoppers and the Department of Public Safety designed to solicit information about the locations of fugitives wanted for serious crimes committed within the state.

Reye Syndrome **Aspirin Present Danger to Kids**

In the midst of the flu season, important new information has become available about the development, in teens and children with flu, of Reve Syndrome, a rare but serious condition that kills 20 to 30 percent of its young victims and leaves many survivors brain-damaged.

The new information comes from a US Public Health Service pilot study of a possible link seen in four earlier state studies between the use of aspirin in treating flu or chicken pox and an increased risk of Reye syndrome.

The Institute of Medicine of the National Academy of Sciences has review the pilot study and found 'strong support' for the link.

Although personnel from the Food and Drug Administration, the National Institutes of Health and the Center for Disease Control will continue the study through next winter, the Institute of Medicine advised that the federal government not wait to inform and protect the public.

As a result, Health and Human Services Secretary Margaret M. Heckler has asked manufacturers to remove any recommended use in flu and chicken pox from aspirin containing products aimed at children. and to add a warning to all aspiring containing products against use for flu and chicken pox in children and teens.

The pilot study looked at the histories of drug treatments and other factors of 29 young people who got Reye syndrome last year. Use of





College Grant and Loan Information

Early planning for future educational financial needs will help avoid the last minute financial complications of post-secondary education.

Many scholarships and grants are available and certainly they should be explored and used to the fullest extent. Very few students, however, are able to meet any more than just a fraction of the total costs through these avenues.

The State of Texas, through the Texas Guaranteed Student Loan Corporation, provides assistance to those desiring to attend a postsecondary institution. The following are the basic criteria which govern this student loan program:

1. The student must attend at least half-time an institution approved by the United States Office of Education;

2. The student must apply to the Financial Aid Office of the institution in light of the financial resources available to that student. Each institution has different financial criteria and just because a student's parents earn more than \$30,000.00 annually, does not automatically eliminate them from qualifying for a low interest rate

Once approved for a Guaranteed Student Loan, the student then goes to his family bank, savings and loan, or credit union. If student loans are not available through this source, they can be obtained by contacting the office noted at the end of this article;

4. These loans can be obtained for up to \$2,500.00 (undergraduate students) or \$5,000.00 (graduate students) per year;

5. The initial cost to the student is a 5 percent origination fee and a 1 percent to 5 percent insurance fee. No further payments or charges are made until six months after the student leaves school. The loan then is repaid over a period of not to exceed ten years (minimum payments \$50.00 per month) at a simple interest rate presently set at 8 percent:

6. The student may attend any approved school regardless of location and if the school is not approved but meets necessary criteria, it can easily be approved if the school will make the necessary effort.

Animals exhibited by these competitors are a part of the 16,313 junior show entries expected for this year's show. Additionally, 8,960 open show entries and 3,011 horse show entries are expected for exhibition at the 1985

Rhett Guthrie, Sonny Guthrie, Alonzo Hernandez, Phillip Hernandez and Stephanie Williams, all of the Coleman County 4-H Club, will present Market Lambs in Houston. Deveda Bible, Douglas Taylor and Patricia Taylor, also of the Coleman County 4-H Club, will present Market Barrows in Houston.

'We take a tremendous amount of pride in knowing that the Houston Livestock Show attracts entries in

the junior show that are more than just animals,' noted Don Jobes, Jr., assistant general manager.

'They represent continuous, hard work by a Texas youngster who's committed himself or herself to a livestock project. These junior show exhibitors are a rare breed in themselves,' he added.

Premium monies available for open and junior show exhibitors top more than half a million dollars in prize money and in premium auction prices paid in excess of market value. Prior to the Show, volunteer committee members contact auction buyers to guarantee that each market animal sold in the four junior auctions brings a price above the current market value of the animal.

Once again, in the market lamb, barrow and steer shows, the threejudge system will be used. This system helps insure selection of an. animal based on production, feeding and carcass merit.

Junior market barrows will again be sifted at the Washington County Fairgrounds in Brenhan on February 23 and 24. Sifted barrows are then loaded directly for sale through normal livestock auction consignment. Non-sifted barrows proceed to Houston and the livestock show competition.

In addition to its position as the world's largest livestock show, the Houston Livestock Show and Rodeo is also the larges donor of agricultural scholarships in the nation. A total charity benefiting youth and education, the Show currently has 885 students on scholarships and annually commits \$1.9 million to its regular scholarship program.

Also, research project money and scholarship endowment funds are given by the Show to colleges and universities throughout Texas.
