Wagon Wheels Ready To Roll

They would gather into one place in their covered wagons, their buggies or whatever their transportation was. Come dusk, they would all gang around the old chuck wagon and feast from the old bean pot.

Then they would gather around the fire and sing the old hymns that everyone knew while a cowpoke here and there played along on his guitar, banjo, fiddle or maybe just a harmonica.

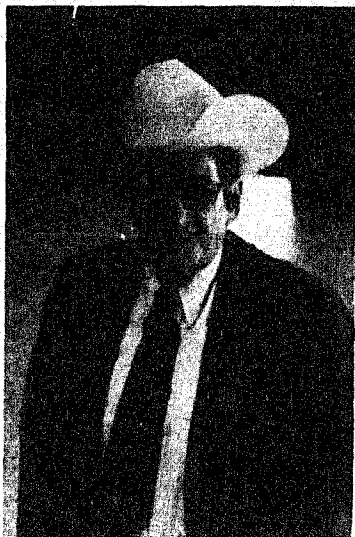
Then some would start testifying! Some young wrangler with an extra good understandin' of the Good Book might even get up and preach a sermon.

Before you knew it, some of the folks had gotten so happy they'd even started shouting!

Those were the good ole days. Wish we could have some times like that in this modern age?

Well, Little George Havens, the former Grand Ole Opry singer and movie actor turned evangelist, and his wife, Lucy, are invitin' folks from all over to their place, the Flying H Acres, between Coleman and Santa Anna, June 20 through June 29 for just such an old-fashioned Cowboy Camp Meeting.

Evangelist for the meeting is 36-year veteran pastor and former movie actor George Havens, a native of Coleman County. Havens

and his wife, Lucy will be assisted this year by the Rev. Buck Hatfield of Snyder, Dr. Marvin Sheffield of Brownwood, music director Dr. Joe Price, and musicians Tommy and Cleo Justus.

Yes, the old bean pot will be there. So will the chuck wagon, the freight wagon and the water wagon. All are original specimens from the Old West.

Folks, who for some reason or another don't own a covered wagon or a buggy, are welcome to come and camp in their house trailers, camp rigs on the bak of pickups, or whatever camping facility they have.

A big, beautifully colored tent will occupy the central place at the camp

meeting under which the Gospel will be proclaimed twice daily. Weekday services will be held Monday through Friday, beginning at 10 a.m. Evening services will begin at 8:00 p.m. nightly.

In the evening at 6:00 p.m. the campers will get together for a potluck supper, and then on the two Saturdays, June 21 and June 28, the entire area is invited to come to the chuck wagon supper, under the cook tent; here the old wood-burning cook stoves are still used in cooking and warming the vittles: the dour dough biscuits, the "creek bank coffee," etc. The camp will furnish the barbecue, biscuits, tea and coffee, etc. The local people may like to bring a salad, vegetable or dessert to add to the fare.

After the services, everyone is invited to gather around a bonfire to sing and pick the guitar and listen to group singing of the old hymns of the faith and cowboy ballads and songs of patriotism for our state and country.

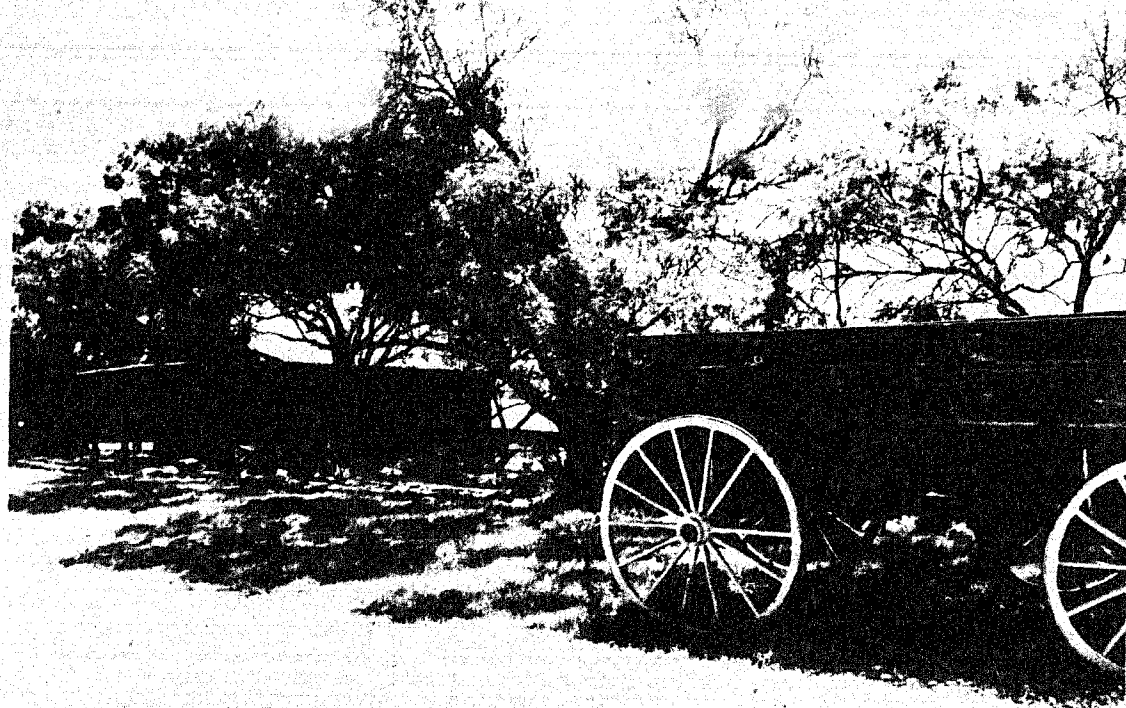

School Board Meets

The board of trustees of the Santa Anna ISD met in regular session on Tuesday night, June 10, to discuss administrative salaries and review T.E.A.M.S. results along with other routine business.

High school principal, Dale Freeman was given an extension of his contract. Freeman and Gerald Brister, superintendent, were each given a 6 percent salary raise.

In other action, the board approved revisions of the Discipline Management Policy and also approved a Library Policy and a Bilingual Policy. Development of these policies are mandated by the state and must meet specific guidelines to be approved by the state.

Nanette Newbern, a resident of Lake Brownwood, was recommended as a cooperative part time counselor. She would be working with the Santa Anna Schools as well as with the Lohn and Novice schools.

Mrs. Newbern was hired pending the action of the other two school boards. She has previously been with Austin, Leander, Round Rock and Brownwood schools.

A review of the Texas Educational Assessment Of Minimum Skills summary report showed that in grade 3, 42 of 43 students mastered the mathematics test, for a percentage of 98. The statewide percentage for mastering the test in grade three is 80 percent. Of the 43 third grade students taking the reading test, 38 mastered the test for 88 percent. The statewide percentage mastering is 74. In the writing test, 33 of the 43 taking the test mastered it, for 77 percent. The statewide percentage is 60.

The 5th grade results were as follows. Thirty-three (33) students tested in mathematics with 30 mastering for a percentage of 91. The statewide percentage is 80. Thirty-one (31) tested in reading

Child Injured By Explosive

Christopher Roberson, eight-year-old son of Rose Marie Roberson, was injured by an explosive at approximately 9:00 p.m. on Friday night, June 13.

The boy was playing near the residence of his aunt, Minnie Young, when the accident occurred. He was taken to Overall-Morris Memorial Hospital in Coleman by private auto.

He was treated there and transferred to an Abilene hospital.

The child was apparently playing with some kind of explosive device when it exploded, injuring his left hand and the abdominal region of his left side.

Deputy Sheriff Wade Turner was not sure what the explosive device was nor how the child obtained it. He did say that two more of the explosives were found and the incident is still under investigation.

City Council Has Busy Evening

The Santa Anna City Council met in regular session on Thursday, June 5, 1986 with all members present.

The minutes of last months meetings were read and approved.

Mr. Collier Watson, the city accountant, was introduced to discuss the 1984-85 audit. Mr. Watson gave a brief explanation on each aspect of the audit. It was stated that the Utility Fund had improved drastically, though the city was not where it should be, but was doing much better than the year before. The General Fund is not supposed to make money, but to be used mainly to run City Hall itself. The Revenue Sharing Fund is based on funds received by the State and must be spent during the year, if not eventually used, it would have to be returned. The Overall Audit was considerably better than the year before. Mr. Watson then answered all questions about the audit from the council and the public.

The Dog Ordinance was then introduced and the Council agreed that the ordinance had not been gone over by the city attorney and revised as it should have been. Mr. Henry Turner, City Police Officer, stated that the main purpose of the or-

dinance being suggested was for the protection of all humane animals that are being mistreated. There was a discussion about the type of ordinance that was needed. Councilman James Spillman made a motion that the Mayor appoint a committee of interested citizens and the police officer to take samples and come up with a new ordinance that will benefit all concerned. Councilman J. T. Avants seconded and the motion carried unanimously.

Discussion for Public Hearing II— for TDCA Application—was opened with Mayor Guerrero explaining the type of grant that the city was requesting. The amount of funds the city is requesting is \$300,000 for the purpose of a Wastewater Treatment Plant Improvement; convert existing plant from spray to flood facility; level ground area; construct emergency overflow ponds and wet weather irrigation; holding pond with pump station valves; piping; modify existing lagoons to facultative lagoons; construct berm around site; obtain discharge permit; engineering inspection and general administration. After a brief question and answer period, the public hearing was therefore closed.

A resolution for the TDCA application was then introduced with Councilman Spillman making a motion the resolution be adopted and Councilman Stanley Hartman seconding with the motion being unanimously carried.

Bids on the maintainer were then opened. The first one was from Mr. W. D. Garrett for \$1505.00; second from Clyde Heavy Equipment Sales for \$877.50 and the third from Marion E. (Boots) Morris for \$635.00. Councilman Hartman made a motion to accept the bid from Mr. W. D. Garrett. Councilman Susie Voss seconded and motion was unanimously carried. The bids on the Red 1975 GMC Trash Truck were then opened, with one being received from Mr. Marion E. Morris for \$75.00. Councilman Hartman made a motion to accept Mr. Morris' bid of \$75 on the Red GMC Trash Truck. Councilman Avants seconded with the motion being unanimously carried. The bids on the white 1979 GMC Trash Truck were opened with one from Mr. Marion E. Morris for \$55.00. Councilman Hartman motioned that the bid be accepted with Councilman Avants seconding and motion being unanimously carried. The Council

asked that the equipment be removed from the city yard within 10 days.

Mayor Guerrero next introduced a resolution for the acquisition of land for the landfill. Councilman Spillman moved the resolution be adopted with Councilman Joe Taylor seconding and the motion unanimously carrying.

A discussion of the Coding of the Ordinances was then opened. The city has a proposal from Sterling Codifiers, Inc. to go through the city's ordinances and clean out, organize and code the ordinances for \$3,000.00 for the first 275 pages and additional pages at \$12.50 per page. Councilman Hartman made a motion to accept this agreement from Sterling Codifiers, Inc. Councilman Spillman 2nd. Motion carried with one no vote from Councilman Avants.

A discussion about a lot of land owned by the City was opened. The lot of land is Block 59, Lot 1. Councilman Hartman made a motion the city put this lot up for sale to take sealed bids and for it to be published in the paper and have the right to accept or deny any and all bids. Councilman Voss 2nd. Motion carried with one obtained by Joe Taylor.

Commodities Tuesday

Commodities will be distributed Tuesday, June 24 from 12 noon till 4 p.m. at the amory. Foods to be available will include the usual processed cheese and butter. Flour and rice will also be available if it arrives in time for the distribution.

The distribution takes place the last Tuesday of each month and the food is furnished by the Department of Agriculture.

Tax Board Meeting

The monthly session of the Coleman County Tax Appraisal Board was held Monday, June 9, at the Tax Appraisal District office in Coleman. Barbara Kingsbery, chairman, led the session that was attended by members Billie Wright, Dwight Nanny and Jake McCreary. Lang Martin, Jr. was absent.

Routine business was on the agenda before the group went into a special hearing for the 1987 budget. A visitor at the hearing was Judi Wilkerson from the Coleman Independent School District.

Budget items were reviewed and some changes made from the original figures. Bill Jones, Chief Appraiser, was instructed to get an estimate for mineral, utility and industrial appraisals from another company in an effort to decrease expenses for the coming year. Other possible cuts in the budget were announced.

Final approval and adoption of the budget is due in September.

Mr. Jones reported that approximately 88 percent of 1986 tax collections have been made, and staff

Many of us let this broken record become our response to the problems where we work...or the never-ending challenges that confront the Church... "Why don't they do this for

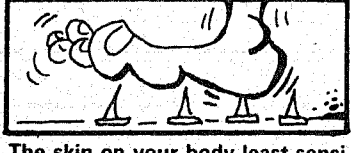

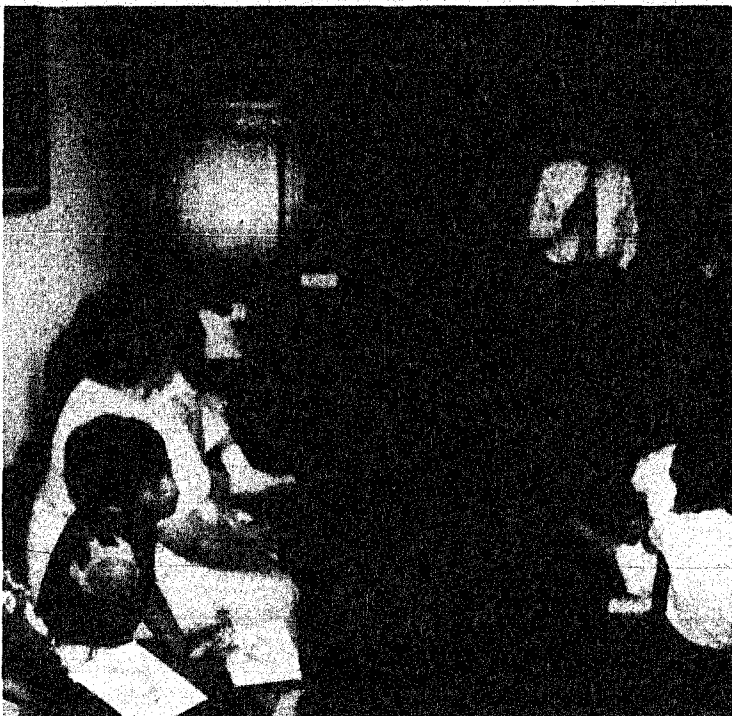

A QUILT FOR SOUTH CAROLINA
Tobacco Leaf

Here is another stunning applique which uses the conventionalized tobacco leaf, itself a sort of symbol of the rich, mellow Southland. This pattern was taken from a very old quilt in turkey red and shutter green coloring, but it seems fitting for a man's room in the browns that match walnut, oak or maple furniture, all appliqued onto deep

cream, ecru or peach tint background.

These blocks cut 18 square and the same design is appliqued onto every one making an exceptionally rich patterning over the whole. Sixteen blocks with a five-inch band of white top and bottom, then a pieced saw border about seven inches all around would finish the top 65x96. Borders of some sort are essential to big bold applique designs like the Tobacco

Leaf.

For the large quilt allow seven yards of white with one and three-fourths each of brown and tan, one-fourth yard of yellow and three yards additional of which ever color is used in the border.

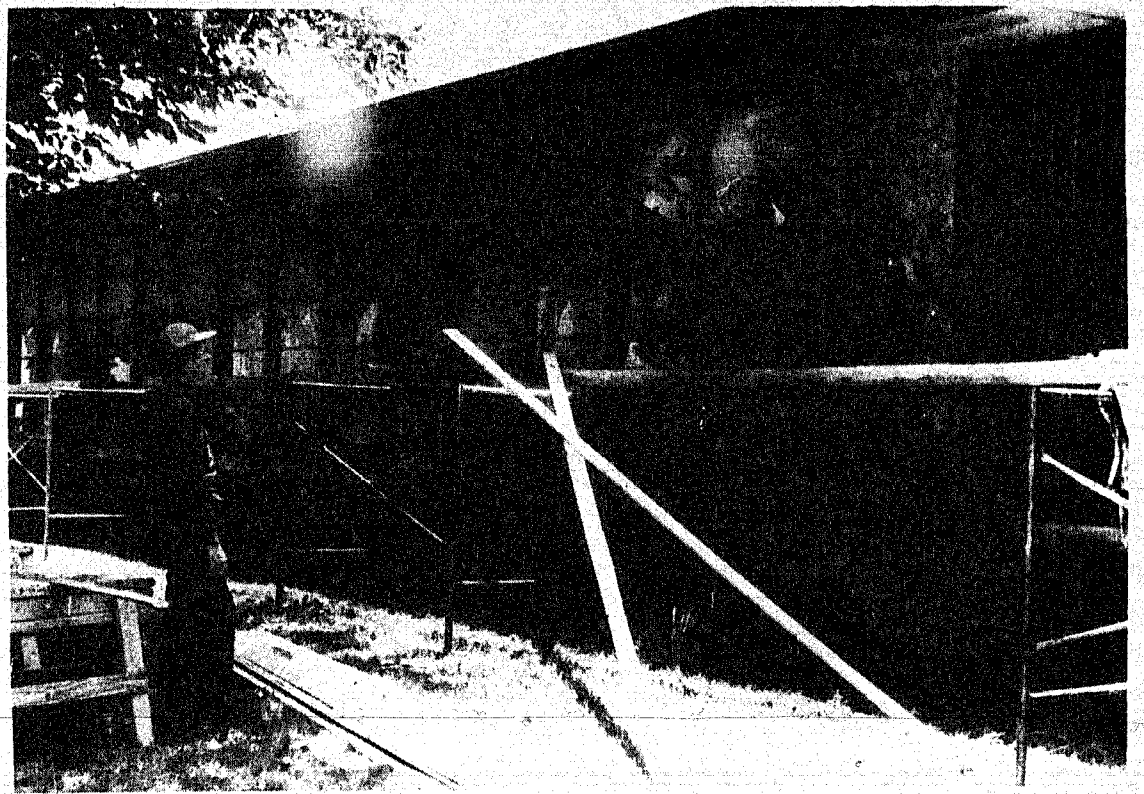

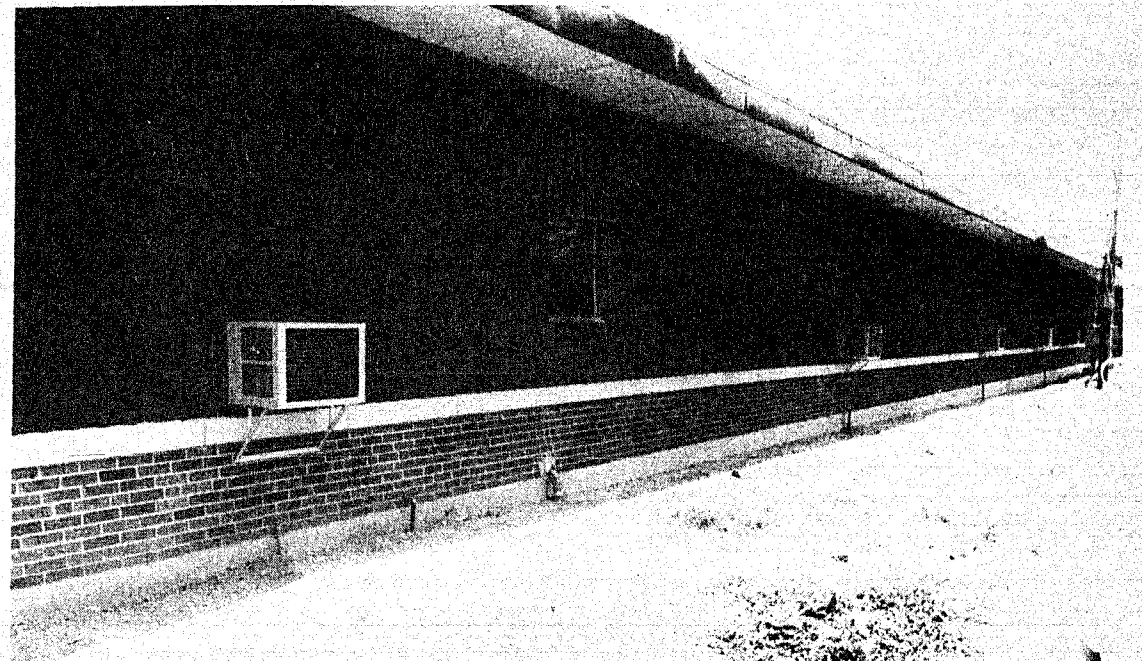

Summer Jobs And Social Security

If you are a young person about to take a summer job, there are some important things to know about Social Security.

First, you probably need a Social Security card because most jobs today are covered by the program. If you do not have a card, apply for one at any Social Security office at least 2 weeks before starting work. Bring with you proof of age, identity, and U.S. Citizenship (or immigrant status).

A little over 7 cents from each dollar earned (up to \$42,000 for 1986)

will be deducted from your pay for Social Security. Your employer matches this amount. These taxes help to finance monthly benefits for about 37 million Americans of all ages, as well as Medicare hospital insurance for most older people and some with long-term disabilities.

Someday benefits also may be paid to you and any dependents if you have worked long enough under Social Security. Monthly payments partially replace income that is lost or reduced because of disability, death or retirement.

When you work, the amount of your wages or self-employment income is recorded on a lifetime earnings record under your name and Social Security number. You earn credits that will be needed before benefits can be paid.

In 1985, you are credited with one-fourth year of work (called a "quarter of coverage") for each \$440 earned, up to a maximum of four credits for the year.

As a young worker, you build pro-

tection fast. In some cases, monthly benefits may be payable with as little as 1½ years of work if you become unable to work for a least a year due to disability, or if you should die and leave a spouse and surviving children.

About every 3 years you should request a statement of your earnings record to make sure all earnings have been properly reported. You can get a request form at any Social Security office to obtain that free statement. The people there also can answer any questions you may have about Social Security.

Almost all Social Security matters can be handled by phone. Medicare questions or filling of medicare claims can be taken care of by calling toll free 800-442-2620. You may file an application to establish your eligibility by calling 915-646-7533 in Brownwood.

A representative of the Brownwood office visits Santa Anna once a month on the first Wednesday from 10:00 a.m. to 12:00 noon.

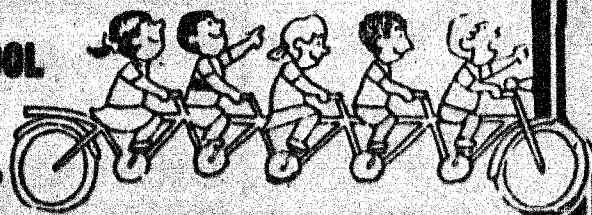

Plan devised to save surplus food program

AUSTIN—A way to salvage a federal emergency food distribution program in Texas was announced by Marlin Johnston, commissioner of the state Department of Human Services.

More than 1.5 million hungry Texans—elderly and unemployed people and the working poor—depend on the free surplus food distributed as a supplement to food stamps.

The program was to shut down in Texas on June 16 because allocated federal funds are running out. The state's share of the \$50 million national program is about \$960,000 short of what it will take to continue operations until Oct. 1, when the next federal fiscal year begins and new funds become available.

Johnston said the Department of Human Services can come up with two-thirds of the money to keep the program running, if the remaining one-third (\$320,000) can be raised locally.

The state agency operates the Temporary Emergency Food Assistance Program on a federal grant of \$3.3 million and an allocation of donated commodities from the U.S. Department of Agriculture. The cost of distributing the food, plus storage of perishables like cheese and butter, have consumed Texas' allocation of federal funds, Johnston said.

"Costs are going up and participation has quadrupled since 1983," he said, adding that 26 other states face the same problem.

The Department of Human Services contracts with 86 non-profit groups to distribute the food to a half-million Texas households in 253 counties. In addition to cheese and butter, limited quantities of dry milk, flour, rice, cornmeal and honey sometimes are available. Distributors are reimbursed for actual costs up to 5 percent of the value of the donated foods.

Johnston said the contractors will be notified immediately of the availability of supplemental state funds and urged to seek matching funds from local sources to continue the program's operation.

The program has been funded by the federal government at approximately the same level for the last three years and has been inadequate to meet rising costs associated with high program growth.

On May 15, Johnston wrote to members of the Texas congressional delegation to advise them of the situation in Texas. At its meeting on May 27, the three-member Board of Human Services said it will pursue federal supplemental funding with a second letter to the Texas delegation.

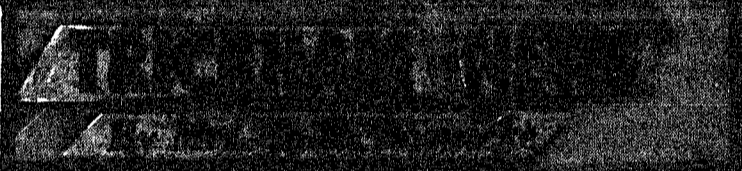
