Boil Water

Notification In Gorma

Due to a major water break the Texas Commission on Environmental Quality (TCEQ) has required our public water system, City of Gorman PWS ID 0670003, to notify all customers to boil their water prior to consumption.

To ensure destruction of all harmful bacteria and other microbes, water for drinking, cooking, and for making ice should be boiled and cooled prior to consumption. The water should be brought to a vigorous, rolling boil and then boiled for two minutes. In lieu of boiling, you may purchase bottled water or obtain water from some other suitable source.

When it is no longer necessary to boil the water, the water system officials will notify you that the water is safe for consumption. The rescind notice will be issued in the same manner as this Boil Water Notice.

Probation Revocation Nets Man 30 Year Prison Sentence

Presiding Judge Steven Herod of the 91st Judicial District Court revoked the probation of JOSUE ANTONIO WILLIAMS, 31, on January 20, 2010 after accepting a plea of true to allegations that Williams had violated his terms and conditions of probation. Williams, a Taylor County resident, had previously been placed on ten years probation on August 28, 2008 for Possession with Intent to Deliver a Controlled Substance: Cocaine. The arrest was a result of a DPS Narcotics Investigation from a traffic stop on Interstate 20. Judge Herod sentenced Williams to thirty (30) years in the Texas Department of Criminal Justice – Institutional Division for violating the terms and conditions of his probation. Williams is now awaiting the disposition of other drug charges in Taylor County.

Cisco Man's Probation Revoked

Presiding Judge Steven Herod of the 91st Judicial District Court revoked the probation of JEREMY HOWARD LANGFORD, 22, on the afternoon of January 20, 2010 hearing testimony from three witnesses that Langford had violated his terms and conditions of probation. Langford, a Taylor County resident, had previously been placed on four years deferred adjudication on June 10, 2009 for Impersonating a Public Servant. The original arrest was a result of a Cisco Police Department Investigation wherein Langford had identified himself as a United States Marshall. Judge Herod sentenced Langford to five (5) years in the Texas Department of Criminal Justice – Institutional Division for violating the terms and conditions of his probation. Impersonating a Public Servant is a third degree felony and carries a maximum punishment range of 10 years confinement. Langford is now awaiting the disposition of another pending charge for Assault Causing Serious Bodily Injury here in Eastland County.

Honey Bee's

This week I found a large group of honey bees foraging in the county. With the warm temperatures we have seen this week, honey bees can be on the move. With the bees moving around, it is important to remember how we manage honey bees in the home and how to be safe if you encounter a swarm.

Honey bees are not truly aggressive - - that is, bees do not search for someone or something to attack. But, like social wasps, honey bees are highly defensive and will attack anything that seems to threaten the colony. You can lessen your risk of a bad experience with bees by learning more about their behavior. It is common to see honey bees foraging for food and water around homes and other structures. Foraging bees are away from the colony and are not likely to sting because they have nothing to defend. Bees visiting flowers and other food sources should be left undisturbed. To discourage foraging bees from gathering around a home or business, remove or prevent access to attractants such as ripeing fruit, opened soda cans and pet water dishes. Make sure outdoor garbage receptacles are covered and well-sealed. Some flowers, trees and shrubs attract bees when in bloom. It is impractical to try to remove all the plants that might attract bees, so people with a fear of bees or allergies to bee venom should simply avoid those areas when bees are foraging.

Many people have never encountered bee swarms even though they occur every year. With literally thousands of bees in the air, swarms may appear dangerous. In fact, they pose little threat. Eventually the swarm will land and remain clustered in one place for a few hours or several days. During that time, scout bees are looking for a suitable nesting site. Once the scouts find a new nest site and communicate its location to the swarm, the bees will move on to their new home. If a swarm lands in a remote site, it should be left alone. The swarm does not contain stored food or immature bees so the bees have nothing to define and are unlikely to sting. Swarms that land near buildings or high traffic areas should be managed. Bees may try to nest in wall voids or floors of buildings if they can gain entry. Professional and hobby beekeepers are often unwilling to collect swarms because of the possibility of introducing diseases, mites or Africanized bees into their own colonies. If no one can be found to remove a swarm near a building or in a high traffic area, the swarm may need to be destroyed.

The most important step is to prevent honey bees from entering a building. Block all holes where pipes and wiring enter, cracks in window framing, knot holes in wood siding, weep holes in bricks, and cracks where wood and brick join. Most of these holes can be filled with caulking, but holes necessary for air flow should be blocked with wire screen. The screen mesh should be less than 1/8 inch. Chimneys should be properly capped. Removing a honey bee nest can easily cost hundreds of dollars, so prevention is the best solution. Honey bees that have moved into a structure should be destroyed as quickly as possible. The longer you delay, the more difficult the job is.
