City of Eastland Imposes Mandatory Water Restrictions For Carbon and Surrounding Areas The Goal Of A 25% Reduction In Consumption By July 25

Due to the severity of the historic drought that has Eastland County in its grip, the City of Eastland has announced mandatory water restrictions that will go into effect at 10:00 AM Saturday, July 9. The odd/even day watering schedule that has been voluntary will be made mandatory. Starting Saturday, watering lawns and other outside vegetation can only occur between 8:00 PM and 10:00 AM and driveways, sidewalks and parking areas may not be washed down with city supplied water. Those wanting to water within the cemetery may continue to do so, but only with handheld sprinklers.

The city's goal is a 25% reduction in consumption by July 25. City staff will continuously monitor consumption. If the goal is not reached, more stringent restrictions may be implemented.

"We are not pleased that water use restrictions must be implemented, but for the good of everyone, we have no choice", said Ron Holliday, Eastland City Manager. "Lake Leon's water level is steadily declining and the drop will accelerate if the present weather pattern continues. We are within four feet of the lowest lake level in history and there is no significant rainfall predicted. There is a finite amount of water in the lake that is actually the life blood of much of Eastland County. If we don't reasonably conserve now, it could spell disastrous consequences further along", he added.

Voluntary water use restrictions have been in effect for the users of city water and the upcoming mandatory restrictions are not that onerous. The voluntary period combined with this forewarning prior to the restrictions becoming mandatory next Saturday should give everyone a reasonable opportunity to get used to a different watering routine, reset sprinkler system controls and the like.

"Compared to last year, the amount of water we have received from the Eastland County Water Supply District since February is up over 30%", offered Leslie Zander, Eastland's Financial Officer. In addition to supplying water to city residents, via decades old contracts, the City of Eastland supplies water to the City of Carbon, Westbound Water Supply District, Olden Water Supply District and Staff Water Supply District. Westbound and Staff have water suppliers other than the City of Eastland and the City also supplies water to EBAA Iron.

"Considering the Sahara like weather conditions we've endured, it's a little surprising our overall usage is not higher. Never-the-less, we have to face reality and cut back consumption. If everyone will cooperate, we can hopefully get through this difficult period without catastrophic effects", she added.

The combined usage of the three water supply districts and Carbon is up over 46% from last year, so they will be asked to comply with the City of Eastland's conservation measures to cut back consumption. EBAA Iron's use is actually lower this year while the City of Eastland's use is up almost 11% from a year ago. Not surprisingly, the biggest city user is the ballpark.

There are numerous small things that can be done to conserve water. Check sprinkler heads to be sure they are watering your lawn and not your street, sidewalk or driveway. Check for leaky faucets and toilets. Take shorter showers and turn off the water when you are shampooing your hair or shaving in the shower. Don't let water needlessly run as you brush your teeth. Turn off the faucet unless you need the water to run. Wash your car a bit less often and then only at a commercial car wash.

While these small measures will make a difference if everyone will collectively implement them, it is, of course, outside irrigation that consumes the most water. Please do your best to cut back on the time and amount of your outside watering. There is no valid reason citizens have to wait to follow the mandatory restrictions until next Saturday.

If everyone immediately implements them, we will save that much more water.

More water conservation tips can be found at: www.epa.gov/watersense. "The absolute last thing in the world we want to do is to fine people who don't follow the mandatory water use restrictions. However, I feel compelled to remind everyone that they can be ticketed if they ignore the restrictions and fines will increase substantially for repeat offenders", Holliday concluded.

SURE Disaster Program Deadline Approaches for 2009 Crops

Agriculture Secretary Tom Vilsack today reminded producers that they have until Friday, July 29, 2011, to apply for assistance for 2009 crop losses under the Supplemental Revenue Assistance Payments (SURE) Program. The program provides crop disaster assistance payments to eligible producers on farms that have incurred crop production or quality losses.

"USDA wants to ensure that all eligible producers are aware of the approaching deadline," said Vilsack. "SURE covers producers on farms in disaster counties that incurred crop production, crop-quality losses or both, but in order to qualify, you need to file in a timely manner. I encourage anyone with questions to visit their local USDA Farm Service Agency Office."

The SURE program takes into consideration losses on all crops grown by a producer nationwide. To be eligible, producers must have suffered at least a 10 percent production loss on a crop of economic significance and obtained a policy or plan of insurance under the Federal Crop Insurance Act or the Noninsured Crop Disaster Assistance Program (NAP), for all economically significant crops. A producer must have a farming interest physically located in a county that was declared a primary disaster county or contiguous county by the Secretary of Agriculture under a Secretarial Disaster Designation or have actual production on the farm that was less than 50 percent of the normal production on the farm due to a natural disaster.

A limit of \$100,000 per person and legal entity collectively received, directly and indirectly, applies to the combination of payments from SURE and the livestock disaster programs administered by FSA - Livestock Forage Program (LFP), Livestock Indemnity Program (LIP) and Emergency Assistance for Livestock, Honeybees, and Farm-raised Fish (ELAP). Persons or legal entities whose average nonfarm income exceeds \$500,000 are not eligible for SURE payments.

A producer interested in signing up for SURE for their 2009 crops must do so before close of business July 29, 2011, at the county FSA office servicing the producer. The sign-up for the SURE program for the 2010 crops will be announced at a later date.





Bovine Mastitis and Heat Stress

Environmental mastitis and these above average temperatures can cause a dollar drain in your herd, but the effect of both can be reduced. The level of mastitis and somatic cell counts rise as temperature and humidity levels move upward. Somatic cells are elevated in response to environmental stress such as high summer temperatures; and it may take weeks or months for them to decrease. Environmental mastitis increases during this time because of the increased liklihood of teat end exposure to bacteria.

Cattle are physically more stressed during the summer. Research has shown high circulating levels of stress hormones interfere with the ability of the immune system to destroy bacterial invaders. Somatic cells enter the udder as part of the immune response. When somatic cells are under the depressing effect of stress hormones, they cannot function fully to protect against mastitis organisms.

To help prevent this problem in a pasture situation provide portable shades and move them frequently to reduce manure build up. Although, trees provide a good source of shade and reduce stress, muddy, wet areas around trees result from manure accumulation. This is a source of environmental organisms that increase clinical mastitis. In free stalls, bacterial contamination of bedding material increase during the summer. Take extra steps to keep bedded areas dry and maintain free stalls to minimize cows lying in the alleys.

Use of sprinklers to cool cows requires constant management to eliminate or greatly reduce the likelihood of "wallow" places. Locating shade only over feed aisles results in cows constantly occupying the area for feed as well as shade. The area becomes overloaded with manure, cows become dirty and mastitis increases as a result. If you are using cooling ponds, make certain the water does not become contaminated with mastitis-causing organisms. Flies are also important vectors of the disease. Biting flies greatly increase stress in your herd and carry disease organisms. This may result in a decrease in production as well as spreading mastitis. Provide clean water. Cows drink tive Director Juan M. Garcia today announced four webinars (internet-based virtual meeting) to discuss about 50 percent more water when the temperature is 80 degrees versus 40 degrees. They need water to cool themselves through increased respiration and perspiration.

All these steps add up to ways to reduce mastitis, either by reducing the stress-promoting hormones or by decreasing the likelihood of creating sites for growth of environmental mastitis organisms. Watching, implementing and correcting management practices to reduce summer mastitis increases milk production and your herd's health thereby providing another plug to stop the Dollar

You increase the possibility of complications, such as heart attack or stroke, if you cut back on your medicines. Allowing your blood glucose, and blood pressure to climb out of recommended ranges can have severe consequences for you. Before you cut back on your medicines, let your doctor know you are having a hard time with costs. Do this before your doctor writes a prescription for you. Many times your doctor can help by prescribing a generic form of your medicine. They might also help you apply for pharmacy assistance, if you ask for help. Check different drug stores for prices before having your prescription filled, too.

Some large department stores and drug stores are offering many prescription medicines for \$4.00 per prescription. While these \$4.00 prescriptions are not the latest, newest drug, they are effective drugs that have been around a long time. Having the latest drug may not mean better results especially if the cost is so high that you do not take it like your doctor prescribed. Also, talk to your doctor about other things you might do to reduce your need for so many medicines. If your health allows, losing weight and walking 30 minutes daily can have a significant impact on your need for

Statement by Gov. Rick Perry on **Disaster Request Approval**

AUSTIN - Gov. Rick Perry today issued the following statement regarding President Barack Obama's approval of a portion of Texas' request for a disaster declaration resulting from 11,940 wildfires that have consumed more than 3.2 million acres since December 2010:

"President Obama's decision to finally approve a portion of our disaster designation request is good for Texas and some of the communities impacted by this season's wildfires. We will continue to work with FEMA to ensure all affected jurisdictions and entities receive the support they deserve after battling these massive fires since December. Our prayers continue to go out to those putting their lives on the line fighting these fires, as well as those whose property and livelihoods remain in danger."

This partial approval only applies to fires fought between April 6 and May 3, 2011, covering just a fraction of the fires fought in Texas so far this season.

On April 15, Gov. Perry sent a letter to President Obama requesting a Major Disaster Declaration for the State of Texas, which would make the state eligible for Direct Federal Assistance and Emergency Protective Measures from the federal government. The governor's request was denied on May 3. Gov. Perry appealed the president's decision on May 26.

Counties qualifying for emergency protective measures, including direct federal assistance, include: Andrews, Archer, Armstrong, Bailey, Baylor, Brewster, Callahan, Carson, Castro, Clay, Coleman, Concho, Cottle, Crockett, Dawson, Duval, Eastland, Garza, Glasscock, Hall, Hemphill, Hockley, Irion, Kent, King, Lynn, Martin, Mason, Mitchell, Moore, Motley, Pecos, Presidio, Scurry, Stephen Sterling, Sutton, Terrell, Terry, Throckmorton, Tom Green, Trinity, Tyler, Val Verde, and Young.

Gov. Perry reminds all Texans of the ongoing threat of wildfires, and urges everyone to observe burn bans and fireworks bans in place over Independence Day weekend.

USDA-FSA to Host Four Webinars on Hispanic and Women Farmer and Rancher Claims Process

(COLLEGE STATION, TX) - June 23, 2011 - USDA Farm Service Agency (FSA) State Executhe USDA Hispanic and Women Farmer and Rancher Settlement Claims Process and current FSA loan programs. These webinars are scheduled for June 30th, July 14th, July 28th and August 11th at 7:00 PM.

On February 25, 2011, Secretary of Agriculture Tom Vilsack and Department of Justice Assistant Attorney General Tony West announced a process created to resolve the claims of Hispanic and women farmers and ranchers who assert they faced discrimination when seeking USDA farm loans during certain periods between years 1981 and 2000. The optional claims process offers a streamlined alternative to litigation and provides at least \$1.33 billion in compensation, plus up to \$160 million in farm debt relief, to eligible Hispanic and women farmers and ranchers.

The interactive webinars will provide an overview of the USDA Hispanic and Women Farmer and Rancher Claims Process as well as FSA farm loan program updates. Farm loan program topics to be discussed include interest rates, terms, and eligibility and security requirements.

"I encourage producers who want more information about the claims process or about FSA farm loan programs to register for one of these webinars," said Garcia. "The webinars are free and open to the first 100 participants who register," he said.

Garcia emphasizes that these webinars are intended as forums to discuss the general plan for the claims process and FSA webinar hosts will not be able to discuss the details of any individual claim during the course of the webinars.

Contaminents that may be present in source

- Microbial conteminants, much as virusee and hectaris, which may come from newage treatment plants, septic systems, agricultural livestock operations, and Inorganic contaminants, much as salts and metals, which can be naturally-occurring or result from urban storm water rumoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

- Festicides and berbicides, which may occe from a variety of sources such as agriculture, urban storm water rumoff, and

- Organic chemical contaminants, including synthetic and velatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water rumoff, and septic systems.

- Radioactive contaminants, which can be naturally cocurring or be the result of cil and gas production and mining activities.

Many constituents (such as calcium, sodium, or iron) which are often found in drinking water, can cause taste, color, and odor problems. The taste and odor constituents are called secondary constituents and are regulated by the State of Texas, not the EPA. These constituents are not caused for health concern. Therefore, secondaries are not required to be reported in this document but they may greatly affect the appearance and taste of your water.
