the report of the Study Com-mittee. Prior to adjourning that meeting, the commission passed an ordinance calling an election on this question for Tuesday, February 11. Numerous cities in the area and throughout the state have already enacted the city sales tax. This tax, if enacted locally, would be collected by the State Commitneller along with locally, would be collected by the State Comptroller along with the state sales tax and the city's 1 percent would be rebated quart-erly. It is estimated that the city would realize from \$6,000 to \$10,000 annually from this source. City officials agreed in the Sat-urday meeting that top priority on these funds should go to the hospital project if needed, prior to a general city facelifting and improvement program.

# **Eligible To Vote? You Must Register Regardless Of Age**

Voter registration is now un-derway for 1969 elections. Re-member you are never too old

derway for 1969 elections. Re-member you are never too old to register. County Tax Collector Edgar Al-tom said, "You must register to be eligible to vote. The age limit is '21 and up.' Last year we reg-istered some people past age 90. Please do not fail to register be-cause you believe your age ex-empts you from registering." Mr. Altom stated that registra-

Mr. Altom stated that registra-tion is moving slowly and dead-ine is January 31st.

Substations have been set up furoughout the county for the con venience of those who are unable to come to Eastland to register or do not have filing applications available.

In Gorman you may register at Todd's Variety Store. In Ran-ger and Cisco at the Chamber of Commerce, and in Rising Star at Jenkins Insurance Agency.

Anyone registering may also register a husband or wife, parent or son or daughter. Sneekenridge with relatives and riends.
