

COMPANY FILES FOR FULL GAS COST RECOVERY

LONE STAR GAS

Dallas, Texas (June 25, 1982) - Stating that the economic vitality of the utility's service area depends on an assured gas supply, Lone Star Gas Co. Senior Vice President Douglas W. Williams announced the utility applied to the Texas Railroad Commission today for an increase in its city gate rate. The company's application requests \$90 million in increased revenues for its Transmission Division, including 100 percent recovery of the increased cost of gas purchases. Using a monthly average consumption of six thoursand cubic feet (Mcf) per month, a Texas residential customer's bill would

The city gate rate is the amount that the compan's Transmission Division is permitted to charge the Distribution divisions for gas delivered for sale to residential and commercial customers and for Distribution company -used and unaccounted for gas. The Transmission Division buys gas from producers and transports it to 536 cities and towns served in Texas by Lone Star Gas Co. The point at which city distribution systems purchase the gas from the Transmission Division for customer consumption is the city gate.

Since Febuary 1980, the Texas Railroad Commission has allowed the company to recover only 95 percent of its increased cost of gas. This partial recovery has resulted in Lone Star being unable to recover \$13.5 million in gas costs through April 1982 and unable to earn the return granted by the commission in 1980. For the same period, the average cost of puchased gas increased from \$1.85 per Mcf to \$3.38 in April of this year, an 83 percent increase. "To compete successfully for new gas supplies, we must recover the increased costs of buying and porviding to our customers this premium fuel," said Williams. "Only with full cost recovery can we pay these increasing prices and hope to meet successfully the intense competitive pressures that now exist to secure additional supplies which our customers rightfully expect. 

1982 TABS RESULTS RELEASED FOR GORMAN ISD

Results of the 1982 Texas Assessment of Basic Skills (TABS) were presented to the school board during its meeting on June 22, 1982, by school counselor Linda Glover.

TABS is a program for basic skills improvement. Part of this program is a test that is given each year tostudents in the third, fifth, and ninth grades. This test measures student achievement in reading, writing, and mathematics. The results of the TABS can be used in planning instruction in these three areas.

The TABS is scored differently than achievement tests. On this type of test it is reported whether or not a student has mastered a specific objective. A student's performance is not compared to other students or to a selected "norm" group.

The State Board of Education has given emphasis to the improvement of student achievement in mathematics, reading and written composition (the basic skills). The State Board has set a goal for the TABS: that 85 percent of students completing high school will demonstrate minimum exit level mastery of mathematics and reading objectives by 1983 and of writing objectives by 1985. Gorman Exit Level-- Eigh-

teen ninth graders were tested on each part of the test. Ninety-four per cent mastered the Mathematics area as a whole. This is well above the statewide goal for 1983. Between 78% and 100% of the students mastered nine

part of the test. On ten of the twelve objectives 70% or more of the students showed mastery. Twenty-four students were tested on the Reading part of the test. Eight objectives were mastered by 58% to 70% of the students. The remaining three objectives were mastered by more than 70% of the students.

Between 70% and 92% of the twenty four students mastered five of the six objectives in writing. Sixtytwo per cnet of the class scored two or better on the written composition.

Gorman third grade--

Twenty-nine students were tested on each part of the test. Seventy percent or more of the class showed mastery in nine out of ten objectives in mathematics. Seventy-five per cent or more of the class showed mastery on all of the reading objectives. Seventy-five per cent or more of the class showed mastery on three of the writing objectives. The other two objectives were mastered by 62%-66% of the class. Seventy-two per cent received scores of two or higher on

the written composition. More detailed group results may be obtained by







Examine the many aspects of today's new microwave-convection oven combinations on the market before making a buying decision.

Microwave-convection ovens are getting a lot of attention right now, as, ideally, they combine the speed and efficiency of microwave cooking with browning and crisping qualities of the convection oven. **HOW OVEN WORKS:**

Microwave-convection ovens allow you to cook with microwave OR convection (circulating hot air) OR a

(Monosodium methanearsonate) or DSMA (disodium methanearsonate). Several applications may be necessary and the bermuda may turn yellow, but it should recover. Some will heat up to 450 degrees F., while others will heat no higher than 300 degrees F.

Convection cooking allows food to be cooked at lower temperatures than you would normally need for conventional cooking.

CHECK FOR ROOMINESS: Combination ovens look very much like microwave ovens, except they're larger and they must be vented for release of hot air. This requires substantial counter space.

USDA ADJUSTS INCOME GUIDELINES FOR SCHOOL MEAL BENEFITS

The maximum income a family can earn and still have their children qualify for free or reduced price school meals will go up 10 percent on July 1.

Assistant Secretary of Agriculture Mary Jarratt said the change is a result of the annual cost-of-living adjustment made by the U.S. Department of Agriculture to help people keep up with inflation.

Under the adjustment, the income limit for free meal eligibility, which is set by Congress at 130 percent of
