Donnie Rodgers Makes Statement

As most of you know, I have filed

for re-election for place 2 on the City Commission. I have lived in Gorman since Jim and I married in 1962, with the exception of five years when we lived at Carlton. I graduated from here and raised four kids here. I went to Ranger Jr. College and have worked at the Post Office for nearly twenty years, so most of you know me.

In the two years as Commissioner, I have learned a lot about the working of the City Commission. The first year was a year of learning exactly what the job encompassed. I went to two Texas Municipal League Schools, one in San Antonio and one at Plano, where I increased my knowledge of the job. During the last year, we paved 8 blocks and resurfaced twenty-one blocks. I know there are more streets that need work, but I exceeded my budget as it is. The City crew painted the Pavilion at Frank Gray Park. They painted as high as they could reach and will finish when we can get a lift for the higher places and the time. The park as been cleaned and we are working on fixing a gate so that the park can be closed after dark unless someone has it scheduled for an outing. At the present time, we have scheduled some major repairs on the swimming pool. It is supposed to be finished before the end of school. I want everyone to know that I support the EDC. I resigned from the board because I felt that Mr. Vaughn had more time to spend on it than I do because he is retired and I work a fulltime job. During my term, I have had an open door policy--If anyone had a problem or a complaint, they could come to me, and many people did. I tried to resolve anything I could. I ask that you re-elect me and let me continue as your Commissioner.

Underwood Wins Democratic Runoff Nomination Precinct 3

In the Precinct 3 Commissioner's race, Bill Underwood won the Democratic Runoff nomination. Wesley N. Warren carried Gorman by receiving 123 votes to Underwood's 93 votes. Underwood received 27 votes to Warren's 15 votes in Carbon. In Rising Star, Underwood received 131 votes to Warren's 26. Early returns showed Warren receiving 16 votes to Underwood's 8 votes. The Democratic nomination was decided with Bill Underwood earning 259 votes to 180 for Wesley Warren.

Underwood will face Republican James New in the November election to determine who will replace retiring Commissioner L.T. Owen.

City Plans for the Rural Resource Team

The City of Gorman is hosting a Rural Resource Team visit during the week of April 25-27. The community sponsors of this event are the Gorman Economic Development Corporation, the Gorman Chamber of Commerce and the City of Gorman.

The Resource Team is being invited into our community to perform several tasks. 1) They will be developing an objective community assessment based on community input, 2) They will be holding Listening Sessions for the community-at-large, 3) They will conduct a Resource Team Town Meeting, 4) They will compile a Resource Team swers. Report for the community, complete with Resource Team Members & #8217; personal recommendations, and 5) They will provide Post-visit support and follow-up. The Resource Team is made up of a panel of knowledgeable individuals from outside the community who are actively involved in some area of rural community development. These members are Ronnie Boston from North Texas Resource Conservation & Development, Dr. Joe McFarland, the resident Director of Research with Texas A&M (Stephenville), Faith Ballard, supervisor of consumer and Family affairs with Extension Agency, Tom Mann from the West Central Texas Council of Government, Patricia Butler with USDA Rural Development, and Ed Ellis from HUD Community Builders Program. These Resource Team members volunteer their time and services as a member of this group in order to make the visit possible for small rural cities to afford such an elaborate evaluation. The cost of such a visit would be in excess of \$15,000-\$20,000 if the City of Gorman were to hire a consultant firm for this type of in-depth evaluation. In consideration for this, the City is responsible for arranging food and lodging for the members and extending a great effort to get the community to attend the Listening Sessions. Registration for Credit by Exam
