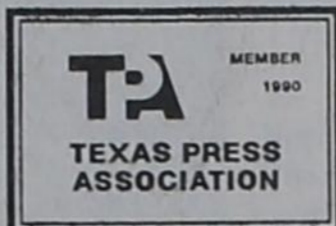

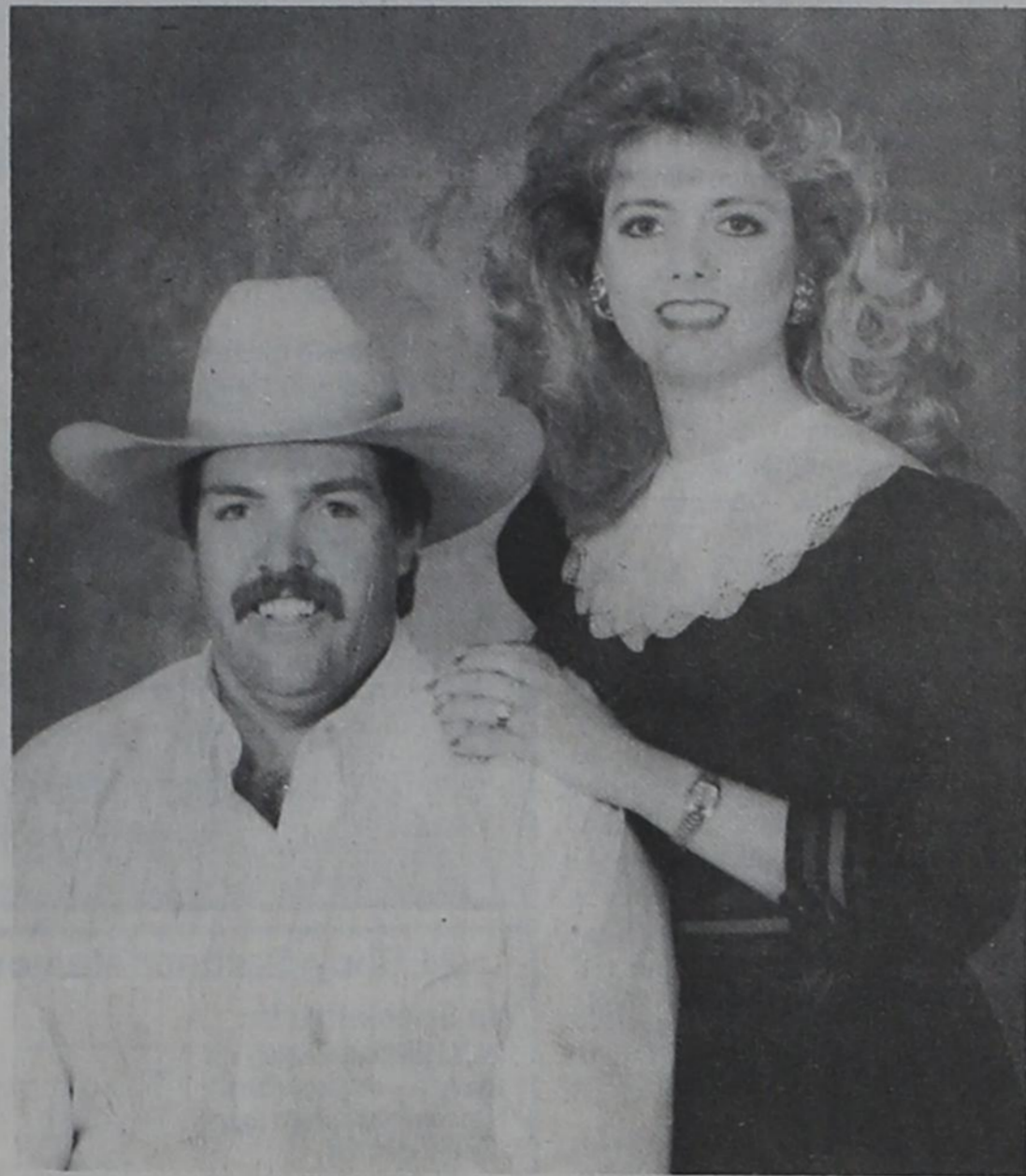

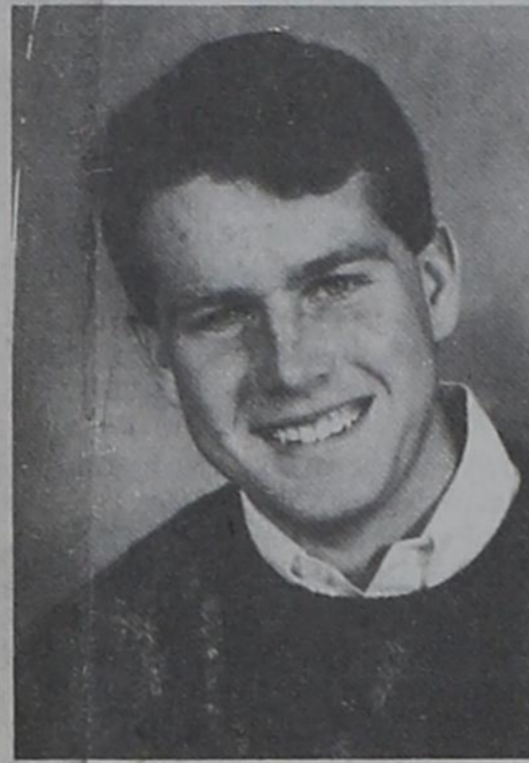
The Ladies of the Kokomo EH Club met and voted that their club would no longer do the birthday parties, but would help as volunteers.

Primary Election Turnout Highest For Off-Year

Austin — Texas recorded its highest primary election turnout ever in a non-presidential year on Tuesday, March 13 when 2.3 million people cast ballots in the Democratic and Republican party primaries, Secretary of State George Bayoud said.

The turnout is believed to be the second highest total for any primary election in Texas history. The highest primary election turnout ever was in March 1988 when nearly 2.8 million Texans voted in the Democratic and Republican party presidential primaries.

This year's primary marked only the third time in Texas history that a primary election turnout exceeded 2 million voters. The turnout on March 13th represents 28 percent of the state's 8.3 million registered voters. The turnout rate is the highest for a gubernatorial primary election since 1978.

"I am extremely pleased that we have set a new record in terms of the number of Texans who turned out at the polls," Bayoud said. "I am particularly happy about the turnout rate because it exceeded the historical average."

Don't be surprised if you see strange looking leaves on your peach and plum trees this spring. Peach leaf curl causes puckered, thickened, curled peach leaves and fruit. It is caused by a fungus and is related to air temperature and free moisture during bud opening. If air temperature is near 68 degrees Fahrenheit and free moisture is present during this time you can expect peach leaf curl -- unless you followed our recommended preventative fungicide program last fall. With the warm moist spell around March 6th, these conditions have been met. Those growers who applied Kocide 101 or chlorothalonil when the leaves were falling in late October should not have this peach leaf curl problem. There is not anything you can do about that problem now, but it doesn't normally ruin your crop or trees. You will have some leaf fall, but by the time summer gets here the problem is usually gone.

If you just didn't find time to prune your fruit trees and they made long growth last year, you can still do some pruning even though the trees have bloomed and are in leaf. Cuts will heal fast and the tree will be stressed very little.

You might hold off on your spring fertilization of fruit trees, especially if they lost their crop to the freeze last year. Many had fertilized last year prior to the April 11th freeze, then lost their crop and consequently grew a lot of wood which had to be pruned off. So wait until you see that you set a crop in late April to early May to put out your fertilizer. Commercial growers may want to split the applications, put out half now and the other half out when you see that you have a crop. If you do not set a crop, you do not put out the second application.

Sub-zero temperatures like those we experienced in December 1989 are hard on warm season perennial grasses. Many homeowners are concerned, and rightfully so, about their St. Augustine, Extension Agronomist, Dr. George Alston, has observed that we have had extensive winter kill on many St. Augustine lawns but

Medicare Open Enrollment Now

People who failed to sign up for the medical insurance part of Medicare when they were first eligible, or who dropped out, may enroll now through March 31 at any Social Security office. Coverage begins July 1.

Medicare hospital and medical insurance is available to almost everyone at age 65, to disabled people under 65 who have been entitled to Social Security disability for at least 24 months, and to most people with permanent kidney failure. Nine out of ten eligible people are enrolled.

Medicare's medical insurance supplements Medicare hospital insurance which is funded by part of the Social Security taxes paid by employers, employees, and self-employed people. Medical insurance helps pay doctor's bills and other medical expenses not covered by hospital insurance. It is funded by individual monthly premiums paid by those who enroll and by Federal general revenues. The basic premium is \$28.60 a month for 1990. In general, the basic monthly premium is increased by 10 percent for each year a person could have had medical insurance but did not.

People 65 and over who are not eligible for Social Security or railroad retirement benefits can get Medicare hospital insurance by enrolling and paying a monthly premium. The monthly premium for these people is \$175 in 1990. People who buy hospital insurance must also sign up for the medical insurance part of Medicare and pay for the monthly premium.

It should be noted that people do not have to retire to get Medicare coverage. On approaching 65, people who want the coverage but wish to continue working may sign up at any Social Security office and have their coverage begin with the month they reach 65.

little if any damage to common bermudagrass. It appears that damage is more extensive on sandy soils, but is also evident on clay soils. Much of the grass was also extensively damaged on turf forms so re-establishment this spring may be out of the question. Good care from the standpoint of herbicides and fertility will be critical to recovery of the lawn. Some homeowners may be faced with the decision to overseed with bermudagrass or maybe even fescue. However, fescue does best when seeded in the fall. Do not use a herbicide that will be severe on St. Augustine and do consider delaying nitrogen application until the grass starts to grow good in order to keep weed competition to a minimum.
