Taken to De Leon Memorial Hospital were Tom Bynum, 13; Andrew Tarver, 10; Melissa Tarver, 8; John Tarver, 7; and Charlie Tarver, 4.

Andrew Tarver was the most seriously injured, suffering a crushed hip, broken leg and severed artery, said Department of Public Safety Trooper Steve Foster.

Foster said Tarver was transferred by helicopter to the Cook-Fort Worth Children's Medical Center, where he was listed in serious condition Monday night.

Melissa and John Tarver were listed in stable condition, but were to be held overnight at De Leon Memorial for observation, said a nursing supervisor there. Charlie Tarver and Tom Bynum were treated and released.
