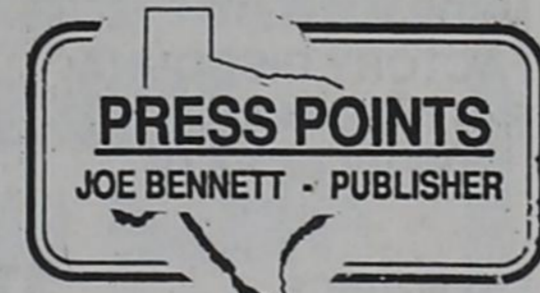
## Child Development Class Invites Kids To Playschool

## Visiting judge rules in favor of Eastland commissioner

EASTLAND — A visiting judge Monday declared incumbent L.T. Owen the winner of the March 10 Democratic primary for Precinct 3 Eastland County commissioner.

Dick Burgess of Carbon, who lost to Owen by 14 votes, had challenged the election, alleging that at least 31 people who lived outside the precinct had cast ballots illegally in the race.

After a two-hour hearing Monday, visiting Judge David Cleveland of Palo Pinto County, declared Owen the winner. He made his decision after a 10-minute recess in which he considered the testimony of Burgess' 20 witnesses. Jim Wright, 91st district judge, had excused himself

from hearing the case.

After testifying about voting March 10, each witness was asked by Burgess' attorney Saul Pullman to point out their residence on a map of Precinct 3.

Many were not able to pinpoint where they lived and complained about poorly defined lines. Some pointed to spots that clearly placed them outside the Precinct 3 boundaries.

On cross examination, Owen's attorney Jim Parker succeeded in bringing out that each person voted where his voter registration dictated.

Jack Shults, who owns a business in Rising Star, but lives in neighboring Comanche County testified he has voted in Rising Star for 33 years.

Frances Ann Simpson said she lives 4½ miles north of Gorman and had voted in Gorman 35 years.

"I'm precinct chairman of that precinct," she said. "This is the first time anything like this has come up."

Under questioning from Parker, several witnesses said they voted for Burgess. This seemed to refute his claims that he would have won the election if the 31 targeted voters had not cast their ballots in Precinct 3.

While Cleveland recessed to review testimony, Burgess seemed to have doubts about winning his case, saying, "I think we went down the tube."

He blamed the loss on the poor details of the precinct map.
