

The Gorman Pantherettes clinched second place in District 19A on Tuesday night when they defeated the Eula girls by a margin of 51 to 37 in the local gym. The Pantherettes edged the Lady Pirates 13 to 11 at the end of the first quarter and each team scored 13 points in the second to make the score 26 to 24 at the halftime intermission. In the third quarter both teams cooled off with Gorman outscoring Eula 7 to 4. But in the final period the Pantherettes pulled away by scoring 18 points to Eula's 9 for the 51 to 37 victory.



A group had expressed interest in renting the "Old Fire Hall" but due to the building being unavailable for rental on the requested day (already scheduled for use on Tuesday nights) no action was taken by the Commis-

The matter of Ector Street, near Birdsong Peanuts, was placed in Abeyance.

David Smothers, Acting Police Chief for the City of Gorman, informed the Commission he would like to be considered for the position of Chief of Police for Gorman on a

permenent basis. At this time Mayor Simpson recognized the Citizens Police Support Group with Mr. Darrell Fish acting as spokesperson for the group. Mr. Fish told the Commission of his, and others in the group, support for strong and effective law enforcement for out city. He further stated his belief that the City Commission should support the police department by allowing the department to function effectively on a departmental level. Mr. Fish gave a verbal endorsement for David Smothers to be elevated from Sgt. to the position of Chief of Police.

Mayor Simpson expressed his appreciation to Mr. Fish and the support group for their interest and concern in the matter relating to the police department and other areas of city government.

A motion was made by Ann Maxfield that the Commission be in closed Executive Session with David Smothers. John Rice seconded the motion. Motion carried 4-0. Time entering into Executive Session 6:48

Mayor Simpson announced the regular meeting would continue at

Ann Maxfield made a motion that David Smothers be promoted to the position of Chief of Police for the City of Gorman, receiving the salary of

Chief effective as of this date, January 16, 1992, and that he, David Smothers, be compensated for the days he has performed as acting chief at the salary scale for chief, and that he be paid an additional \$50.00 per week until another officer is named to the department, at which time he would receive only the salary for Chief of Police. Seconded by Howard Hagood, the motion carried 3-1. For: Maxfield, Hagood and

Rice. Opposed: Smith.

It should be noted Johnny Smith expressed his support of the police and their duties, but is of the opinion the period should have been longer for applications allowing applicants outside the current personnel time to apply and be screened. Commissioner Smith stated to Chief Smothers he accepted the decision of the Commission's vote and woould support the Chief and the department as long as they merited his support by operating in a professional and effective manner for the Citizens of Gorman.

At the request of the Mayor and the Commissioners Chief Smothers will continue screening applicants for the vacant position of patrolman and will bring the applications before the Commission to be reviewed by them and the Chief's recommendations will be considered.

A motion was made by John Rice that the position of officer when filled for the Gorman Police Department be paid a salary of \$1,100.00 per month for the probation period of ninety (90) days. Seconded by Howard Hagood the motion carried 4-0.

Chief Smothers expressed his appreciation to the Commission for his promotion to chief and stated his intentions are to run as efficient, effective, and professional law enforcement service for the Citizens of Gorman. He noted there is a need for several items to be considered for purchase that will enable the department to operate efficiently. Items needed: various forms, PR-24 baton, tape recorder, camera, finger printing kit, and typewriter.

John Rice made a motion that the forms requested by Chief Smothers be ordered immediately. Seconded by Johnny Smith, motion carried 4-0.

The Chief of Police will present the Commission with prices of the other items at the next meeting.

John Rice made a motion to accept the verbal resignation of Brett Ashley as Chief of Police, City of Gorman, as voiced by Mr. Ashley at the January 9, 1992 meeting. Seconded by Johnny Smith, motion carried 4-0.







1992 Exemption and Special **Valuation Applications Available**

Eastland County property owners wishing to sign up for 1992 property tax exemptions and/or special land valuations may obtain the necessary application forms from the office of the Eastland County Appraisal District. The office is located on the second floor of the Eastland County Courthouse in Eastland. The telephone number is 629-8597 in Eastland, and the necessary applications can be requested over the phone.

The compiled application form must be filed with the Eastland County Appraisal District by May 1, 1992 if it is to be considered timely

There are numerous exemptions and/or special valuations available through the State Property Tax Code. A partial list of these is shown at the end of this article. If a property owner has a question as to his or her eligibility, they should contact the Appraisal District for assistance.

Homeowners can take advantage of the partial homestead exemption which is available. This exemption must be applied for before May 1, 1992. This exemption does not have to be applied for every year. If the residential homestead owner resides in the same house for 1992 that he or she lived in for 1991 and they received a residential homestead exemption on it for 1991; they do not have to re-apply for 1992. An exception to this would be a person who received the exemption in 1991 but turned sixty-five during the 1991 year. This person would need to re-apply as he or she would be aligible for additional exemption amounts available to those residential homestead owners over sixty-five years of age.

If you have any question as to whether you are receiving a homestead exemption or as to your eligibility for it or one of the other available exemptions or special valu-

ations; please contact the Appraisal

Partial exemptions and/or Special Valuations available are: residential homestead; Over 65 Residential homestead; Disabikity Residential homestead; Disabled Veteran; and Open Space Land Valuation (ag use).

BUSINESS PERSONAL PROPERTY RENDITIONS MAILED

Business owners within Eastland County have recently been mailed their 1992 business personal property rendition forms by the Appraisal District.

The State Property Tax Code requires that all business personal property be rendered each year by April 1. The 1992 rendition form, along with a letter explaining the requirements of the law, has been mailed to all known business owners within the county.

If you, as a business owner, have not yet received a rendition form, you may call and request that one be sent to you. The telephone number to call is 629-8597 in Eastland.

In the early hours of 1992 a group of 14 students and sponsors from Trinity Christian Academy (TCA) left De Leon for three days of missionary work at the Hands of Luke Medical Clinic and Children's Home in Juarez, Mexico, just across the Rio Grande from El Paso.

The group traveled in two pickup trucks and a Suburban filled with clothing, medicines and medical supplies for the clinic and orphan- task.

"Taking Matthew 25:35-36 as their motto," said TCA principal Beth Dunwell of Gorman, "they literally carry out the verse. In addition to treating those who are sick, they also provide clothing, food, a prison ministry amd a home for homeless children."

In Matthew 25-35-36 Jesus says: "For I was hungry and you gave me something to eat. I was thirsty and you gave me something to drink. I was a stranger and you invited me in. I needed clothes and you clothed me. I was sick and you looked after me. I was in prison and you came to visit me." (New International Version).

The TCA mission group completed several projects while in Juarez:

Kathy Goins of Comanche, along with her daughter, Heather, her cousin, Linda Bergman of Kansas, and Annie Gutierrez of Proctor, assisted with cooking and dishwashing in the children's home, "an all-day duty," said Mrs. Dunwell, "with so many mouths to feed!"

Bob Dunwell of Gorman and Bill Bergman of Kansas, a carpenter, built a stairway for the clinic.

Lonnie Goins of Comanche and Weldon Bennett of Sidney installed a six-foot cabinet and counter top, which were purchased by Goins, in the ministry's kitchen.

Rocardo Gutierrez of Proctor and Cecil Funderberg of Eastland assisted with both the construction projects and the kitchen duty.

Mrs. Dunwell, David Campbell and Shanna Lewis, all of Gorman, and Natalie Hammond of Hasse worked in the ministry's pharmacy, sorting samples and getting them ready for use.

"Jensen and Brittany Goins of Comanche," Mrs. Dunwell said, "were our best goodwill ambassadors as they played non-stop with the children. They did not experience any language barrier in their play!"

The group also bought an automatic washing machine for the children's home (which had previously been using rub boards and a 1940's vintage ringer washer) and some materials for the pharmacy.

The TCA workers had hoped to repair the ministry's roof but were unable to do so because they lacked the \$2,000 needed for materials. The group hopes to return for that project later this year, as the workers see it as a serious need for the ministry.

Congress Extends

Washington — Congress has voted overwhelmingly to extend jobless benefits by 13 weeks for unemployed workers whose coverage was expiring, says U. S. Senator Phil Gramm of Texas.

"This marks the second extension approved by Congress," Gramm said. "It is a step to help our workers cope with the recession, but it is no

"They received lots of samples and partial bottles of medicines from various places," said Mrs. Dunwell. "However, a lot of work is required to get the pills from the foil packets in the cardboard boxes they were shipped in, into the larger bottles in the pharmacy for dispensing."

"Hands of Luke Medical Ministries," said Mrs. Dunwell, is a faith ministry (one which depends completely on outside contributions for its financial support) organized and sponsored by Dr. Marco Samaniego and his family." Luke, author of one of the New Testament gospels, was a first-century physician.

"Other than its spiritual ministry" continued Mrs. Dunwell, "its major thrust is medical care to the indigent of Juarez, especially those of evangelical churches in the area."

Working alongside Hands of Luke is another ministry called Daystar, operated by a retiree from Michigan, who gets food from bakeries, a milk plant and other places in El Paso and distributes it in Juarez. First fed are those in the children's home, then those from churches requesting assistance.

The rest of the food is distributed in the makeshift cardboard villages surrounding Juarez, which are estimated to be growing at a rate of 20 families per day.

Mrs. Dunwell said the ministry still has other projects which need to be done, such as completing a large room at the clinic to be used as a hospital ward, and the establishment of warehouse space in El Paso where materials can be received and pro-

For the hospital ward, the ministry needs floor tile, sheetrock work, painting, and furnishings such as beds, bedside tables and other equipment. The clinic offers surgery and delivery services but currently has only two beds for recovery and no place for longer hospital stays.

Hands of Luke received donations of medicines, clothing, Bibles, medical supplies and equipment, and infant formulas from churches in many places in Texas and other states. But there is no place except Dr. Samaniego's home in El Paso to receive, sort and store the supplies before transporting them to Juarez.

What's New for '91

Social Security Number for Dependents Age 1 or Older. If you can claim any person age 1 or older as a dependent, show that person's social security number on your tax return. If your dependent does not have a number, see your tax forms package for instructions.

More Benefit with the Earned Income Credit (EIC)—Use New Schedule EIC. You may be able to take this credit for 1991 if you earned less than \$21,250 and a child lived with you. But you must file new Schedule EIC with Form 1040 or Form 1040A to do so. Read the instructions in the tax package to see if you can take this

Increased Deduction for Exemptions. The deduction for each exemption-for you, your spouse, and dependents—is \$2,150 for 1991. But your deduction may be limited if your adjusted gross income is more than \$75,000. See further information in your tax package.

Limit on Itemized Deductions. If your adjusted gross income is more than \$100,000 (\$50,000 if married filing separately), you may not be able to deduct all of your itemized deductions. Read the Schedule A instructions in your tax forms package. Also, personal interest (such as interest you paid on car loans and credit card balances) is no longer deductible.

Maximum Tax Rate of 28 percent on Capital Gains. If you have a net capital gain, your tax may be less if you can use the tax computation on Schedule D (Form 1040) to figure your tax. See Part IV of Schedule D to see if this applies to you.

Alternative Minimum Tax Increased. The tax rate for individuals has increased to 24 percent.

Standard Deduction Increased. Because of the increase, it may be to your benefit to take the standard deduction this year even though you itemized deductions in the past. Use the Standard Deduction Chart in your tax package to figure the correct

Texas Agriculture Commissioner Rick Perry says that the Texas Department of Agriculture will resume inspection of fresh fruits, vegetables, nuts and peanuts under a newly signed cooperative agreement with USDA.

"Since taking office, I've been concerned that Texas was one of only three state departments of agriculture in the country that did not have such a cooperative agreement with USDA to inspect products for producers and shippers," Perry said. "We have worked hard in the past year to make sure this new agreement clarifies the state's and the federal government's roles, and provides the best possible atmosphere to work in."

The agreement calls for the TDA to conduct visual inspections of fruits, vegetables, nuts and peanuts for size, grade and maturity priority to shipping and selling. Producers and shippers pay fees for this service.

For some of these products, a federal inspection is mandatory because of federal marketing orders and other regulations. All are inspected because of consumers' demands for quality products. In addition most fresh

All monies from the prior operation of TFIS by TDA will remain separate from the new program, because a rider in the 1991 general appropriations act sought to transfer these funds to general revenues of the state.

Choose the Form that Fits



Continuing tax changes make it possible for many taxpayers to file simpler returns. Although you may receive in the mail this year the same type of form you used to file last year, you should review your tax situation to see if filing a different form is necessary or more beneficial.

Generally, use the green "EZ" form (1040EZ) if your filing status is single; you are under 65; you are not blind; you claim no dependents; your taxable income is less than \$50,000 and is only from wages, salaries, tips, taxable scholarship and fellowship grants, and certain interest of \$400 or less; and you do not itemize deductions, claim any adjustments or credits, or owe any other taxes than amounts from the tax table.

If you do not qualify to use Form 1040EZ, use the pink "short form" (1040A) if your income is only from wages, salaries, tips, taxable scholarship and fellowship grants, certain interest, dividends, pensions, annuities, IRAs, social security and unemployment compensation; your taxable income is less than \$50,000; you do not itemize deductions; your only adjustment to income is for certain contributions to an IRA; your only credits are the credit for child and dependent care expenses, credit for the elderly or disabled, and the earned income credit; and, your only other tax is for advance earned income credit payments.

From a tax savings standpoint, use the blue "long form" (1040) if you have itemized deductions that exceed your standard deductions and have adjustments to income or credits that you cannot take on Form 1040A or Form 1040EZ. You must use Form 1040 if your taxable income is \$50,000 or more; you had certain types of income such as capital gains, self-employment earnings, rents or royalties; you itemize deductions or claim certain tax credits or adjustments to income; and you owe other taxes or claim certain additional payments.
