


### High School Awards **Banquet Set Tuesday**

#### **House Completes Action on 2002 Farm Bill**

On Thursday, May 2, the House of Representatives completed action on the 2002 Farm Bill, clearing the way for a final vote by the Senate and a signature by the president. All indications are that the president will sign the Farm Bill once the Senate has approved it.

The official title of the Farm Bill is the Farm Security and Rural Investment Act of 2002. This is a six-year farm bill that expires in 2008, replacing the so-called Freedom to Farm Act of 1996. While it is not a perfect bill, I believe it will be good for Texas and the Nation.

First and foremost, this Farm Bill provides for a strong safety net for our agricultural producers. The bill retains the flexibility in production and reliability of decoupled assistance that were provided for in the 1996 Freedom to Farm Act.

Above and beyond that, the counter-cyclical payments it provides to program crop producers will mean that Congress will not need to provide additional income support when prices are in decline. Marketing loan tools will continue to be available to program crop producers.

As a result of the new Farm Bill, total agriculture spending will be increased by about \$7.4 billion a year, an increase of 70 percent. Specifically, crop subsidy spending is increased by about \$4.8 billion per year. The new Farm Bill provides for an 80 percent increase in spending on farm conservation programs. At the insistence of the Senate, this Farm Bill includes a new conservation program, the so-called Conservation Security Program (CSP). The Senate believes this program will encourage farmers to adopt better conservation and environmental practices.

There was much talk about a Senate provision to ban packer ownership of livestock 14 days prior to slaughter, however this provision was eliminated during the House and Senate Farm Bill conference.

This is not to say that this issue has been completely resolved, however. I wouldn't be surprised if Congress pursues further action to address what some folks see as predatory actions on the part of the meat packing industry.

Unfortunately, the final bill also includes a "country-of-origin" labeling section to require that meat, fish and produce be labeled with the country of origin. The original House bill had included a labeling requirement on fresh fruits and vegetables only. A number of us in the House had strong reservations about country-of-origin labeling and the burden it would impose on the nation's food industry.

While country-of-origin labeling might sound good to some folks, I am concerned about the impact that such reporting requirements will have on our food processors. The last thing our food industry needs is more regulation and paperwork, the costs of which will ultimately be passed on to the consumer in higher prices.

The labeling provision will be voluntary for the first two years and mandatory thereafter. Let me say, however, that this is another issue that the House Agriculture Committee will be carefully looking at in the very near future.

On the subject of peanuts, the new Farm Bill provides a quota buyout of 11 cents a pound per year over 5 years (55 cents total), and provides a target price of \$495 per ton. In addition, the farm bill allows for the payment of storage costs for peanuts under loan and provides a \$355 per ton loan rate and a \$36 per ton fixed payment rate.

Wool and mohair will receive marketing loans or loan deficiency payments based on a loan rate of \$1.00 per pound for graded wool, \$.40 per pound for non-graded wool, \$4.20 per pound for mohair, and \$.40 per pound for unshorn pelts.

The dairy industry will end up with a national counter-cyclical program that would trigger direct payments to dairy producers when the Boston Class I milk price falls below \$16.94 per cwt of milk.



On the subject of payment limits, the Senate had originally wanted a cap of \$275,000 per year, however the House and Senate conferees ultimately settled on an annual limit of \$360,000 per year. These payment limits will not apply to 2002 crops. The new law also makes unlimited use of generic certificates for marketing loan gains.

Regarding the timing of this farm bill, it has been my goal all along that an agreement could be reached in time for the 2002 crop year. USDA officials have indicated that it could take at least four months to implement certain portions of this measure.

Once the Farm Bill is signed into law, Agriculture Secretary Veneman said this week that farmers should not expect to see any money from the Farm Bill until autumn. She noted that last year USDA issued supplemental AMTA (Agricultural Market Transition Act) checks in August, but that farmers should not anticipate that schedule this year.

As I have mentioned in the past, the original House Farm Bill was 379 pages, while the Senate bill was 1,333 pages in length.

#### **USS San Jacinto**

Each year Texans commemorate the Battle of San Jacinto - an 18 minute battle fought on April 21, 1836, that secured Texas' independence from Mexico and changed the course of American history.

We Texans love to reflect on our rich heritage and San Jacinto Day is no exception. The official state of Texas celebration takes place at the San Jacinto Battleground State Historical Park. This year, thousands of Texans attended the festivities, which included a reenactment of the battle and a reading of General Sam Houston's account of the events by his great-grandson, Sam Houston IV. I was pleased that the United States Navy accepted my invitation to take part in this year's San Jacinto Day celebration. In April, the USS San Jacinto docked in the Houston Ship Channel in honor of the 166th anniversary of the battle.

The Navy christens its battleships with the names of important historical figures, heroes and key American battles. The USS San Jacinto, the third ship in the Navy to bear the name of this important battle, pays homage to the rich legacy of Texas while serving as a beacon of American military might. The first ship to carry the name of the battle was an early experimental.

propeller-driven warship, commissioned in 1851. The second was a light aircraft carrier that saw extensive combat in the Pacific during World War II. The current USS San Jacinto, an Acgis cruiser, was commissioned on January 23, 1988, in Houston by Vice President Bush. The ship's motto, "Victory is Certain," is a quotation from General Sam Houston's speech to his outnumbered men before the battle.


The ship has docked at the Port of Houston four times previously, but this year's arrival marked the first time the visit has coincided with the annual San Jacinto Day festivities. The highlight of the program was a re-enlistment ceremony for 10 crew members conducted by Captain John MacKercher Jr. on the steps of the San Jacinto Monument. Since its commissioning, the USS San Jacinto has served our country

with distinction - the ship is equipped with the most advanced naval weapons system in the world. Aegis, a computerized, quick reaction air defense system, provides extraordinary capabilities against attacking aircraft and missiles.
