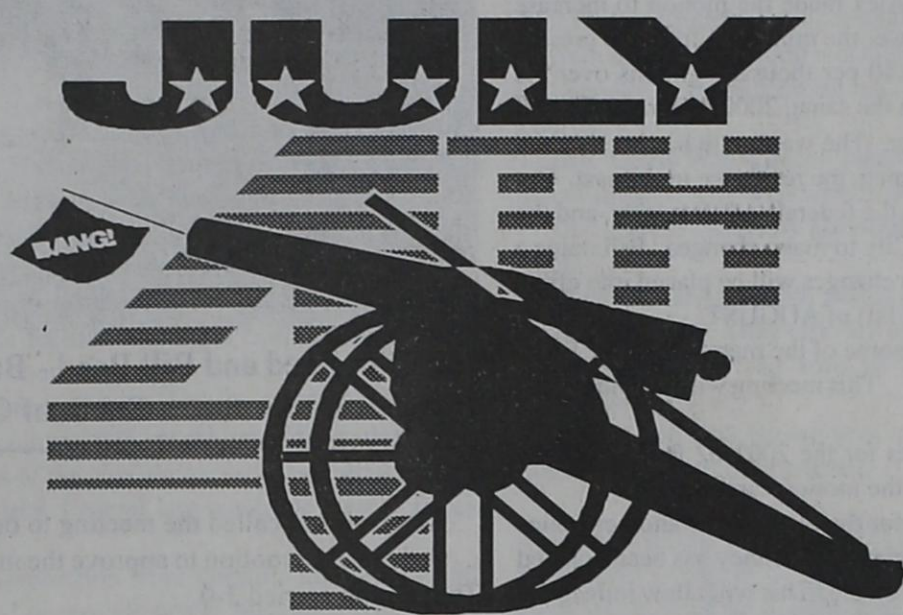
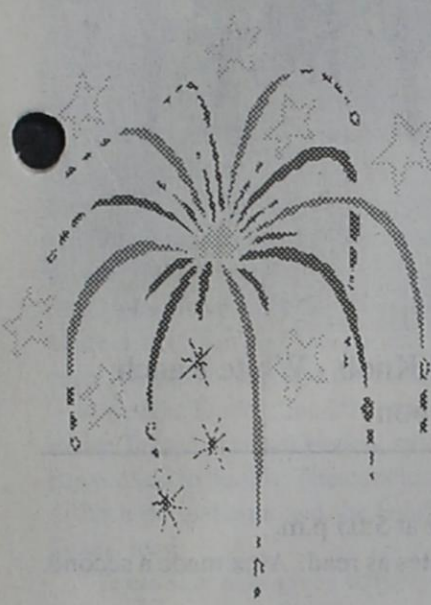

### FIREWORKS DISPLAY



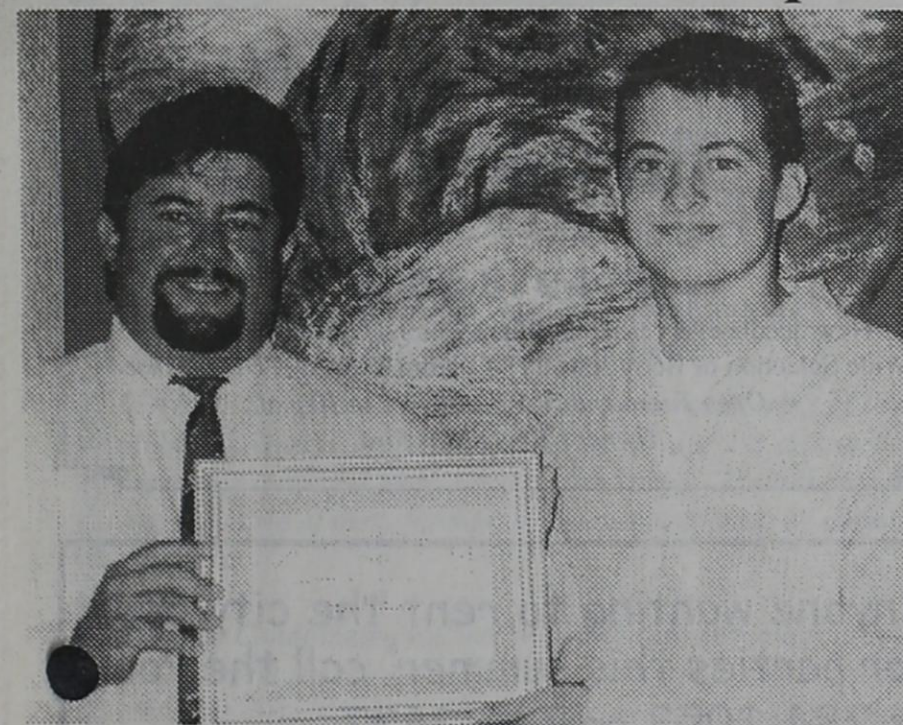

### Senior Citizens Dance Slated In DeLeon July 7

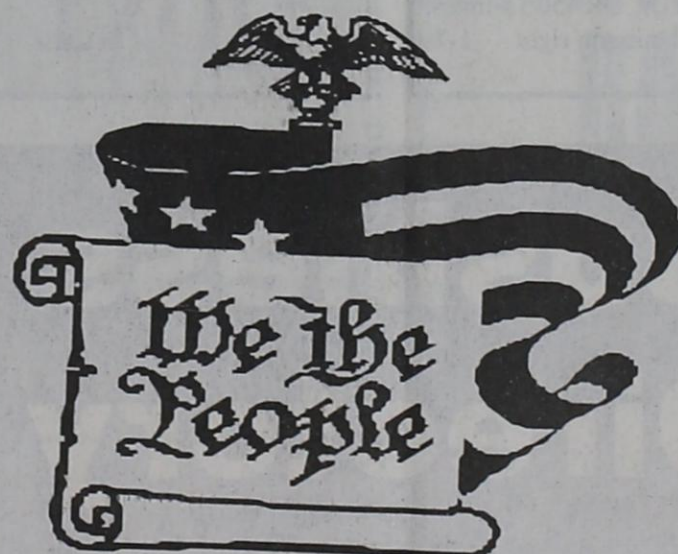
There will be a Senior Citizens dance this Saturday night, July 7, at the DeLeon City Hall starting at 7:00 p.m.

### Peanut "Turn Row" Tour to Highlight Summer Challenges

The past several years a Peanut "Turn Row" Tour has been held early in the peanut season to highlight "challenges" to peanut producers. This year we are experiencing problems with weeds, lack of rain and some early root rot diseases. These and other challenges will be highlighted on the Peanut "Turn Row" Tour set for Tuesday, July 10. Plans are to register at UAP Southwest at 9:30 a.m. and then leave on the tour at 10:00 a.m. Two continuing education credits will be offered to private, commercial and non-commercial applicators. To preregister please call the Texas Agricultural Extension Service at 915/356-2539.

Individuals with disabilities who require an auxiliary aid, service or accommodation in order to participate in this program are encouraged to contact the Texas Agricultural Extension Service in Comanche County at 915/356-2539 to determine how reasonable accommodations can be made.

At least two stops will be included on the tour focusing on weed control, disease management and irrigation timing. Dr. Robert Lemon, Extension Agronomist, Texas A&M University will address weed control options for growers including what's working and what's not. Focus will be on a weed control plot looking at recently labeled products as well as new products on the horizon.

A second stop will be of coastal weed control. This is unusual for a peanut tour but a new grassburr control product is on the market and many peanut producers grow coastal in rotation. This stop will allow producers to see how well the product is working and potentials for reducing coastal stands.

# City Minutes

June 7, 2001

The Gorman City Commission met on the above date. Those present were Mayor Robert Ervin, Commissioners; Alex Granado, Donnie Rodgers, Bill Vaughn, and Judy Warren. Others present were: Lori Dodd, Doug Caffey, Abel Saldana, Frank Fenley, and Adam and Sylvia Hampton.

Mayor Ervin called the meeting to order at 5:10p.m.

Judy made the motion to approve the minutes of the May 17, and the May 11 meetings. Alex made a second and the motion carried 3-0. (Donnie stepped in a few minutes late.)

Bill made a motion to approve the bills for payment. Alex made a second and the motion carried 4-0.

Adam and Sylvia Hampton were present to request some enforcement and some assistance from the Commission. They inquired about the ordinances on keeping of animals, health hazards, property maintaining, etc. The City was asked to enforce these ordinances that are already in place. Not only would it help with some of their problems, it would help in the progress of cleaning up Gorman. The Commission agreed with the Hamptons, and will to the best of their ability get something done.

On Department Head Reports, Lori was present to report activities of the EDC, and Gorman Grow. Also to acquire the permission to apply for a Texas Parks and Wildlife Grant.

Judy made the motion to apply for the grant and Donnie made a second. The motion passed 4-0.

Doug submitted his monthly report. As did Frank with ACO, and Vickie submitted her monthly report.

Donnie made the motion to call the applicants that had previously applied for the cleaning job, the City Office and the Community Center. Socorro Ramirez was next for the position. If she doesn't want the position, it will go to the next person. Judy made a second to the motion and motion carried 4-0.

After very much thought and discussion Alex made the motion to increase the water rate to \$3.00 per thousand gallons over the minimum from the present \$2.95. And to increase the sewer rate to \$1.40 per thousand gallons over the minimum. The minimum rates will remain in the same, 2000 gallons @ \$11.50 on water, and 2000 gallons @ \$7.50 on sewer. The water rate has been raised two times where as the City has not passed it on to the residence in the past. But the rising costs of maintaining standards with the federal and state laws, and the rising costs of any expenses have forced the City to make changes. Bill made a second and the motion carried 4-0. This costs changes will be placed into effect on the bill which will be mailed out the first (1st) of AUGUST.

The Commission would like to meet with some of the members of the Baseball Commission at the next June meeting. This meeting will be held at 5:00 p.m. on June 21, 2001.

Judy made the motion to adopt the figures for the 2001-02 Budget for the City of Gorman. Donnie made a second and the motion carried 4-0.

Bill made a motion to put a \$5000.00 cap for the purchase of another Police vehicle. Alex made a second. The motion carried 4-0. Money has been donated to the City to go towards the purchase of this vehicle. This will allow mileage to be kept down, and vehicles to last longer.

At 7:35 p.m. Judy made the motion to convene into Executive Session. Donnie made a second and the motion carried 4-0.

At 8:00 p.m. Judy made the motion to adjourn from Executive Session and return to Regular Session. Donnie made a second and the motion carried 4-0.

No action after Executive Session. There being no further business Judy made the motion to adjourn from the meeting and Donnie made a second. Motion carried. 8:00 p.m.

June 21, 2001

The Gorman City Commission met on the above date. Those present were Mayor Robert Ervin, Commissioners Alex Granado, Judy Warren and Bill Vaughn. Absent was Commissioner Donnie Rodgers. Others present were Robbie and Lori Dodd,

nd Leonard Silva. Mayor Ervin called the meeting to order at 5:05 p.m. Judy made a motion to approve the minutes as read. Alex made a second. The motion carried 3-0. Judy made a motion to approve the bills for payment. Alex made a second and the motion carried 3-0. No action on citizens in-pit. No action on personnel issues. No one was present from the baseball commission. Lori Dodd reported that she would be attending a workshop next week. She also reported that the grant for video cameras for the police cars was approved. Also the "Fall In Love With Bass Lake" grant was approved. This is a project involving the 7th and 8th grades. That will begin in October.

Glenn is to be sure that the area around the City Park is kept well mowed and clean. And also a tree at the swimming pool needs to be cut down. The Dodd's asked the Commission to allow them to hold a public fireworks display at our City Park. The Commission said that they thought it would be really nice for our community. Robbie Dodd will supply his own fireworks.

This is not a City sponsored activity. Just wanting to see some good ole fashion 4th fun!

The Commission also requested that the City crew have the new uniform shirts monogrammed.

There being no further business for discussion Bill made the motion to adjourn, Alex made the second. Motion carried. Time was 6:45 p.m.

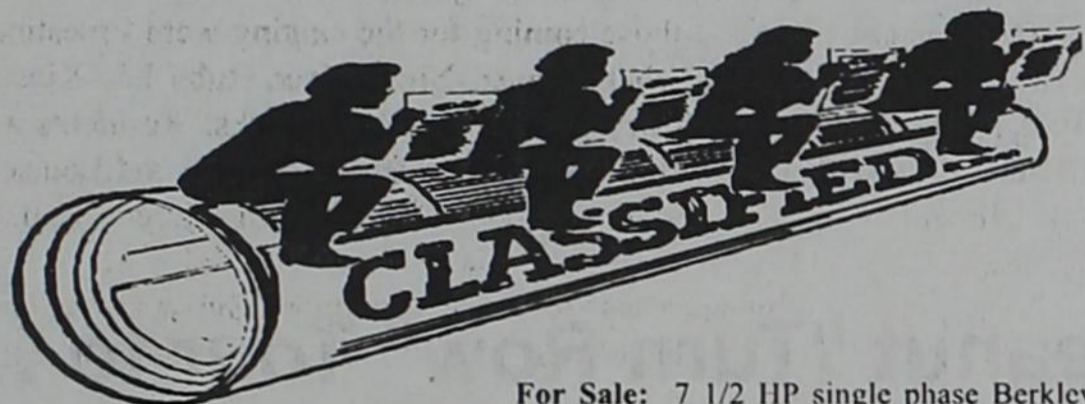

## PATIENTS' BILL OF RIGHTS

Congress is debating the Patients' Bill of Rights, legislation to help patients get the kind of medical treatment they deserve without delay or legal haggling. When we are dealing with the health care of most Americans, it is important to avoid unintended consequences, such as increasing the cost of providing quality medical care. We don't want to do anything that would discourage employers from providing their employees with medical coverage. We need to make sure we are not creating more problems than we are solving with the bill.

Getting good medical care in our country has grown complicated. The vast majority of us like and trust our doctors. We don't want an insurance company telling our doctors what kind of care to give us. Parents should be able to take their child to the pediatrician without having to get permission from their insurance company or health maintenance organization (HMO) first. People should be able to see a specialist when they need one, and to get emergency treatment at the nearest emergency room without calling a health care gatekeeper first.

If an HMO denies the treatment you need, then you should have the right to an immediate, impartial appeal to a panel of doctors. If the panel rules in your favor, you should receive your treatment, period. If the HMO ignores the findings, you should be able to go to court. Such a system should favor patients, first and foremost, with quick action to make sure they get the treatment they need in a timely manner.

We can't afford to turn over patient care decisions to accountants and insurance companies and trial lawyers.

Texas has already taken the lead on patients' rights, and is showing the rest of the country the way. In our state, if an HMO denies coverage for a certain procedure but the patient and the doctor disagree with that decision, a patient can make an internal appeal within the HMO first. If, after the HMO reviews the appeal and still refuses to cover the treatment, the patient can appeal again to a panel of outside experts not associated with the HMO. If the outside panel has made a decision and the patient still feels he or she has been unfairly denied care, the patient can sue the HMO in court.

It works. Fewer than 20 lawsuits emerged from more than 300 appeals heard under Texas' external review system since 1997. At the same time, the system has proved to be fair. The conclusions of the appeals are virtually 50/50 in favor of both the patients and the health plans. Federal law would do well to follow Texas' lead.

Texas law also gives employers protection from lawsuits involving health coverage. Employers are not required to provide health insurance coverage to their employees. Small business often can barely afford to give their employees this benefit. Exposing them to lawsuits and millions of dollars in potential damages because they voluntarily provide their employees with medical insurance just doesn't make sense. I offered an amendment to the bill that would have applied Texas' employer protection provisions to the entire nation. Unfortunately, it failed, but I will continue to work to secure this protection for employers in the final bill.

Congress has to get this right. If health costs continue to climb, the result could be disastrous. Answering a recent series of nationwide polls, an overwhelming majority of employers stated unequivocally they would have to pass on any new health-insurance costs to their employees, by either raising employees' premiums — or by eliminating coverage. Small businesses are especially vulnerable.

The best prescription for America's health provides more protection for patients, enhances the quality of care and promotes greater access and affordability.

### Secondary Constituents

Many constituents (such as calcium, sodium, or iron) which are often found in drinking water, can cause taste, color, and odor problems. The taste and odor constituents are called secondary constituents and are regulated by the State of Texas, not EPA. These constituents are not causes for health concerns. Therefore, secondaries are not required to be reported in this document but they may greatly affect the appearance and taste of your water.

### DEFINITIONS

#### Maximum Contaminant Level (MCL)

The highest permissible level of a contaminant in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**Maximum Contaminant Level Goal (MCLG)**  
The level of a contaminant in drinking water below which there is no known or expected health risk. MCLGs allow for a margin of safety.

#### Treatment Technique (TT)

A required process intended to reduce the level of a contaminant in drinking water.

#### Action Level (AL)

The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

NTU - Nephelometric Turbidity Units

MFL - million fibers per liter (a measure of asbestos)

pCi/l picocuries per liter (a measure of radioactivity)

ppm - parts per million, or milligrams per liter (mg/l)

ppb - parts per billion, or micrograms per liter (µg/l)

ppt - parts per trillion, or nanograms per liter

ppq - parts per quadrillion, or picograms per liter
