
### **Bobby Joe Wright**

# 12 Years Sentence For **Possession of Drugs**

Timothy Sharp, age 34, was sentenced to 12 years confinement in a For Sale: Dodge Motorhome with fridge Texas Department of Criminal Justice facility by 91st District Court Judge Steven Herod for the offense of Possession of a Controlled Substance, Methamphetamine, more than one gram but less than four grams.

> The case was tried to a jury, but after the State, represented by the Eastland County District Attorneys Office, put on the evidence in its case through testimony of two state troopers, a jailer and a DPS chemist, the Defendant elected to withdraw his initial plea of not guilty and enter a plea of guilty directly to the Court. The Defendant had previously elected the Court to assess punishment in the event of a conviction. 91st District Judge Steven Herod presided over the trial and sentencing. Attorney David Hooper of Abilene represented Sharp at trial

The punishment range for the offense included up to a maximum of ten years confinement and a ten thousand dollar fine. Because Sharp had previously been convicted and imprisoned on three prior felony offenses, the District Attorneys Office sought an enhancement to the punishment, extending the range available to the Court to a maximum of twenty years.

District Attorney Russ Thomason stated "This conviction was made possible by collaboration of officers of the Eastland Police Department and Troopers from the Texas Department of Public Safety here in Eastland."



### What is an EDC? Submitted by Mark Simmons

AN EDC IS A NON-PROFIT CORPORATION THAT IS CREATED BY A MUNICIPALITY. THESE NONPROFIT CORPORATIONS ARE ALSO CALLED DEVELOPMENT CORPORA-TIONS. THE ACT DETAILS THE MANNER OF CREATING AN EDC. 1 THE PURPOSE OF THE EDC IS TO PROMOTE THE CREATION OF NEW AND EXPANDED INDUSTRY AND MANUFACTURING ACTIVITY WITHIN THE MUNICIPALITY. IN OTHER WORDS, AN EDC WORKS TO PROMOTE LOCAL BUSINESS DEVELOPMENT.

AN EDC OPERATES SEPARATELY FROM A MUNICIPALITY, WITH A BOARD OF DIREC-TORS TO OVERSEE ITS EFFORTS. HOWEVER, EDC ACTIONS ARE REVIEWED AND SUBJECT TO APPROVAL BY THE CITY COUNCIL OF THE MUNICIPALITY THAT CRE-ATED THE EDC.2

#### **VERY BRIEF HISTORY OF EDC'S**

FROM 1979 TO 1989, EDC'S WERE DEPENDENT ON FUNDING FROM PRIVATE SOURCES, OFTEN DIFFICULT TO OBTAIN. DURING THIS TIME, EDC'S WERE PRO-HIBITED FROM RECEIVING FUNDING FROM THE STATE OR LOCAL GOVERNMENTS BECAUSE OF A TEXAS CONSTITUTIONAL PROHIBITION AGAINST THE EXPENDI-TURE OF PUBLIC FUNDS TO PROMOTE PRIVATE BUSINESS ACTIVITY. 3 AN AMEND-MENT TO THE TEXAS CONSTITUTION WAS PASSED IN NOVEMBER OF 1987 AL-LOWING THE USE OF PUBLIC FUNDS FOR THE PUBLIC PURPOSES OF DEVELOP-MENT AND DIVERSIFICATION OF THE ECONOMY OF THE STATE. 4 THEREAFTER, THE TEXAS LEGISLATURE PASSED LAWS ALLOWING STATE AND LOCAL GOVERN-MENT FUNDS TO BE USED TO PROMOTE ECONOMIC DEVELOPMENT.

IN 1989, THE ACT WAS AMENDED BY ADDING SECTION 4A, ALLOWING THE CRE-ATION OF A NEW TYPE OF DEVELOPMENT CORPORATION THAT COULD BE FUNDED BY THE IMPOSITION OF A LOCAL SALES AND USE TAX DEDICATED TO ECONOMIC DEVELOPMENT. THE TAX COULD BE LEVIED ONLY AFTER APPROVAL OF THE VOT-ERS BY THE CITY. A SECTION 4A EDC USE OF PUBLIC FUNDS WAS GENERALLY LIMITED TO THE PROMOTION OF NEW AND EXPANDED INDUSTRIAL AND MANU-FACTURING ACTIVITIES.

1991 BROUGHT SEVERAL AMENDMENTS TO THE ACT, ONE BEING THE AUTHORIZ-ING OF A NEW SALES TAX CALLED A SECTION 4B SALES TAX. CERTAIN CITIES (A TOTAL OF 73) WERE AUTHORIZED TO IMPLEMENT A ° CENT SALES TAX, PURSU-ANT TO VOTER APPROVAL, TO PROMOTE A WIDE RANGE OF CIVIC AND COMMER-CIAL PROJECTS TO PROMOTE ECONOMIC DEVELOPMENT. FROM 1991 TO 1993, 19 CITIES ADOPTED THE NEW SECTION 4B SALES TAX.

THE RESULTING POPULARITY OF THE SECTION 4B SALES TAX WAS THE IMPETUS FOR THE 1993 AMENDMENT MAKING A SECTION 4B SALES TAX AVAILABLE TO ANY CITY ALSO ELIGIBLE TO ADOPT A SECTION 4A SALES TAX. ACCORDING TO THE AG, MORE THAN 475 CITIES HAVE EITHER A SECTION 4A OR A SECTION 4B SALES TAX FOR ECONOMIC DEVELOPMENT. PRIMARY USES BY CITIES OF THESE TWO TAXES ARE:

- BUSINESS ATTRACTION;
- II. INCENTIVES TO BUSINESS:
- III. LAND AND BUILDING PURCHASE, LEASE, AND UPGRADE;
- IV. INFRASTRUCTURAL UPGRADE AND PLACEMENT RELATED TO COMMERCIAL AREAS; AND
- V. TRAINING AND EDUCATION.

#### **PROJECTS**

#### **SECTION 4A PROJECTS**

THE USE OF SECTION 4A TAXES IS MORE RESTRICTED THAN A SECTION 4B COR-PORATION. SECTION 4A TAXES MAY BE USED FOR THE MORE TRADITIONAL FUND-ING OF ECONOMIC DEVELOPMENT INITIATIVES THAT FACILITATE MANUFACTUR-ING AND INDUSTRIAL ACTIVITY. THE 4A TAX MAY BE USED TO FUND THE PUR-CHASE OR PROVISION OF LAND, BUILDINGS AND EQUIPMENT FOR PROJECTS. THE TERM "PROJECT" IS DEFINED UNDER SECTION SPECIFICALLY, UNDER SEC-TION 2(11)(A) OF THE ACT:

"Project" shall mean the land, buildings, equipment, facilities, targeted infrastructure, and improvements to promote new and expanded business development or found by the board of directors to be required or be suitable for the promotion of development and expansion of...

The 12 categories of expenditures listed in Section 2(11)(A) that 4A taxes may be used for are:

- 1. Manufacturing and industrial facilities- (note that there is no definition under the Act of what constitutes a manufacturing or industrial facility);
- 2. Recycling facilities;
- 3. Distribution Centers- (distribution centers are more favorable to cities with access to major airports or ports and areas that have passed the Freeport exemption):
- 4. Small warehouse facilities- (capable of serving as decentralized storage and distribution centers, again, more favorable to cities with access to major airports or ports);
- 5. Closed or realigned military bases- (a project designed to promote the development of or the redevelopment/or expansion of a closed or realigned military base). The military base must have been closed or realigned pursuant to the action/recommendation of the Defense Closure and Realignment Commission; 5
- 6. Related facilities- (any facilities related to any of the above, whether in existence or to be constructed);
- 7. Facilities to promote new and expanded business development- (the broad wording appears to expand the term "project" and authorized the use of 4A tax proceeds to also promote certain commercial and retail business development); Continued On Page Four

February 1, 2004 is the one year anniversary of the Space Shuttle Columbia disaster. In light of that anniversary and President Bush's recently announced plan, Sen. Kay Bailey Hutchison has devoted this column to America's role in space exploration.

Mars 2020

In January President Bush set forth a bold and far-reaching vision in search of what lies beyond the stars. By 2015 we will again land on the moon. By 2020 we will set our sights on another landing – Mars. Future generations will determine what follows, but it will undoubtedly be beyond the wildest imaginations of today.

Space exploration is more than a science fiction tale – it is our destiny. Americans have expanded frontiers since the first settlers arrived, so it is entirely fitting that the U.S. lead the exploration of space. That spirit challenges today's scientists and researchers to search for cures for cancer, AIDS and diabetes; develop lighter, stronger and more resilient materials; and create new technologies to transform our military, our economy and our healthcare industry.

As a Houston reporter in 1969, I had the privilege of covering Neil Armstrong's extraordinary first steps on the moon. Growing up with the Johnson Space Center in my back yard and the first generation to plant a flag on the moon, the mysteries of space have always held a deep fascination for me. I have been awed by the tremendous discoveries our space program has produced, from insulin pumps to hurricane monitoring systems. When the Columbia disintegrated in the skies above North Texas last year, I heard the sonic boom as I was walking in my neighborhood and ached for the loss of those astronauts. But beyond my personal connections, I have come to understand that an ambitious agenda for NASA will help secure America's leadership in the 21st century, and ensure we continuously push the envelope to discover that which remains unknown. No one exemplifies that spirit more than Texans.

The president's plan is threefold. First, the shuttle will return to flight and America will complete its work on the International Space Station by 2010, fulfilling a commitment to our 15 partner countries. Second, we will begin developing a new manned exploration vehicle to explore beyond our orbit to other worlds – the first of its kind since the Apollo Command Module. Finally, the United States will return to the moon as early as 2015, and use it as a stepping-stone for more elaborate missions into space. To achieve this goal, the president is asking for a \$1 billion increase over NASA's current \$86 billion five-year budget, and the reprogramming of \$11 billion already allocated. Funding this vision is a priority, but we must not shortchange or under-fund existing programs within NASA. While the costs may seem staggering, the price of inaction is even higher. Consider that investment in NASA has led to the development of CAT scans, MRIs, kidney dialysis machines and fetal heart monitors, it's a small price to pay for the lives – present and future – saved through these advances.

A renewed vision for our space program will also ensure the continuation of basic research, one of NASA's fundamental tenets. NASA fulfills one of the most critical roles of the federal government. Private industry neither has the financial wherewithal nor the capability to conduct basic research on a mass scale. Industry specializes in applied research – the art of crafting real-world products from pure research, and keeping the production jobs in America. Everyday applications like satellite television and cellular technology are tangible results of the Agency's activities, but are merely byproducts of a much greater endeavor. Without their core research, we'd be decades behind in every field.

The mission to Mars will also inspire the next generation of scientists. Those young boys and girls who sat wide-eyed as man first stepped on the moon, grew up to become the scientists, engineers and mathematicians of the digital revolution. Today's youth are more apt to name athletes or actors, rather than astronauts, as their role models. We need to resurrect the explorer's spirit that has lain dormant for too many years.

One year ago, the Columbia disaster renewed questions about the mission of our space program. It also exposed critical flaws within NASA and validated the nagging suspicion the Agency was floundering without clear direction. The Administration's new proposal will help revitalize the Agency with the vision and mission it has lacked for too long. The initiatives offer tremendous potential to further research in energy, geology, and health sciences, keeping us at the forefront of space exploration and maintaining our economic viability and defense prowess. And it will keep the dream of reaching new frontiers alive. Going to space is mankind's destiny and leading that effort is America's.

### IPAA RECOGNIZES STENHOLM'S LEADERSHIP ON OIL, GAS ISSUES

Washington, D.C.-The Independent Petroleum Association of America (IPAA) recently honored Congressman Charlie Stenholm (TX-17) with its Independent Oil and Gas Award of 2003. The IPAA presents the award each year to "elected representatives who work vigorously to maintain and enhance America's domestic oil and natural gas resources."

"I am pleased the IPAA has seen fit to present this award to me," Stenholm said. "For many years, I have worked to represent the interests of the independent oil and gas producers of West Texas in Congress.

"Whenever independent producers come to Washington, I always make sure they have an opportunity to present their views and concerns to Congressional leaders from around the country," Stenholm said. "It's very important for Members of Congress who are not as familiar with the oil and gas industry of West Texas to get to know more about the industry and its importance to our economy."

Last November, Stenholm worked to prevent the Environmental Protection Agency (EPA) from implementing overly burdensome regulations regarding stormwater runoff from oil and natural gas drilling construction sites. The legislation would have requested the EPA to extend the stormwater permit to include runoff from the production site before drilling actually occurs.

Stenholm and Congressman Joe Barton (R-TX) of Ennis worked together to encourage members of Congress to vote against a motion that would harm Texas oil and gas production. They were successful and defeated the motion by a margin of 210 to 188 with Stenholm leading 18 other Democrats to vote against the measure. Stenholm and Barton engaged in a lengthy discussion on the floor of the House and described the problems these regulations would cause for independent oil and gas producers in West Texas.

"When it comes to developing an energy policy, we have to separate the wheat from the chaff so we can meet our country's short-term energy needs and still plan for our long-term energy demands," Stenholm said. "That's why I have always been an advocate for increased domestic oil and gas production. We've got to continue producing from the low-volume, marginal wells around West Texas, fully using the resources we already have."

According to the IPAA, independent producers drill 85 percent of the nation's wells and produce 75 percent of the country's natural gas and more than 40 percent of the country's crude oil supply, including 60 percent of the crude oil in the lower 48 states. The members of the IPAA are generally small businesses, employing fewer than 15 people.

- 8. Facilities to promote job creation and retention- (section 4A corporation may aid in the retention as well as the creation of new jobs);
- Job training facilities- (EDC's may help provide facilities needed for job training that meets certain statutory requirements);
- 10. Educational facilities- (this may include any public technical institute, public junior college, public senior college or university, medical or dental unit, or other agency of higher education as defined under Section 61.003 of the Texas Education Code);
- 11. Targeted infrastructure- (expenditures for infrastructure should be reasonably related to an authorized project under the Act, not just the funding of the general infrastructure needs of the city); and
- 12. Research and Development Facilities.

 $\leftarrow\leftarrow\leftarrow$  It must be noted that Section 4B taxes are also authorized for use of the above 12 categories of expenditures.  $\leftarrow\leftarrow\leftarrow$ 

Two additional expenditures are authorized under Section 4A(i) of the Act for 4A taxes:

- i. Business airports- (a general aviation business service airport that is an integral part of an industrial park; and
- ii. Port-related facilities- (port-related facilities to support water-borne commerce).

Additionally, in 1997, the Act was amended to allow the voters to approve the use of the Section 4A sales tax to do projects authorized under Section 4B. <sup>6</sup> This was done to allow cities with a Section 4A tax the flexibility to propose Section 4B projects to the voters without having to both repeal or reduce the Section 4A tax and adopt a Section 4B tax. This amendment also allows Section 4A corporations to use the 4A tax towards a sports venue facility.<sup>7</sup>

What types of specific expenditures are allowed? How can you spend the money?

Knowing the general categories of expenditures under the statute does not advise what types of specific expenditures are allowed. Consequently, cities should review the definition of the term "cost" under Section 2(4) of the Act. Section (2)(4) states that costs for a project may include:<sup>8</sup>

Land and facility improvements- the costs related to acquiring, construction, improvements, and expansion of land and buildings;

Machinery and supplies- costs of machinery, equipment, inventory, raw materials and supplies;

Financial transaction costs- the cost of financing charges and interest before and during construction and the necessary reserves;

*Planning costs*- the cost to research and to develop projects, legal services, development of plans and specifications, surveys, cost estimates; and other necessary or incidental expenditures to determine the feasibility and practicability of undertaking projects;

Cleanup costs- cleanup of contaminated property is allowed, but only after approved by the voters in an election called and held for that purpose. The wording for the ballot is provided by Section 4A(t) of the Act.

#### Section 4B Projects

Section 4B of the Act expands the use of the sales tax to civic and retail projects. Section 4B EDC's have greater flexibility on the uses of the sales tax. In addition to expenditures for land, buildings, equipment, facilities and improvements for items that fit under the definition of "project" under Section 2(11)(A) of the Act, the 4B sales tax may also be used for:

Air or water pollution control facilities.

Athletic facilities- Professional and amateur sports, including stadiums and ballparks;

Parks and related public space improvements- Projects that promote athletic, park, or tourist related facilities or activities including; public parks, park facilities and events, open space improvements, museums, learning centers, and municipally-owned buildings. Expenditures for open space improvements, museums, and learning centers can only be made to the extent they promote sports, entertainment, tourism, or public park purposes;

**Tourism and entertainment facilities**- Entertainment, tourist, and convention facilities, including auditoriums, amphitheaters, concert halls, and exhibition facilities;

Commercial facilities- Related store, restaurant, concession, and parking facilities;

**Certain public facility improvements-** Facilities such as public safety facilities that will promote new or expanded business enterprises;

Transportation improvements- Related streets, roads, and area transportation facilities;

Infrastructural improvements- Related water and sewer facilities; drainage, and demolition. It should be noted that the use of the Section 4B tax for residential water or sewer improvements that are not related to an existing or anticipated business entity or area would probably not qualify as a Project. Tex. Att'y Gen. Op. 95-072 (1995), (unlikely that the construction of sewer facilities in a residential subdivision would promote or develop new or expanded business enterprises);

**Other business-related improvements**- Any other improvements or facilities to promote new or expanded business enterprises;

**Affordable housing-** Projects required or suitable for the development and expansion of "affordable housing" as defined by federal law (42 United States Code Section 12745);

Water supply facilities; and

Water conservation programs.9
