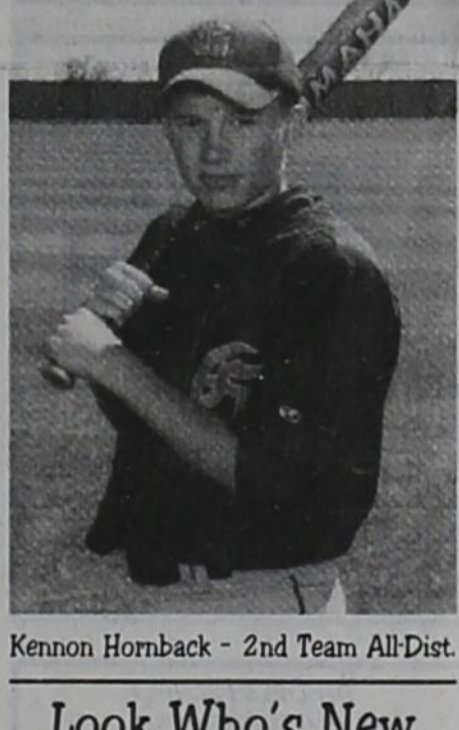

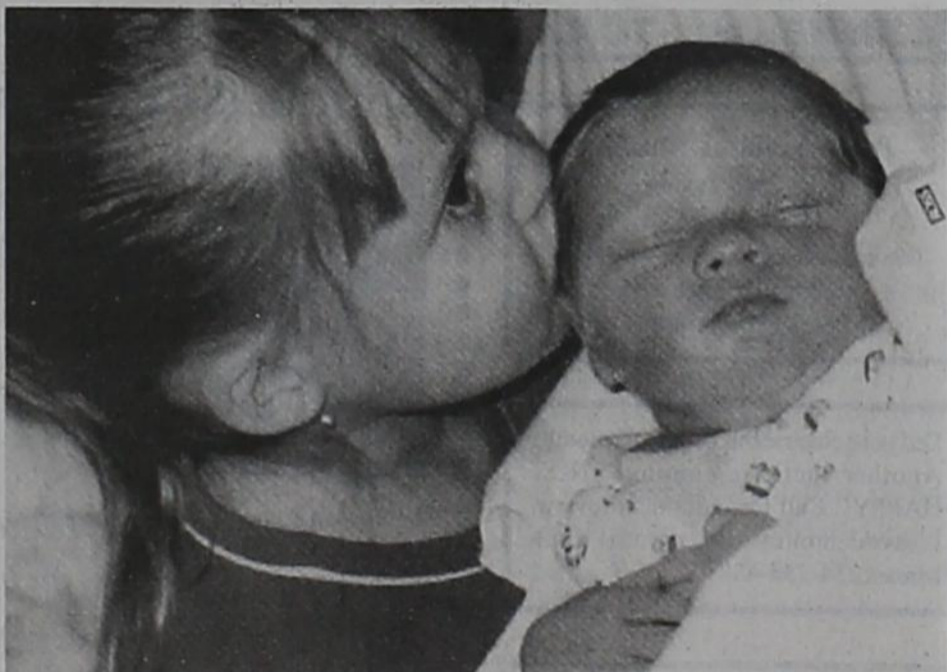

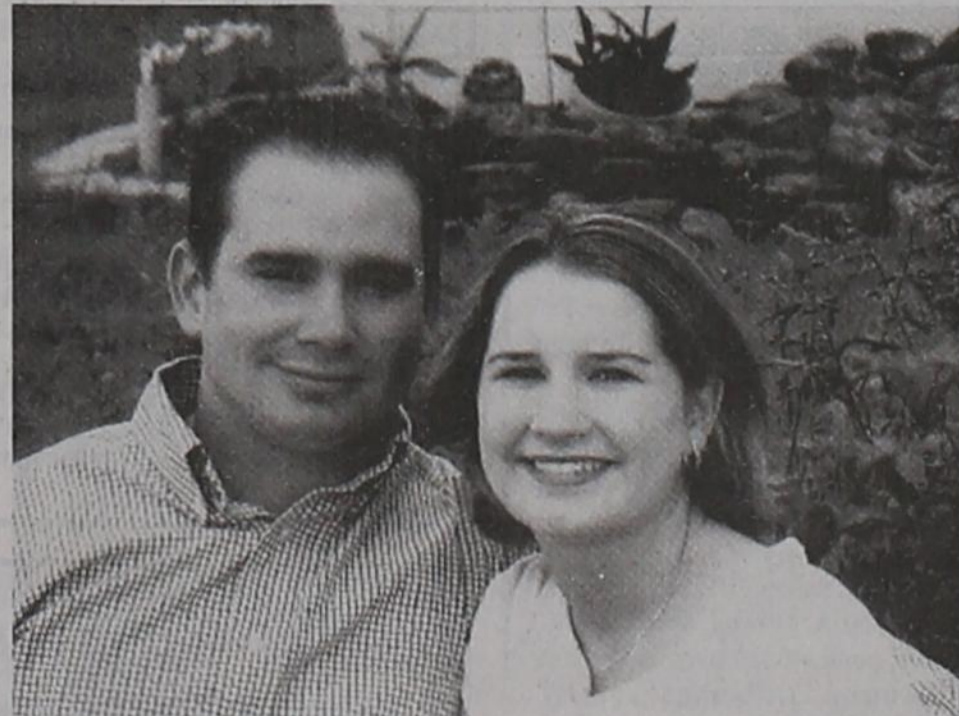
Caitlyn Rainey

**Neva Ross**

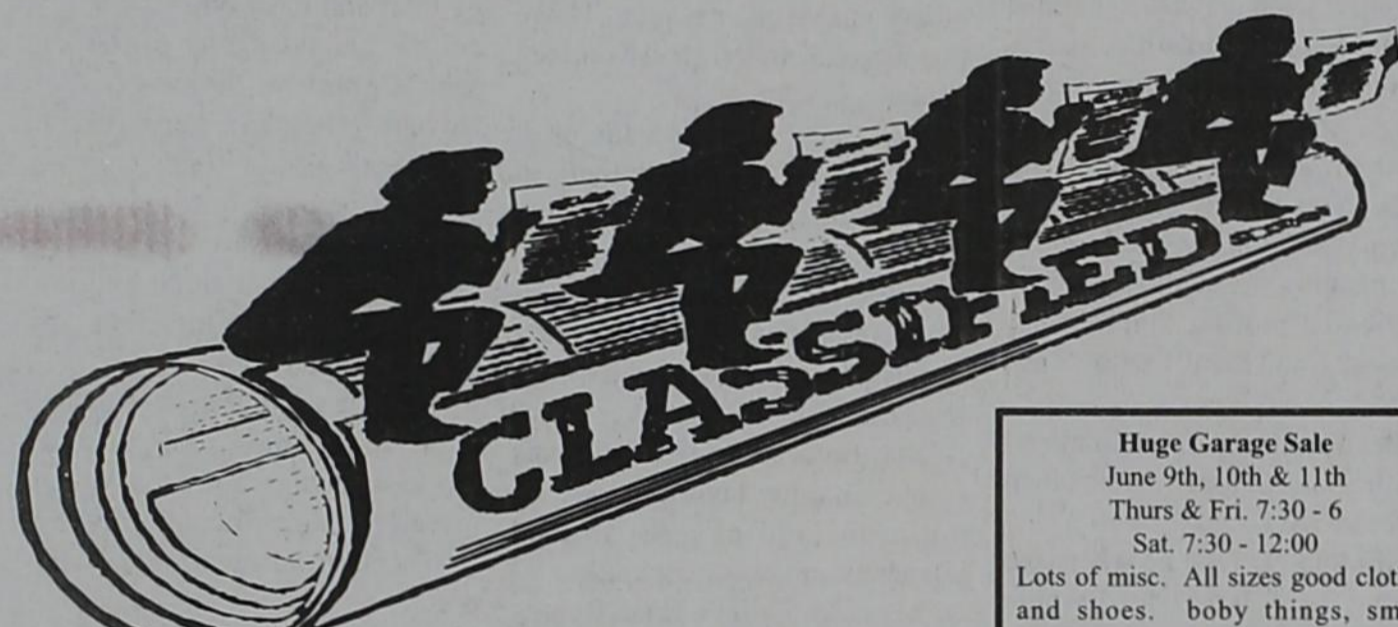

Monda was raised in Carbon and is the daughter of the late Sibyl and Henry Underwood. She is a sister of Edna Powell and Don Underwood of Gorman, Milton Underwood of Eastland and Tincy Gorman of Abilene.

Bill and Monda have positive recollections of Gorman and have visited here often during their married life. The Oldhams met while both were in college at Abilene Christian University. They were married in 1954. Since then both received advanced degrees. Bill has an Ed.D. in Mathematics from the University of Northern Colorado and Monda has an MSE in Art from Harding University. Both have also studied and taught in Europe. Before her retirement Monda served as Chairman of the Art Department and was also an instructor at Harding Academy in Searcy Arkansas. She served as Adjunct Art Instructor throughout her career as well as giving private lessons in painting, glass and sculpture. ## High School Teacher Sentenced For Indecency With A Child

On May 26, 2005, Lelan Jones, 39, a former drama teacher at Boerne High School, was sentenced to seven years in prison and fined \$1,000 in the 91<sup>st</sup> Judicial District Court by the Honorable Judge Steven Herod after entering a plea of guilty to Indecency with a Child.

Prior to that on April 28, 2005, Judge Steven Ables of the 216<sup>th</sup> District Court in Bandera County, handed Jones a sentence of seven years in prison after he pled guilty to having performed oral sex on a male student in his home in Boerne on October 15, 2003.

The Eastland County charge arose out of a Child Protective Services investigation of a teacher at the Boerne High School for sexual abuse of students. The Kendall County Sheriff's Department assisted in the investigation and asked the Eastland County Sheriff's Office to participate once it was determined that an offense had also occurred in Eastland County.

During that investigation, it was discovered that one of the incidents of abuse occurred at Cisco Junior College while Jones was employed as the director of the summer theatre. The victim, a sixteen-year old student, was participating in a play during the month of June, 2003 when the incident occurred, but did not immediately come forward. Once the victim became aware of pending charges against Jones in Kendall County, authorities were contacted. The sentence recommendation was made after consulting with the victim, the victim's family and local law enforcement.

A pseudonym was used in all public files to the take the place of the minor victim's real name in order to protect his/her identity, address and telephone number. Under article 57.01 of the Texas Code of Criminal Procedure, a victim may choose a pseudonym to be used instead of the victim's name to designate the victim in all public files and records concerning the offense, including police summary reports, press releases, and records of judicial proceedings.

## Gorman Police Dept. To Allow ATV Use Only In City Limits Under Conditions

The Gorman police Department will allow the operation of 4-wheelers and 3-wheelers only in the City Limits under certain conditions which are as follows:

1. The operator has a valid driver's license.
2. The operator attaches to the back of the vehicle on top of an eight foot long pole a triangular orange flag
3. The operation of the vehicle occurs in the daytime
4. A person may no operate, ride or be carried on the vehicle unless the person wears a safety helmet that complies with United States Department of Transportation standards and eye protection.
5. A person may no operate a vehicle in a careless or reckless manner that dangers, injures or damages any person, public or private property.
6. A person may not carry a passenger unless the vehicle is designed by the manufacturer to transport a passenger
7. A person younger than 14 years of age who is operating a vehicle must be accompanied by and under the direct supervision of the person's parent or legal guardian
8. A vehicle must have a brake system maintained in good operating condition
9. A vehicle must have an adequate muffler system in good working condition and a spark arrester.
10. A vehicle headlight and tail light are illuminated during any operation
11. A person may not operate a vehicle that has an exhaust system that has been modified with a cutout, bypass, or similar device or the spark arrester has been removed or modified
12. Operation of the vehicle must be within the city Limits of Gorman
13. The operator of a vehicle must yield right-of-way to other traffic on roadway
14. The operator shall obey all traffic laws
15. Any violation of these guidelines is a Class C misdemeanor and a citation will be issued to the operator of the vehicle and/or the parent/guardian

The Gorman Police Department asked that the operators of 4-wheelers and 3-wheelers use good judgment and ride safely.

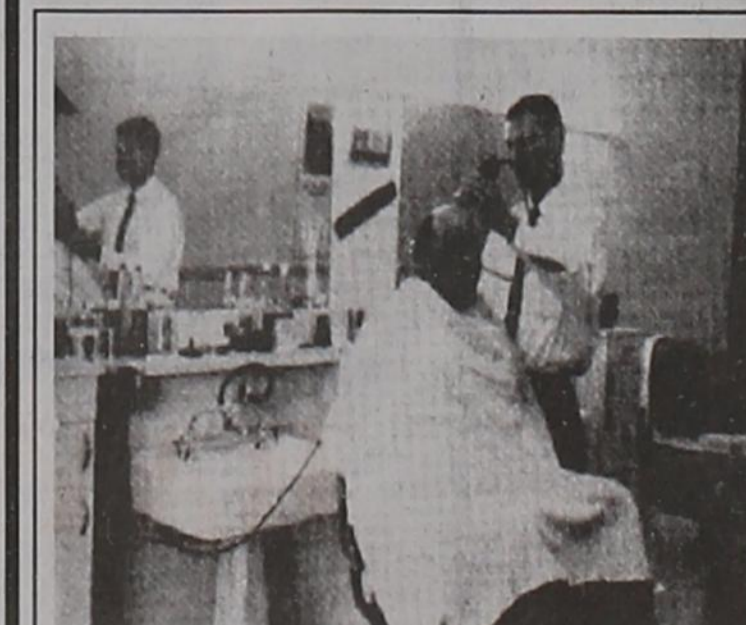
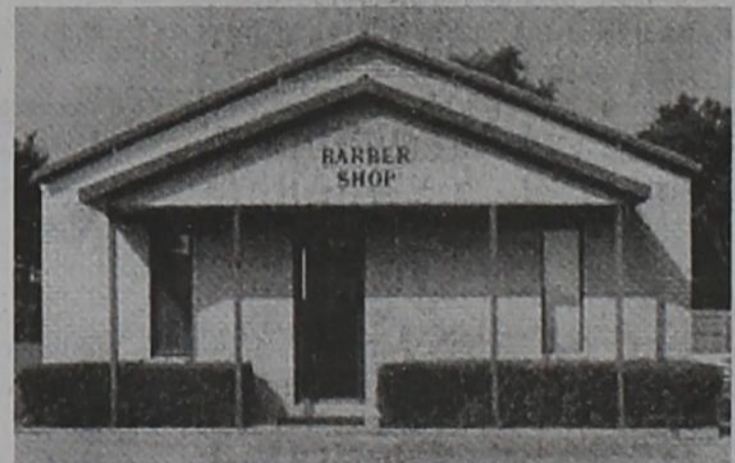
