The Gorman Panthers took the opening kick and drove for a score and really never looked back as they jumped to a 21-14 lead at halftime, then added 13 in the third and 8 more in the fourth period for a strong District win by a 42-14 edge.

On the opening drive the Big Red moved 65 yards in 7 plays with Reggie Sanchez breaking loose and racing 43 yards for the score with 8:12 left in the period. The drive featured runs of 2, 6, 3 and 2 by Matt Underwood and a 4 yard keeper by Tyson Swanner. The run for point failed and Gorman was up 6-0.

But on the first Pirate possession they returned the kick to the Gorman 39 and scored in 5 plays with Keegan Seaton going in from 1 yard out for the score with 5:05 left. Seaton made most of the yardage. Bradley Addison added the point after and Perrin had the lead 7-6. Then after exchanging possessions, they Big Red got the ball on the Perrin 43 on an interception by Matt Underwood. From there the Panthers scored in 7 plays with Sanchez again getting free and racing in from 20 yards out with 9:50 left in the half. The drive featured a 5 yard run by Sanchez, runs of 4, 2, and 7 by Underwood and a 4 yard keeper by Swanner. Swanner hit Zack Fox on a pass for the 2 pointer and Gorman was out front for good with a 14-7 lead. This was impressive to both students and adults alike. His important character message was about dream makers and dream takers. As a recipient of a bachelor's degree from the University of North, Texas, Randall excelled in academics and athletics. He encouraged students to set goals and avoid making negative choices. As he carried elementary students around on his back, he encouraged them to think about how giving in to cheating, drugs, alcohol, tobacco and other choices could make goals hard to reach. Our students continue to talk about the TEAM Impact presentation and the positive character reinforcement.

77 Texas School Districts, 41 Schools **Recognized by Standard & Poor's**

NEW YORK -- Standard & Poor's School Evaluation Services today recognized 77 Texas school districts as academic "outperformers." In a separate have significantly narrowed the achievement gap between higher- and lowerperforming student groups.

dard & Poor's, school districts, over the course of two consecutive school years (2003-04 and 2004-05), had to show a significantly higher percentage of students that scored proficient or above on the state's reading and math tests when compared to other school districts with similar levels of economically disadvantaged students.

Academic achievement levels are compared with the percentage of economically disadvantaged students because educators and researchers have found that there is often a strong correlation between the two indicators.

Registration Deadline Is Nov. 3 For December ACT Test

College-bound high school students can take the ACT college admission exam on December 9, 2006, the next national test date. The deadline for ostmark or online registration is November 3. The late registration deadline is November 16 (an additional \$19 fee is required for late registration). Students can get registration materials from their high school counselor or they can register online on ACT's student website (www.actstudent.org).

ACT scores are accepted by virtually all colleges and universites across the nation, including the Ivy League. The basic ACT exam includes four parts; English, reading, mathematics and science. An optional writing test is also available. Some colleges require or recommend a writing score, but many do not.

The basic exam takes three hours to complete, plus an additional 30 minutes for those who opt to take the writing test.

The basic registration fee for the ACT is \$29. An additional \$14 fee is required for students who choose to take the ACT Writing Test, bringing the total registration fee to \$43 for these students. Free sample tests are available from school counselors and on ACT's website, which also offers additional free practice tests.

The ACT has long been popular in the Midwest, but its popularity is growing rapidly on the East and Est Coasts as students in those areas become aware that it takes less time to take the ACT, the writing test is optional, and virtually all schools that require admissions tests accept ACT scores.

Their success should be commended, and their practices should be more closely examined to illuminate the strategies that can be implemented by educators in other parts of Texas who are working hard to raise the performance of all students."



We held our regularly scheduled board meeting Monday, October 9, 2006 in the high school auditorium. The meeting was called to order at 7:00pm and began in regular fashion with a prayer given by trustee, Daryl Hirst and the Pledge of Allegiance. All trustees, Bobby Rich, Jeff Seaton, Melinda Harrington, Daryl Hirst, Beth Underwood, Larry Thompson, and Mark Simmons were present as well as Superintendent Perry, Principal Panter, Counselor Hampton, and Athletic Director Talbert. Lori Dodd was also present as a guest. Principal Reeves was absent. There were no questions regarding the consent agenda that the board had already reviewed in their packets and it was passed with no discussion other than Mr. Simmons requesting a different format be used in future packets listing checks register.

Superintendent Perry reviewed the fund balances and the tax office report with the board and then Coach Talbert reported on the success of the football team and expressed his good feelings about their future prospects, but emphasized that they had to take it one game at a time, that every week would be a challenge. Then Counselor Hampton reported on her contacts for the last month and went over a schedule of upcoming events in which she and our students will be involved. Superintendent Perry then made a presentation for Mrs. Reeves regarding the Governor's Educator Excellence Award Grant. Mr. Panter then fielded some guestions regarding his report that had been included in the trustee's packets regarding walking the stage at graduation and the beginning of the ZAP Program. Ms. Harrington then reported on she and Mr. Perry' attendance at the TASA/TASB Annual Conference in Houston. She stated the speakers were incredible and the performance of the students was great. The most impressive speaker was retired Coach Gene Stallings. She also discussed the main issues that were discussed at the delegate assembly. Mr. Perry then gave his report. Discussed was: the ordering of an electronic sign, the need for a new football scoreboard that supports 25 second clocks for next year, the need to update the sign on the side of Maxfield Elementary building, possible upcoming bus purchases, property that the school might want to purchase, an open records request from Kenneth Heathington regarding certification of our teachers and specifically the status of our band director. There was one other open records request from David Freeman for a list of delinquent taxpayers for the past five years, a list of the top 25 tax payers with the amount of tax they pay, the number of students that attend GISD that live outside the district, and a copy of the complete tax roll. He then discussed the scheduled public meetings to be held on October 25th at the Community Center at noon and the other on October 30th at 6pm at the high school auditorium. He requested that some board members be present at both meetings but not more than three. He also informed them that representatives from Cadco, DSA, and First Southwest Company would be present at the meetings to answer any questions the public had about the proposed building project that would be funded by the bond election. Lori Dodd reported the final figure of spending on the park project. She overcome obstacles as they work to achieve their greatest aspirations.


There being no further business for discussion Joe made the motion to adjourn with a second from Don. Motion carried 3-0, time was 6:40 p.m.
