

#### Texas Landmark To Receive Recognition -**Gorman's Blackwell Hospital To Be Dedicated**

#### Dr D.V. Rodgers to be Recognized In Memoriam

If you are from this part of the country and are between the age of 28 and 87, there is a good chance you or someone you know was born in the Blackwell Hospital in Gorman, Texas. Whether you were born there or are simply interested in a significant part of Texas history, you won't want to miss the dedication ceremony for this Texas landmark.

The hospital was founded in 1919 by two brothers, George and Edward Blackwell. This was a period of extensive growth in the north Texas area due to the large oilfields nearby. The hospital made a tremendous impact on the county and surrounding area. New physicians added to the staff included Dr. David V. Rodgers (1910 - 1971), George Blackwell's son in law who joined the staff in 1938. His contribution to the hospital will be recognized with a memorial marker.

Make plans now to attend the dedication ceremony for the Blackwell Hospital Historical Marker and the Dr. D.V. Rodgers Memorial marker following the 10:00 AM Peanut Festival Parade on Saturday, September 9, 2006 in Gorman, Texas. The Blackwell Hospital Historical Committee is in charge of events. The dedication will take place at the hospital site on West Roberts Street in Gorman.





## ORDINANCE NO. 2006-04

AN ORDINANCE OF THE CITY OF GORMAN, TEXAS, LEVYING TAXES FOR FISCAL YEAR BEGINNING OCTOBER 1, 2006 AND ENDING SEPTEMBER 30, 2007: PROVIDING DIS-COUNTS FOR ADVANCE PAYMENT OF AD VALOREM TAXES; PROVIDING FOR THE COL-LECTION OF DELINQUENT TAXES; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, notice of a regular meeting with the adoption of a tax rate was duly posted on the

WHEREAS, a regular meeting was duly held at the time and place as provided for in the notice of such meeting and all interested persons were given opportunities to be heard on said tax rate;

WHEREAS, it is necessary, at this time, that said ordinance be passed levying taxes on all property, both real and personal, within the City of Gorman, Texas, in accordance with such budget and all requirements of Article 7244c RCS of the State of Texas have been complied with:

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GORMAN, TEXAS, AS FOLLOWS:

Section 1: That there is hereby levied, and there shall be collected for the use and support of the municipal government of the City of Gorman, Texas, for the year 2006 upon all property within the corporate limits of the city of Gorman, Texas, subject to taxation for the year 2006, a tax at the /100 dollars on each One Hundred and no/100 (100.00) valuation of property to be assessed and collected for the purposes hereinafter stipulated, to-wit,

Section 2: All taxpayers shall be allowed discounts for the payment of 2005 ad valorem taxes due to the City of Gorman, Texas, said discounts to be allowed under the following condi-

(a) Three percent (3%) discount on ad valorem taxes due to the City of Gorman, if same are paid within the month of October,

Section 3: The general laws of the Texas, and all provisions of Article 7336, and of Titla 122 of the Revised Civil Statutes of Texas, penalties, interest, cost, and the collection of delinquent taxes, insofar as such provisions may be applicable in connection with the collection of all taxes assessed and levied by the City of Gorman, Texas, for the year 2006 are hereby referred to and

Section 4: This Ordinance shall take effect and shall be in full force and effect from and after



#### Local Man Receives Heart Transplant

David McCann, a lifelong Stephenville resident received his long awaited heart transplant at St. Paul University Hospital in Dallas on July 27th.

It has been a uphill battle for the McCann family since his first heart attack 2001 which left David unable to work. He had been an employee of Rayloc for nearly 30 years. His second heart attack in November 2004 resulted in severe damage to the left side of his heart which led to emergency surgery in December of that year. His condition deteriorated rapidly and so did his quality of life. The simple activities of daily living left him exhausted and struggling to catch his breath. He was in and out of the hospital for months. In April 2005, David returned to St. Paul where he underwent a relatively new life saving procedure known as Left Ventricular Assist Device (LVAD), which is basically a electronic or battery operated heart pump. His family had to be educated and certified on the use of the machine in order for him to return home. After his return home, he had to be monitored 24 hours a day. His strength and stamina improved over the coming months, but still he exhausted easily.

With all the physical and financial hardship David has gone through over the past 5 years, he still keeps his chin up, his spirits high and is quick with a smile. When asked how he does it, he simply stated "I love my life. I want to be here for my family. I want to watch my grandchildren grow up. I want to be there for their birthdays, their Christmas', their weddings. When I look into their little faces, I will myself to live, and if it is in God's plan, I will."

It is apparent that family has always played a important role in David's life. He grew up in a 2 bedroom house with 9 brothers and sisters. In 1971 David joined the army. For 2 years he was stationed in Thailand where he worked as a supplies and deport coordinator. In 1973 he returned home and went to work for Rayloc. After his father passed away, he moved his mother into his home and was continuously involved in her care until she passed away of liver cancer in 1987. He married his wife Jeannette in 1983 and adopted her 3 year old son, Ricky. Jeannette and David had another child, Candra Sue McCann in 1984, but she died 4 days later from complications from her birth. Jeannette was injured in a car accident a few years later which left her unable to work or even drive. Ricky is now a grown man, married with two young children of his own, McCayla 7 and Jarred who is 3.

Since the heart transplant, David's health has improved tremendously. He said "He truly felt blessed to get a second chance at life." He also said "His mind is clearer than it has been in years, and he feels younger than he has in years." He is excited that the doctors told him he could probably return to work in a year. For him, being able to once again provide for his family by the labor of his own hands and the sweat of his brow as he used to is a blessing in itself. David is way too proud to ask for a helping hand, as he has lived his life by what he could afford on his own. The expenses are mounting and David and his wife have to stay at St. Paul for at least 3 months. That puts the McCann's coming home around the holidays. David has spent the last several holidays in the hospital struggling for his life. If ever anyone deserved some help, it would be this family. Holidays are hard enough even without the load of medical bills, medications, the responsibility of keeping of the cost of the home in Stephenville and the cost of living in the guest house located near the hospital in Dallas. This article is being written and sent to the local papers in hope that the Lord will give me the right words to encourage the editors to print this article. If it reaches print, I pray that this reaches people with the talent and organizational skills to put together fund raisers, garage sales, bake sales, auctions whatever they can think of to raise money for this family's great need. Anyone associated with a church, civic group or organization that could afford a monetary gift or fund raiser would be greatly appreciated. Maybe even teachers could make time for their students to make letters or cards to send to David while he recuperates and the holidays approach. 216 Texas Counties Qualify For Livestock Assistance Because of Drought

AUSTIN – Agriculture Commissioner Susan Combs today announced that livestock producers in 216 drought-stressed Texas counties may be eligible for \$14.5 million in assistance under the recently announced federal Livestock Assistance Grant Program. The livestock block grant is part of a broad-based national drought disaster assistance program for American farmers and ranchers announced by the U.S. Department of Agriculture this week.

USDA will distribute \$50 million in state block grants to 20 states to help livestock producers recover losses suffered because of the ongoing drought. Assistance may cover such items as the cost of lost forage, supplemental feeding, the cost of relocating livestock to new pastures and the cost of emergency water supplies.

The Texas Department of Agriculture is working with statewide agriculture and livestock groups to establish the criteria for distributing the funds in Texas.


"The funds released by USDA will provide a much-needed infusion of dollars to Texas producers devastated by the ongoing drought," Combs said. "With the entire state facing unprecedented economic setbacks because of this year's drought, I appreciate all that Agriculture Secretary Mike Johanns has done to help our hardworking producers recover some of their losses during these desperate times.

"We will be working closely with our livestock groups, the Governor's Office and USDA to set up the criteria, announce a sign-up period and distribute the funds from the block grant to our producers as quickly as possible," Combs said.

Only livestock producers in the eligible counties who suffered a loss of forage production because of the 2006 drought may receive assistance. Payments are limited to \$10,000 and cannot exceed the amount of lost forage production and related losses.

Brandon Powel Chooses Locations In and Around His Hometown to Film His Debut Movie

Who would have thought that Gorman would be a backdrop to a movie intended for distribution? I would guess the answer is 'nobody.' Still, next summer Brandon Powell is shooting his first feature length movie, "Trial By Self," in and around Gorman. "The area is absolutely perfect for the story," Brandon said with a shrug as he talks of his first feature, "...besides, it is an extremely personal story and this is where I grew up. It simply makes sense for me to shoot this movie here. Shooting it anywhere else would be a compromise I am not prepared to make."

Brandon is currently a senior at Howard Payne University in Brown-wood and goes by the name Devon (pronounced Devin) but this is simply a nickname, "I think the name confuses a lot of people in Gorman they hear it," Brandon says laughing. He will not be graduating in however because of scheduling conflicts. The movie is very low budget but a low budget movie is still expensive, "I am a lot closer to having the money to shoot it but I am short \$2,000 dollars. I will be earning this money between now and then. The crazy thing is that after I shoot {the movie} I will need to earn more money to edit it, make film prints and then travel the festival circuit in order for it to get picked up!" He seems upbeat about it though, as if he knows things will work out, "Anything worth doing is difficult and is worth working for. It is easy to get agitated about it but I am doing it. Most people don't get to make their dreams come true. I am very lucky. I have family that supports my crazy endeavors and what else can I really ask for?"

Gorman residents who want to help Brandon with this project in any way can do so. "It will take a village to shoot this movie," he says dryly. "I have raised a lot of interest around HPU and I will probably hold auditions for actors either right before or right after Christmas break. There are roles for anyone from people in their 30s or 40s, to High School and college aged kids. If anyone in town, especially men and women in there 30s and 40s would like to act in a movie they are urged to audition. People have shown a lot of interest in acting as crew members too. It is a good experience for College students I think." As far as the \$2,000 dollars goes he doesn't seem worried at all, "I am applying for jobs on campus at Howard Payne and I might have a fundraiser. It isn't such an outrageous amount really. The post production will be the expensive part. I already have some of my equipment bought. The camera alone was the price of a car! I didn't think I would be this far."

Anyone who wants to donate any amount of money to Brandon in order for him to raise the \$2,000 is welcome to. "Of course I would accept donations! Who wouldn't? When you think about it, even donations in the amount of a dollar would add up. I wouldn't count on donations to get me the money but I would accept them and I would also include those who gave money to the film in the credits."
