The Gorman Panthers opened the season on a winning note Friday night when they hosted the Evant Elks at Brogdon Field. The Big Red scored 12 points in the first quarter and added 8 more in the second for a 20-0 halftime lead. They added 7 in the third and 13 in the fourth for a 40-0 win.

After holding the Elks on their first possession with an interception by Matt Underwood, the Panthers moved 58 yards in 5 plays with Keifer Wilson catching a Tyson Swanner pass for 25 yard score with 9:15 left in the first. The kick for point failed and the Panthers were up 609. The drive featured a 21 yard run by Underwood and an 8 yard run by Drew McCreless.

After stopping the Elks on their next possession the Big Red got the ball on their own 43 and scored in 8 plays with Matt Underwood getting the final 12 yards on a run with 2:21 left in the quarter. The kick for point again failed and Gorman was up 12-0. The drive featured a pass of 18 to Matt Underwood, runs of 1 and 15 by Justin Little, runs of 4 and 8 by Underwood and 8 yards by Swanner.

On their next possession the Panthers took the ball on their own 29 and scored in 10

## New Home/Remodeling County Inspection

Program Law Takes Effect September 1  
INSPECTIONS DESIGNED TO CATCH PROBLEMS BEFORE HOMEBUYERS MOVE IN

Starting Labor Day, builders and remodelers must have the fruits of their labor inspected at least three times, if the project does not require inspection by a city building official.

House Bill 1038, passed by the 2007 Legislature, created a County Inspection program for all homes built or remodeled if the work was performed in unincorporated areas or in cities that do not offer municipal inspections. In anticipation of the program's Monday start date, the Texas Residential Construction Commission has been designing the program rules and signing up fee inspectors.

The three new inspections include a foundation inspection before concrete is poured, a framing and mechanical systems assessment before wallboard is installed and a final inspection upon completion.

The inspections must be performed by a fee inspector that is either a licensed engineer, a registered architect, a professional Texas Real Estate Commission inspector or a third party inspector certified by the Texas Residential Construction Commission. To access a list of fee inspectors that have already registered with the commission, visit <http://cics.trcc.state.tx.us/login.aspx>.

Commission Executive Director Duane Waddill said the new program works toward providing quality construction for Texans by bridging an oversight gap that, until now, existed for new homes or remodeling jobs where the home had no city inspector obligated to evaluate the work.

"This program will ensure that inspections are performed throughout the state of Texas, leveling the playing field for consumers. These inspections will provide homebuyers in unincorporated areas or in cities that do not offer municipal inspections with the protection that their home was constructed with the same standards as a home within city limits," Waddill said.





Based on last year's tax rate of \$.84 (preceding year's adopted tax rate) per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$186.56 (tax on average taxable value of a residence homestead in the taxing unit for the preceding tax year, disregarding residence homestead exemptions available only to disabled persons or persons 65 years of age or older).

The average taxable value of a residence homestead in Gorman this year is \$22,539 (average taxable value of a residence homestead in the taxing unit for the current tax year, disregarding residence homestead exemptions available only to disabled persons or persons 65 years of age or older). If the governing body adopts the effective tax rate for this year of \$.91481 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$206.18 (tax on average taxable value of a residence homestead in the taxing unit for the current tax year, disregarding residence homestead exemptions available only to disabled persons or persons 65 years of age or older).

If the governing body adopts the proposed tax rate of \$.987 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$222.45 (tax on the average taxable value of a residence homestead in the taxing unit for the current tax year, disregarding residence homestead exemptions available only to disabled persons or persons 65 years of age or older).

Members of the public are encouraged to attend the hearings and express their views.



### New Law Promotes Free Marriage Education Classes

*Couples Who Complete Courses Can Waive Marriage License Fee, Waiting Period*

The Texas Health and Human Services Commission (HHSC) is spreading the word about a new state law, which takes effect September 1st, the encourages couples to attend free marriage education classes before applying for a license. Couples who complete the skills-based course will pay less for their marriage license.

House Bill 2685 increases the marriage license fee to \$60. However, the fee will be waived for couples who complete an eight-hour premarital class, and those couples can forgo the 72-hour waiting period to get married. Counties may continue to charge up to \$12 in local fees for a marriage license.

The state's initiative, called "Together in Texas," promotes free marriage education classes that provide eight hours of training on communication skills, conflict resolution and other elements of a healthy marriage.

Starting September 1st, couples who complete a class will receive a certificate that they will take to their County Clerk when they apply for their marriage license. The certificate is good for one year and serves as proof that the couple is eligible for the discounted marriage license fee.


