Panthers Outrun Bulldogs; Host Tolar Rattlers Friday

The Gorman Panthers journeyed to Ranger on Friday night to take on the Bulldogs in District play. Neither team scored in the first quarter but the Panthers spotted the Bulldogs 6 points in the second period before getting cranked up and scoring 13 points before intermission for a 13-6 score. The Big Red then added 7 in the third period and another 12 in the final period for a 32-19 score.

The Bulldogs opened the scoring in the second period when they got a Panther fumble on the Gorman 42 and in one big explosive pass play scored the TD with 9:54 left. Ewing hit Justin Krantz for the score. The kick try failed and Ranger was up 6-0.

Then after holding the Bulldogs on their next possession the Big Red got the ball on their own 38 and scored in 6 plays with Ben Burgess going in from 6 yards out with 2:29 left. The kick failed and the score was tied at 6-6. The drive featured a 44 yard pass to B.J. Ramirez, an 11 yard run by Burgess and 2 runs of 2 and 5 by Ramirez.

The Panthers came back on their next possession when they recovered a Bulldog fumble on the Ranger 31 and went the distance in just 2 plays with a 12 yard run by Burgess and the scoring run of 19 by Burgess with 35 seconds left in the half. Ramirez added the point after and Gorman enjoyed a 13-6 advantage at the intermission.

Both bands did a good job with their performances and the Panther Marching Band did they routine that they were to do at the Band Contest.

The Panthers came out ready to play after the break. They took the ball on their own 35 and moved the distance in 9 plays with Ramirez getting the honors from 8 yards out with 8:01 left. Ramirez added the point after and Gorman was up 20-6. The drive featured runs of 14, 13, 5, 11, 2 and 2 by Ramirez and 6 by Burgess.

The Bulldogs came back on a drive of 80 yards, scoring in 10 plays with T.J. Ewing getting the final 1 yard on run with 10:12 left in the 4th. Ewing added the point after and the score was 20-13.

The Bulldogs got the ball with a on-side kick at the own 42 and scored in 4 plays with the Ewing scoring on a 25 yard pass with 8:57 left. The kick failed and the score was 20-19.

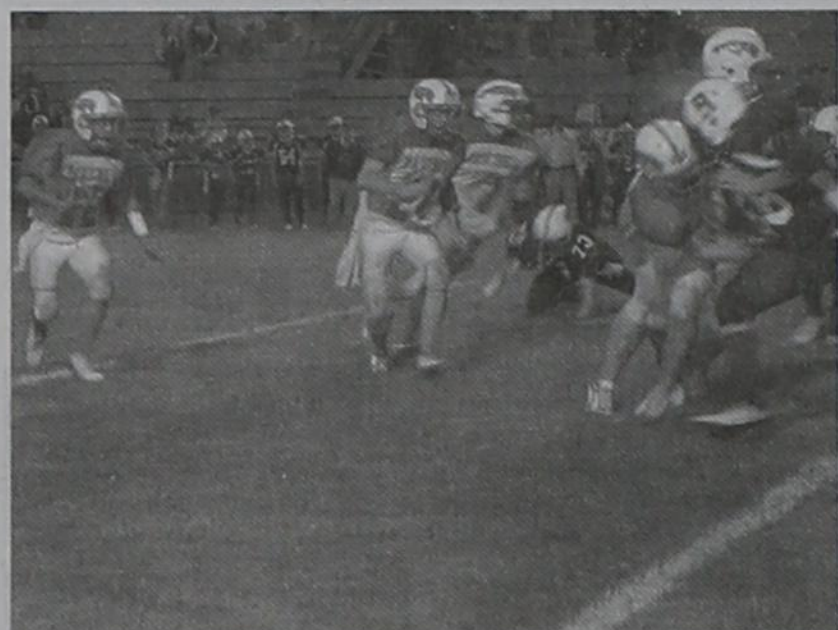
However, the Big Red answered right back with a 60 yard drive in just 3 plays with Ramirez getting the final 48 on a thrilling run with 7:33 left. The kick failed and Gorman led 26-19.

After holding the Bulldogs on their next possession the Panthers got interception on their own 27 and scored in 7 plays with Ramirez getting the final 37 on a great run with 1:09 left. The kick failed and Gorman enjoyed a 32-19 edge. The drive featured a 17 yard gallop by Justin Little, and runs of 8, 4, 1, and 13 by Ramirez, and a 3 yarder by Burgess.

Ramirez led the Panthers with 174 yards on 24 carries. Burgess got 80 on 13 and Little got 24 on 5 carries.

Gorman will host Tolar on Friday night in another District Contest. The Rattlers have a very good team, but the Panthers always play the Rattlers very tough. So come on out and back the Panthers to Victory.

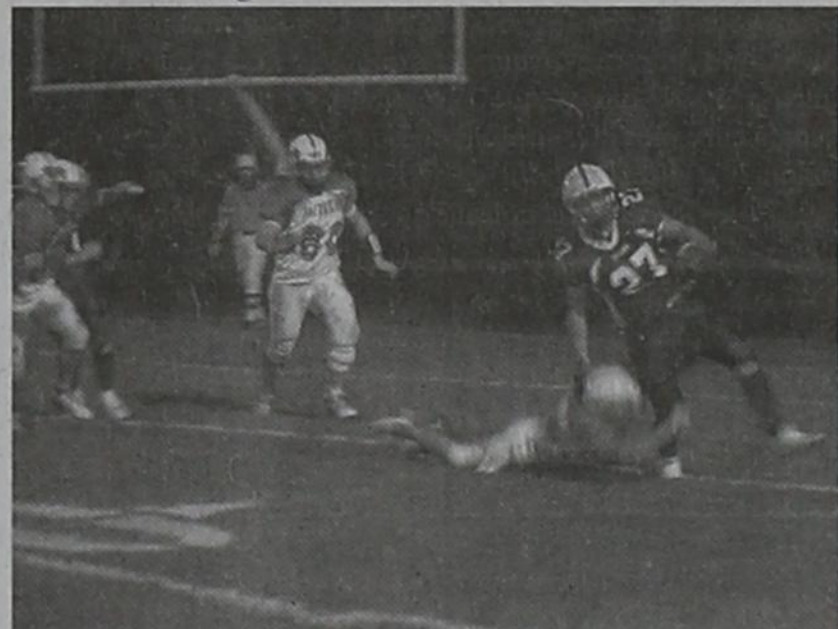

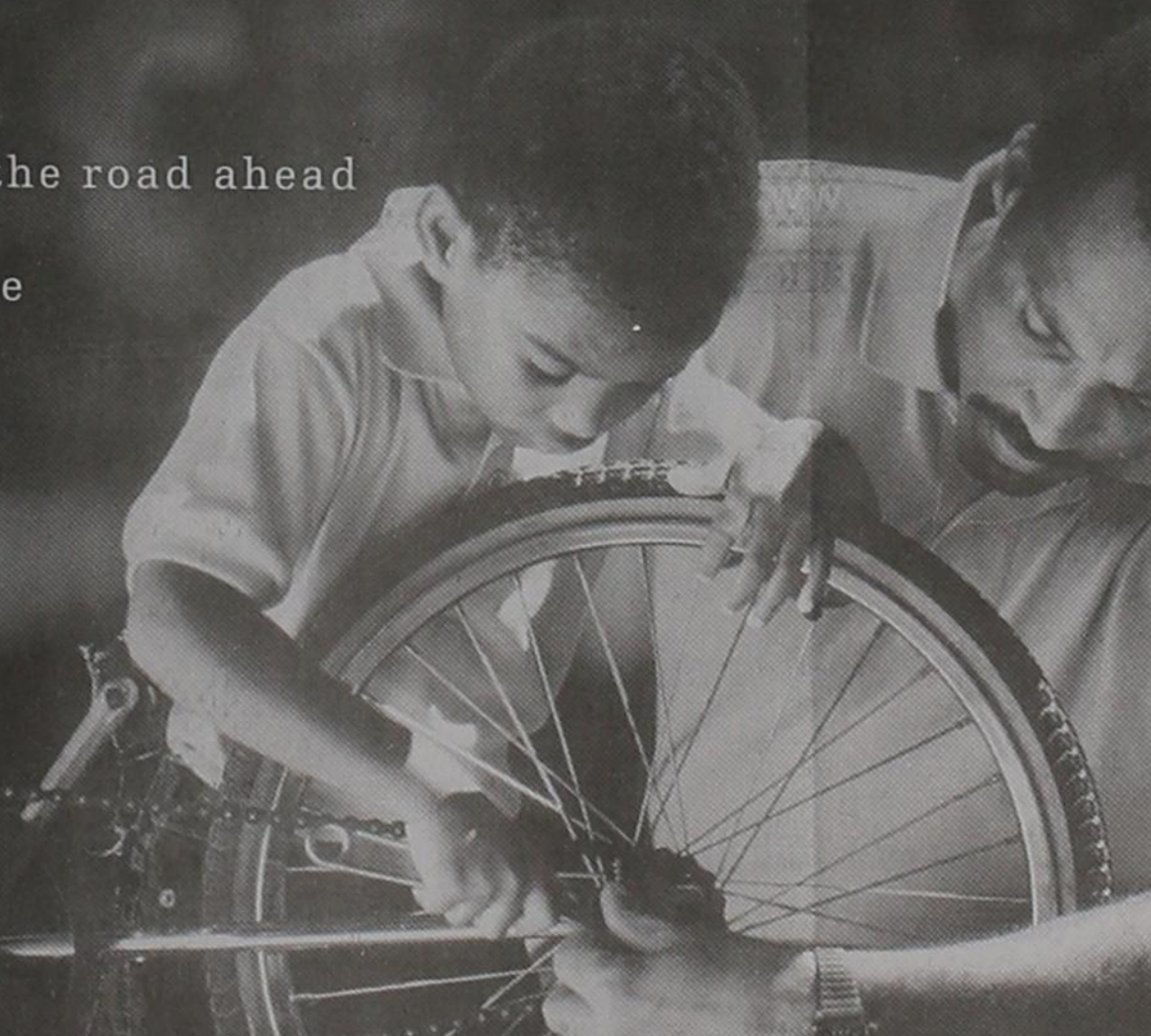

2010 Direct and Counter-cyclical Program Sign-up Begins

Enrollment for the 2010 Direct and Counter-cyclical Program (DCP) and the Average Crop Revenue Election (ACRE) program has begun and will continue through June 1, 2010.

USDA computes DCP Program payments using base acres and payment yields established for each farm. Eligible producers receive direct payments at rates established by statute regardless of market prices. For 2010, eligible producers may request to receive advance direct payments based on 22 percent of the direct payment. USDA will issue advance direct payments beginning Dec. 1, 2009. Counter-cyclical payment rates vary depending on market prices. Counter-cyclical payments are issued only when the effective price for a commodity is below its target price. The effective price is the higher of the national average market price received during the 12-month marketing year for each covered commodity and the national average loan rate for a marketing assistance loan for the covered commodity.

The optional ACRE Program provides a safety net based on state revenue losses and acts in place of the price-based safety net of counter-cyclical payments under DCP. A farm's payment is based on a revenue guarantee calculated using a 5-year average state yield and the most recent 2-year national price for each eligible commodity. For the 2010 crop, the 2-year price average will be based on the 2008 and 2009 crop years.

An ACRE payment is issued when both the state and the farm have incurred a revenue loss. The payment is based on 83.3 percent (85 percent in 2012) of the farm's planted acres times the difference between the State ACRE guarantee and the state revenue times the ratio of the farm's yield divided by the state expected yield. The total number of planted acres for which a producer may receive ACRE payments may not exceed the total base on the farm. In exchange for participating in ACRE, in addition to not receiving counter-cyclical payments, a farm's direct payment is reduced by 20 percent, and marketing assistance loan rates are reduced by 30 percent.

The decision to enroll in the ACRE Program is irrevocable. The owner of the farm and all producers on the farm must agree to enroll in ACRE. Once enrolled, the farm shall be enrolled for that initial crop year and will remain in ACRE through the 2012 crop year.

The June 1, 2010, deadline is mandatory for all participants. USDA will not accept any late-filed applications.

Gorman City Commission Minutes

OCTOBER 15, 2009

The Gorman City Commission met on Thursday Oct. 15, 2009 @ 5:30 p.m. Those present were Mayor Robert Ervin, Commissioners Nathan Files, Joe Casey, David Stanley, and Durward Webb. Others present were Glenn Scitern, Trace Gortt, Shirley Lewis, Franklin Fenley, Jim Baker, Bill Kendall, Ron Holliday, Mark Pipkin, Terry Simmons, Charlie Torrez, Stephen Watson, and Larry Vernon.

Durward led the opening prayer followed by the Pledge of Allegiance and the Texas Pledge.

Mayor Ervin called the meeting to order @ 5:35 p.m.

David made the motion to approve the minutes as read, with a second from Joe. Motion carried 4-0.

Joe made the motion to approve the bills for payment. Durward made a second. Motion carried 4-0.

Shirley Lewis was present to discuss the water odor and discoloration she has at her Brandon Place apartment. Glenn is to flush lines in that area and find out if anyone else is having this problem and to get a water sample from Ms. Lewis' residence.

Mr. Franklin Fenley was present to discuss his current water bill. Mr. Fenley felt that although he had had a leak the month before, that this could not be a correct reading. He wanted the Commission to consider possibly making some adjustments. Glenn reported that he had already replaced the meter and it would be monitored.

Jim Baker, Bill Kendall, Ron Holliday, Mark Pipkin, Terry Simmons, Charlie Torrez, Stephen Watson, and Larry Vernon were present to discuss the need for more funding to be provided by the County for the eight fire departments. The County currently allocates \$12,500 to each fire department. The City of Eastland and Cisco have jointly prepared a letter addressed to Judge Rex Fields expressing the need for the county to take steps towards assuming the responsibility for rural fire protection. This letter also expressed gratitude for the current funds that are distributed, the aid given to Carbon, as well as the statement made that county residents should aid in paying a fair share of emergency costs. The letter goes on to state that their departments will continue to respond to calls outside their jurisdictions for the allocated amount of \$12,500 for this fiscal year. Due to costs exceeding the current allocated amount they will continue to provide service for the fiscal year beginning October 2010, but would require \$20,000, and for the 2011 fiscal year \$30,000. And concluding that hopes are for diligence in finding means to support rural fire protection. This letter is scheduled to be released to Judge Fields on October 16, 2009. Ron Holliday and Mark Pipkin stated that if Gorman wants to be included in this joint letter, they would gladly push back the date, and include Gorman.

Mayor Ervin thanked those in attendance for this presentation and asked that we have the opportunity to discuss the matter and we would let them know on Friday the 16th the City's decision.

The Commission discussed this joint letter, and decided not to join in with the City of Eastland and Cisco at this time. It was agreed that there is definitely a need for more funding for rural fire protection, and the County must diligently continue to work towards finding a source to resolve this issue. This matter cannot be "put on the back burner". However, the City of Gorman will convey its own thoughts to Judge Fields.

An invitation was presented for the Mayor and City Commission by the Gorman Chapter #443 Order of the Eastern Star to attend a celebration of the chapter's 100th anniversary. Further more, Mayor Ervin signed a Proclamation to proclaim that Sunday November 8, 2009 as a day of celebration for the Gorman Chapter No. 443 Order of the Eastern Star.

The Commission discussed some issues of concern with Glenn and Trace.

There will be more use of the chipper. A schedule for use and location will begin on Monday. Residents will be notified.

Amendments to City Ordinances #286 and #289 were read. Amendment to ordinance # 298 amends the penalty up to \$500 and amendment to ordinance # 286 amends the speed limit on McCall Street to 20MPH, and penalty up to \$500. David made the motion to pass, approve and adopt these amendments. Joe made a second. Motion carried 4-0.

David made the motion to retain Jacob & Martin Engineering for the SEDCO grant funds. Joe made a second. Motion carried 4-0.

David made the motion to adopt Resolution #10-15-2009. A resolution stating the intent for the City of Gorman to accept funds from the Energy Efficiency and Conservation Block Grant. And that the City of Gorman will comply with the requirements. Nathan made a second. Motion carried 4-0.

Nathan made the motion to raise the Staff water rate to the contract agreed 20% above the City's cost. Joe made a second. Motion carried 4-0.

There being no further business for consideration or discussion David made the motion to adjourn. Nathan made a second. Motion carried, time was 8:05 p.m.

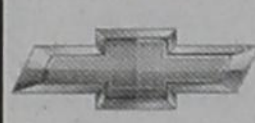
