President Obama ran on Hope and Change. We got that from him.


We hope we don't lose our jobs and homes and the change is we went from under President Bush to worse under President Obama.





ful wife, mother, grandmother and great-grandmother. She loved her family dearly and was a wonderful friend to many.





Multi County Cotton Management Seminar

Texas AgriLife Extension Service in Comanche, Erath and Eastland County will host a Cotton Management Seminar on February 2, 2012 at the Highway 6 Café in De-Leon. Registration will begin at 9:30 a.m. and the program will start at 10:00 a.m. A sponsored meal will be provided at noon and the meeting will conclude at 3:00 p.m.

Dr. Gaylon Morgan, State Cotton Specialist will discuss variety selection and provide discussion on the variety trial conducted across the state. Dr. Paul Bauman, Extension Weed Specialist will provide information on weed management for cotton production including management plans to avoid glyphosate resistance weed development. Dr. John Robinson, State Cotton Economist will discuss market outlooks and marketing your cotton in 2012. 



Drinking Water: An Invaluable Resource Taken for Granted

(NU) - You turn on the tap, and water comes out. Period. Safe, plentiful and affordable drinking water is one of our nation's most precious resources and something most of us take for granted.

But what if you turned the tap and nothing happened, or if the wa-ter you drank made you sick? While pouring a glass of water

may seem simple, before it arrives at your tap there is a complex process of collecting, storing, treat-ing and distributing that helps en-sure its availability and quality. In fact, water utilities implement comprehensive water management plans to ensure that adequate amounts of drinking water are available. These include conservation and reuse, reclamation and

sourcing strategies.

Drinking water supplied by utilities is always treated to remove contaminants and harmful microorganisms. That treatment process typically consists of clarification (to remove dirt and other particles), filtration (to remove even smaller particles) and disinfection (to kill bacteria and most viruses). The water is then delivered to residential and commercial customers via an extensive pipe network.

Drinking water utilities are committed to protecting public health and constantly monitoring and reassessing their methods for treating water to ensure its quality. In part, this is due to changing government regulations, which periodically alter water quality standards. In addition, they may undertake other forms of treatment



an extensive cleaning process before it arrives at your tap.

not expressly required to comply with regulations in order to ensure that drinking water meets and often exceeds the standards and needs of local communities.

For example, they may seek to remove trace compounds that are not currently regulated, and to enhance the aesthetic quality of the Drinking water utilities carry

out these services while also managing costs and minimizing environmental impacts of their processes; they are committed to keeping drinking water affordable. Water utilities and other stakeholders invest more than \$12 million each year in the Water Research Foundation to sponsor research that enables water utilities, public health agencies and other professionals to provide safe and affordable drinking water to the public.

So the next time you pour a glass of water from the tap, take a moment to honor the commitment and significant investment made to ensure the quality of that water.



Business Personal Property Rendition Due By April 16, 2012

The following is provided to Eastland County business owners as a reminder that business personal property renditions must be filed with the Eastland County Appraisal District by April 16, 2012.

Section 22.01 of the State Property Tax Code requires that all business personal property be rendered each year.

A new section of the code added by the 2004 Texas Legislature imposes a penalty of ten percent (10%) for all renditions not timely filed by the April 15 dead-

In an effort to assist business owners in meeting this requirement; rendition forms were mailed out in January, 2012 to all know Eastland County business owners. If you own a business and have not received a rendition form; please contact the Eastland County Appraisal District at (254) 629-8597 in Eastland, Texas. The Eastland County Appraisal District Office is located on the second floor of the Eastland County Courthouse Annex Building at 102 N. Lamar in Eastland, Texas.

A "business personal property rendition" is a report to your county appraisal district that lists all the taxable property the business owned or controlled as of January 1, 2012.

Who must file a rendition?

You must file a rendition if you own tangible personal property that is used to produce income - Such as the inventory and equipment used by a business. If you render late, do not render or file an incomplete or false rendition, a 10 percent to 50 percent penalty may be imposed. Are There Any Advantages To You?

The advantages of filing a rendition are:

(1) You give your opinion of your property's va;ie The apprasial district must notify you in writing of any value change and explain how you can protest that value to the appraisal review board.

(2) You record your correct mailing address so your tax bills will go to the right address. If your bill is mailed to the wrong address, the law still holds you responsible for paying your taxes on time or paying extra charges for late payments.

(3) You can also file a "report of decreased value" to notify the appraisal district of significant depreciation of the value of your property in 2011. The district will look at your property before assigning a value in 2012.

What's the deadline to file?

The Last day for filing 2012 renditions is April 16, 2012. You can get an automatic extension to May 15, 2012 (or the next business day if a weekend) if you ask for it in writing on or before the April 16, 2012 deadline. The chief appraiser may grant an additional 15 days after May 15, 2012 for an owner who shows good cause in writing.

File renditions with the Eastland County Appraisal District which is located in the Eastland County Courthouse Annex Building at 102 N. Lamar in Eastland, Sandra Cagle was with us to visit, especially with Texas. The office is on the second floor and the telephone number is (254) 629-8597.
