USDA Reminds Producers of Approaching CRP General Sign-up

WASHINGTON, Mar 7, 2012 — U.S. Agriculture Secretary Tom Vilsack today reminded landowners, farmers and ranchers that the opportunity to enroll in the Conservation Reserve Program (CRP) general sign-up 43 is approaching. Producers who want to offer eligible land for CRP's competitive general sign-up can enroll March 12 through April 6, 2012, at the Farm Service Agency (FSA) service center.

CRP is a voluntary program that assists farmers, ranchers and other agricultural producers to protect their environmentally sensitive land. Producers enrolling in CRP plant long-term, resourceconserving covers in exchange for rental payments, cost-share and technical assistance.

Producers are encouraged to contact their local FSA service center or visit FSA's website at http:// www.fsa.usda.gov/crp for additional information regarding CRP.



"On The Wilder Side"

I know it's a bit brainy, but I thought you might be interested in how the Greek-English Lexicon defines the various words for "love"

Eros is passionate love, with sensual desire and longing. The Modern Greek word "erotas" means "(romantic) love". However, Eros does not have to be sexual in nature. Eros can be interpreted as a love for someone who you love more than the Philia love of friendship. It can also apply to dating relationships as well as marriage. Plato refined his own definition. Although eros is initially felt for a person, with contemplation it becomes an appreciation of the beauty within that person, or even becomes appreciation of beauty itself. It should be noted Plato does not talk of physical attraction as a necessary part of love, hence the use of the word platonic to mean, "without physical attraction".

Philia, means friendship in modern Greek, a dispassionate virtuous love, was a concept developed by Aristotle. It includes loyalty to friends, family, and community, and requires virtue, equality and familiarity. In ancient texts, philia denoted a general type of love, used for love between family, between friends, a desire or enjoyment of an activity, as well as between lovers. This is the only other word for "love" used in the ancient text of the New Testament besides agape, but even then it is used substantially less frequently.

Agape, In Ancient Greek it often refers to a general affection rather than the attraction suggested by "eros"; agape is used in ancient texts to denote feelings for a good meal, one's children, and the feelings for a spouse. It can be described as the feeling content or holding one in high regard. The verb appears in the New Testament describing, amongst other things, the relationship between Jesus and the beloved disciple. In biblical literature, its meaning and usage is illustrated by self-sacrificing, giving love to all--both friend and enemy. It is used in Matthew 22:39, John 15:12, and in 1 John. However, the word "agape" is not always used in the New Testament in a positive sense. If Timothy 4:10 uses the word in a negative sense. Thus the word "agape" is not always used of a divine love or the love of God. Christian commentators have expanded the original Greek definition to encompass a total commitment or self-sacrificial love for the thing loved. Because of its frequency of use in the New Testament, Christian writers have developed a significant amount of theology based solely on the interpretation of this word.

By Henry A. Buchanan Iran poses a problem for America, and for a large part of Europe, because Iran needs nuclear energy, and America and a large part of Europe don't want Iran to have nuclear energy. Why? Because we are all afraid that

The board of the Eastland County Museum welcomes our newest board member, Jeff Clark. Jeff is well known in the area for his diligent county research, especially in the Alameda and Chaney communities and writings of Eastland County history printed in past editions of these newspapers. Jeff is associated with Ranger Realty in Ranger and has already shown great enthusiasm as a board member.

Work began Thursday by Mike McClure Construction on sealing the windows at the Museum. Work continued Friday with the installation of window tinting and UV film. This work should help protect the exhibits from UV exposure and fading, as well as keeping the Museum cooler this summer.

U.S. Department of Justice Refuses Approval of Photo Identification Law for Texas Voters

The United States Department of Justice today refused to approve Senate Bill 14, passed by the Texas Legislature and signed into law in 2011 for the purpose of voter fraud prevention. SB 14 requires voters in Texas to provide certain government issued photo identification when voting to help ensure positive identification at the polls.

"The Dept. of Justice's decision is extremely disappointing, especially since the data they demanded came from matching two separate data sets never designed to be matched, and their agency was warned that matches from these data sets would be misleading." said Secretary of State Hope Andrade. "My office will continue working with the Texas Attorney General's Office in seeking to implement the will of the citizens of Texas, as enacted by our duly elected representatives in the Texas Legislature."

As a result of the Dept. of Justice's refusal to allow implementation of SB 14, current law pertaining to approved documentation required for voting, meaning a Texas Voter Registration Card, will apply in the May 12, 2012 Uniform Election and the May 29, 2012 Primary Elections.

Approved documentation in addition to, or in lieu of a voter registration card includes at least one of the following:

·A driver's license or personal identification card issued to you by the Texas Department of Public Safety. You may also bring a similar document issued to you by an agency of another state, even if the license or card has expired;

•A form of identification that contains your photograph and establishes your identity;

•A birth certificate or other document confirming birth that is admissible in a court of law and establishes the person's identity;

Your United States citizenship papers;

·Your United States passport;

Official mail addressed to you by a governmental entity; or ·A copy of a current utility bill, bank statement, government check, paycheck, or other government document that shows your name and address.

Cotton Loan Rate Differentials

WASHINGTON, Mar 5, 2012 - The U.S. Department of Agriculture's (USDA) Commodity Credit Corporation (CCC) today announced revised loan rate ranges and base-quality ranges for upland cotton strength and length uniformity, and changes to the staple lengths for which distinct color and leaf loan rate differentials are provided.

CCC uses measures of strength and length uniformity in determining the price support value of a bale of upland cotton. The base-quality ranges for these factors are those for which loan rate Are you all ready for another experiment at the premiums and discounts do not apply.

cotton, the value ranges for strength and length uniformity loan rate adjustments will be denoted in whole units, consistent with the price reporting of the Agricultural Marketing Service (AMS). For example, the 2011-crop loan adjustments were provided for On April 5th, there will be a defensive driving class ranges such as 25.5 - 26.4 grams per tex for strength and 79.5 -82.4 percent for length uniformity. Effective for the 2012 crop, whole-unit ranges are established such as 25.0 - 25.9 grams per tex for strength and 80.0 - 80.9 percent for length uniformity.

Effective with the 2012 crop loan schedule, the base quality range for strength is established at 26.0 - 28.9 grams per tex and for length uniformity at 80.0 - 81.9 percent. These new ranges are consistent with AMS price reporting and the objectives of the marketing assistance loan program.

CCC is also revising the upland cotton staple lengths for which distinct differentials are provided. All upland cotton having staple lengths of 31/32-inch and shorter will be subject to one distinct schedule of color grade and leaf differentials. Additionally, upland cotton of staple length 37/32-inch will be subject to color grade and leaf differentials separate from those applicable to all upland cotton of staple lengths of 38/32-inch and longer.




