
REAPING THE WHIRLWIND.



And they will find that court harrassment will prevent their illegal traffic from being profitable. If Ranger folk were not of one mind on that determination before the Atwood trial, they are now. The deliberate harrassment, if not insult, to respectable women of the community by summoning them as witnesses for the defense has aroused a storm that will not die down. They pruptions were dragged to Eastland just as surely as if they were under arrest, and for two days kept in or near the courthouse-which is no comfortable place to spend such a length of time. Their testimony was not called for, and no one expected it to be called for, for by no conceivable means

could they have any evidence that would be of benefit to the defendant. Such tactics should meet the opposition they deserve. Further than that, there should be some court protection for "innocent witnesses." And yet the Eastland courts say there is none-that a defendant has the right. in order to establish his innocence, of calling any witnesses he desires. That may be true, provided they are REAL witnesses; no one desires to hamper the acquittal of any innocent man. But when a witness protests that he has no evidence, then he should have some protection from virtual arrest on the whim of a defense attorney. Apparently, a lawyer can summon a
