

DESCHANEL IS ELECTED PRESIDENT OF FRANCE TODAY

VULCAN OIL COMPANY'S NANNIE WALKER NO. 1 ON TEAR; 1,500 OR BETTER

Vulcan Oil company's Nannie Walker No. 1, coming in with natural production of 500 barrels from the roof of the deep pay, after passing through the top black lime without a shot, this morning "went wild" and is making a flow estimated at upwards of 1,500 barrels.

Nannie Walker No. 1 is located on the joint holding of the Vulcan with Texas Pacific Coal and Oil company, in block 6, section 41, twelve miles north of Ranger, near the new town of Frankell.

The well struck the top of the black lime at 3,212 feet and went through it without a shot. It started flowing at midnight, when it struck a second pay at 3,574 feet.

Natural production without the use of nitro hypox is unusual in Stephens county wells.

KY. DISTILLERS HARD HIT BY PROHIBITION

LOUISVILLE, Ky., Jan. 17.—Kentucky distillers still held several million gallons of liquor today, notwithstanding attempts to export it. Last unofficial figures were that 35,000,000 gallons, valued at approximately \$400,000,000, remains in bonded warehouses.

Whiskey interests of this state waited until early December in the belief that the president, the supreme court or congress would lift the wartime prohibition ban. When the supreme court held the law constitutional and neither the president or congress raised the ban, they prepared for shipment of their stocks to foreign countries, but were said to have been only nominally successful.

About that time some Kentucky interests announced, following a similar announcement in Chicago, that they would institute a suit in the court of claims, Washington, late this month or early February in an effort to secure reimbursement from the government for the whiskey that remained in the country after today.

One almost immediate result of the permanent ban clamped down today may be the closing for good of the 300 Louisville saloons that survive the wartime law by conversion into soft drink dispensaries. A number of the proprietors declared today that they cannot operate under present profits and therefore expect to begin new businesses.

Meanwhile, the real work of prohibition enforcement officers began today. They were said to be ready to suppress all violations of the law in this state.

W. C. T. U. PLANS DRY CAMPAIGN IN S. AMERICA

CHICAGO, Jan. 17.—The prohibition campaign will be carried to South America by the Women's Christian Temperance Union, according to an announcement today.

The campaign will be started in Uruguay, where headquarters will be established next month. A systematic campaign also will be carried on in the Argentine, it is announced.

Legion Post Is Organized at Brooklyn Today

NEW YORK, Jan. 17.—Formal organization of a post of the American Legion in Brooklyn composed entirely of members of the Masonic fraternity was announced today.

CISCO N. E. RY. GETS FIRST BIG MOGUL ENGINE

CISCO, Jan. 17.—The Cisco North-eastern Railway company of this city received the first mogul engine with equipment for the road now being built from this city north into the Stephens county oil fields. The new monster is a ten-wheeler and was inspected by scores of railroad men who pronounced the machine as one of the latest models built for pulling big loads.

Connections have been made with the Texas & Pacific railway tracks in the eastern portion of the city and a string of flatcars have been delivered to the new road. Building material for the other portion of the road will be soon hauled from this city by the new equipment.

Hundreds of citizens visited the spot Thursday to inspect the new engine.

FIND PLOT TO OVERTHROW GOVERNMENT

LITTLE ROCK, Jan. 17.—Governor Brough of Arkansas, addressing a meeting of merchants last night here, said that he had received confidential information from the war department that a nationalist plot to overthrow the government had been discovered.

The plot, he said, was of serious proportions, and the war department urged that Arkansas troops be held in readiness.

ENTENTE WILL REOPEN TRADE WITH RUSSIA

LONDON, Jan. 17.—Commercial relations will be opened between the allied nations and the Russian people immediately as the result of a decision reached by the supreme council of Paris yesterday.

This step, which reverses the former policy of the allies toward Russia, does not imply an altered attitude toward the Trotsky-Lenine government, according to the statement issued by the council.

Clothing, medicines, agricultural machinery and other necessities will be shipped into Russia from the entente nations in return for grain, flax and other products, which the Russian people desire to export.

Clemenceau Not to Be in Race for Pres. of France

PARIS, Jan. 17.—Premier Clemenceau has announced that he will withdraw as a candidate for the presidency of France.

He asked his supporters to vote for President Poincaré for re-election.

J. F. CONNELL APPOINTED TO P. M. POSITION

Among the nominations for postmasters sent to the senate by President Wilson is mentioned the name of J. F. Connell, for appointment as postmaster at Ranger.

Mr. Connell formerly lived here but is now living in Fort Worth.

When asked if he knew anything in regard to the appointment Postmaster Kelly stated that he talked with Mr. Connell about two months ago, at which time he said he would not accept an appointment as postmaster here.

"Of course, he may have changed his mind," stated Mr. Kelly.

"What effect will the appointment have on the situation here in case Mr. Connell does not accept?" he was asked.

"The law is a little peculiar in this respect," Mr. Kelly said. "There has been no commissioned postmaster here since Charley Davis resigned, about a year and a half ago. I am not eligible to take his place for the reason that I was not a citizen of Ranger eighteen months ago, and this qualification is necessary, according to the ruling. Mr. Connell is qualified under this section."

"In case he refuses the appointment, a new examination will be held. This will bring the problem down to date and clear up the situation."

Mr. Kelly stated that he is expecting Mr. Connell in town today or tomorrow and would find out about the matter. He had sent the dispatch telling of the appointment, until it was called to his attention by a Daily Times reporter.

OIL FEVER SPREADS IN NACOGDOCHES COUNTY

NACOGDOCHES, Jan. 17.—The oil fever is spreading in Nacogdoches county. Local companies have been, or are being, organized for the testing of certain sections of the county and an extensive leasing campaign is under way.

Drilling is going on in the southeastern part of the county where oil is believed to be. A joint stock company is also preparing to drill in the northern part of the county.

GAS HEARING IS SUDDENLY BROUGHT TO END

EASTLAND, Jan. 17.—The Texas railroad commission, which has been in session here for two days with the purchasers, operators and consumers of natural gas in an effort to devise ways and means for the conservation of gas in Texas, adjourned yesterday without taking any definite action on the plea of Mayor Davis of Fort Worth, who was appointed spokesman for the consumers of more than twenty cities, to stop the Lone Star Gas company from furnishing other cities with gas until it can give absolute assurance that Fort Worth and Dallas will receive an adequate supply this year and next winter.

Mayor Davis was persistent in trying to get some promise from the commission that it would act. Commissioner Earle B. Mayfield stated that the commission has no jurisdiction to act in the matter. Mr. Mayfield stated, however, that the commission will do everything in its power to aid the consumers and to stop the wanton waste of gas.

Mayor Davis later stated that the matter probably will be taken to the courts if necessary to stop the company from piping gas to other cities which rightfully belong to Fort Worth and Dallas.

The meeting adjourned rather unexpectedly following Mayor Davis' speech. Commissioner Mayfield expressed his thanks and appreciation to the producers, operators and consumers for the facts given to the commission and promised that every issue will be taken up in order to clarify the matter and to stop waste.

OLD ENEMY OF PREMIER CLEMENCEAU IS NAMED HEAD OF THE REPUBLIC

By Associated Press. VERSAILLES, Jan. 17.—Paul Deschanel was elected president of France by the national assembly here today. He received 734 votes.

DUEL IS RECALLED.

PARIS, Jan. 17.—The fight between Premier Clemenceau and Paul Deschanel for the presidency recalls that they have already met on another field, that of honor, twenty-six years ago.

Then Clemenceau was neither deputy nor senator. Deschanel, becoming offended by the terms of an article written by Clemenceau, sent his seconds to Clemenceau, who was noted as a duelist.

The men met with swords and Deschanel received a wound over the eye which was so severe that his seconds refused to allow the duel to continue.

CITY SCHOOLS ATTENDANCE ABOVE 2,200

Attendance at the city schools is now above 2,200, Superintendent McDonald stated today. This figure includes only those who are in the scholastic age. On account of the crowded condition of the schools, those under age or over age are not admitted.

Final examinations for the first term begins the latter part of next week. It is expected that about twenty-five pupils will be promoted from the wards to the high school following the examinations.

The second term begins Monday, January 26. All parents who have children in the scholastic age and not attending school are urged to start them on that date.

Miss Marion Shoffstall, formerly with the Daily Times, has been employed as commercial teacher, to take the place of Miss Betty Hughes, of Paris, Texas, who resigned.

One trouble after another interferes with the construction of the new school buildings in Young and Cooper additions. A few days ago Manager Clements, of the firm of David S. Castle, announced that structural steel for the buildings had arrived and work would be pushed to completion.

Now a shortage of crushed rock is holding up work on the structures, Superintendent McDonald, of the city schools, stated today. Work at Tiffin is also at a standstill. The building there is of brick construction, and it is the plan of the contractors to wait until the other two buildings are ready for brick work and then finish all three together.

The buildings will not be ready for occupancy during the present school year, in the opinion of Superintendent McDonald.

By using the half-day plan in some of the grades, the schools will be able to make out this year with the present buildings.

NEW FUEL BEING PERFECTED BY THE WAR DEPT.

Staff Special to The Times. WASHINGTON, Jan. 17.—The general supplies branch of the war department is conducting tests of colloidal fuel, which is a mixture of finely ground coal, suspended in fuel oil. In the liquid form it can be used in any oil burning furnace. The fuel is heavier than water and can thus be sealed against combustion and evaporation.

W. F. & R. Station Making Progress

Progress on the freight and passenger depot of the Wichita Falls, Ranger & Fort Worth railroad is being made since the weather cleared up. The framework of the freight depot is partially up.

It is the aim of the Janssen Construction company, which has the contract for the building, to complete the structure by the middle of February.

SAYS ALLIES HAVE DONE RUSS GREAT DAMAGE

VLADIVOSTOK, Jan. 17.—General Rudolph Gaida, formerly commander of the Czech-Slovak forces in Siberia, declared before he left here for Shanghai that "the allies are doing Russia more harm than the bolshevik and the sooner the allies leave it the better it will be for Russia."

General Gaida, with his Czech-Slovak troops defeated the bolshevik at Perm. He led the revolutionary movement which took place here November 13, was captured by government authorities and agreed to leave Siberia.

"All the allies have done in Russia," he said to The Associated Press correspondent, "is to support black monarchy—Kolchak, Denikine, Yudenitch and the Atamans. All the future can hold is absolute monarchy of absolute bolshevism. The central group, the social revolutionaries, the social democrats and the other smaller groups of similar political orientation, will be unable to assume leadership. All Siberia west of Lake Baikal will fall to the bolshevik, and from Baikal to the Pacific will be Japanese dominated provinces controlled by the Atamans."

General Gaida stated that he believed that the only people who can tie Russia together again are those who are now known as bolsheviks. These so-called bolsheviks he termed them, are not the reds of the days of error in European Russia. Today, he said, there is a national movement in Russia for a clear democracy and that the crucial form, which is now being displayed eventually will work itself out in a moderate social program.

He said that the army that was approaching Lake Baikal from the west, the army that he defeated at Perm last winter was an officered army, with generals, colonels, captains and soldiers. It was disciplined. There was a military staff, schools and academies for training men for the army. The doctrine of communism were gone from it; personal rights in property had been established and were being maintained. The world should know more of the facts regarding actual conditions in Siberia, Gaida said.

"The democratic movement is inevitable," he concluded.

General Gaida was asked if in his opinion the allies could not aid in the realization of this pure democracy of which he had spoken by lending aid to the government formed at Omsk and headed by Admiral Kolchak. He laughed heartily.

"No, Nikly!" he said, which is Czech for "No, never."

3 FIREMEN DIE IN CINCINNATI FIRE; BIG LOSS

CINCINNATI, Jan. 17.—Three firemen were killed and a score of persons injured when an explosion blew out the wall of a building occupied by a tea company in the river front district early today.

The fire loss is approximately \$100,000.

# H-K RAILROAD TO CONSTRUCT WIRE SYSTEM

Hamon & Kell shortly will start the construction of their own telephone and telegraph line along the route of the Wichita Falls, Ranger & Fort Worth railroad, reaching from Ranger in both directions and with exchanges at Frankell, Jakehamon and other towns along the line which will be opened later.

Shipment of steel for the track laying will start Monday and part of the machinery for its installation already is in Ranger. Grade both ways from Ranger is ready for the steel. When material is ready that the work may go ahead without delay, J. J. Harrison expects to average a mile of steel a day with his gang of 200 men.

# BI-PARTISAN TREATY MEET IS UNDER WAY

WASHINGTON, Jan. 17.—Although little progress has been made in settling the issues over Article X of the League of Nations covenant, the chief stumbling block, factional leaders in the senate treaty fight are still hopeful that the bi-partisan conference, which reconvened today, would result in a material step forward in the negotiations for compromise reservations, satisfactory to the majority.

# Okla. Republicans Start Fast Fight

First guns in the fight for the position of republican committeeman echoed in a telegram received today by George McQuaid, manager of townships for the Hamon & Kell interests, from Dynamite Ed Perry, republican wheelhorse and backer of General Woods in the coming presidential race.

The fourth district republican convention, meeting at Shawnee, Okla., Friday, started the fight off in merry fashion with a split in the convention. The regular convention endorsed Jake Hamon for republican committeeman and the backers of James J. McGraw withdrew and started a convention of their own.

McQuaid, Disney of Muskogee and Jim Harris repudiated General Wood in the convention, tore off their Woods buttons and threw them at the chairman, suggesting that they be given to McGraw, who recently has been appointed vice chairman for the southwest of the Woods campaign.

These events, bulletined by Dynamite Ed, foreshadow a lively campaign right along the line up to Chicago.

# \$75,000 Fire at Marshall Today

MARSHALL, Jan. 17.—The machine shops of the Marshall & East Texas railroad here were totally destroyed by a fire of undetermined origin today entailing a loss of \$75,000.

He made no mention in his speech of the proposal credited to him to extend the Plumb plan to all public utilities corporations and industries generally. He summed it up as "a plan for the ownership of the railroads by the public and their democratic operation by representatives of the public and the employees."

### ROCKET ABLE TO REACH MOON, IT IS NOW CLAIMED

WASHINGTON, Jan. 17.—Communication with the moon, if that satellite, despite the lack of atmosphere, should be inhabited, may be possible by means of the invention of a multiple charge high efficiency rocket devised by Prof. Robert H. Goddard, of Clark college, Worcester, Mass. Details of the invention were announced by the Smithsonian institution.

The determining factor of the efficiency of a rocket is the velocity of the ejection of the gases, due to the explosion of the propelling material, and Prof. Goddard has brought a 61 per cent increase in efficiency through improvements permitting the rapid escape of gases. His rocket is capable of a speed of 8,000 feet a second. The institution's statement says:

"An interesting speculation described in the publication arising from Prof. Goddard's work is on the possibility of sending to the surface of the dark part of the new moon a sufficient amount of the most brilliant of flash powder, which, being ignited on impact, would be visible plainly in a powerful telescope. This would be the only way possible of proving that the rocket really had left the attraction of the earth, as the apparatus never would come back, once it had escaped that attraction."

"While this experiment would be of little obvious scientific value, its successful trial would be of great general interest as the first actual contact between one planet and another."

The great scientific value of Prof. Goddard's experiments, it is pointed out, lies in the possibility of sending recording apparatus to moderate and extreme altitudes within the earth's atmosphere.

John Barleycorn, jovial and eccentric monarch of years of ascendancy, today lies in his grave, mourned by those who have been his more or less ardent supporters in all the time of his reign. In the tears of a few we see the real grief of mourners who have lost a bosom friend, a life-long companion; in others' grief there seems to linger the bibulous emotion that rose so readily from the cups; yet in the tears of others who profess to weep can be seen the trace of a smile.

For the few who mourn there are thousands who viewed John's passing with no more than casual interest, or the approval, without enthusiasm, which the public accords most steps that are recognized to be inevitable. He was at his best in a circle of friends. His sallies seemed shafts of wit, and he inspired in all who were congenial with him the same specie of brilliancy. Taken home as a guest, he lost his attraction and in the morning he was a wretched bed-fellow.

Corrupt, beyond a doubt, he worked hand in glove with the country's worst enemies and complicated every problem that he was permitted to have part in; where not invited he was an arrant meddler.

### Pershing Due in El Paso Feb. 1 or 2

EL PASO, Jan. 17. — For probably the second time in history the full general's salute of seventeen guns will be heard in El Paso when Fort Bliss artillery greets Gen. John J. Pershing on his arrival here on his present tour of the country. Available records indicate that Gen. William Tecumseh Sherman in 1880 received the only previous similar salute here. General Pershing is scheduled to arrive here on Feb. 1 or 2. Should he arrive on Sunday, Feb. 1, no salute will be fired because it is not permissible on the Sabbath under army regulations.

Old residents recall interesting events in connection with the visit of General Sherman forty years ago. With President Rutherford Hays, he was making a "swing around the circle." The party traversed the northwest, thence down to San Francisco, and, returning, traveled by rail to Tucson, Ariz. There was no railroad between Tucson and El Paso, and General Sherman and staff crossed the then desert to El Paso in "buckboards," while President Hays went north from Tucson by rail.

General Sherman's visit to the then frontier-border village of El Paso created quite a stir locally. He was tendered a banquet at the "leading" hotel on the site of which stands today a modern department store. Oftentimes told of a joke on the hero of

TORTURED 4 YRS. IN MEXICO, BOY COMES TO U. S.

By Associated Press

HOUSTON, Jan. 17.—After four years of torture in a foster home in Mexico City, William Alfred Moore, 13-year-old American boy, has found a real home again in the United States, after an adventure including a wild ride from the City of Mexico to the Rio Grande, thence by various stages to Houston.

Through the efforts of Houston women, who clothed him and kept him under observation for several weeks, a temporary home has been found for him and he will reside in Navasota until relatives have been located.

William's story is that he was living with his mother in Corpus Christi when his father, a physician, perished with the sinking of the Titanic in mid-Atlantic. His mother died, he says, at Corpus Christi when he was eight

years old and he was then taken to Mexico City by the woman who had done his mother's washings. William says he received nothing but beatings because he could not understand the language spoken by her soldier husband and because he persisted in the use of his native tongue. So he ran away.

Four days and three nights he spent riding on the trucks of passenger trains in Mexico. Only once did he stop, and then to obtain food. Arriving at the Rio Grande border, he swam across, but was sent back to Mexico again. Dauntless, at another place he again crossed and for several months earned a livelihood by shining shoes at Rio Grande City. Then he went to Corpus Christi where he worked in a pharmacy for \$7 a week. With what money he could save he bought a bicycle, and shipping it by express to Houston he followed on the train trucks.

William speaks a broken English with a Mexican accent. He also writes Spanish, which he learned by watching others and copying what they wrote.

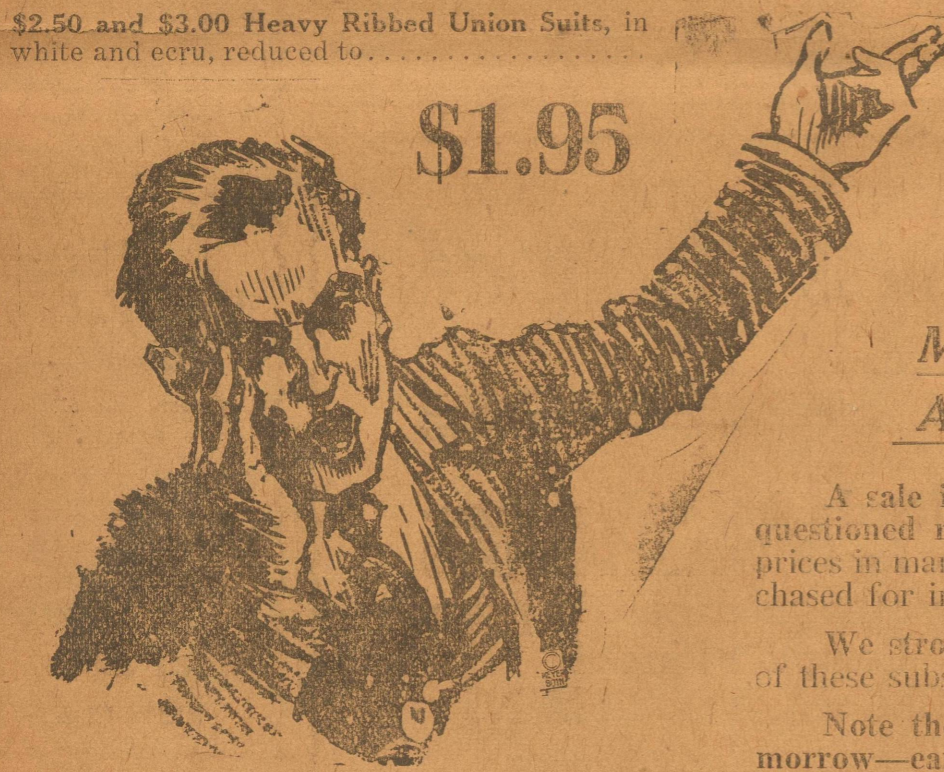
