Frenzied customers are besieging others whose financial stability is questioned.

MASKED MAN SHOTS GIRL IN CHURCH CHOIR

PORTLAND, Ore., March 4.—Mrs. William Fuller, 17, a member of St. Stephens pro-cathedral choir, was shot and seriously wounded at the church by a masked man who entered while the choir was practicing, ordered its members to put their hands up and then fired without waiting for them to do it. The assassin escaped.

NATIONAL GUARD CRITIC FINALLY GETS PROMOTED

WASHINGTON, March 4.—The promotion of Maj. Robert G. Peck to a lieutenant colonelcy, which has been vigorously opposed on the ground that he had made public statements disparaging the Missouri and Kansas National Guard, was confirmed today by the senate. The confirmation followed pleas by several senators that Major Peck had been punished sufficiently by the war department. Major Peck was attacked by the American Legion for his alleged statement that the Thirty-fifth division, composed mainly of Missouri and Kansas national guardsmen "had borne all the earmarks of a national guard outfit."

HOLE ABANDONED AT DEPTH OF 3,955 FEET

FORT STOCKTON, March 4.—At the depth of 3,955 feet the Pinal Dome Oil company, which has been engaged for the past seventeen months in drilling a deep test north-east of Fort Stockton eight miles, ceased drilling operations last week, and the crew is now busily engaged in plugging the hole. No definite decision has been reached by the operators relative to their activities in this field, but as Superintendent Kerr states that the drilling of this one well gives them no cause to alter their opinion of the field, and proves up nothing from the drilled hole, it is assumed that the Pinal Dome company has, as yet, entertained no thought of abandoning all further endeavors to drill in a producing oil well.

SINCLAIR WINS SUIT FOR FAULTY HORSE

NEW YORK, March 4.—Harry F. Sinclair, Texas oil man, was awarded \$100,000 by a jury, holding that the race horse "Playfellow," brother of "Man o' War," was unsound when purchased from James F. Johnson. The purchase price was \$100,000. During the trial Sinclair claimed that "Playfellow" was represented to him as being sound and that he found afterward that the thoroughbred was afflicted with "wind-sucking."

ROBBER THROWS ACID.

SAN ANTONIO, March 4.—As a victim of an unusual highwayman, George Marsh is suffering from burns about his face, said by physicians to have been caused by carbolic acid. While walking in the 300 block of Van Ness street Marsh was accosted by a man in army uniform who pushed a pistol against Marsh's stomach and demanded money. When Marsh said that he had no money the highwayman threw the contents of a small vial over his victim's face. Marsh rushed to a nearby residence and telephoned for the police, who summoned a doctor and took the injured man to his home.

LEWIS REFUSES PERMIT TO MAKE STATE SCALES

INDIANAPOLIS, March 4.—Efforts of coal mine operators to negotiate separate wage agreements rather than deal with the international union is a thrust at the very life of the United Mine Workers and will not be tolerated, President Lewis said today in a telegram to Frank Farrington, head of the Illinois miners, who had asked what course to pursue in regard to an invitation of the Illinois operators to a wage conference.

'S ALL RIGHT, CAPTAIN! SAVANNAH, Ga., March 4.—Edward H. Summers, while making for a New York steamer today, was taken into custody when an officer found liquid dropping from one of his suitcases. In less than two hours he had appeared before a federal judge, pleaded guilty to violation of the prohibition law, paid a fine of \$250 and reached the steamer in time to sail.

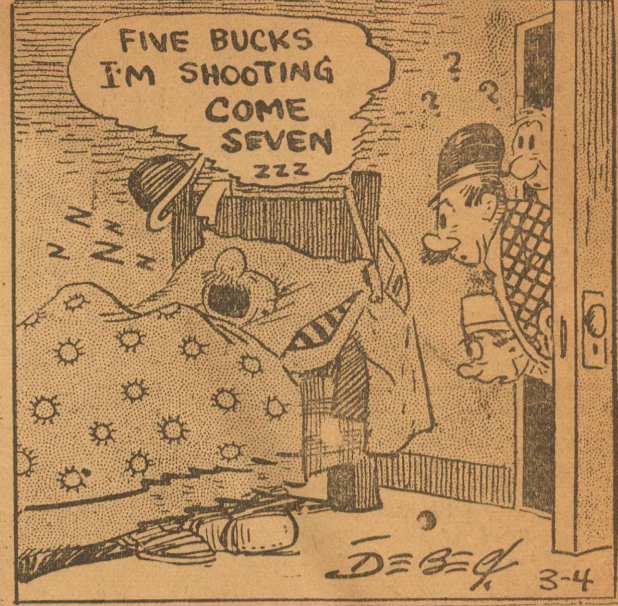
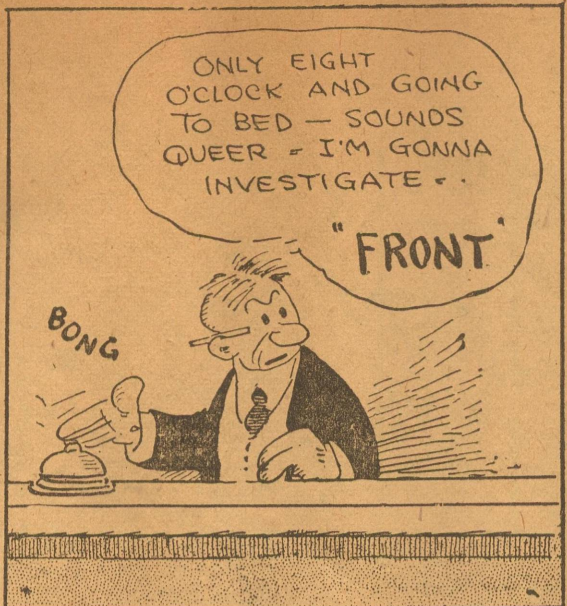

LAND OWNERS ARE LOSERS IN RIVER BED SUIT

AUSTIN, March 4.—The final ruling of District Judge George Calhoun of the Travis county district court was in favor of the state in the case of Adkins vs. State of Texas from Stephens county. He held that permittees on state land have the right of ingress and egress over the lands of adjacent property owners.

On a former day Judge Calhoun sustained the validity of the mineral act of 1917 which empowered the land commissioner to issue oil and gas permits on the beds of streams classed as navigable under the constitution, being those thirty feet in width or over.

It was admitted in the Adkins case that the South Fork of the Brazos river came under that classification and Judge Calhoun held that the permit act was valid, thus denying the relief sought by Adkins, who would enjoin the state's permittee from drilling in the river bed opposite his land, he being the riparian owner. In the river bed in controversy is in the oil district of Stephens county.

After sustaining the permit act Judge Calhoun held under advisement the question as to whether a permit given by the state carried with it the right of egress and ingress across the surrounding land. Judge Calhoun now holds that it does.

FIVE MOURNERS BURNED IN FIRE AT GIRL'S BIER

NEW YORK, March 4.—Five mourners around the bier of 4-year-old Engelina Zarcarese were seriously burned when the draperies on the little coffin caught fire from lighted candles in the Zarcarese home in Brooklyn.

The fire spread rapidly and soon the whole room was blazing. When the firemen arrived they were driven back by the intense heat and thick smoke. They had been able to see, however, the five bodies of the mourners lying on the floor where they had been overcome.

Playing their hoses in front of them, and stumbling through the smoke, the firemen were able to reach and drag to safety the five adults and rescue the charred body of the little girl.

14 Operations, 45 Skin Graftings, to Save Girl's Life

DALLAS, March 4.—After undergoing fourteen operations and forty-five skin-grafting applications, doctors say that Dorothy Cannon, 6-year-old daughter of Mrs. M. E. Cannon of Hearne, will be discharged from Baylor hospital within another month a well child.

Given up as dead when she was found lying on a live wire in a puddle of water last June, and then looked upon as a hopeless case for two months after she was brought to the hospital, Dorothy will be dismissed with very few visible signs of the agonizing condition which kept her flat of her back for nine months.

BRECKENRIDGE GIRL IS FATALLY BURNED

BRECKENRIDGE, March 4.—Estelle Parsons, 6, daughter of Mr. and Mrs. R. A. Parsons of West Taylor street, is dead from burns received when her clothing caught fire from a gas heater at the family home.

BRIDE OF PRIEST CAUSES HIS ARREST

NEWARK, N. J., March 4.—A bride of three days, Julia Mahanna Yonan, 21, caused the arrest of Rev. M. Simon Yonan, 57, a Norwegian priest, who said his pastorate was in New Britain, Conn., charging that the priest first tricked her into marriage and then threatened to kill her because she refused to live with him.

The priest was paroled on his promise to answer the charge tomorrow in court.

COAL OPERATORS WILL MEET TEXAS MINERS

INDIANAPOLIS, Ind., March 4.—Representatives of the Union Coal Miners of Oklahoma, Arkansas, Texas, Kansas and Missouri will meet with officers of the Southwestern Interstate Coal Operators' association on March 9 for an informal discussion of wage matters.

BURGLAR AT STRAWN

FRIENDLY CHATTER ANSWERED MADALYNNE'S LETTERS OF LOVE

LOS ANGELES, March 4.—Madalynne Obenchain's love letters to J. Belton Kennedy, for whose murder she is now on trial for her life, unfolded the story of a broken heart.

For a period of years, from 1917 to 1921, they speak the language of one who loves to hear the same old love story from one man in one way—sweet and pure and undefiled.

Her letters prove that Madalynne loved unselfishly, beautifully. She was ever willing to humble herself for him. Kennedy's letters in reply thus far discovered were cautious, conservative and semi-humorous. While she wrote of love, he would reply about having a good time at the beach. While she penned lines telling how she longed for him, he replied with the suggestion that she meet a good friend of his in San Francisco and entertain him.

In 1917 she wrote: "It's hard for me to write. Cold pen and ink were never meant for me to tell you what is in my heart."

Later she wrote: "I always think of you in my dream world."

Kennedy replied that he was having a fine time sailing his new motor boat.

During the war Kennedy wrote he was wild to go to the front. Madalynne answered:

"If any accident happens to keep you away from the battle field then I am truly glad."

The following year she wrote: "Belton, dear, you are never out of my mind. I dream you are close to me, that your lips press mine so hard it seems to waken me."

Kennedy replied that he had met an author who was very interesting. A few weeks later Madalynne wrote from the seashore: "As I look across the golden path the moonbeams are making, I build a beautiful dream castle for you and me."

Kennedy replied, explaining to Madalynne how to handle a certain banking deposit.

Later Madalynne wrote: "My happiness is so great; every hour I feel that I am sitting by your side."

Kennedy wrote jocularly about his hand not being so temperamental as it used to be.

Madalynne's letters during the four years grew gradually more romantic and sentimental. Kennedy's replies seem to contain just enough romance to keep a woman puzzled.

Parental objections prevented Kennedy marrying her. She married Ralph Obenchain, but her letters proved her love for Kennedy never waned.

WOMAN DRUGS 'SECRET AGENT' ONCE 'FOCH AID'

NEW YORK, March 4.—A well-dressed young Frenchman, who said he was once secretary to Marshal Foch, at one time an attache of the French embassy at Washington and now connected with the United States Secret Service, was found unconscious from an overdose of heroin in Proctor's One Hundred and Twenty-fifth street theater yesterday.

An usher found him apparently asleep in an orchestra seat at the close of the matinee performance. Unable to arouse him the usher called a policeman and an ambulance came from Harlem hospital.

Dr. Carleton Simon, special deputy commissioner, in charge of the narcotic division, who was sent for, brought the drugged man out of his stupor. The victim said he was Edward Marquis de la Faire, twenty-six.

Gave a Badge Number.

He appeared to be hazy as to when he joined the secret service, but said his badge number was 467 and that he was in the service under the name of Edward de Zaldo.

This is what he told Simon: "I was on duty in Havana, seeking a woman the government has long wanted for smuggling. I traced her to the St. Charles hotel in New Orleans and from there to New York."

"I located her here, but she never suspected my mission. I managed to strike up a friendship with her, and for several days we have been going around the city together. Today we went to the theater, and it was in the performance that she gave me the drug."

Credentials Gone.

MENNONITE VANGUARD NOW ON WAY TO MEXICO

KANSAS CITY, March 4.—A special train bearing 150 Mennonites, the advance guard of a host of 20,000 leaving Canada for the promised land—Mexico—reached this city last night over the Chicago, Milwaukee & St. Paul railroad.

They are bound for Chihuahua, Mexico, where the sect has purchased 200,000 acres of land and where twenty villages have been laid out.

The Mennonites, among the richest people in Canada, are leaving Canada because of alleged persecution. Their decision to migrate was made last summer when members of the colony purchased the Mexican tract for \$8 an acre. Since that time they have been selling their holdings around Plum Coulee, Manitoba, and within a month the entire colony will have moved to Mexico.

The first special train, in addition to Pullman and dining cars, will include twenty-three cars of livestock and farm implements.

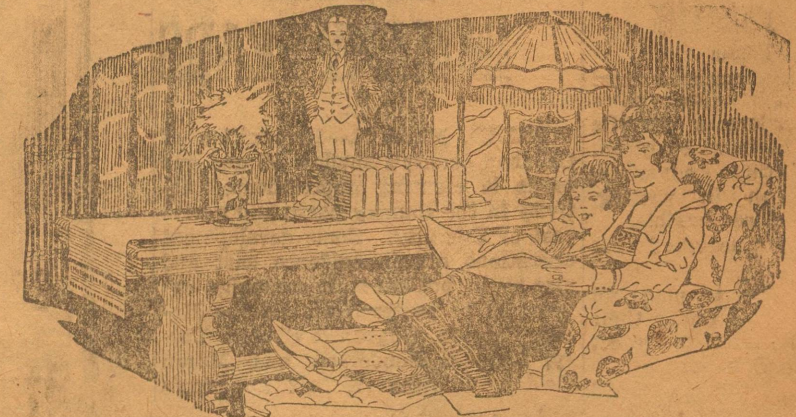

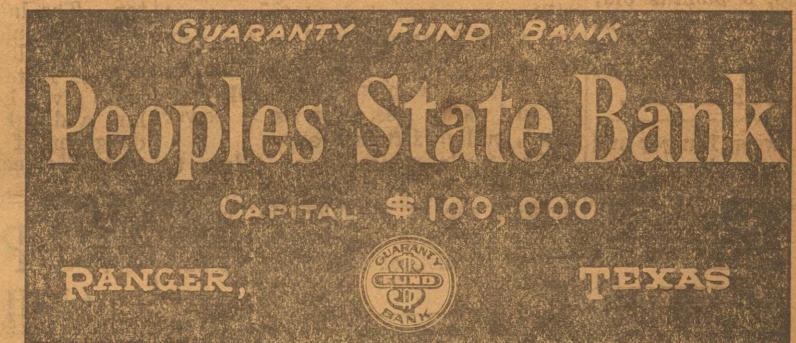
