RANGER PLANS JULY FOURTH CELEBRATION

INJUNCTION IS PERMANENT FOR CERTAIN TIME

Court Says Road Money Must Be Held Until Pending Suits Are Ended.

Judge George L. Davenport of the Ninety-first district court, Saturday rendered a decision in the George Davison vs. Eastland county injunction case, in which a temporary injunction had been granted, making the injunction permanent during the pendency of the suit now before the courts. Counsel for Eastland county excepted to the ruling of the court and gave notice of appeal to the Eleventh court of civil appeals at Eastland.

Eastland county has 20 days in which to perfect its appeal and the stenographer was given an order for a transcript in the case and instructed to begin work on it at once in order to have it ready before the time limit for appeal expires.

Chief Justice William Panfill of the Eleventh court of civil appeals, because of having represented the county in the suit, will be disqualified to sit in the case. Under circumstances of this kind the other two members of the court, Associate Justices Little and Rigdell, may render the opinion.

Court's Opinion.

Following is Judge Davenport's opinion:

"After careful consideration of the pleadings of the parties and the evidence offered on the hearing to dissolve the temporary writ of injunction heretofore issued in this case, I am of the opinion that the issues raised by the motion to dissolve are purely issues of fact, it being evident that if the defendant, Davison, has legal rights in the funds belonging to Eastland county, and which were impounded in the Security State Bank & Trust company at the time of its failure, that it would be the duty of the court to perpetuate the injunction until the rights of the parties to the litigation shall have been determined by the courts.

"The application of defendant, Davison, for injunction is predicated upon sub-division two of article 4643 of our statutes, which reads as follows:

"Writs of Injunction—Granted When: "Judges of the district and county court shall either in term or vacation, hear and determine all applications and may grant writs of injunction returnable to said courts in the following cases:

"Sub-Division No. 2—Where, pending litigation, it shall be made

Inauguration of Von Hindenburg May Induce Disorders

BERLIN, May 9.—Berlin today looked forward to possible disturbances and violence in connection with the entrance of former Field Marshal Von Hindenburg into the city Monday for inauguration as president. He will be inaugurated formally on Tuesday.

Drastic precautions against outbreaks are being taken. Red Cross emergency stations have been established throughout the city. Fears that a pitched battle may develop have been increased by announcement of a community meeting to be held two hours after Von Hindenburg's entrance into the city Monday, and word that militant nationalists are concentrating in the city.

Four Hold-Up Men Go to Penitentiary

SAN ANTONIO, May 9.—Sentences of five years each in the federal penitentiary at Leavenworth was given four men by Judge Duvall West, in United States court here, after the quartet pleaded guilty to holding up a poker party at Fort Sam Houston and at Camp Stanley. The holdups were staged to enable the men to obtain money with which to buy an acetylene torch. Gus Jones, head of the department of justice, told the court.

DALLAS MAN KILLS WOMAN AND HIMSELF

DALLAS, May 9.—Two persons are dead here today as a result of a rooming house murder and suicide. Albert Davis fatally shot Mrs. Virginia Peak and then turned the gun on himself. Both died shortly after the shooting.

YOUTH REFUSES TO GIVE ALIBI TO THE POLICE

St. Louis Boy Questioned in Effort to Solve Murder of His Father.

ST. LOUIS, May 9.—Nonchalantly defying all attempts to question him, Edward Dillon sits in a cell at the Clayton police station tonight—the first prisoner taken in an attempt to solve the murder of his father, Dr. William A. Dillon.

The father, a prominent surgeon, was found slain on the campus at Washington university more than a week ago. Young Dillon, a sleek-haired and fashionably clad lad of 19, was arrested Friday night when authorities learned that he was chief beneficiary in his father's insurance.

Police say he will be held indefinitely until the answers several quite leading questions. The principle question the youth has been asked and which he refuses to answer was "Where were you on the night of April 30?"

That was the night the father was killed. The youth has answered the question with laughs, and complete refusal. He has inferred that he might have been with a girl, but he will not give definite answer.

In one long grand of questioning young Dillon remarked: "If it comes to a question of hanging for the death of my father, then I'll talk."

Defendant in Trial For Murder Denies That He Is Crazy

KANSAS CITY, Mo., May 9.—Thrills aplenty were furnished at today's session of the trial of Roscoe Warren, slayer of John C. Deskin, when Warren took the stand in his own behalf.

Warren, president of a Masonic hunting club, shot Deskin, a trustee of the organization, after Deskin demanded that Warren be removed because of alleged misappropriation of the club's funds.

Warren, whose defense is insanity, sobbed and shouted his answers.

"I am not crazy, I've told you a thousand times I am not crazy," he screamed at his attorneys. Early in the session he tried to attack a deputy sheriff. He was quieted only when threatened with a black jack. After the outbreak seven deputies stood guard over him.

Bertram Moore, a tailor, told how Warren would order six suits at a time and demanded that the suits match in color the horses he rode.

Other defense witnesses testified that Warren wore women's kimonos in his apartments.

OKLAHOMA CITY, Okla., May 8. Jeff Durec, "the phantom," and last of Oklahoma's notorious bank bandits, was captured at Phoenix, Ariz., late yesterday, according to a telegram received today by W. D. Boling, chief of the federal bureau of investigation here.

RUM RUNNERS GET JOLTS IN EAST AND WEST

Dry Navy Seizes Forbidden Goods in Lake Erie and on Atlantic Coast.

DETROIT, May 9.—Two cruisers of the dry navy which have been wintering on the Detroit river, took a quiet run into Lake Erie today and gave the rum runners of that section the biggest jolt they have received this year.

The fleet seized three large motor-boats loaded with ten barrels of beer, six hundred and forty-two quarts of whiskey, and 11,000 quart bottles of beer, capturing seven men.

All seven men were arraigned today before Commissioner J. S. Hurd, pleaded "not guilty," and were held in bond of \$2,000 each for examination May 19.

ASBURY PARK, May 9.—A "skirmish" in the Atlantic coast rum war was fought today in the Delaware river, according to word telephoned to the headquarters of the Fifth coast guard here this afternoon.

Coast guardsmen from the Herford Inlet station, near Cape May, seized 100 cases of liquor which rum runners were attempting to land. After jettisoning the liquor the smugglers raced away in their boat.

Rum Row Ships Unable to Break Through Blockade

NEW YORK, May 9.—For the fourth successive day New York has gone without replenishment of its liquor supply. Coast guard officials conducting the government's "war" against the rum fleet said today that boats returned last night to their base at Clifton, N. Y., and described the situation on rum row. Thirty rum ships and the shore since last Tuesday.

Eight of the coast guard picket vessels are now in the liquor fleet. A careful check-up showed there had been no communication between the but none is making any effort to run the government blockade.

ALLEGED OIL SWINDLE PROBE IS UNDER WAY

LOS ANGELES, May 9.—Investigation of the asserted \$20,000,000 oil swindle of Texas and Oklahoma companies will be resumed by a grand jury next week. Seven thousand pounds of evidence, including books of the oil firms, were partially scanned by the investigators at the first day's session, and the remainder are to be gone over Thursday. Companies are the Invader Oil corporation and subsidiaries and the Owenwood Oil corporation of Fort Worth.

The probe was brought here because most of the alleged victims lived in California, according to Prosecutor S. W. McNabb. Approximately 5,000 people in this state were victimized by the promoters, it is alleged.

WIND STORM TAKES TOLL AT SAN ANTONIO

Wrecks Airplanes and Hangars At Flying Field; Blows Over Freight Car.

SAN ANTONIO, May 9.—The wind and rain storm which visited Southwest Texas Friday night bore down on Artesia, a station on the International-Great Northern railway south of San Antonio with such force that it derailed several box cars of a train on a siding there. One of the cars was blown over on its side, necessitating the dispatch of the wrecker. International-Great Northern officials said early Saturday that no one was injured.

Work was started Saturday morning clearing away the twisted wreckage of the airplanes and hangars of Stinson field. Thirteen airplanes were totally demolished and two others badly damaged. The machine shop and assembly room were blown over. Three hangars were razed. Damage was estimated at about \$50,000.

The storm suddenly appeared out of the southwest at 10:30 p. m. and caused a panic among residents of the southwest portion of the city. The wind through the city reached a velocity of 42 miles per hour and was accompanied by .64 of an inch of rain.

France's Finance Minister Submits Plan to Cabinet

PARIS, May 9.—Finance Minister Caillaux laid before the French cabinet today details of his plan to meet the situation created by France's financial difficulties. The plan has two main points: first, to balance the budget by taxation; second, to employ money received as payment under the Dawes plan for the benefit of districts devastated by the war. The cabinet gave Caillaux full power to defend his program in parliament, even to the extent of calling for a vote of confidence, should such action become necessary.

WILL OF W. L. CRAWFORD UPHeld BY APPELLATE COURT

DALLAS, May 8.—The will of Col. W. L. Crawford, who died in 1920 leaving practically all of his estate, valued at \$200,000, to Mrs. Kate Lamar Crawford, was upheld today by a ruling of the fifth civil court of appeals.

The will was contested by Mrs. Lucy Craycroft and other children of Colonel Crawford by his first wife. Litigation in connection with settlement of the estate led to the fatal shooting of Paul O'Day, attorney, by William Lester Crawford, here last September.

POULTRY LOOKS ATTRACTIVE AS PRICES CLIMB

Bankhead Association Making Success of Marketing and Prospects Encouraging.

Prospects for the Bankhead Poultry association becoming an important factor in regulating prices paid to farmers and poultrymen for their products in Eastland and Stephens counties are becoming better every day, according to W. S. Jarrett, manager of the organization, with headquarters at Cisco. Completion of the cold storage plant in Cisco for the poultry association insures sufficient cold storage for two carloads of eggs at one time, with facilities for four cars easily added.

"Eggs never again will be sold about here for less than 20 cents per dozen," declared Mr. Jarrett. "The 15-cent egg is no more for Eastland and Stephens county farmers."

Entering the fourth successful week of operation, the association, under the guidance of Mr. Jarrett, has handled 125 cases of eggs, 1000 fryers, 400 hens and 50 roosters.

Hens are being held now that the rain has lived things up, according to Mr. Jarrett. Virtually the entire output of roosters was exhausted last week, and it will be several weeks before another bunch will be available. Hens culled from the layers are being put on the market for sale, but all others are being held by the poultrymen.

JOCKEY HURT IN RACE REPORTED NEAR DEATH

NEW YORK, May 9.—Little Benny Marinelli, the Johnny Dundee of the turf in the affections of Italian turf followers, was reported, dying late today at the Mary Immaculate hospital in Jamaica where he was taken yesterday after he had been dangerously wounded in a spill at the Jamaica track.

The little jockey who came up from the teeming tenement district of the east side to become one of the most able jockeys on the metropolitan tracks, sustained a fractured skull and internal injuries when he was stepped on by his mount in a spill.

MISSISSIPPI STEAMER SINKS, SCORE DROWNED

Party of Civil Engineers on Inspection Trip Get Caught In Wreck.

MEMPHIS, May 9.—With the known dead placed at 22, a government crew today attempted to raise the hull of the engineering boat Norman, which sank in the Mississippi river, 15 miles below here, last night. If the attempt is not successful a diver will try to break into the submerged cabin and take out the bodies believed to have been trapped in the vessel.

The government boat, Chocotaw, which accompanied the Norman on its ill-fated expedition was equipped with derricks and grappling irons and ordered back to the scene to try to raise the hull.

Only five bodies had been recovered at noon. An official list of 22 was issued. Another list compiled by members of the party shows four more still unaccounted for.

The steambot was on an inspection trip carrying 40 civil engineers and sank near Lakeview, Miss. The engineers were attending the convention of the American Association of Civil Engineers, in session here, and had gone to inspect the Mississippi river revetment work.

Maj. D. H. Connolly of the first and second river districts of Memphis, Mayor Rowlett Paine of Memphis and Fire and Police Commissioner Allen were reported on the Norman when she sank.

INQUIRY TO BE MADE INTO CAUSE OF DISASTER

WASHINGTON, May 9.—A board of inquiry of three army officers will be appointed immediately to determine the causes of the accident to the steamer Norman and lay the blame, if any, on the responsible parties, it was learned at the war department today.

The department has wired urgently to the Memphis office of the army engineering corps for a detailed report of the disaster. No report has been received up till noon.

MEMPHIS, May 9.—United States army engineers grappled tonight in the swirling waters of the muddy Mississippi river for the bodies of 19 victims of the steamer Norman, which capsized Friday afternoon with the loss of 22 lives. All but three victims were trapped in the cabin.

Lake Hagaman Is Almost Full and Soon Be Over Top

Rainfall aggregating 84 hundredths of an inch fell in an hour and a half Friday night, pouring enough water into Lake Hagaman to put it within two feet of the spillway. According to the government rain gauge at the Leon lake power plant of the Oil Cities Electric company the total precipitation was 84 hundredths of an inch. More rain fell last night and the water was reported almost over the spillway.

Ranger now has an adequate water supply for all purposes for the summer and on into fall, even if another hard rain does not fall. With the long drought broken, it is said by the old-timers that plenty of water will fall this year.

The rain was widespread, although diminishing as it went westward. Hard rains were reported at Dallas and Fort Worth with the Trinity river at the 31 foot stage at Dallas. The river is over half a mile wide in many places, according to information here.

FARMERS BANK, DUNCANVILLE FAILS TO OPEN ITS DOORS

DALLAS, May 9.—The Farmers Bank of Duncanville, Dallas county, failed to open its doors for business today, according to advices here. Cause of the shutdown was not learned. The bank was a private institution.

DALLAS, May 9.—Absence of W. C. Cupp, cashier, over the week-end, was the reason for the closing of the Farmers bank at Duncanville, Dallas county today, according to George W. Riddle, Dallas banker, tonight. Riddle, former owner of the Duncanville bank, a private institution, said the failure of relief from Dallas to arrive at Duncanville resulted in the failure to open today. Merchants familiar with the situation said that no alarm was felt over the broken schedule.

EXPECT GREAT THINGS OF YOURSELF.

Giving his own horse to a messenger who protested that it was too magnificent for a common soldier, Napoleon replied: "Nothing is too magnificent for a French soldier."

The world is full of people like this poor French soldier, who think that what others have is too good for them; that it does not fit their humble condition; that they are not expected to have as good things as those who are "more favored."

They have grown up under this conviction of their inferiority, and, of course, they will be comparatively inferior until they claim superiority as their birthright.

A vast number of men and women, who are really capable of doing great things, do small things, live mediocre lives, because they do not expect enough, do not demand enough of themselves. They do not know how to call out their best.

BOMB FOR EUROPE

Ambassador Houghton's maiden speech, at the Pilgrims dinner in London is interpreted as a keynote in more than the significance usually attaching to ambassadorial utterances.

Mr. Houghton very firmly said that American aid to Europe may cease unless there is more peace based upon good will. Under all circumstances this is taken to imply that President Coolidge makes his advocacy of American membership in the World Court contingent upon guarantees of peace and also that the government at Washington will discontinue foreign loans for military purposes.

If this be a correct interpretation of the address the people of the United States are to be congratulated on the fact that this government, by this action, will do more to promote peace in the world than could ever be possible by participation in European councils. President Wilson had a very bitter and humiliating experience in that line, and it will be a long, long time before another American administration will be inveigled into a poker game with marked cards and stacked decks.

While there has been no direct statement from this government, it must be conceded that Mr. Houghton's remarks are well founded. It will now remain for this government to "make good" and effectually enforce peace by making the sinews of war impossible.

There isn't a man or woman living who cannot think thoughts worth fortunes. But they lack the spark of self-confidence which makes the difference between the Doer and the Dreamer.

General Greely Sees New Land in Cold Far North

By United Press.
 WASHINGTON.—With powerful engines driving United States navy planes through the air, instead of dogs drawing sledges over rough ice, there is every likelihood of the MacMillan Arctic expedition reaching the hypothetical land north of Alaska, according to Maj. Gen. A. W. Greely, dean of living polar explorers, commenting on the latest effort to clear up the secrets of the far north.

General Greely commanded an expedition sent to the Arctic by the United States government in 1881-84, and almost died of hunger at Cape Sabine, Ellensmere island.

"I am confident there is land of some sort west of Axel Heiberg island and north of Alaska," said General Greely, "I advanced that theory something like 40 years ago after I had observed peculiar flat-topped icebergs with well marked stratifica-

tions floating out of the Polar sea. Such bergs come from relatively smooth land where the yearly layers of snow are not broken up, and are well known in the Antarctic. No such icebergs originate in Greenland or in the known lands to the east.

"While I suggested the existence of land north of Alaska from my observation of icebergs, other students advanced the same opinion based on the study of tidal fluctuations. For more than a generation explorers have hoped to reach this supposed land but apparently the task is too great for dogs and sledges. But with airplanes it will be a different story. A 600-mile flight to the center of the unknown region and return should not be a difficult undertaking. I believe the trip will be made with little difficulty and that when this unknown region is visited a heretofore unmappped land will be discovered."

LEXINGTON, Ky., May 9.—The general assembly of the Presbyterian church of the United States (Presbyterian church south) will meet here May 21-28. The assembly represents 17 synods, with a membership of 438,818 communicants. The retiring moderator, Dr. Thonton Walling of Louisville, Ky., will preach the opening sermon, after which a new moderator will be selected.

Texas-Oklahoma Boundary Dispute Testimony Taken

BONHAM, Texas, May 9.—State and national officials were here today seeking information to clear up the long standing boundary dispute between Texas and Oklahoma. Arthur Stiles, of the state reclamation department, and Arthur Kidder, of

the general land office at Washington, were taking testimony from land owners relative to the meandering of the Red river.

Instances have occurred, the officials were told, where large tracts of land have been shifted from the Texas side of the river to the Oklahoma side by the changing stream. The Red river is nominally the boundary line between the two states.

Citizens' Military Training Camp Is Attracting Boys

FORT SAM HOUSTON, May 9.—Convinced by investigation and personal observation that there is nothing militaristic about the citizens' military training camps and that they fill a long felt need for a national school in mental, moral and physical development, educators, women's clubs, business men, the newspapers and public spirited citizens everywhere are rallying to the support of these camps.

Over fifteen hundred applications have been received at the headquarters of the eighth corps area for the 1925 C. M. T. camps for this corps area. The bulk of the applications are from young men who have attended the camps of the past, clearly proving that the best advertisement of the camps is the good will and hearty response evidenced by the former students who are returning again this year.

The quota to be trained in the eighth corps area this year is 3400, and a minimum objective of 5000 applications has been set in order to formally approve a total of 3400 to be subsequently ordered to the six camps of the corps area. Any healthy young man between the ages of 17 and 24 may apply for the first year course.

The six camps for the eighth corps area will be held at Fort Sam Houston, San Antonio, Texas; Fort Bliss El Paso, Texas; Fort Crockett, Galveston, Texas; Fort Sill, Lawton, Oklahoma; Fort Logan, Denver, Colo.; and Fort Huachuca, Arizona.

PREFERS TO BE "AMERICAN" RATHER THAN AN EARL

DENVER, Colo., May 9.—"Plain American," is a better title than that of Earl of Oxford in the opinion of John Aubrey, 90-year-old shoemaker, who declared today he was the lost heir to the Oxford estate in England.

Cut off from his family because he married a village girl, according to his story, Aubrey emigrated to America and won the title which he says is better than all others. In his 51 years of residence here he has worked as a railroad conductor, hotel proprietor and shoemaker—virtually a jack of all trades.

Aubrey broke his silence of years when he learned that former Premier of England Herbert Asquith had chosen the title of "Earl of Oxford" when nobility was conferred upon him by his king. Asquith was later denied the title when heraldic records showed that a "lost heir" to the same might be supposed to exist.

"Why should I vex my old age with it?" Aubrey replied when asked if he would push his claim. "It's an empty honor anyway."

BRIDGE SPANNING NECHES RIVER FORMALLY OPENED

 BEAUMONT, May 8.—A link in the Old Spanish trail connecting New Orleans and Houston was forged today when Gov. Miriam A. Ferguson ripped a silken barrier from across the new Neches river bridge, replacing ferries which have been in use for many years. The new bridge was constructed at a cost of \$600,000. Thousands of visitors were here to hear the governor's address.

BANDIT ARRESTED IN ARIZONA IS IDENTIFIED

PHOENIX, Ariz., May 9.—The bank robber arrested here late yesterday was fully identified today as Jeff Duree, last of the notorious Duree brothers band of Oklahoma and Kansas, according to Sheriff John Moore.

Duree will probably be turned over to Kansas or Oklahoma authorities as a fugitive from justice, Moore said.

Wichita Falls Woman Heads County and District Clerks

FORT WORTH, May 9.—Mrs. Alma Y. Miller of Wichita Falls was elected president of the county and district clerks' association of Texas Friday afternoon at the Texas. She formerly was vice president. She will become the first woman president the organization has ever had.

First vice presidency went to Albert Townsend of Houston. Sam Williams of Fort Worth, Tarrant county district clerk, was made second vice president, and Mrs. George C. Sweat of Waxahachie was elected third vice president.

SALE OF MUNITIONS TO INDIVIDUALS BANNED

 GENEVA, May 9.—The international conference on traffic in arms voted today to prohibit entirely the sale of arms to private individuals.

Some delegates favored total prohibition of all traffic in arms, excepting under conditions to be laid down by the League of Nations. Turkey was the only nation dissenting when a vote was taken on the question of prohibiting all sale of munitions to private parties.

 to appear that a party doing some act respecting the subject of litigation, or threatens or is about to do some act or is procuring or suffering the same to be done in violation of the rights of the applicant, which act would tend to render judgment ineffectual.
Duty of Court.
 "It is evident from careful consideration of the article of our

statute quoted that where any party to pending litigation contemplates or threatens to impair or dispose of in any way the subject matter of the litigation upon application of any adverse party, it becomes the duty of the court to issue such restraining orders as will prevent the disposal or impairment of such subject matter in litigation; and to retain as nearly as possible the property in statu-quo during the pendency of the litigation and until its final determination by the courts.
 "From reading of the pleadings of the defendant, Davison, it is apparent that he asserts claim to an

interest in said funds, his allegations in part being that he is the owner of the contract between Eastland county and Fleming-Stitzer Road Building company; that the contract provides that the full amount of the bond issue was to be expended on Eastland county's public roads under said contract, and alleging that by virtue of such conditions in said contract, Eastland county is legally bound to expend the funds rimounded in said bank, or so much thereof as may be recovered by Eastland county, when the same is available, on its public roads, and, that as the holder of said contract, he

would have the legal right to construct such roads and to the compensation therefor, provided for in the original contract.
Issues of Fact.
 "Eastland county, of course, denies that Davison has any such rights, contending that the contract previously existing between Eastland county and Fleming-Stitzer Road Building company has been consummated and Eastland county relieved of further obligation thereunder, and contending further that Davison has no rights under said contract, but admits that a portion of said funds have been collected by Eastland county, approximately \$40,000, and that small amounts of such funds have already been expended on Eastland county's public roads under contracts other than the Fleming-Stitzer Road Building company contract, involved in this litigation. These issues of fact, however, being raised by the pleadings, and a jury having been demanded to try and determine the issues of fact, I doubt the wisdom or authority of the trial court to invade the province of the jury by undertaking to determine, in advance of a trial on its merits, such issues of fact.
 "I am, therefore, of the opinion that the motion to dissolve the writ of injunction should be denied, and that the injunction heretofore issued shall be perpetuated until the rights of the parties are determined by the courts.
 "The effect of Judge Davenport's ruling making the injunction permanent is that all remaining funds derived from the sale of the \$4,500,000 road bond issue are tied up until the final outcome of the suit of Eastland county vs. G. A. Davison, in which it seeks to collect from Davison or his bondsmen, approximately \$64,000 discount on bonds. Other road funds are not affected. The suit of the County vs. Davison, which is set for hearing on May 18, has been tried twice and each time resulted in a hung jury.

PRESBYTERIAN PASTOR AT WEATHERFORD RESIGNS
 WEATHERFORD, May 9.—Dr. S. D. Logan, pastor of Grace Presbyterian church for five years, has tendered his resignation to take effect June 1. Dr. Logan came here from Tennessee, and in addition to his ministerial duties has taken an active part in civic enterprises, and has been an active member of the Chamber of Commerce.
 He will take a several months vacation and then make his permanent home in Tyler. The church here has not yet called a pastor.

MRS. SURLS RETURNS FROM MOTHER'S DEATHBED

Two hundred dollars extra prize money has been added to the bucking horse contest and to the steer riding contest. The entry list of cowboys and cowgirls who seek to win part of the prizes and secure a chance at the world titles held by the champions who will compete has become so heavy that only the riders of proven ability will be allowed to compete. The management has not taken responsibility for injuries or death of any contestant.

The Simmons cowboy band will be the official band for the rodeo. This band will play continuously during the performances. Clad in their vivid purple shirts and caps they present a colored picture.

The wild horses and steers reached Cisco Saturday and are penned at the football park. Visitors will be allowed to look them over Sunday afternoon. Never has such a string of vicious steers and horses been brought to West Texas and they are worth riding miles to see.

Recipes for Dinner In Month of May

Miss Mary Jane Parker of the Calumet Baking Powder domestic science department offers the following suggestion for a Sunday dinner in May:

Pineapple-strawberry cocktail
Roast lamb, mint sauce
Current jelly
peas Mashed potatoes
Turnips White salad
Ice cream marshmallow cake
Coffee.

Following are the recipes:
Cocktail—Four slices of canned pineapple, one pint of strawberries, diced; three tablespoons powdered sugar, and four tablespoons of juice from the pineapples. Mix and keep

cold till serving time.
Roast leg of lamb—Have the bone removed from a small leg of lamb, and the fat taken off without breaking the skin if possible. Stuff the cavity with a dressing made of one pint of moistened toast crumbs, squeezed dry, one egg, beaten, one tablespoon melted butter, salt and pepper and a small onion, minced. Sew up the leg, tie in a neat shape, and roast, allowing 20 minutes to a pound. Season the meat with salt and pepper, after it has been partly cooked. When tender, skim off the fat from the gravy and add water, thickening with flour and milk. Garnish meat using small turnips, boiling until tender; pour off excess water, season and add a sauce of melted butter.

White Salad—Allow seven large, white cherries (canned) for each person to be served. In the cavities

made by removing the pit put a blanched fibert. Serve on heart of lettuce leaves with a dressing made of mayonnaise and whipped cream.
Marshmallow Cake—Make a layer cake of any plain white cake. Between the layers place marshmallow, which have been slightly heated to soften. Cover with an icing made of one cup of powdered sugar, into which butter the size of a walnut has been rubbed, and enough thick cream added to make it the right consistency. Flavor with vanilla.

"Oh, I'll take it," replied the lady, "but I think you should come down more."

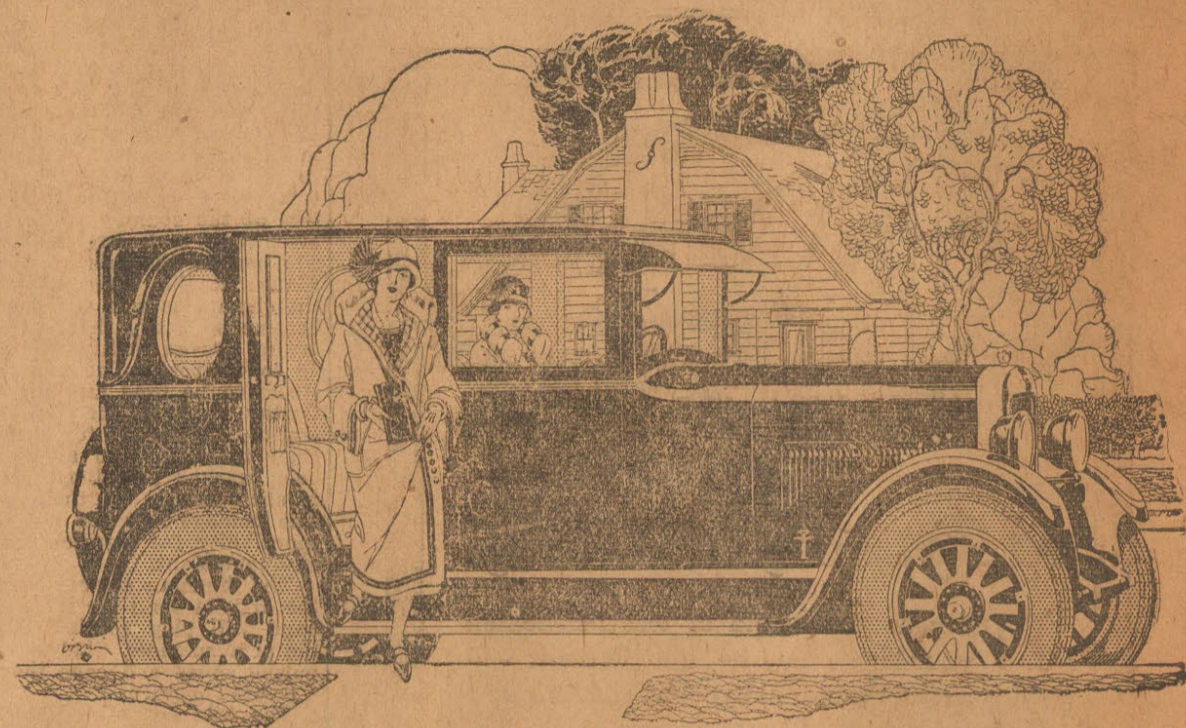
A survey of the store lighting conditions in an important western city recently completed showed that out of a thousand stores in that city just one per cent were properly lighted.

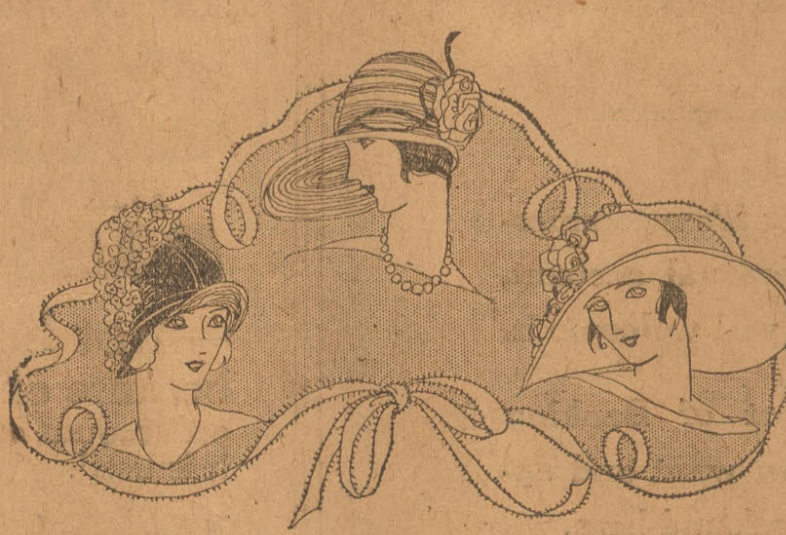
