Hamon Estate Receiver Asked

MUSKOGEE, Okla., June 1.—Application was filed in federal court today for the appointment of a receiver for the late Jake L. Hamon's estate. The application was made by the Liberty Trust company of St. Louis.

The estate of the late Republican national committeeman who was shot to death by Clara Smith Hamon at Ardmore, is valued at over \$3,000,000 in the petition filed by the St. Louis institution. It is set forth that the estate has liabilities greatly in excess of \$1,000,000 and that it owes the plaintiff company \$101,242.78.

The charge is made in the petition that Frank L. Ketch, administrator of the estate, has refused to allow the claim of the St. Louis institution, despite the fact that the plaintiff has a court judgment. The petition also charges that the administrator is allowing claims of other creditors.

Frank L. Ketch, administrator, Jake Hamon's widow, Mrs. Georgia Hamon Rorer, and his children, Jake L. Hamon Jr., and Ora Belle Hamon, are made defendants in the suit.

DAUGHTER'S PLEA SENDS FATHER TO DEATH IN ELECTRIC CHAIR

MICHIGAN CITY, Ind., June 1.—William E. Donovan, 38, was executed here early today for the murder of his wife. The execution followed the plea to Governor McCrae of Donovan's 17-year-old daughter, Mabel, to affirm the death penalty. Friends of Donovan were attempting to obtain clemency from McCrae when the daughter wrote the governor.

Donovan walked to the electric chair with resignation. The letter from Mabel, who is 17 years old, reads in part: "I am writing you in behalf of my mother who was murdered by my father, who was sentenced to death on June 1. I understand there are many efforts being made to get the sentence changed to life imprisonment. I do not want the sentence changed. I was an eye-witness to the murder. I had seen her kicked and beaten many times ever since I was old enough to remember. But because she loved us children, she made the best of it. My father cared for no one but himself. I want to say that the sentence given him is surely what he deserves."

EX-GOVERNORS ASKED TO AID IN WAR GRAFT PROSECUTIONS

WASHINGTON, June 1.—The Woodruff-Johnson resolution, providing for investigation of alleged laxity of the department of justice and the war department in prosecuting war grafters was given its death blow today. By a vote of 7 to 4 the house rules committee reversed its act of May 1, when it ordered the resolution reported to the house. Originally the committee voted 6 to 5 to press the investigation.

Attorney General Daugherty announced today that he would devote all the time possible to the pending war graft cases. In Chicago, where he will address the Illinois Bar association, Daugherty will confer with former Governor Francis McGovern of Wisconsin, noted prosecutor, and ex-Governor Deneen of Illinois, to secure their services, if possible. The attorney general has given up his vacation and will not go to the National Bar association convention in San Francisco.

MILE AND A HALF EXTENSION MADE NORTH OF TIFFIN

O'Donnal et al. Well on Hagaman Land Estimated Making 200 Barrels.

The three-mile stretch between the Texas company's big gasser on the Hagaman tract near Tiffin and production to the north has been virtually proved, oil men feel, by production found yesterday in the well of O'Donnal et al., which is located just west of the Ranger Rock crusher. The Mason & Ardizzone well in the same vicinity is reported on sand and expected to be in in the next few days.

An estimated production of 200 barrels was encountered in the O'Donnal well at 3,130 feet, in what is declared a high grade sand. The well is to be drilled deeper as soon as flow tanks can be erected and a large production is expected. The O'Donnal well is located about a mile and a half south of production and midway between production and the big gasser brought in by the Texas company several days ago.

The sand in the Mason & Ardizzone well was found at about 3,040 feet.

This stretch of territory was passed up during the boom days without a test, although the Hagaman and Gholson tracts to the north yielded numerous 1,000-barrel wells, which are still good producers.

G. O. P. EMPTIED DINNER PAILS, IS BATTLE CRY

INDIANAPOLIS, Ind., June 1.—Indiana Democrats meeting here today in state convention, laid the foundation for the fall campaign with a series of speeches blaming Republican management of national affairs for the business depression that has caused much unemployment. Speakers attacked the Republican state administration as spendthrift.

In the "Keynote speech," Frederick Van Nuy of this city declared the failure to ratify the Versailles treaty with its League of Nations covenant was largely responsible for the present economic and industrial difficulties.

The Washington conference, out of which grew the four-power pact and the naval limitation treaty, was described by Van Nuy as "the shadow of the substance of the League of Nations."

WOMEN KILLED IN KY. ROBBERY PLOT

BOWLING GREEN, Ky., June 1.—Reports have reached this city of a triple killing in Clay county, Tenn., about forty miles from here, in which three women met death.

It is said that a Clay county man sold his farm for \$1,800. This became known, and several men neighbors went to his house and asked him to go hunting.

They dressed as men, and with blackened faces went to the farm after he left. They tried to force the farmer's wife to give up the \$1,800 and, failing, are alleged to have cut the woman's throat.

LUCK BIGGEST AID TO SUCCESS, EDUCATOR SAYS

CHICAGO, June 1.—Luck is a dominant factor in human affairs, success is due less to ability than to luck.

This is the surprising assertion of A. N. Farmer, well-known educator, touring the Middle West to select a site for the \$10,000,000 home for fatherless and motherless children to be built by the Brotherhood of American Yeomen.

Mr. Farmer's statement is a slap at the tradition in which educated people are brought up. Most people are taught to believe there is no such thing as luck.

Only one man in a hundred, all starting at twenty-five with equal ability and opportunities, will be wealthy at sixty-five, according to Mr. Farmer. He submits the following statistics based on experience to prove this.

At 35 five of the number are dead, one is wealthy, ten are well-to-do, forty-nine live on their earnings, thirty-five have made no progress.

At 45, sixteen are dead, one is wealthy, three are well-to-do, sixty-five live on their earnings, fifteen are no longer self-supporting.

At 55, twenty are dead, one is wealthy, thirty-five live on their earnings, thirty are not self-supporting.

At 65, thirty-six are dead, one is wealthy, three are well-to-do, sixty on their earnings, fifty-four are not self-supporting.

"Why," asks Mr. Farmer, "is only one man in 100 of equal ability and equal opportunities rich at sixty-five? Luck is the answer."

"Thrift has much to do with it. But success will be lacking unless a man has excellent business opportunities, good health, a healthy family and a frugal wife. Doctors' bills have swamped many careers. So have extravagant wives."

"Once a man gets going the rest is easy. But if he marries before he has a good start, he often finds difficulty in getting started at all."

"Friends are a big figure in success. Education means much, but it must be of a specialized kind nowadays."

"I don't know what luck is, but it is one of the most important forces in the world in moulding human destinies."

FALLS ELEVEN STORIES; IS ONLY SLIGHTLY DAZED

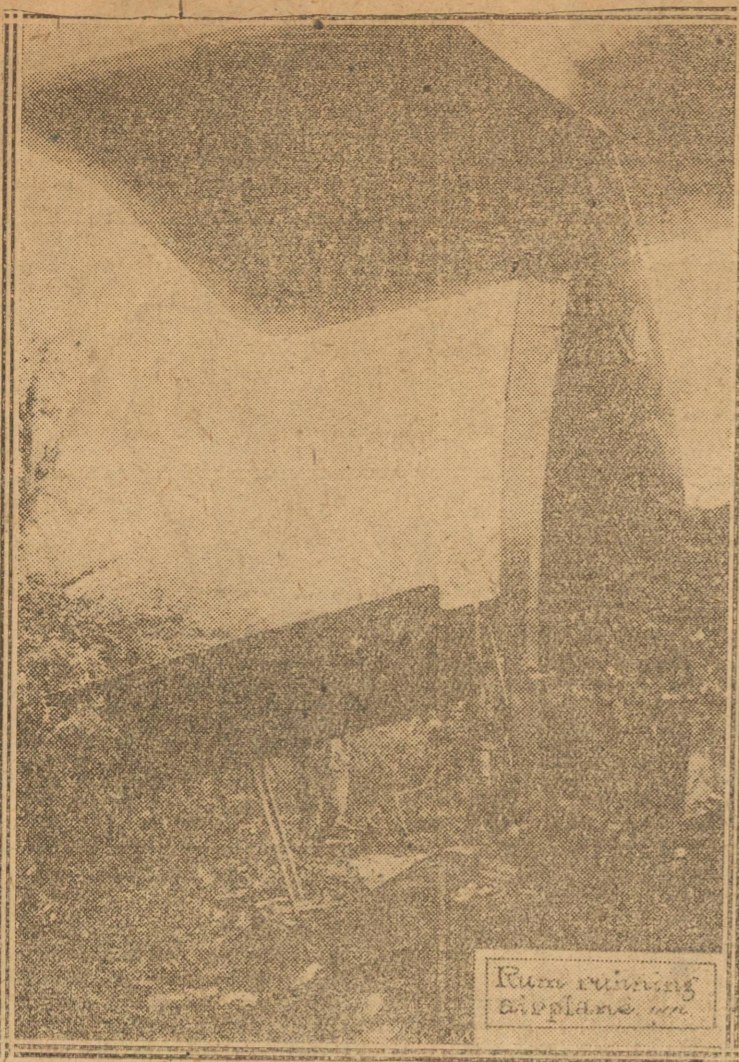

'MADMAN'S' EXPLOITS IN LINCOLN MAKE DIME NOVEL SOUND TAME

LINCOLN, Neb., June 1.—All Lincoln was on the trail today of Fred Brown, alias Gus Grimes, "Omaha madman," who chained two women in a hole under his shack last Saturday night. Brown's hairbreadth escapes in Lincoln during the last three days would shade a dime novel hero.

When last seen he was riding in an automobile stolen from Child Brodie, head of a national detective agency. Walter Schroeder, probate officer, exchanged shots with Brown shortly after midnight last night when he encountered the fugitive in the outskirts of Lincoln.

Brown since he appeared in Lincoln has drawn \$300 from a bank, escaped from a woman who recognized him on Main street in daylight and tried to hold him until officers arrived, and has entered restaurants several times to obtain food.

Lincoln police are undecided whether Brown is a master bandit with a keen, bold mind, or is half mentally unbalanced and blessed with unbounded luck.

N. Y. FAMILY BATTLES HORDE OF SWALLOWS.

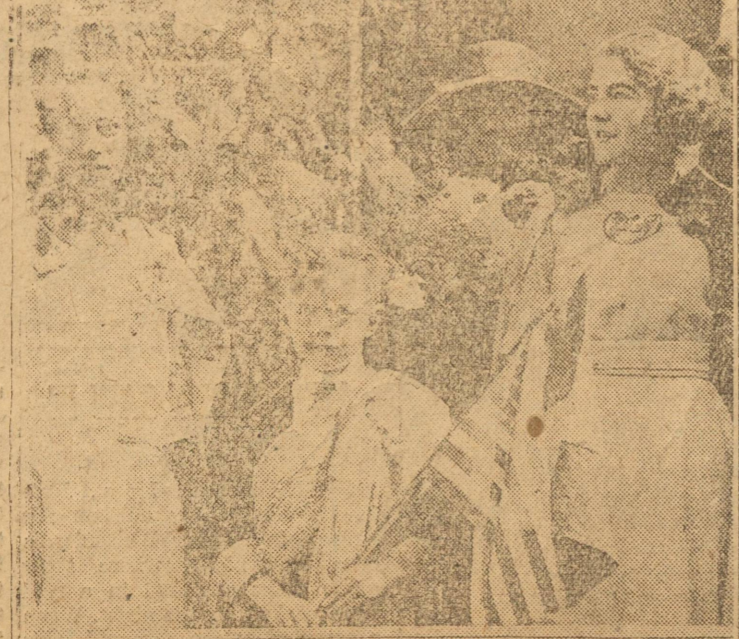
The invading forces used strategy, and while the Rices were at the movies flew into the chimney capouled as a cloud of smoke. At least that's what the neighbors say it looked like.

When the Rices returned, they heard the roar of thousands of whirling wings. Enemy "air forces" were in possession of the field. Their sooty feathers had left heavy smudges on new wall paper and furnishings. They roosted calmly on chairs and tables and refused to be driven when doors and windows were opened.

Then the Rices went into action. Most of their household goods already had been destroyed by the swallows, and the two began hurling the debris at the birds. The swallows retreated but they had left piles of dead behind. Rice counted 5,000 bodies before he became too tired to do anything but shovel out corpses.

After the battle the shipbuilder got busy strengthening his first line of defense. Today he could be seen placing a heavy steel grating over his chimney.

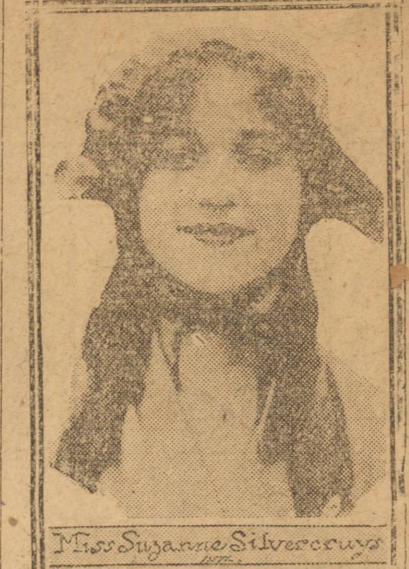

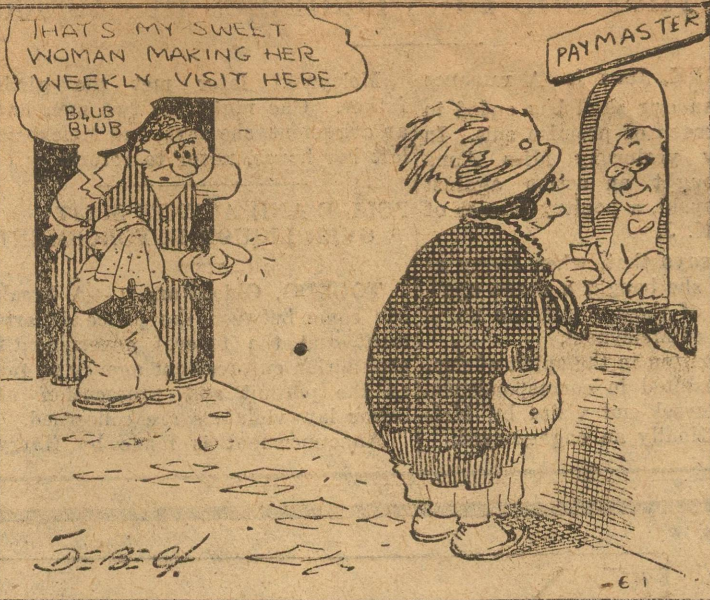
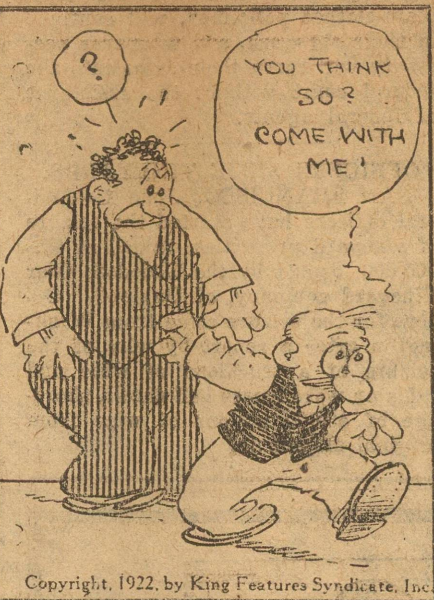

to replace street lamps broken by mischievous boys, according to George E. Carlson, city commissioner of gas and electricity.

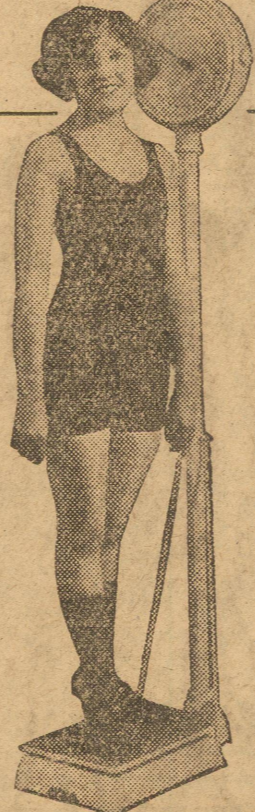
