

OKLAHOMA LEGISLATORS MEET IN CAPITOL

Sightseers Interfere With the Firemen

FIRE CHIEF IS INDIGNANT OVER SPREAD OF FIRE

Declares Autos Banked in Line of Work Cause of Flames Gaining Headway.

Dozens of automobiles lined up on North Marston street interfered with the laying of hose to fight a West Walnut street frame residence fire last night, and a delay of probably five minutes in stretching the hose resulted. By that time the fire was beyond control.

The house owned and occupied by J. E. Harbin was totally destroyed and all the contents lost. The fire started from a burning gas light.

After the chemical apparatus had apparently extinguished the flames, escaping gas from a gas light caused the fire to break out again and Chief Chapman ordered his men to lay hose to the fire hydrant at the rear of the Marston building on North Marston street, a distance of 450 feet from the fire.

Autos Jam street.

The autos had so jammed up the street that the firemen had to abandon their plans and lay their lines down Walnut street east and then south on Austin to a fire hydrant at the rear of the Paramount hotel. This required the use of 1,200 feet or 750 feet more than needed if the automobiles had not blocked the approach to the Marston street hydrant. This diminished the water pressure and with the time lost in carrying the hose two additional blocks, the fire had undisputed sway.

Chief Chapman was indignant today over the inconsideration of sightseers. "The only relief I see is for the city commission to pass and enforce an ordinance that would prohibit the approach of automobiles within 300 feet of a fire," he said.

Police Helpless.

Policemen were on the ground but their efforts were futile. The fire alarm was sounded about 8 o'clock, an hour at which ordinarily several hundred automobiles are in the downtown district. A large number of them immediately started for the scene when the fire siren on the fire truck sounded.

Harbin, who is a clerk at the J. M. White & Co. store, said the insurance he had on \$1,800 worth of furniture wouldn't pay for his wife's clothes. The insurance on the house, which he said would cost about \$800 to replace today, was also small.

The Harbins were on a short ride to Eastland when the fire destroyed their home. They arrived in Ranger about 9:40 o'clock and were not apprised of the disaster until they arrived at their home.

German Resistance In Ruhr Officially Comes to An End

BERLIN, Sept. 26.—The end of the German passive resistance to the Franco-Belgian occupation of the Ruhr and Rhineland was proclaimed officially today.

BERLIN, Sept. 26.—President Ebert today issued a proclamation to the German people saying that the struggle to support the financial strain of holding out in the Ruhr was too great and must be abandoned, but only without the surrender of the slightest part of German territory.

"It depends upon the powers which invaded us and their allies to restore peace to Germany by adhering to their treaty agreement or by rejecting this to bring about the peaceful relations between the people that should proceed therefrom," says the proclamation.

MACON MAN ON TRIAL

MACON, Sept. 26.—After calling a few character witnesses in an effort to discredit testimony given by state witnesses in the trial of Dr. C. A. Yarnborough, Macon dentist, charged with flogging W. O. Barnes, the defense rested its case.

Storm Reported on Way From Bahamas To Gulf of Mexico

HOUSTON, Sept. 26.—A storm warning was issued here today following report of a storm moving across the South Atlantic and towards the gulf coast, the first storm of the season, was received from the Bahamas islands.

Advices by the local weather bureau said the storm was central in the vicinity of the Bahamas and was moving northward attended by shifting gales. Vessels in the South Atlantic were advised to use every precaution.

Police Trying to Locate Slayer of High School Girl

MILLVILLE, N. J., Sept. 26.—Detectives are trying to solve the mystery of the slaying of Emma Dickson, 15-year-old high school girl, and are going to Philadelphia to question a young man there who may be able to throw some light on the killing.

Irma Hummel, chum of the slain girl, has identified a picture of the Philadelphia man, whose name the police will not reveal, as the man she saw in a motor car with Miss Dickson the day she disappeared.

A bloody hatchet was found in a shed near here and some of those working on the case believe the girl was attacked in the shed and her body afterwards taken in an automobile to the woods where it was found.

ALLEGED FLOGGER IS FOUND GUILTY, DRAWING FIVE-YEAR SENTENCE

GEORGETOWN, Ex., Sept. 26.—Murray Jackson, alleged member of a band that flogged R. W. Burleson, faces a penitentiary sentence of five years, following conviction of an alleged assault with a prohibited weapon in connection with the flogging of Burleson. The jury was out about 20 minutes.

Frequent references were made to the Ku Klux Klan during progress of the trial. Witnesses testified that Jackson was a klan member and that the plan had planned to raise a fund to pay for his defense.

LIQUOR SMUGGLED IN ENCASED IN CANDY

GALVESTON, Sept. 26.—Candy is the latest means of smuggling liquor into the three-mile limit along the gulf discovered by officers here. When a shipment of fine candy was contained on a ship recently, it was discovered that each piece was filled with a high grade liquor.

Officers had examined the ship carefully and found no signs of liquor. But just before leaving the ship a customs officer sighted a considerable supply of candy boxes. On opening one he found it contained chocolate candy. It happened, however, that one piece had become crushed and its contents leaked out. On further inspection, each piece was discovered to contain about a teaspoonful of liquor. The candy came from Germany. It was confiscated immediately.

Officers declare this is one of the most novel schemes that has been discovered in efforts to get liquor into this country along the gulf. The officials now are paying close attention to candy shipments that may come under their inspection at port points.

MARLIN LAWYER APPOINTED JUDGE OF APPELLATE COURT

AUSTIN, Sept. 26.—Judge James Robertson of Meridian has resigned as a member of the Tenth court of civil appeals at Waco, and John W. Spivey of Marlin has been appointed to the place on the bench, according to announcement at the governor's office this morning. The appointment becomes effective Sept. 29.

Reynolds was on the flat car when the team of horses were scared and he was thrown to the ground while removing casing from the car to the wagon.

Reynolds' parents live in Gorman. He was employed by Williams Bros. pipe line contractors.

'Princess Petrolia' Will Be Crowned At Oil Exposition

TULSA, Sept. 26.—Plans for a gathering here of oil interests, to be known as the international petroleum exposition and congress, at which discussion of every phase of the petroleum industry will be interspersed with exhibits of educational value and recreational features, are being rapidly concluded by committees of local oil men. The exposition and congress will open October 8 for one week.

Three full-sized drill rigs, one cable tool, one rotary and one diamond core will be in operation during the week. The plans call also for a complete miniature refinery, a working model of an absorption gasoline plant and a model tank and tank cracking unit. Model tank steamers, tank cars and air tight steel tanks have been promised.

Entertainments will include parades and pageants in the court of king petroleum, concluding with the coronation of "Princess Petrolia" at the end of the exposition.

Educational and historical phases of the industry will be emphasized in the display. Equipment used in the world's first oil well, drilled in 1859 by Col. E. L. Drake, will be sent from Bradford, Penn. Thos. Galey of Independence, Kans., plans to send tools used in the Mid-Continent field's first wildcat well near Neodesha, Kans.

DAUGHTER OF ORANGE MAN IS ACCIDENTALLY KILLED

ORANGE, Texas, Sept. 26.—The eight-year-old daughter of Bill West, resident of the oil fields, was killed this morning when a shotgun held by her father went off when he stepped into a hole. The father was overcome by grief.

JACK WALTON FACING CRISIS, KLANSMAN SAYS

Hanging Promised if Blood of Klan Is Spilled in State Of Oklahoma.

WILMINGTON, Del., Sept. 26.—"If one drop of klanman blood is spilled in Oklahoma today, Governor Jack Walton of that state will be hanged before sunset. The klan in Oklahoma has done no harm. It has been law abiding and we feel that the legislature has the right to meet."

This statement was made by Dr. J. H. Hawkins of Atlanta in addressing 400 members of the Wilmington provisional klan early today. Dr. Hawkins is a klan official who is engaged as an organizer.

"Orders to mobilize the klan of Oklahoma have been issued," he said. "They will fight for their constitutional rights, but will fight within the law."

Governor's Agents Prevent Assembly In Hall of Hotel

OKLAHOMA, CITY, Sept. 26.—With the atmosphere charged to a feverish pitch, Charles Brice, speaker pro tem of the house, attempted to call the members to order. He had just uttered the words, "Gentlemen of the house—" when Colonel Keys broke in and called on every member to remain motionless. He then read the governor's order forbidding an assembly.

W. E. Disney, representative from Muskogee, asked if the gathering was being dispersed as legislators or individuals.

"You are being dispersed as legislators," Colonel Keys responded. Throughout the proceedings no one but the military approached the chamber. For a moment the situation took on a threatening aspect. There was determination written on the face of Colonel Keys as he read the governor's order. He spoke in a harsh voice and left no doubt as to his intentions to carry out the orders of his chief.

Not more than 200 persons witnessed the scene. The legislators left the capitol and went to their headquarters at a local hotel. They were met by 10 armed operatives of the governor in civilian clothes, and informed that they could not meet in the hotel. They went to another hotel.

"We have met the enemy and we are theirs," said W. D. McBee, leader of the special session, after the failure to meet. "But we are not through."

Representative Disney declared the legislators will remain in Oklahoma City three months. A meeting of the house legislative legal committee was in progress in a downtown hotel one hour after the legislators were dispersed.

Several secret operatives of the governor were ordered from the hotel by Representative Singletary, from Oklahoma City. They left without a protest.

Col. R. A. Sneed, secretary of state, declared he filed the call of the session in the archives of the state, where it would become a part of Oklahoma's history.

"It is the most glorious public document in the history of Oklahoma," he said. "A new Magna Charter of American liberty and a dedication to justice in this republic."

STATE OFFICERS START TO LEAVE OKLAHOMA CAPITOL OKLAHOMA CITY, Sept. 26.—A move by several state officers to evacuate the capitol building because it had become an armed camp, filled with gunmen, soldiers and detectives, was started here today by E. R. Hughes, Republican member of the corporation commission.

COLONEL KEYS, NATIONAL GUARD COMMANDER, MAKES IMPRESSIVE ADDRESS TO THE LAWMAKERS

Gathering Attended With Little Noise of Demonstration. Governor Walton Stays at His Home. "End Is Not Yet" Says McBee, Who Claims Meeting Satisfactory and Plans Appeal to Courts.

OKLAHOMA CITY, Sept. 26.—The Oklahoma legislature, attempting to convene this morning for the impeachment of Governor Walton, was dispersed before the door of the hall of representatives today by the Oklahoma national guard. The members left the capitol building silently. There was no demonstration.

Court action will be instituted immediately, according to W. D. McBee, leader in the lower house who was instrumental in getting the call for the legislature signed.

The insurgent legislators had been gathering in the capitol throughout the morning preparatory to an attempt to convene in extraordinary session at noon. A few minutes before 12 o'clock they started crowded before the locked and guarded door of the hall of representatives.

Colonel Key Enters.

Exactly at noon, as the representatives stepped forward as though to rush an entrance, a shout was heard at the entrance of the senate chamber, across the lobby, attracting the legislators' attention. Colonel W. S. Key of the national guard, military commander of the city, asked them to assemble about him. They did so quietly. Meanwhile the governor's detectives and plain clothes men had formed an outer cordon.

Colonel Key read an order from Adjutant General Markham informing the representatives the governor had warned him the legislature must not try to convene and he asked the legislators to disperse. The crowd melted quietly away and left the capitol in a body, discussing developments in low tones. It was apparent that the leaders had anticipated Governor Walton's orders and the representatives had their own plans prepared. No attempt was made to force an entrance into either the house or senate chamber. The governor's detectives and plain clothes men followed the legislators from the building.

Governor Walton remained in the executive mansion all day and did not come to his office in the capitol. Several hundred women, each waving an American flag, gathered in front of the capitol. They were mostly wives and daughters of the law makers.

Just a few minutes before 12 o'clock a call for a special session of the legislature, bearing signatures of 65 members, was filed with the secretary of state.

PRESIDENT REFUSES FEDERAL BUILDING TO OKLAHOMA SOLONS

WASHINGTON, Sept. 26.—President Coolidge has directed that all federal officers in Oklahoma maintain the strictest neutrality in any clash that may occur between the forces of Governor Walton and the civil authorities in Oklahoma. The president is determined the federal government shall not be drawn into the Oklahoma trouble by either side unless it becomes necessary to intervene to prevent a large loss of life or suppress mob violence.

Orders prohibiting the use of the federal building were telegraphed late last night by Campbell Bascom Slemm, private secretary to President Coolidge, to the custodians of all the federal buildings in Oklahoma.

CAPITOL O FOKLAHOMA SWARMED WITH GUARDSMEN

OKLAHOMA CITY, Sept. 26.—Military occupation of the state capitol building, intended to prevent the meeting of the lower house of the legislature, was completed at 9:50 this morning. About 100 guardsmen were stationed in the building, every corridor, every outside entrance and all driveways in the vicinity were patrolled.

A statement warning the house members not to carry any guns to the capitol was issued by W. D. McBee, leader in the special session program. He told the legislators as they gathered to march at noon to the capitol, "there must not be the least thing provocative in our attitude."

McBee said the legislature had not thought of using the federal building for the legislative session.

MORE TO FOLLOW SAYS M'BEE TO OKLAHOMA STATE

OKLAHOMA CITY, Sept. 26.—The Oklahoma legislature has not given up its fight to convene, according to a bulletin issued today by W. D. McBee, a leader in the lower house. The statement was issued immediately after the legislators had obeyed the military order to disperse. It read as follows:

"About 70 members of the house of representatives, feeling it their duty to convene to restore constitutional government in Oklahoma to take the place of the conditions of despotism, have met the emergency by convening with its duly appointed speaker pro tem. Temporarily we are thrown out.

"We realize that our constitutional rights are in the balance, as did our forefathers in 1776. We feel that our cause is just and we will 'carry on.' Never in the history of the American republic has such a complete dictatorship been established as now prevails in the once fair state of Oklahoma. There is more to follow."

MARCH ON CAPITOL PUSHES STATE FAIR NEAR TO OBLIVION

OKLAHOMA CITY, Sept. 26.—With all business suspended in this city early today, the people were prepared for war. Members of the state legislature were assembling at 9 o'clock for the march on the capitol, which is surrounded by a military cordon armed by Governor Walton and with the executive's order to "shoot to kill."

If the members of the legislature manage to gain entrance to the capitol building, the house of representatives will be convened in extraordinary session and impeachment proceedings against Governor Walton begun.
