Top O' Texas CattleWomen selected Bob and Dianne Buckingham as their Ag Family of the Year. Each year a family is selected that represents the best of farming and ranching in the area. The week of March 17-23 is Ag Week in the United States and we would like to call attention to the fact that people spend the least of their annual income for food and clothing than any other country in the world. Farmers and Ranchers are also some of your best conservationists of the land, water and wildlife.

Bob and Dianne Buckingham operate 66 Ranch a commercial Hereford operation north of Shamrock, Texas in Wheeler County.

Bob and Dianne have operated 66 Ranch for over 32 years they have two sons Bobby who lives in Alva, Oklahoma and Danny who lives in Sunray, Texas. They also have two granddaughters, Julia and Billie, who live in Alva, Oklahoma.

Through the past 32 years they have built a commercial Hereford herd. One half of their Hereford cows are bred for F-1 cross calves the other to top Hereford bulls for replacement heifers each year. They also run yearling's year around in the winter on wheat and grass in the summer.

They have been Stewarts of the land and have used conservation practices since before they became important. There philosophy is "If you take care of the land it will take care of you." Bob is conservative in amount of cattle that he runs to allow for year around grazing to be sure that his cattle have sufficient pasture. On others he has rotations for his cattle. By his practices there is forage for his cattle year around and any wildlife that is there.

Bob and Dianne work together in daily operations. Bob is an avid horseman and all cattle work is done horseback. In the spring they have a branding crew who rope and drag as it was done in the past. Dianne does the cooking for the crews, hauling meals to different locations.

Besides raising Hereford cattle they also raise registered quarter horses. Some of the gelding they raise are ridden and used on the ranch.

Bob and Dianne are members of Texas & Southwestern Cattle Raisers, National Cattlemen's Beef Association, Texas Hereford and American Quarter Horse Association.

Dianne is an active member of American National CattleWomen and Top O' Texas CattleWomen serving as past president. She is Local treasurer; local and state chairman of Beef Gift Certificates.

She has served on many commit-

tees and responsible for the publishing of local cookbook for Top O'Texas CattleWomen. In her spare times she helps at the Methodist church with Boosters, Funeral taskforce, and their annual Bazaar. She is also member of Thursday Literary Club.




Deadre Henderson of Canadian attended the Rolling Plains Bobwhite Brigade held June 23-27 on the Krooked River Ranch. The Bobwhite Brigade is designed to teach teenagers about quail management, improve public speaking skills, and encourage leadership.

Thirty teens from the rolling plains region of Texas spent approximately 100 hours at the camp. These "cadets" were divided into six cabin groups called coveys, just like quail. Each covey was named after a species of quail that resides in the United States. There were the Gambel's, Bobwhite, Blue, Mearn's, Mountain,

ranchers to Ph.D.-holding biologists, were present to inform cadets about various subjects, activities, and demonstrations. These activities and demonstrations ranged from quail dissection to shotgun safety. marching and shooting contests, and, at the end, the top covey was the first to choose items from a table full of merchandise donated by Cabela's.





pies the building next to the bank on the west. Edward Meek occupies the next building with Dry Goods and Grocery Store.


The three buildings mentioned are each of concrete blocks. They are one story and 30 feet by 70 feet.
