County Expected To Have Electronic Voting Machines By January 1, 2006

Commissioner's Court met in reqular session on Monday, March 28, 2005, at 10:00 a.m.

Ten items were on the agenda. The court approved for payment thehourly payroll time sheets as

The commissioners approved the payment of the bills.

Item #3 was the consideration of the budget. County treasurer, Jauna Benefield informed the commissioners of \$8,000 in the budget, which is allocated for D.A.R.E.: this moneys can be moved to the D.A.R.E. account with \$12,000 budgeted. The moneys in the D.A.R.E. account can then be used for salary for Deputy Burrell and offset the shortfall in the sheriff's budget. The transfer was approved. Commissioner Moore requested the permission to transfer \$5,000 from his "materials" budget to "repair and supply"; the transfer

was approved. The court moved to contact Phoenix I with a list of repairs to be

Wheeler County made at the courthouse in an effort to bring the restoration project to a close. Signs for the offices have not been received either.

No action was taken on the burn

The commissioners passed a resolution stating Wheeler county will work toward using funding to help with the Help America Vote Act. The federal government expects Wheeler county to have voting machines by January 1, 2006. Funding is to be available for the purchase—no allocation for training; no money is in the account at

The court approved the transfer of employee Dean Lax from precinct 4's payroll to precinct 2's payroll effective April 1; salary will remain the same.

The court also approved the transfer of county employee, Frank Moya, from courthouse maintenance to precinct 4 with the salary to be base pay for a county road

The commissioners were informed of a need for a ramp at the county jail. It was decided to present a design at the April 11 meeting. Inmate labor will be used in the project.

Hwys. 83/152 Improvements Scheduled For Next Year Left Turn Lanes for Hwy. 83 At Light

The Texas Department of Transportation (TxDOT) is planning a project in Wheeler to rehabilitate the pavement with a new surface on US 83. This project will begin at the roadside park south of Wheeler and continue through the city of Wheeler to the north city limits. The plans call for the widening of US 83 with two lanes both north and south and a dedicated left turn lane throughout the project.

US Highway 83 presently measures 64' from the back of the curb to the back of the opposite curb. This distance will be increased to 66' and will not pose a problem for property owners.

On SH 152, the roadway will be narrowed by 7' on both sides,

Glenn Williams, 96 Services Are Wed.

Glenn Luther Williams, 96, died Saturday, March 26, 2005 at Wheeler, Texas.

Services were at 2:00 P.M. Wednesday, March 30, 2005 in the First United Methodist Church in Wheeler with Rev. Rick Carstensen, Pastor officiating. Burial was in the Wheeler Cemetery under the direction of Wright Funeral Home.

Mr. Williams was born to Luther and Ruby Texas (Baker) Williams in Tecumseh, Oklahoma on April 29, 1908. The family moved to a ranch south of Wheeler when he was a small child, and there he and his two younger sisters grew up. As a young man, Glenn worked in the County Clerk's office, and also was employed at the local bank. One June 2, 1932 he married Idabel Carter of Wellington. The newly married couple lived on the family ranch several years before moving to New Mexico where he ranched near Artesia. then in the Corona area before buying a ranch north of Mountainair. In 1947 he changed careers, sold the ranch and bought the local hardware store. It was in Mountainair that he and Idabel raised their children. A devout Christian who lived his faith, he was active in church as well as in community affairs. He was also a Mason. Glenn, however, was always a rancher at heart. After their children were grown he sold the hardware store and he and Idabel then returned to Wheeler for 6 or 7 months each year where he began to restore and improve the same land he had loved as a boy. After Idabel's passing in 1989 Glenn made the ranch at Wheeler his permanent home. He worshiped regularly at the Wheeler United Methodist Church.

He was preceded in death by his parents, Luther and Ruby Williams, his wife, Idabel, 2 sisters, Wilma and Claire Williams who passed away before he was born, and his younger sisters, Bennie May Whitener and Ruby Lee Sandifer.

Glenn's family find confort in knowing that he is with the Lord Jesus and his loved ones who have gone on before, and that all those who survive him may one day through faith in Christ, join him there as well.

Survivors include 1 son, Glenn Carter Williams and wife, Beatrice, also of the ranch; 2 daughters, Carita Shockey and husband, Don, of Mountainair, NM and Catherine Dailey and husband, David, of Albuquerque, NM; 10 grandchildren; and 16 great-grandchildren.

making the roadway one lane in each direction with a dedicated left turn lane from two blocks west of US 83 to the east city limits of Wheeler. A raised median will be placed at the courthouse to separate the courthouse parking from the highway traffic.

Presently, the US 83/SH 152 intersection has an asphalt surface. This will be replaced with concrete for one block in all four directions. This will eliminate the rutting that is experienced each summer due to truck traffic. The intersection will also be reconfigured for a wider turning radius to accommodate truck traf-

Parallel parking will be implemented on SH 152. This is for the safety reasons and will eliminate motorists from having to back out

As another safety feature of this project, sidewalks will be added on the west side of US 83 only. This will add a safe pedestrian path to the school.

This project will let in December 2005; it should tentatively begin in the spring of 2006.

A project was let in December 2004 to overlay the pavement surface with 2" of hot mix on SH 152 from the east city limits of Wheeler to the Oklahoma State line. This project should begin mid-summer.




FILING OF A BUSINESS PERSONAL PROPERTY RENDITION IS NOW MANDATORY (Texas Property Tax Code Sec. 22.28)

The Wheeler County Central Appraisal District is making it publicity known that a 10% penalty of the tax liability will be imposed for failure to file a 2005 timely rendition.

Renditions are due on or before April 15th of the current tax year. With approval of the Chief Appraiser a 30-day extension will be granted if requested in writing before the statutory deadline.

The District or County Attorney will be authorized to bring a civil suit on behalf of the Appraisal District for fraud if there is evidence that a rendition included false information, or if the owner intentionally omitted required information in order to avoid taxation. If the courts, finds fraud, the monetary penalty is 50% of the tax liability. The matter may also be referred for criminal charges under Section 37.10 of the Penal Code.




