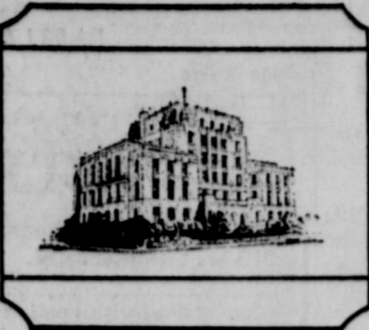

Funeral services for James McCarty Daniel, 79, were held Friday at 3 p.m. in the Arrington Hamner Funeral Chapel with Mr. Milton Underwood, pastor of the Church of Christ, officiating.
 Mr. Daniel died Wednesday in the Eastland Memorial Hospital after an illness of three years.
 Born Dec. 6, 1885, he was a lifelong resident of Morton Valley. He was a farmer and rancher.
 Survivors include three sons, Varge of Eastland, Worth of Dallas and Col. George Daniel of Arlington, Va.; one brother, Ed Daniel of Cisco; and six grandchildren.
 Pallbearers were Jack Baker, Vernon Carter, Curtis Young, W. Q. Verner, Nute Hart and R. M. Sneed.

Judge George Davenport To Be Buried Sunday at 2 p.m.

Funeral services for Judge George L. Davenport, 91, will be held Sunday at 2 p.m. in the Arrington Hamner Funeral Chapel in Eastland with Rev. J. Lester Davenport, his nephew, officiating.
 Judge Davenport died Saturday morning at 2 a.m. in All Saints Hospital at Fort Worth, where he had been a patient for some time.
 He came to Eastland with his parents at the age of 14 and read law in local law offices. He was admitted to the bar in this county and was county attorney for two years.
 Miss Davenport, all of Eastland.
 Born Aug. 27, 1873, in Coryell County (Eagle Springs, Tex.) he served as 91st District Court Judge in Eastland from 1921 until his retirement in 1952. His vacancy on the bench was filled by the late Judge T. M. Collie.

New Highway Patrolman, On Duty In This County, Familiar With Enforcement

Law enforcement is not entirely new to Patrolman Kenneth Perry, although he has just completed the Texas Department of Public Safety Academy for Patrolmen and been assigned to the Eastland office of the Highway Patrol.
 Perry, 26, is the son of Mr. and Mrs. Fred Perry of Fort Worth. His father is presently with the Mansfield (near Fort Worth) Police Department, and was formerly with the Tarrant County Sheriff's Department.
 A native of Goldthwaite, young Perry graduated from Lakeworth High School near there in 1956. He served with the Army at Ft. Wainwright, near Fairbanks, Alaska, with an artillery-missile unit for two years, being discharged in July, 1963.
 He drove for ICX Freight Co. in Fort Worth before joining the DPS and attending the 16-week academy in Austin, which began Nov. 17. He was among the 89 who graduated from the academy, of the 122 who began the course.
 He picked the highway patrol as a career because he had friends who are patrolmen and is aware of the public service to be rendered by patrolmen. Friday was his first day of duty, and he joined Veteran Patrolman Jack Therwanger in cruising the highways of Eastland County.
 Sgt. Roger Sosebee, Eastland office supervisor, expressed his appreciation in securing the caliber of man Perry presents to join the patrol here.
 Listing baseball and skin-diving as hobbies, Perry has played semi-professional baseball, and attended the Red Sox instructional school in Florida in 1957.
 His assignment to the Eastland office comes at a good time because of the recent duty loss of Patrolman E. M. Rogers, who is recovering from injuries in an Abilene hospital. Rogers was reported in good condition at week's end, and it was reported that he might not have to have additional surgery. He sustained severe, multiple injuries when struck by an auto recently while directing traffic following a crash east of Ranger.

 Survivors include his wife, Evelyn, a teacher in Eastland High School; one son, John H. of Fort Worth; one daughter, Mrs. Ellen Elliston of Dallas; three brothers, A. S. of Cisco, S. L. of Hico and R. Q. of Muleshoe; three sisters, Mrs. Earl Moon of Strawn, Mrs. A. A. Pesch of Breckenridge and Mrs. Howard Hanyan of Vernon; and four grandchildren.

Ranger Woman's Murder Trial Opens Monday; D A Will Ask Death Penalty

Maurine Bratton, 45, of Ranger will go on trial for murder in 91st District Court Monday morning. She is under indictment for the Sept. 30, 1963, slaying of her former husband, R. L. Bratton. The couple had been divorced for some time. The shooting occurred at Mrs. Bratton's ranch home near Ranger.
 She has been free on \$2,500 bond since.
 Her attorney, Bill Hart of Eastland, said that no continuance motion will be asked, and that he is ready to go to trial.
 District - County Attorney Perry Brown states that he is also ready for trial.
 A special venire of 100 persons has been called for possible service, and qualification will begin at 9 a.m. Monday. Mr. Brown indicated that he will attempt to qualify jurors on the death sentence.
 District Judge Frank Sparks, who estimates that the trial will take about three days, expressed confidence that a jury can be picked from the venire, without calling additional.
 (Attorneys can strike 15 each for no stated cause and any number for cause.)
 The indictment against Mrs. Bratton charges murder with malice.
 The case this week will mark the first murder trial in the 91st District Court to be presided over by Judge Sparks and prosecuted by Attorney Brown.
 Attorney Hart successfully represented a Ranger Negro last fall and won an acquittal on a murder trial.
 Mrs. Bratton, her 19-year-old daughter and two grandchildren, live at the ranch home near Ranger.

'Top Quality' Entries Vie In Successful Stock Show

A Hampshire, shown by Bill Cozart, Cisco FFA boy, is the grand champion fat pig of the 1965 Eastland County Livestock Show which unreeled in Eastland this weekend.
 Over 500 animals competed for prize money and ribbons in the annual show, and the quality of the stock prompted judges to exclaim "Tops," and "As good as you'll find," repeatedly. Some \$1,800 went as prize money.
 Terry Geye, Rising Star FFA member, showed the reserve champion fat pig, a Duroc, during the Friday afternoon competition.
 All animals were to have been on the grounds by 10 p.m. Thursday and classifying and sifting began at 8 a.m. Friday. Judging of Angora Goats began at 10 a.m. and the breeding swine judging at 1 p.m. Fat barrow judging began at 2. Breeding sheep (fins wool, Southdown and others) got under way at 7 p.m. Friday, followed by a FFA-4-H judging contest.
 Saturday's action began with fat lamb judging at 8; fat steer judging at 11; and breeding beef cattle at 2 p.m. The annual auction at the Eastland Auction Co. closed the crowd-attracting event Saturday night.
 Sam Kimmell of Cisco is president of the sponsoring Eastland County Livestock Raisers Association, and Robert Kincaid of Cisco was general show superintendent. Both called this year's show a great success.

Ranger Riding Club Sweeps Parade Honors

The Eastland County Livestock Show marched along Friday afternoon as the annual stock show parade made its debut along the streets of Eastland. A band, riding clubs, girls and automobiles highlighting the cowboy affair.
 The winners were announced after the parade which consisted of Ranger Riding Club taking 1st place honors for the best riding club and followed by the Rising Star Riding Club, placing 2nd place entry. The Eastland Band took honors for the band section led by senior drum major Jeanne Hanna.
 Other prancing horses and their riders consisted of the Eastland Riding Club, better known as the Eastland County Sheriff's Posse, Cisco Riding Club, and a group of horsemen riding to show their beautiful horses.
 The auto dealers of Eastland pitched in their shiny wares as they showed off their special cars, which consisted of cars red in color to a faint white. Pipkin Sport Center's entry traveled with a large live rattlesnake that didn't appreciate getting so much publicity.

'Olden System Assured With 80 Customers'

Eighty customers had been secured for the Olden Water Supply Friday, and the committee stated that the system is definitely underway as only 75 customers were needed to secure the system.
 A goal of at least 110 customers has been set by the committee in order to lower water rates to the minimum cost.
 Persons interested are urged to contact Bill Hunter, secretary, or any member of the steering committee.
 Cost to the individual is a \$50 deposit and monthly water bill, which are presently estimated to run between \$4.50 and \$6. There will be no tax or mortgage obligation.
 Water will be purchased from the City of Eastland, and a 30-year loan will be negotiated with the Farmers Home Administration to put the system into being.
 The only source of revenue will be from the sale of water and will be used to repay the government loan, and to pay for other operating expenses. The association will be a non-profit organization.

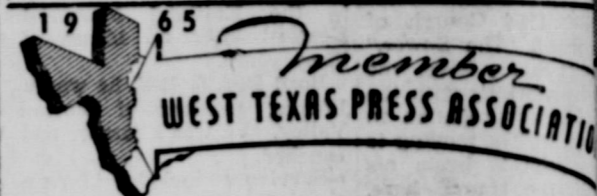

"The period set by law for securing the 1965 sticker ends at midnight, April 15, and there can be no extension of that deadline," Boustead pointed out. "Any Texas motorist whose vehicle does not display the new sticker after April 15 is subject to arrest by any sheriff or his deputy, any city policeman, or by officers of the Department of Public Safety."

Boustead said that in the remaining month of the inspection period there is sufficient time for the 5,300 official inspection stations to inspect the remaining vehicles without undue inconvenience to the motorist, provided the vehicle owners act promptly.

"From now until the deadline, every minute of the inspection station's time will be at a premium," he warned, "and waiting lines will become general throughout the state."

He suggested that congestion at inspection stations would be lessened if known defects in a vehicle were repaired prior to presenting the vehicle to the station for inspection.

Inspection stations are located in towns throughout the county.
