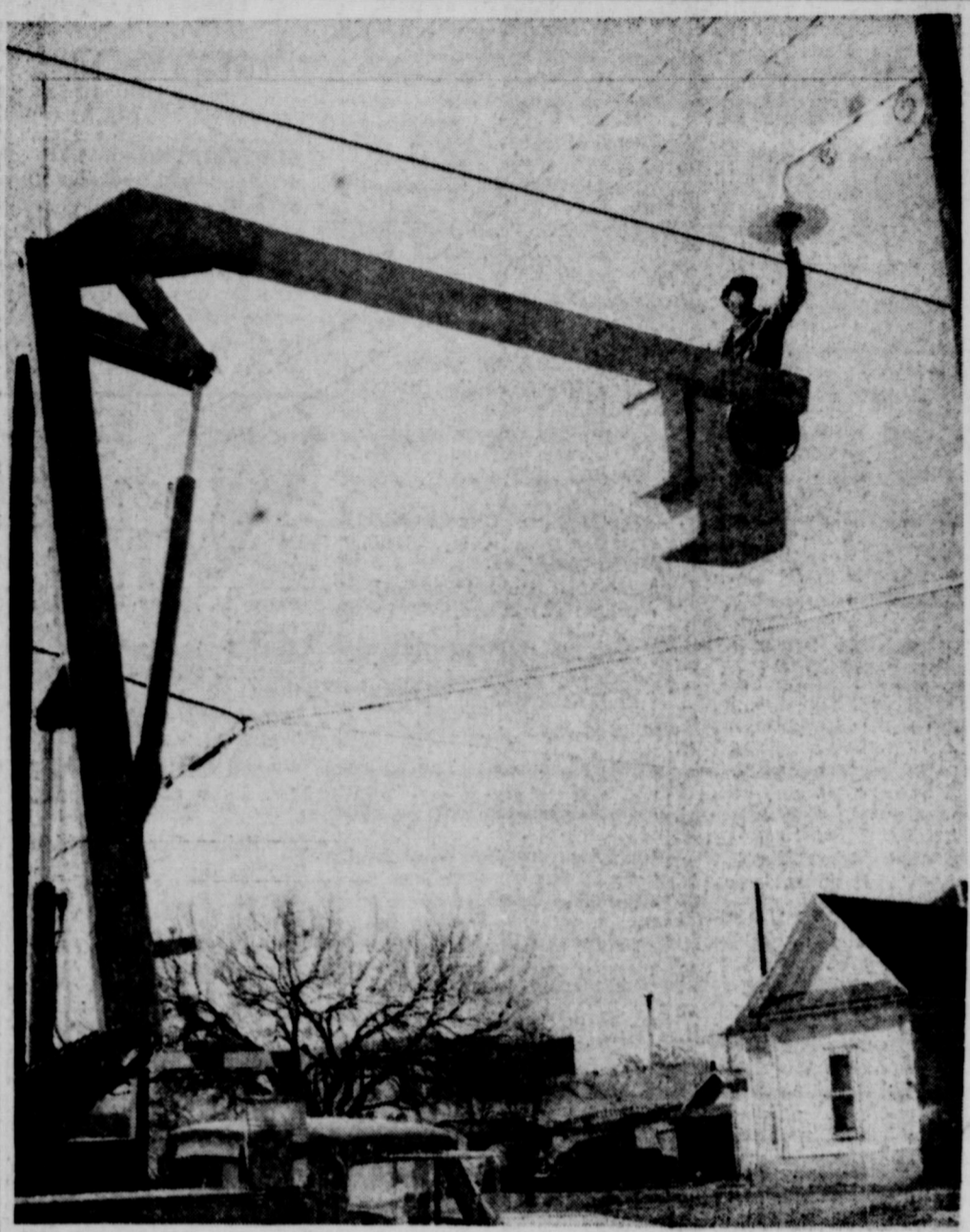

'Lift Bucket' Being Used By TESCO Pole Climbers

Pole-climbing isn't what it used to be. To help make the work easier for the Texas Electric Service Company "pole climbers," the company has put into service a new lift device. And according to the operators, their high tasks are being tackled a lot easier and a lot safer. The use of the one-man elbow truck, as it is commonly called around Texas Electric, is to alleviate the need for the workers climbing the poles for repairs. The 1½ ton truck has a fiber-glass basket with a capacity of 300lbs, sufficient to lift a man and his tools. The elbow lift reaches into space 37 feet, and is operated on 2,000 pounds of hydraulic pressure. The '65 truck used to operate the basket has torsion suspension and can be moved to any position without tipping the truck. The lift and truck are equipped at all times with protective measures for the workers, while repairing the company wires. Operators of the truck are Marlyn Jackson and James Sherrill, both of Eastland. To sum up the advantages of the truck, according to L. J. Maloney, the division engineer manager, the truck provides workers with a more convenient and safer device for their skilled work.

Expense Allowance Okay If Commissioners Agree to Use Own Vehicles, DA Says

Eastland County Commissioners will be entitled to a \$75-a-month expense allowance if they amend their original order authorizing the allowance to provide that they use their own private vehicles on official duties in the county, according to an opinion written by District-County Attorney Perry T. Brown for County Treasurer Ellen Justice. Attorney Brown bases his opinion on the third reply from the State Attorney General's Office regarding the legality of Eastland County Commissioners expense allowances. The court voted on Jan. 11 to pay themselves the allowances "as provided by law." The text of Mr. Brown's opinion for Mrs. Justice is as follows: "Dear Mrs. Justice: "Replying to your request for the opinion of the Attorney General's letter of the 18th of March: Said letter states that it is not to be construed as an official opinion of the Attorney General's office. "From said letter it is the apparent position of the Attorney General's office that the laws as stated in Article 2350a is clear. However, the application of said law depends upon the existing facts. The position of the Attorney General, as I understand it, is that if the Commissioners use their private vehicles in traveling in their districts to perform the duties of their office or attending the county seat that they may at their discretion, vote themselves the expense allowance provided in Article 2350a. "According to the position of the Attorney General's office, as it is my opinion that the order entered on the 11th day of January should be amended stating that the Commissioners elect to use their own private vehicles for the transportation on their official duties within the district and in the county instead of pickups that have been provided. 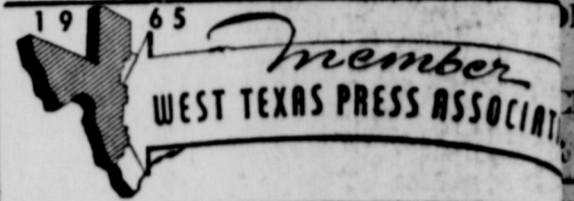

vided by the county. As the Commissioners themselves know the facts, any action they take will be as to their discretion.

"If the Commissioners revise said order of January 11 as herein suggested, and submit a copy of said revised order to you and to the other officials involved, according to the policy of the Attorney General, you would be authorized to issue and approve their vouchers for said expense allowance.

Text of a letter, which was accompanied by copies of earlier opinions regarding commissioners' expenses, received by Mr. Brown from the Attorney General's Office, is as follows:

"Dear Mr. Brown:
"This will acknowledge your letter of March 10th concerning traveling expenses for the County Judge and County Commissioners in Eastland County while traveling on official business inside the county.

You further state that Eastland County owns a number of pickups that are assigned to the Commissioners' precincts, and that you are desirous of knowing whether the members of the Commissioners Court are authorized to allow themselves \$75.00 per month for traveling expenses in the county pursuant to the provisions of Article 2350o of Vernon's Civil Statutes.

"This letter is not to be construed as an official opinion of the Attorney General's office, but in an effort to be of assistance to you I am enclosing copies of Attorney General's Opinions WW-513 (1958) and C-299 (1964). From reading these opinions you will observe that the question of whether the Commissioners are actually using the county pickups as a means of conveyance while traveling on official business within the county is a factual determination and, as you further know, this office is prohibited from passing on factual questions and can only pass on legal matters.

"I invite your particular attention to Opinion WW-513 wherein it holds that if the

Commissioners are using the county vehicles as their method of transportation while traveling inside the county, they may not be allowed expenses for operating their private vehicles; however, if, on the other hand, the commissioners use their private vehicles while traveling on official business within the county, the Commissioners Court may allow them the traveling expenses authorized by Civil Statutes. Also I believe that Opinion C-299 fully explains the allowance of traveling expenses to the County Judge while traveling on official business within his home county.

"I trust that the foregoing explanation will assist in the solution of your problem, and as above stated, this letter is not to be construed as an official opinion of the Attorney General's office.

Cancer Society Shows Relationship Between Cigarettes And Cancer

"If teenage smoking is to be reduced and if youngsters are to be discouraged from ever acquiring the cigarette habit, it will be the young people themselves who must do it," declared Mrs. Dortha Harris, Ranger Cancer Crusade chairman. "We can't pass laws that will stop them. But we can help, by making smoking seem less desirable to young people and by setting an example for them to follow."

Mrs. Harris cited an American Cancer Society study which showed that the percentage of teenage smokers is highest among children of families in which both parents smoke cigarettes; lowest in families in which neither parent smokes, and intermediate in families in which only one parent smokes cigarettes. Smoking behavior of boys was shown to conform more closely to that of the father, while the smoking behavior of girls follows more closely that of the mother.

"If people did not smoke cigarettes, at least 75 per cent of all lung cancer deaths could be prevented," Mrs. Harris said. "This year, over 47,000 Americans will die of lung cancer. And unless something is done to prevent it, the number will increase each year."

The American Cancer Society, which pioneered in research showing the relationship between cigarettes and lung cancer, is cooperating with other voluntary health agencies and the U. S. Public Health Service in a nationwide educational program to teach the facts about smoking, particularly to teenagers. American Cancer Society literature, filmstrips and teaching guides have been prepared for high school students to discourage them from taking up smoking, or to encourage them to stop smoking if they already do so.

The leaflets, "Shall I Smoke?" and "Answering the Most-Often Asked Questions About Cigarette Smoking and Cancer" have been distributed to most of the nation's secondary schools.

Another major phase of the ACS campaign is centered on gaining the cooperation of adults who influence young people—parents, teachers, clergymen, and athletes. Adults who smoke are urged to be honest with young people and tell them that smoking is not a status symbol but instead a dangerous habit difficult to break.

Governor for Day ...

Senator Creighton Due Honors On April 20th

A statewide celebration honoring Texas Sen. Tom Creighton of Mineral Wells is expected to be one of the outstanding public events of the year, when the newly elected senate president pro tempore becomes "Governor - for-a-Day" on April 20 in Austin. Sen. Creighton, who has represented the 22nd senatorial district since 1960, will on that date assume the duties of chief executive, by virtue of his election on January 12 to the post which made him third in line of succession to the governorship. It is the highest position that may be held by a member of the state legislature.

Second in line to Texas Governor John Connally is Lieutenant Governor Preston Smith. However, both officials will be out of the state, thus creating the vacancy in the top executive office. In assuming the responsibilities of the governor's chair, Senator Creighton will carry on all routine duties for the day. Following a brief ceremony in which he will take the oath of office, a reception is to be held for friends and guests during the morning at the governor's offices in the capitol building. A press conference is scheduled with the capitol press corps, and for some 50 visiting newsmen, television and radio representatives who are expected for the event from all major areas of the state. At the noon-hour, Governor Creighton will join his family for luncheon at the executive

community and state - level projects since his graduation in 1950 from the University of Texas School of Law.

As a partner in the Creighton & Creighton law firm with his father, the late J. R. Creighton, and brother, John R. Creighton, he was in 1952 and again in 1954 honored as one of the outstanding men in Mineral Wells. He served as local president and later as state vice president of the Texas Junior Chamber of Commerce, and a national director of the U. S. Jaycee organization.

Creighton is past president of the Mineral Wells Lions Club. In 1959, he was named president of the Palo Pinto County United Fund, and has served as district commissioner of Boy Scouts and regional vice president of the Texas chapter of the Association of the U. S. Army.

Prior to his election in 1960 to the office of Senator for his 10-county district, Creighton served eight years as county attorney for Palo Pinto County. Married to a Mineral Wells girl, Sue Sparks, they are the parents of three sons, Thomas William Creighton, Jr., 13, Kenneth Roy Creighton, 11, and Mark Creighton, 8. Many friends in Mineral Wells recall that Tom and Sue were married on a national network program, known at the time as "Bride and Groom."

As a member of the state senate, Creighton served as chairman of the Interim Election Law Study Committee of the 58th Legislature, prior to election to his present post as head of the senate body.
