



New Eastland-Carbon Highway Is Okayed

Work Is Included In Next Program

The State Highway Department Monday announced that they would spend \$745,000 during the 1961-62 calendar year on state highways in Eastland County. The major project in the construction program will be the re-routing and paving of Highway 6 between Eastland and Carbon.

The announcement came from Robert J. Milligan, district engineer, of Brownwood, and Gordon Smith, Eastland resident engineer.

Also included in the program is a two mile project for the extension of State Highway 206 from the Callahan County line northeast to Farm Market Road 569. A total of \$100,000 was allotted for construction and \$5,000 for right-of-way.

The Highway 6 project calls for grading, structures and surfacing from Farm Market Road 1627 in Carbon north to U. S. Highway 80 in Eastland, a distance of approximately 10 miles. Estimated cost of \$610,000 for construction and \$25,000 for right-of-way. In addition, additional \$5,000 was allotted for the purchase of right-of-way from Highway 6 in Eastland north to present Highway 6, a distance of 1.3 miles.

At a March meeting of the State Highway Commission a consolidated advance planning program for the 1961-62 fiscal year was formulated. This new program amounted to \$2,855,000 for District 29's nine counties. This money is to be spent on the

Hit and Run Defendant Is Charged With Murder

Charges of murder without malice were filed Monday against Melvin Larry McMinn, 45, of Olden, who is accused of the hit-and-run death of Homer Hopper, 62.

McMinn, who was arrested Saturday and charged with failure to stop and render aid at the scene of an accident, a felony, thus faces even a sterner charge now.

Mr. Hopper died Friday afternoon after being struck down 2.3 miles east of Eastland on Highway 80.

McMinn was arrested by Sheriff J. B. Williams and Highway Patrolman Les Strawn while at work in Olden. They made the arrest after finding gray hair and dried blood on the fender of McMinn's yellow 1956 pickup, Sheriff Williams said. Yellow paint was found on the clothes worn by the victim.

The murder without malice count charges that McMinn was under the influence of intoxicating liquor when his vehicle allegedly struck the Eastland man. McMinn remained a prisoner in Eastland County jail this morning in lieu of bond. Peace Justice C. E. Owen set his bond at \$2,500 on the murder without malice charge and \$2,500 on the failure to stop and render aid charge. The defendant is being held over for grand jury action.

Mr. Hopper had lived in Eastland County all of his life. He was a native of Kokomo.

Survivors include a son, J. S. Hopper of near Fort Worth; a brother, Ace Hopper of San Angelo; and two sisters.

Graveside rites for Mr. Hopper were held at 2:30 p.m. Sunday in Simpson Cemetery at Kokomo under the direction of Hammet's Funeral Home.

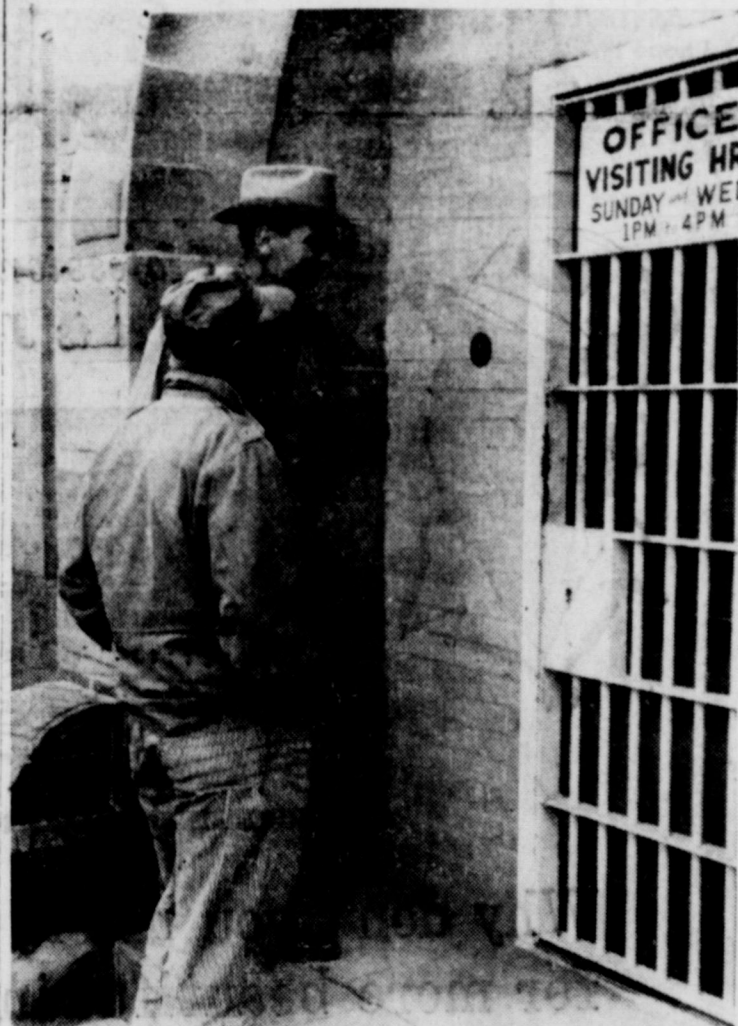

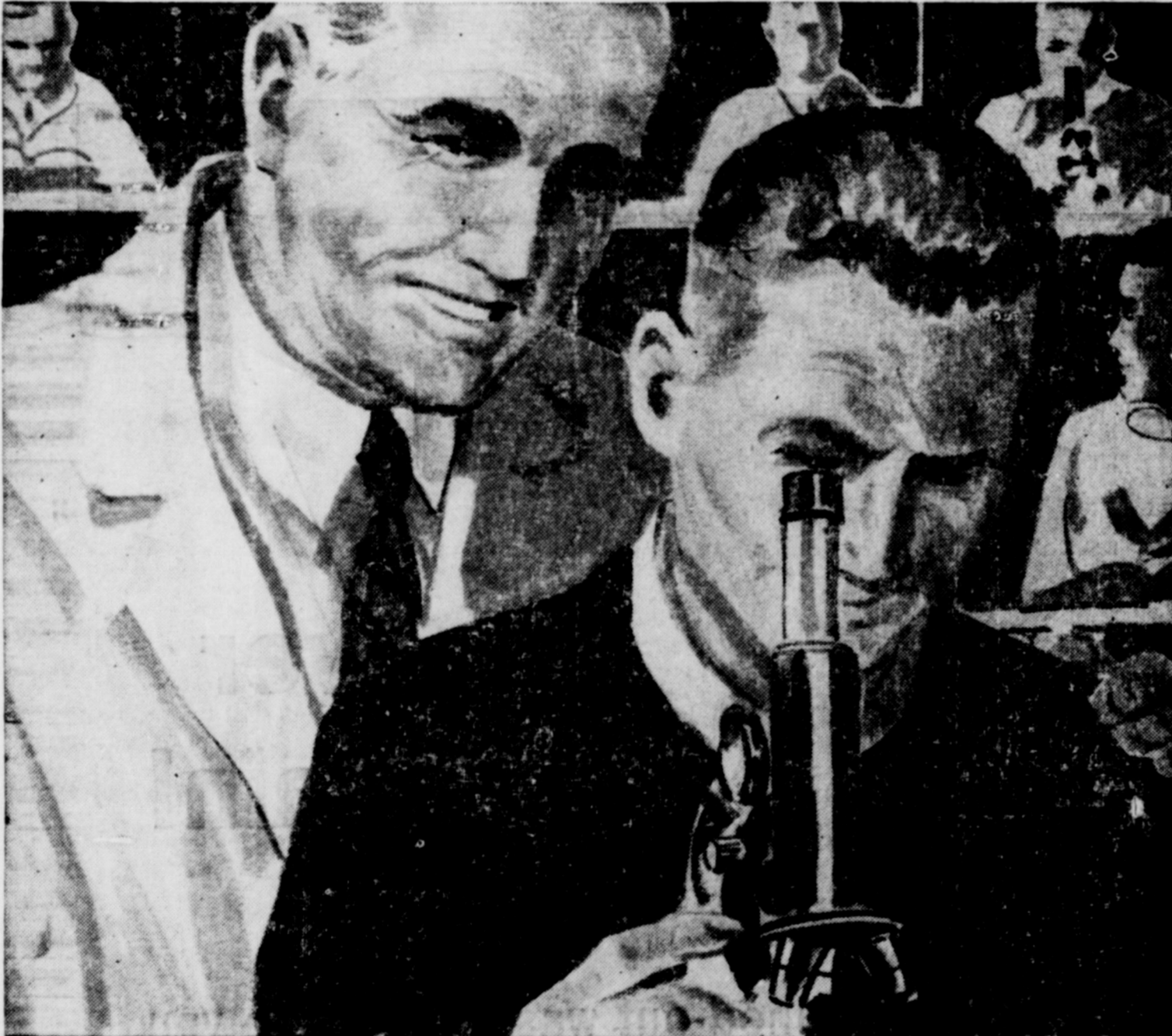
